Late surge carries Boyne past East Jordan

BOYNE CITY — After a very slow pace for the first three quarter, the Ramblers finally broke from the pack and nearly doubled their point total with a 24 point fourth quarter explosion in handing East Jordan a 51-38 Lake Michigan Conference loss on February 10.

Corey Redman paced the Ram-

blers with 16 points and 10 boards, while Keegan LaBlance added 15 points and Jay Redman 11 points in leading Boyne City.

The Red Devils struck first as Noah Bacchus nailed a triple to open the scoring after about a minute of play, shortly before the Ramblers struck as a driving Ryan Carson spun out of a double team and found an open Jay Redman for a 15 foot jumper.

The game moved back and forth with neither team able to find a rhythm do to their opponent's defense.

East Jordan took a 15-9 lead with 2:57 left in the second as a hot shooting John Richards connected on three triples for the Red Devils.

The Red Devils led at the break 19-17, and a Boyne City layup by Garritt Moeke at the end of the third knotted the game at 27-27.

"We were out of sync for most of the game," Boyne coach Nick Redman said. "Hats off to coach Weber for that, they did a good job of slowing the game down and we played their pace."

The Ramblers took the lead for good on a Keegan LaBlance triple with 6:19 remaining in the fourth and then added to it with a steal and layup conversion on the next possession for a 34-31 Boyne City lead.

With 1:38 remaining in the contest East Jordan looked to send the Ramblers to the line every chance they got and freshman Corey Redman brought it home for Boyne, hitting 7-of-8 free throws in that time frame. ""I am proud of how the guys stuck together," coach Redman said. "We didn't play well but stepped up in the fourth quarter when we needed it, we knew free throws would be big against them."

The Ramblers, which improved to 10-4 overall, 6-4 conference also got seven rebounds from Ryan Carson.

East Jordan slipped to 3-12 overall, 1-9 conference was led by 17 points from John Richards.





Rayders roll past Kalkaska, but three game win streak ends against Elks

CHARLEVOIX — The Rayders came into the game flying high on a three game winning streak, only to see that come to an end at the hands of the Elks 68-55 on February 10 in Lake Michigan Conference play.

Luke Morrison led three Elks in double figures with 28 points, while Phillip Hayes added 15 and Austin McMullen chipped in with 13.

The shorthanded Rayders were led by 16 points from Charlie Hamilton, while Andrew Potter finished with14 and Tanner Catt added 11.

Caleb Gelinas finished with eight points for Kalkaska, 0-9, 0-13.



Section 48-201. Medical Use of Marijuana

A.Intent and Purpose. The purpose of this section is to implement land use regulations to address the medical use of marijuana as authorized by the enactment of the Michigan Medical Marijuana Act (hereinafter referred to as the "MMMA"), Initiated Law 1 of 2008, MCL 333.26423, et seq, and its administrative rules, R333.101, et seq.

B.Regulations for Qualifying Patients. The medical use of marijuana by a qualifying patient in that qualifying patient's dwelling is hereby recognized as an accessory use to the principal residential use of the dwelling and can be established without a zoning permit in any zoning district, but shall be subject to the following regulations:

- 1. The qualifying patient must be issued and at all times must maintain a valid registry identification card by the Michigan Department of Community Health under the provisions of MMMA.
- 2. All marijuana plants or products must be contained within the dwelling in an enclosed, locked facility that permits access only by the qualifying patient
- 3. If a room with windows within the dwelling is utilized to grow marijuana for medical use, any artificial lighting shall be shielded to prevent glare, must not be visible from neighboring properties, and must not be visible from adjacent streets or public ways.
- 4. All activities of the qualifying patient shall be in strict accord with all state law and regulations.
- C.Regulations for Primary Caregivers. The medical use of marijuana by a primary caregiver is hereby authorized as a home occupation by right in any zoning district, provided that all of the following regulations are met:
 - 1. The primary caregiver must be issued and at all times must maintain a valid registry identification card by the Michigan Department of Community Health under the provisions of the MMMA, and all activities of the primary caregiver shall be in

- nance
- 3. All marijuana plants or products must be contained within the dwelling in an enclosed, locked facility that permits access only by the primary caregiver.
- 4. If a room with windows within the dwelling is utilized to grow marijuana for medical use, any artificial lighting shall be shielded to prevent glare, must not be visible from neighboring properties, and must not be visible from adjacent streets or public ways.
- 5. No more than one (1) primary caregiver shall be permitted to function as a home occupation servicing qualifying patients within a dwelling.
- 6. No qualifying patients under the age of 18 (eighteen) shall be permitted at any time at a dwelling in which a primary caregiver is functioning as a home occupation, except in the presence of his/her parent or guardian and except when the qualifying patient resides with the primary caregiver at the dwelling.
- 7. No marijuana for medical use shall be dispensed by the primary caregiver to qualifying patients at the dwelling in which a primary caregiver is functioning as a home occupation, except when the qualifying patient resides with the primary caregiver at the dwelling. Except as provided herein, the primary caregiver shall deliver all marijuana for the medical use of such qualifying patient, and such delivery shall take place on private property away from public view. Any such delivery vehicle shall be unmarked and not bear any emblem or sign that would indicate the nature of its cargo.
- 8. No marijuana for medical use shall be consumed, smoked, or ingested by a qualifying patient by any method at a dwelling in which a primary caregiver is functioning as a home occupation, except when the qualifying patient resides with the primary caregiver at the dwelling.
- 9. A dwelling in which a primary caregiver is functioning as a home occupation shall display indoors and in a manner legible and visible to his/her qualifying patients:
 - a. A notice that qualifying patients under the age of eighteen (18) are not allowed at a dwelling in which a primary caregiver is

- b. A notice that no dispensing or consumption of marijuana for medical use shall occur at a dwelling in which a primary caregiver is functioning as a home occupation.
- 10. A dwelling in which a primary caregiver is functioning as a home occupation shall not have any outdoor signage that would indicate the nature of the primary caregiver services being conducted in the dwelling.
- 11. A dwelling in which a primary caregiver is functioning as a home occupation shall not be located within three hundred (300) feet of any of the following uses:
 - a. Any church or place of worship and its accessory structures.
 - b. Any public or private school, having a curriculum including kindergarten through twelve grade and its accessory structures.
 - c. Any preschool, child care or daycare facility and its accessory structures.
 - d. Any public facility, such as libraries, museums, parks, playgrounds, public beaches, community centers, and other public places where children may congregate.
- 12. The portion of a dwelling in which a primary caregiver is functioning as a home occupation, including any room or area utilized to grow marijuana for medical use, shall contain electrical service and wiring meeting the applicable requirements of the electrical code in effect in the City.
- D.Relationship to Federal Law. Nothing within this section is intended to grant nor shall it be construed as granting immunity from Federal law. Further, nothing in this Ordinance permits activities that are otherwise illegal under state or local law.
