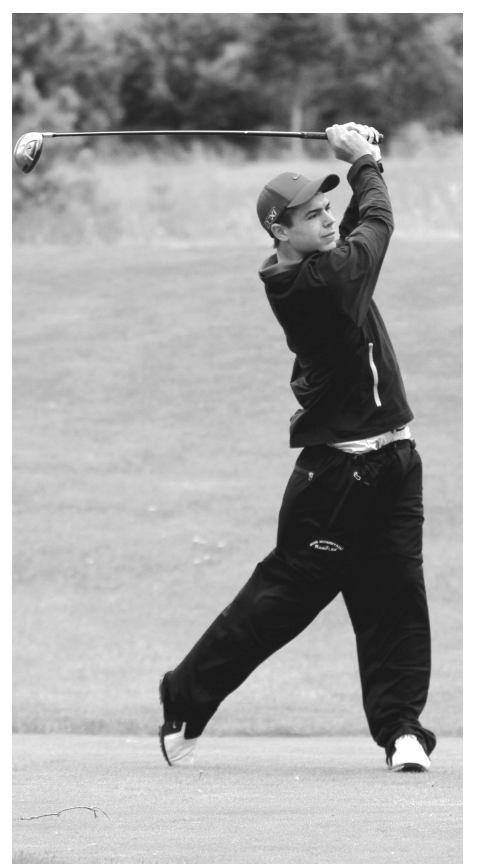

When buying exercise equipment, you should think about certain things. Among these are:

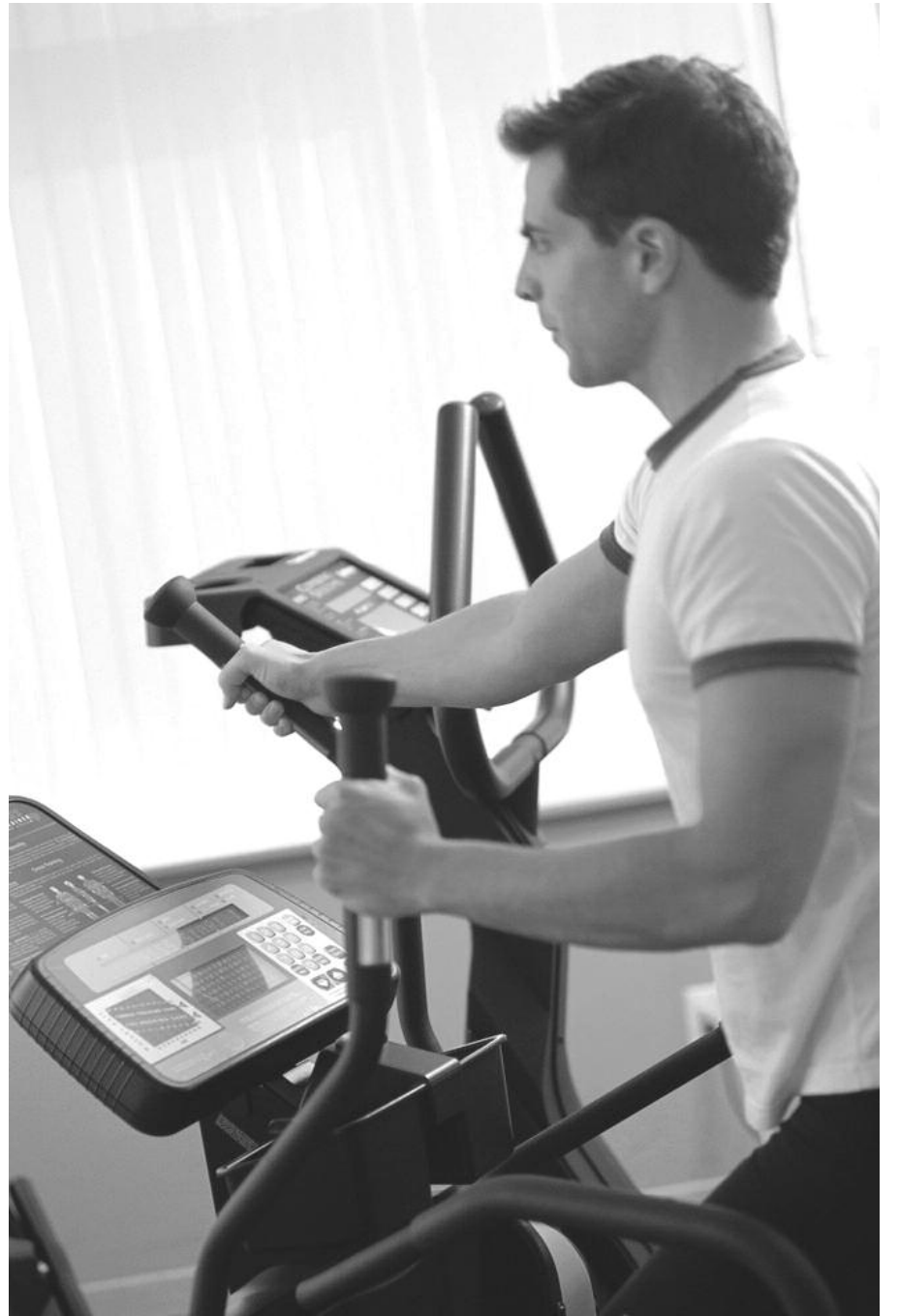

- Is it well made? Does it seem rickety? Are sharp edges covered or smoothed?
- Is it adjustable? Can you make it easier or harder?

Aerobic Exercisers

When people think about buying a home gym, they immediately think of aerobic exercise equipment. Stationary bicycles, treadmills, elliptical trainers, and stair steppers all fall into this category. These machines are good for burning fat and improving cardiovascular health. Aerobic exercise is essential to fitness, so if you're only going to buy one piece of equipment, an aerobic machine is what you should buy.

EXERCISE BIKES. Almost every American is familiar with these. An exercise bike is great for overall cardiovascular fitness, tones the legs and buttocks, and aids in losing weight. Many of these also have some kind of built-in exercise for the arms. Exercise bikes come in a range of prices, from \$80 to \$500.

TREADMILLS. A treadmill lets you walk or run inside your home, with many models offering incline adjustments (simulating



hills) and built-in programs to keep your interest. There are great fitness machines, but probably aren't for people with degenerative bone or joint disease, as they offer a relatively high impact level. Treadmills are also fairly expensive, ranging from \$399 to \$2499 and more.

ELLIPTICAL TRAINERS. These are not as common as bikes or treadmills, but offer a great workout without the impact of treadmills. Ellipticals offer a motion more like cross-country skiing or hiking, which helps reduce wear and tear on the joints. Many also include some kind of arm exercise. They range in price from \$399 to \$999.

STAIR STEPPERS. Most people are fairly familiar with these machines, which offer an exercise that is similar to climbing a flight of stairs. Arm exercises aren't usually an option with these. Some of these are very inexpensive, with prices as little as \$80, but stick with those that cost

\$150 and up.

Weight / Resistance Machines

Many people are afraid of weight equipment, and it's true that free weights can be dangerous. But weight training is an essential part of fitness. Resistance machines offer a range of weight and resistance exercises that build muscle and improve endurance. Many people consider buying some kind of multi-gym or fitness machine for the home, and that's a good idea for someone who has the space to spare and the money to spend. Prices range from \$399 to \$900 and up.

To find out more, go to your local sporting goods store or stop by a department store. They usually have a good range of exercise equipment. With a little money and a little effort, you may find yourself traveling the road to a fitter, firmer you very soon.

Norwood Township Ordinance Number 4 of 2012

An ordinance to amend Articles III, of the Norwood Township Zoning Ordinance pertaining to General Provisions.

The Township of Norwood Ordains:

Section 1. Amendment of Article III, Section 3.36
Article III, General Provisions, of the Norwood Township Zoning Ordinance is hereby amended to add Section 3.36 Site Reclamation to read in its entirety as follows:

Section 3.36 Site Reclamation

Final grading and site restoration in accordance with the unique character of the surrounding area shall be included in a reclamation plan submitted as part of the site plan application, (when required by this Ordinance), and must be approved by the Planning Commission prior to the issuance of a zoning permit.

1. General Reclamation requirements

A. All reclamation activities shall be initiated, as described in the approved reclamation plan, at the earliest possible date, and will be phased if so authorized by the Planning Commission.
B. Areas shall be reclaimed pursuant to the reclamation plan approved by the Planning Commission and shall comply with the following minimum standards:

- 1.) Upon completion of the excavation or the expiration of the SUP, whichever is sooner, the site shall be restored in compliance with the approved reclamation plan, including all disturbed surfaces, shall be stabilized with vegetation to minimize erosion issues.
- 2.) Vegetation shall be restored by the appropriate seeding of grasses, or the planting of trees and shrubs, to establish a permanent vegetative cover on the land surface to stabilize the soil and minimize erosion and match the pre-existing vegetation unless otherwise approved by the Planning Commission.
- 3.) The reclamation area shall be graded so that no gradients in disturbed earth are steeper than a slope of 1:3 (vertical:horizontal).
- 4.) The native stockpiled topsoil and additional materials (as necessary) shall be spread over the disturbed area, to a depth equivalent to the pre-excavation depth, except exposed rock surfaces, roads or other planned improvements which remain in accordance with the approved reclamation plan.
- 5.) Backfill and grading materials shall not be noxious, flammable or toxic.
- 6.) Fill and soils shall not be overly compacted and of sufficient quality to be well drained, non-swelling. If the reuse plan involves development of dwellings or other buildings, fill and soils shall be of proper bearing.
- 7.) Any site debris, brush and tree piles, temporary structures and/or berms which are not part of the approved reclamation plan shall be removed.
- 8.) All temporary structures and/or structures no longer being utilized for their intended and approved purpose (including associated footings to a minimum depth of five feet) shall be completely removed from the premises upon completion of the activity unless said structures are of sound construction and are compatible with the reclamation goals. Said structures shall be accurately depicted upon the approved reclamation plan.
- 9.) If the reuse plan involves a recreational or wildlife facility, reclamation plans shall be reviewed by recreation, fisheries and wildlife specialists in the Michigan Department of Natural Resources.
- 10.) The reclamation process shall be completed within one year and shall comply with all federal, state, county, or local erosion control, soil stabilization and/or runoff requirements or ordinances.

11.) The Planning Commission may impose additional reclamation requirements based on the site specific conditions to ensure the reclaimed site will be compatible with surrounding areas.

C. The applicant shall be required to post an acceptable performance bond pursuant to Section 8.06 of this Ordinance in the amount of the estimated reclamation costs, as approved by the Township.

D. Site activities shall not be initiated on any location of the site until such performance bond has been posted for that area of the site. The performance bond shall be held by the Township for one year from date of completion of the restoration to ensure that site restoration is established.

For long-term projects, a re-evaluation of the performance bond shall be required every three years to ensure the performance bond is still a sufficient amount for adequately covering the restoration cost for the site.

2. Site Specific use requirements
A. Sand and/or Gravel Borrow Pit Reclamation: For an excavation site, reclamation concurrent with excavation activities shall be undertaken to the extent that the reclamation activities will not interfere

with the excavating activity or if the activity will damage the reclaimed areas. Areas shall be reclaimed pursuant to a reclamation plan approved by the Planning Commission and shall comply with the following additional standards:

- 1.) Excavation, which has created or extended lakes, ponds or other bodies of water shall meet standards and specifications (particularly with respect to underwater slopes and drop-offs) promulgated by the U.S. Department of Agriculture, Natural Resources Conservation Service, and shall be approved by that agency.
- 2.) Where excavation operations result in a body of water, the owner or operator shall place appropriate "Keep Out-Danger" signs around said premises not more than one hundred fifty (150) feet apart.
- 3.) Fencing for public safety may be required by the Planning Commission, based on site specific conditions such as proximity of the excavation area to a property line, or road right-of-way.

Section 2. Severability

If any section, clause, or provision of this Ordinance be declared unconstitutional or otherwise invalid by a court of competent jurisdiction, said declaration shall not affect the remainder of the Ordinance. The Township Board hereby declares that it would have passed each part, section, subsection, phrase, sentence, and clause irrespective of the fact that any one or more parts, sections, subsections, phrases, sentences, or clauses be declared invalid.

Section 3. Conflicts.

If any provision of the Norwood Township Zoning Ordinance conflicts with this Zoning Ordinance Amendment, then the provisions of this Zoning Ordinance Amendment shall control

Section 4. Effective Date.

This Ordinance shall become effective eight (8) days after being published in a newspaper of general circulation within the Township.

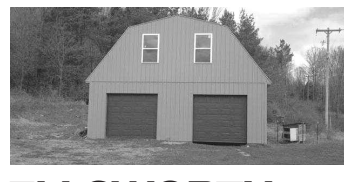

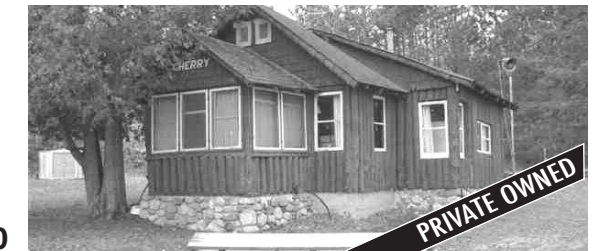

Make spring cleaning less of a chore by following these smarter—and mostly greener—tips for this annual rite of homeownership.

Bathrooms

When it's time to get down and dirty, many people start with the bathroom. Allen

Rathey, founder of The House-keeping Channel, says removing mineral deposits, rust, and such from toilets doesn't have to mean chemical warfare. Don rubber gloves and use a pumice stone to erase stubborn stains. If you want more scouring power, Rathey recommends mixing baking soda with acidic vinegar. The concoction is just as effective as conventional cleaners, and there are no toxic fumes to inhale. This approach works equally well on tub and

shower stains.

Buy your supplies in bulk to save. A 64-ounce bottle of vinegar costs about \$4; a 12-pound bag of baking soda, about \$7. Both items can be used throughout the house. For just \$1 you can mix equal parts vinegar and water in a 32-ounce spray bottle to make a terrific all-purpose surface cleaner. That's about \$4 cheaper than buying a spray cleaner at the store.

Spring cleaning is the per-

fect time to extract dirt from porous grouted surfaces. For tile floors use your usual cleaner, but don't mop. Instead, run a wet/dry vac, which will suck contaminants out of the grout. Mopping drives the grime into the grout rather than removing it. According to Rathey, grout can harbor stinky bacteria that leave a bad odor in the bathroom. This technique is more time-consuming than mopping, but it's worthwhile to do at least once a year.
