

Charlevoix County Commissioners made the announcement that the proposed non-motorized trail to run alongside the Boyne City/Charlevoix road will not officially be under construction until sometime next year.

Lucas Porath of NDG Consulting came before commissioners last week to explain the difficulties facing trail construction this year. Although Phase 1 has received funding, bids for the project have not yet been placed due to disagreements between Young State Park owners and the Michigan Department of Transportation (MDOT). According to Porath, the two cannot agree on what the easement is in front of Young State Park.

Phase 1 of the trail starts in Boyne City and runs to the Bay Evangeline Township line for a total distance of 3.2 miles. The path runs directly across Young State Park property which is owned by the DNR. The DNR would like to lease the easement to the Road Commission as opposed to giving a "granted easement" which MDOT would like in order to give the go ahead for the trail. According to Porath and County Parks and **Recreation Director Ross** Maxwell, this discord between the DNR and MDOT is the only issue standing

News DEQ cleans up for gas station site in East Jordan

EAST JORDAN-Orange tape and caution barrels at the corner of C-48 and M-66 have raised questions for some commuters or been lumped in with other road construction projects further up C-48, on the bridge by others, but the backhoes tearing up the property behind the Charlevoix Properties office are part of a soil contamination clean-up conducted by the Michigan Department of Environmental Quality.

The cleanup across the street from the EZ Mart/BP Station is a MDEQ project to clean up soils and groundwater contaminated by fuel from a former Mobil filling station on the site. The project is expected to last through the months of July and August with another few weeks to reestablish cover vegetation.

The property ceased to be used as a gas station in the mid 1980's and prior to Charlevoix Properties taking up residence in 1990 it was a video store. The clean-up is taking place now because of funds available from the Obama administration specifically to clean up these sites. "I knew the site was contaminated when I purchased it. I had a BEA completed which identified what was here and I





made a record of that," said Property owner Gary Strange who stated there was a large amount of contamination.

Strange has pictures of the gas station located on the property that date back to 1940 before environmental regulations were in place." It goes way back, so now there is funding available to do cleanup so the site can be restored and put back into the market for development," he said.

Charlevoix Properties is still open during the clean-up project. The hours of operation are 9-5 and parking is available in the front of the building. "T'm happy that the project is finally underway I'm looking forward to it being completed. They just did this at the Top Ten store across from the farmers market. The site looks nicer when they are done than when it started and I hope that is the case here," said Strange.

Boyne City Bike Racks

Five new bike racks designed by The Woodshop and fabricated by family owned and operated P.I.W Corporation in Gaylord have been placed around town. in front of construction. "The hang up all along has been the DNR and MDOT are not agreeing on the terms of that easement," said Maxwell at the meeting.

The commissioners were frustrated with the delay, but more so with the disagreement between the DNR who helped fund Phase 1 and MDOT.

"This is ridiculous the



same people loaning you the money are the same people who have problems..." said Commissioner Chris Christenson.

Maxwell explained that once an agreement between MDOT and the DNR is reached a two month lag will ensue before bids can be accepted. Following that it will take 3 to 4 weeks to find the right contractor. With that time line bid opening wouldn't be feasible until at least October according to Maxwell.

"Basically what you're saying is you're not going to get it built this year," stated Commissioner Ronald Reinhardt.

In other commissioner news, two millages will be on the August ballot for community members to decide whether or not to fund. One is the Parks and Recreation Millage which will allow voters to choose whether or not to fund area parks which are currently funded by the county. Another is the Veterans Millage which gives voters the option to give funds to any projects involving area veterans. According to some of the commissioners such a millage may be a good thing in the long run.

"This would probably generate more money than we currently give them," said Reinhardt of the Veterans Millage.

The next commissioners meeting will take place Wednesday, August 13th at 9:30 a.m. in the County Building located in Charlevoix.

News _____ **Classic Instruments of Boyne City goes green**

BOYNE CITY - Classic Instruments of Boyne City has made their commitment to the environment a physical part of their business. Instead of making cost a priority the company that creates instrumentation for classic cars, boats and other vehicles, have poured a new permeable concrete parking lot intended to keep all of the surface water on their site without using a retention pond.

The "green" parking lot which costs about 50-75 percent more than a normal parking lot will also eliminate site run off that would create erosion. Classic Instruments has found a way to balance the demand for development with the need to preserve our nat-

ural resources. "We still have a manufacturing plant to run and we are still going to have trucks in and out and all of the things that happen in the normal course of business, but at the front of our minds throughout this entire building project has been how to minimize our impact to the environment," said Ron Hanna, General Manager.

The permeable concrete allows water to go straight through and not run off the surface of the parking lot. Underneath the concrete is 8 inches of stone to hold the water and let it dissipate into the ground, instead of sheeting off the top which creates erosion from the runoff. Typical parking lots are sloped to allow the surface water to run off, and require a holding pond to hold that water and let it go into the ground, or a ditch system to move the water.

Without this lot, the runoff from the back of the building would have to all go to the pond in front of the building.

Pervious concrete is a basic mix of coarse aggregate, cement, water and little to no sand. Also known as "no-fines" or porous concrete, this mixture creates an open cell structure allowing rainwater to filter through to underlying soil. "From what we know, this is the first permeable concrete project of this size that is being completed this far north and we committed to do it, with help from Bayko Concrete and R&B Excavating, in an effort to do the best for our environment and be a leader in green initiatives so that others may follow once proven successful," said Hanna.

The company considered the option of using permeable concrete an excellent choice for storm water management. "Living up north, we have a large percentage of our employees that are outdoors people and we are close to a natural trout stream. Besides managing the surface runoff, the permeable concrete has the advantage of not being a large heat sink like an asphalt lot would be," he said.

Part of Classic's company mission statement is 'provide an ever increasing level of service to their customers, employees, and community.' Hanna said, "Making the investment into this permeable lot is definitely a benefit to our local community and environment."



Many Treasures to be found at Goodwill Retail & Distribution Centers in Petoskey and Gaylord

It is a well-recognized name that symbolizes services and programs that provide a means for people in need to get back on their feet and regain their treasured independence. Goodwill has been around since 1902, when a Boston area Methodist Minister named Rev. Edgar Helms began collecting used household goods and clothing, and hired those who were down on their luck to mend and repair those goods for resale. Here in Northern Michigan, Goodwill opened their doors at Asgard Enterprises in 1972, and today the non-profit organization offers vocational, housing, transportation, nutritional and family strengthening programs across the region.

Goodwill also continues to offer gently used clothing, household items, books, home décor accessories and more at their Retail and Donation Centers. In our area, centers are located in Petoskey and Gaylord, employing a total of 34 people, utilizing proceeds from sales at each location to help support programs throughout Northern Michigan that help people overcome barriers to independence.

"Part of our business model is also being 'green,'" observes

Ruth Blick, Director of Marketing and Communications for Goodwill Industries of Northern Michigan. "Everything that is donated to our stores is either reduced, reused or recycled. Items that come in that don't meet quality standards go thru our salvage program. We are also in partnership with Dell Reconnect and we accept all types of computer equipment and recycle those items. Many people don't realize that a computer monitor can contain up to a pound of lead. We are able to safely recycle those units."

Goodwill also recycles metal items, cardboard, purses, belts,

shoes, books and clothing. The gently used items on the sales floor follow a rotation model where they are on display for four weeks a regular price, then half-off for a week, then reduced per item to 99-cents for adult sizes and 49-cents for children sizes, and those items are finally recycled if not sold.

"So there are always items at sale prices when someone visits our store." observes Ruth Blick. "People want to see different items on display when they visit us. Thousands of items are regularly coming in and going out of our stores."

Submitting items for donation

is easy. Each location has a drive up donation center, open 7 days a week, and members of the Goodwill team will happily unload items from the donator's vehicle.

The 6,000 square foot Goodwill Retail and Donation Center at 1361 Pineview Drive in Gaylord is open Monday through Saturday from 9 am to 7 pm, and Sunday from 11am until 6 pm. The 6,700 square foot Goodwill Retail and Donation Center at 1600 Anderson Road in Petoskey is open Monday through Saturday from 9 am to 8 pm, and Sunday from 11am until 6 pm.

Watershed Council calls on super sniffers for monitoring assistance

Tip of the Mitt Watershed Council, in partnership with the City of Petoskey and the City of Charlevoix, were recently awarded grants from the Petoskey-Harbor Springs Area Community Foundation and the Charlevoix County Community Foundation to bring Logan, the sewage sniffing dog, and his trainer, Karen Reynolds of Environmental Canine Services, to Northern Michigan.

Logan will be investigating storm drains in the cities of Petoskey and Charlevoix on August 4 and 5, respectively, to identify and locate sources of human fecal contamination in storm drains that discharge to local lakes, rivers, and streams.

"Dogs have amazingly sensitive noses and with their help we are able to locate sources of bacterial

and Research at Tip of the Mitt Watershed Council. "Finding the precise locations where waste enters the storm drain network is challenging, but the dog's keen sense of smell and specialized training narrows our search for contamination and, as a result, is more cost effective.'

The public is invited to see Logan the "super sniffer" and his trainer in action during a free demonstration on Monday, August 4 at 4:00 p.m. in Pennsylvania Park, next to the Watershed Council office, in Petoskey and again on Tuesday, August 5 at 4:00 in East Park in Charlevoix. The event will include a meet and greet with Logan, followed by a presentation, demonstration and question-and-answer session. The event is open to all ages.

A Great Lakes Energy Cooperative member was contacted today by scammers attempting to collect money. The electric member, a local business in Gaylord, was contacted by phone by a person posing to be with Great Lakes Energy. The caller had an accent and threatened to shut off the member's electric service if the account was not paid immediately.

The GLE member wisely hung up and called his electric cooperative to report the incident. The member received confirmation from Great Lakes

Energy that the call requesting payment was a scam.

This is the same scam that was reported in June by another GLE member. Other utility customers across the country have also been targets of similar scams.

Any GLE member who receives a call from someone claiming to be from Great Lakes Energy and feels pressured for immediate payment or personal information is advised to hang up the phone and call their electric cooperative. Great Lakes Energy members

can call 888-485-2537 and speak to any GLE member service representative. Co-op members, or any consumer, should never give out personal information, including financial account numbers or social security numbers, over the phone or internet to someone they do not know.

for over a year as part of what he calls his Michigan First Listening Tour. "I've had the privilege to meet with folks in Charlevoix and Boyne City. I think it is important that we do more listening than talking, and I will continue to make sure that the issues families struggle with around their kitchen table are the top priority in Washington," he said. Peters stated that one of his goals was to make sure that Northern Michigan has a strong voice in the U.S. Senate. He said his top priority is working to reinvest in Michigan's economy and grow jobs. "We have the talented workforce, robust small businesses, agriculture success, and the entrepreneurial spirit as Michiganders to lead the nation and the globe," he said. In the U.S. Senate, he intends to work to strengthen the economy and the middle class focusing particularly on small businesses while working to promote conservation and job creation. Gary Peters lives in Oakland County with his wife Colleen.

Land didn't respond to inquiries.

For Michigan's representative in congress, 1st district, Republican Alan Arcand and Democrat Jerry Cannon are running for incumbent Dan Benishek's seat. Michigan's 1st congressional district is a United States Congressional district containing the entire Upper Peninsula of Michigan and part of the Lower Peninsula.

Alan Arcand believes in the preservation of the constitution. The Air Force veteran describes himself as being firmly grounded in the constitution and is challenging Benishek because he says that "A lot of his voting is unconstitutional."

Benishek and Cannon did not respond to inquiries.

Republicans Greg MacMaster and Wayne A. Schmidt and Democrats Phil Bellfy and Jimmy Schmidt are all vying for State Senator representing the 37th district to replace Sen. Howard Walker, R-Traverse City, who declined to run for a second term. The 37th district includes Luce, Chippewa, Mackinac, Emmet, Cheboygan, Charlevoix, Antrim and Grand Traverse Counties.

The Senate consists of 38 members who are elected by the people of districts having approximately 212,400 to 263,500 residents. Senators are elected at the same time as the governor and serve 4-year terms concurrent with the governor's term of office. Terms for senators begin on January 1, following the November general election.

Phil Bellfy is passionate about the environment. He has been working on environmental issues for forty years. He is a retired MSU professor where he taught Native American Studies and English. He currently resides in Sault Sainte Marie. "I want to represent human beings. I want to deal with issues that affect people and I do not adhere to the philosophy that corporations are people," he said. He believes the Enbridge pipeline under the straits is an environmental threat that needs immediate attention and is against fracking. He also stated the destruction of the middle class, the right to work law and the defunding of the public schools as issues he has a deep interest in. "Education is very, very important to me," he said.

Jimmy Schmidt, a resident of Central Lake, describes himself as pro-life and pro traditional marriage and strongly supports the personal property tax reform ballot question, Proposal 1. The proposal would reduce and eliminate the personal property tax on small job providers and manufacturers, as well as provide more stable funding for local services, including police, fire, ambulances, schools, jails, senior services, roads, and libraries. "I support legislature that helps the people," he said. He also supports a part-time legislature and hydro-electric power. "In 2008 the state of Michigan put a cap on our ability to choose which electric company we want, I want to remove that cap," he said.

Wayne Schmidt is presently chairman of the House's transportation committee, was first elected to the Michigan House of Representatives in November 2008 in the 104th district representing the residents of Grand Traverse County. His third term of office ends in 2014. Throughout my work as a State Representative, I have focused on examining the issues, finding the best solution and crafting a genuine plan for the future to effectively deal with the problems facing our state. I believe the taxpayers expect me to solve problems, find solutions and get results," he said.

Greg MacMaster did not respond to inquiries.

The 105th district in the state legislature consists of Charlevoix, Antrim, Otsego, Montmorency and Oscoda Counties. Republicans Triston Cole, Tony Cutler, and Michael Vickory and Democrat Jay Calo are running for the seat currently held by second-term state Rep. Greg MacMaster, R-Kewadin. MacMaster announced his intentions to not seek a final third term and run for state Senate.

There are 110 Michigan Representatives who are elected by the people of districts having approximately 77,000 to 91,000 residents. Legislative districts are drawn on the basis of population figures through the federal decennial census. Representatives

are elected in even- numbered years to 2-year terms, with the current term expiring on December 31, 2014. Each Representative is limited to serving 3 terms.

Tony Cutler believes in smaller government that works at the local level. "As a city commissioner, I know first-hand the importance of taking the power out of Lansing and putting it back into the hands of the people," he said. He has worked to cut taxes and make government more accountable on the local level. "We need the right kind of experience representing us in Lansing and not out of state special interest," he said. Cutler teaches Marketing, Finance and Economics at Boyne City High School and as





such has a desire to see a focus on education that will give students the best possible opportunities to succeed. He is a graduate of East Jordan High School and Lake Superior State University, "I credit public education for helping me throughout my life and look forward as a legislator to ensuring our students have the same opportunities I had," he said. Another priority for Cutler is roads. "Fixing Michigan roads is a major priority that we must deal with head on. It has been suggested that we reallocate taxes paid at the pump to go to roads. While that sounds good in theory, this is a typical politician plan; fix one problem and create two new ones. Reallocating those dollars means taking away from education and local revenue sharing and as a teacher and city commissioner, that just isn't common sense," he said. Cutler is suggesting a funding mechanism tied directly to roads. "One that accounts for alternative fuels and more fuel efficient cars and one that will be guaranteed to go directly towards road improvement," he said.

Jay Calo was born and raised in Kingsford, in the UP. He attended Michigan State University and earned a degree in Political Science. He has a unique background having worked in the Michigan House, as a public school teacher, and for the private sector. "I believe this diverse history of careers prepares me to be a strong advocate for what we need in Northern Michigan," he said. He has a desire to see a strong Michigan.

"I want my two young daughters to grow up in a strong and secure Michigan, like the one I grew up

dividuals to improve private lands, has participated in the prosecution of farmers and has become much too powerful. It's time to rein them in," he said. "We need new ideas and people who will think outside of the box to bring solutions to the problems that in many cases have been created by State and Federal governments," he added.

Cole did not respond to inquiries.

The 106th district consists of Cheboygan, Presque Isle, Alpena, Alcona and Iosco counties. Three democrats are running against incumbent Peter Pattalia (R) of Presque Isle.

Robert Kennedy lives in Harrisville with his wife Margy. Issues he feels strongly about include repealing the state pension tax imposed on retired people, restoring full funding for public schools, business tax incentives linked specifically to job creation, protecting our fresh water and natural resources, fair revenue sharing with our local units of government, protecting the reproductive rights of women, repealing the "Right to Work" laws, and marriage equality, regardless of sexual orientation. Mackinac, Chippewa and Emmet Counties. Candidates Lee Chatfield (R) from Levering and Jim Page (D) from Sault Saint Marie are contending incumbent Frank Foster (R) from Petoskey.

Jim Page decided to run for office after becoming dissatisfied with the current lack of positive leadership in Lansing. He is a former math and computer education instructor at Sault Area Middle School. He plans to become the middle class voice for all of Chippewa, Mackinac and Emmet counties, as well as part of Cheboygan County.

Frank Foster is seeking a third term in the state House's 107th district "I am a 4th generation resident of Emmet county. My family is in the construction business building family homes and cottages in Northern Michigan. I was elected in 2010 and serve as chairman of the house committee on commerce and I am focused on job creation," he said. He is also a strong supporter of local control and has earned endorsements from Right to Life of Michigan PAC, MI Chamber of Commerce, National Rifle Association, MI Farm Bureau, and long list of other projob organizations. "I am passionate about Northern Michigan. 4 years ago Michigan was in trouble, our employment was above 13% and my friends and neighbors were being forced to move out of state to find em-

ployment. I'm happy to say that over the past 4 years we have focused on job creation, creating more than 250,000 new jobs, and Michigan is on the comeback," he said. Foster believes that we still have work to do to make Michigan a more business friendly state through investing more into our local roads and bridges but believes we are moving in the right direction. "My most important goal is to help create an environment that allow the next generation of residents to live work and raise a family here in Northern Michigan," he said.

Lee Chatfield didn't respond to inquiries.

Candidates running for State Senator representing the 36th district include Joe Lukasiewick (D) from Greenbush and Jim Stamas (R) from Midland.

Joe Lukasiewick is passionate Michigan's resources including its people. "It's shameful that we are about to pass Michigan off to the next generation in worse shape and with more unresolved problems than what we inherited," he said. Lukasiewick stated that he is running for his daughters and granddaughters, as well as that of Michigan.

Stamas didn't respond to inquiries.

State proposal 14-1 will also be on the August ballot. The proposal is actually a referendum on Public Act 80 of 2014, which was approved with bipartisan support by the Legislature this past March. The amendment is intended to make sure schools, local communities and libraries don't lose revenue during the historic phase-out of the Personal Property Tax (PPT). Michigan's PPT is a tax that businesses pay on items such as machinery, furniture and other equipment. Since many neighboring Midwest states don't levy a similar tax, the PPT has put Michigan at a disadvantage for retaining and attracting additional jobs. Although eliminating the PPT will help encourage job growth, schools and libraries receive a portion of their funding through the personal property tax. Voters have the chance to decide whether the state should dedicate a portion of the use tax to local municipalities to reimburse them for 100 percent of all revenues lost as a result of the PPT exemptions. Thee use tax will be a companion to the sales tax, levied on the use, storage and consumption of certain tangible personal property, like telephone services, used auto sales and hotel rooms.

If approved by voters, the portion of the use tax dedicated to local governments and schools would go into the Local Community Stabilization Authority to provide revenue for services including police safety, fire protection and ambulance emergency services. It would allow the reimbursement to local governments and schools to occur automatically without legislative action. This plan will not increase anyone's taxes. It's an attempt to protect revenue for schools and local governments while eliminating PPT.



in," he said. Calo also believe this current legislature has done a disservice to the people of Northern Michigan. "Many tax breaks have been given to large corporations, all on the backs of the working and middle class. And what do we have to show for the increased tax bill? Not driveable roads, not strong, fully funded schools and not a secure future. I want to help change this," he said.

Michael Vickory believes that most if not all of the problems within the State can be solved with people making decisions to promote their own prosperity and freedom. "I am first and foremost a free-market, individual liberty and freedom candidate with no exception. I believe in the hard work, intelligence and ability of the "Forgotten Man" or the people of the State of Michigan," he said. His goal as a representative is to remove the barriers that have kept the people from creating jobs, improving education, and repairing and building infrastructure (roads, sewers, etc.). ""The Forgotten Man or the people of Michigan who go to work, raise their families, work in their communities and really make our communities vibrant do not receive benefits from the subsidies and corporate welfare programs promoted by lobbyists and the Michigan Economic Development Corporation and big agriculture," he said. He intends to work to repeal the legislation that has created the Michigan Economic Development Corporation, 21st Century Jobs Fund, Pure Michigan and other corporate welfare programs. "This will save the taxpayers of the State of Michigan \$300 million a year," he said. Vickory also believes that curtailing the power of the DNR through the limitation and reduction of the acreage that the State owns by selling off land to private individuals and use the excess funds from timber sales, oil and gas leases to repair the roads and other infrastructure projects. "The DNR has recently given grant money to private in-





MOMS-TO-BE: TAKE CHARGE FOR A HEALTHY PREG-NANCY AND A HEALTHY BABY

ting the food she ate for dinner, feeling her sway as she walks around the block. But Mom influences the health and happiness of her offspring in even more powerful ways than that! Research has found that in the belly and after birth, some of a child's genes can be flipped on or off depending on what Mom does (or doesn't do) while she's pregnant. And that can affect a child's health and happiness throughout life. What are these powerful gene-flippers? The food Mom eats; how much weight she gains during pregnancy; how she reacts to stress; and her exposure to environmental toxins.

So, if you want to take control of your pregnancy and protect your bundle of joy, before and after you deliver:

1. Start prenatal vitamins before you get pregnant. Take a daily prenatal vitamin supplement containing folic acid for three months before you start trying to conceive; keep taking it while you are breastfeeding. In a recent Norwegian study of more than 85,000 kids, this simple step reduced children's risk for autism and autism-spectrum disorders by 39 percent.

2. Tune up your diet, too, before you make a baby. According to a new Australian study, women who munch more fruit and lean protein before pregnancy are 50 percent more likely to deliver a full-term baby than women who dine on high-saturatedfat and high-sugar foods.

3. Eat for 1.1 -- not for 2! Pregnant women do need to gain weight, but just the right amount According to the Institutes of Medicine, you should gain 25-35 pounds if you started at a healthy weight (BMI 18.5-24.9); 15-25 pounds if you were overweight (BMI 25-29.9); less than 15 pounds if you're obese (BMI over 30). Best way to avoid gaining too much weight? Eat 10 percent more calories than usual during your first and second trimesters; up that to 15 percent to 20 percent more for the last three months. Gaining excess



weight increases your risk for high blood pressure, diabetes and premature delivery. And gaining too much weight increases the chances that your child will become obese later in life. (Hear those genes flipping?)

4. Wash your hands. A University of California, San Francisco, study found fewer than 20 percent of obstetricians regularly talk with their pregnant patients about toxins such as phthalates, BPA (bisphenol-A) and BPS (bisphenol-S, probably just as bad), pesticides and PCBs. They all can alter healthy fetal development.

Here's how to reduce your exposure: Don't handle cash register and store receipts. BPA (a hormone disruptor) is in the paper; wash your hands if you come into contact with it. Don't microwave food in plastic containers; stay clear of pesticides; and eat two to three servings a week of fish like salmon, tuna (light canned), and/or cod. They're low in contaminants, such as mercury, and are loaded with omega-3s, which are so important for fetal brain development.

5. De-stress. High levels of stress during pregnancy increase the chance that a child will be overweight by age 10 to 13, according to a new Danish study. Other new research suggests a connection between a pregnant woman's stress level and an increase in her child's later risk for asthma.

De-stress with a daily relaxation technique: a breathing exercise, mindful meditation, listening to your favorite music or taking a walk. One recent British study reported that taking a yoga class also can keep expectant moms cool, calm and collected.

6. Protect your breast-milk supply, which is important for your infant's immune health. You'll increase production of breast milk if you gain a healthy amount of weight, eat a healthy diet and get the amount of exercise that's right for you. Another breast-milk booster, for women who develop gestational diabetes (known

Renowned artist exhibit at Jordan River Art Center

A retrospective exhibit of works by the renowned artist, Charles Culver will be exhibited August 3 — 15 at the Jordan River Art Center. The opening reception is August 3. He states: "I do not paint animals but only the images that animals

arouse. A real artist never desires to be the foremost artist of his time, but merely one of the good artists of all time."

Watercolors and paintings from his entire career will be on display, including the exquisite "Caged Lion" displayed once before because of its size: 80" wide x 42" height. This watercolor consists of 8 sheets of watercolor paper pieced together to create the entire image.

Charles Culver died in 1967 at the age 59. His artwork tells us of a life spent observing the world around him. The variety of his subject matter and different style periods exhibit a unity of mind. The animals, plants, landscapes and townscapes are Michigan. His style is whimsical, vigorous, sensitive and clearly recognizable. His sanctuary was the Northern Michigan village of Bellaire.

The problem of earning a living as a fine artist is universal, and in order to support his family, Charles spent years as a commercial artist in Detroit for General Motors and Ford Motor Company. He also taught his beloved medium of watercolor at the College for Creative Studies in the 1960s.

City Launches "Resilient East Jordan"

Public kick-off meeting for community planning process scheduled for Thursday, Aug. 14 at 6 p.m.

EAST JORDAN, Mich. - July 29, 2014 - The City of East Jordan is working to improve the community's capacity to absorb future shocks and stresses in a groundbreaking master planning process called "Resilient East Jordan.'

The Resilient East Jordan project will address a wide range of concerns, such as natural resource preservation, efforts to build the local economy, and ways to manage the impacts of climate variability. Project organizers have scheduled a large Public Kick-off Meeting on Thursday, August 14 at 6:00 p.m. at the East Jordan Civic Center to discuss the project and to organize work groups on a number of community planning topics. The Public Kick-off Meeting will include informational presentations on community resilience and the planning process along with opportunities for residents to share their ideas for the future of the East Jordan Community. A Trail Towns presentation, discussing how to leverage recreational

trails for community and economic development, is also planned as a part of the Public Kick-off Meeting. Parking and the entrance to the Civic Center is located behind the building off of the alley, which can be accessed from Esterly Street.

Much of the funding for the Resilient East Jordan project is being provided through the Traverse City-based Land Information Access Association (LIAA), which is also managing the project. A nonprofit community services and planning organization, LIAA has partnered for this project with the Michigan Municipal League, the Michigan Townships Association, the Michigan Association of Planning, and urban planning professionals at the University of Michigan. The City of East Jordan is contributing funding toward the project and has also secured a grant of support from the Charlevoix County Community Foundation. East Jordan is one of only five communities in the State participating in this

unique planning opportunity. which includes the cities of Grand Haven, Ludington, Monroe and St. Joseph.

The project will help the City of East Jordan complete a review of its municipal master plan, with an eye toward buffering the greater community against damaging forces that can cause longterm economic and human hardships.

"Master planning processes lay the groundwork for transportation improvements, economic development programs, and neighborhood improvement efforts," said Dusty Christensen, a community planner with LIAA. "Planning with resilience in mind allows communities to reduce their vulnerabilities to wild swings in the economy, extreme weather events, and other impacts."

Project leaders expect the master-planning process, which began in June, to take about nine months. To date, East Jordan planning commissioners, elected officials, staff, and other community stakeholders have participated in two working meetings to learn about the project, identify important community planning topics, and discuss the planning process.

Additional public involvement workshops are planned for September 18, September 30 and October 14. Project leaders have also scheduled an intensive two-day planning and design workshop, or "charrette," which will be focused on downtown East Jordan. Times and locations for the scheduled public gatherings are available on the project website www.resilientmichigan.o rg/east_jordan.

According to East Jordan City Administrator Chris Yonker, public participation is vital to the planning process.

"Participation in the planning system should not be limited to just the planning commission, project proponents or other related government agencies; it should extend to our ordinary citizens, businesses and other stakeholders," Yonker said. "The

complaint

involvement of citizens in the formulation of policies and strategies, which affects land-use planning and development, is essential to ensure that the master plan prepared by the planning commission is in agreement with the wishes of the people. Participation also instills a greater sense of belonging and ownership as citizens can influence the future of the community in which they will be living and working. We view public participation as a way of citizen empowerment and regard it as a vital part of our democratic governance.'

Everyone throughout the community is encouraged to learn more about the project and participate in the public discussions. 

Boating Accident Investigated Further

Norma Jean Babcock CHARLEVOIX: The cause of a boating accident on Round Lake that occurred Friday, July 25 during the Venetian Festival has been determined by local authorities.

At approximately 9:18 on Friday morning 26-year-old Jonathan Richard Yurewitch attempted to back a 65 foot vessel out of Ward Brothers Marina when he reportedly "had a medical problem" which caused him to strike a nearby dock and boat house. The Charlevoix County Sheriff's Department later revealed it was determined that Yurewitch suffered a seizure causing him to lose control of the vessel.

According to a press release on the day of the accident a passenger on board the boat put it into neutral and contacted emergency personnel for assistance. The Charlevoix County Sheriff's Office, Charlevoix EMS, Charlevoix City Police and the U.S. Coast Guard all responded to the scene of the accident.

The Charlevoix County Sheriff's Office explained that no other injuries were reported from the accident. The vessel crashed into the dock and began to grind down the side of it before running into a pillar and garage door of the property located at 123 Belvedere Ave.

Yurewitch was taken to Charlevoix Area Hospital where it was determined a seizure caused him to lose control. He was later reported to be in stable condition.

Interactive website has northern Michigan trail maps

GAYLORD - Hikers, bicyclists, off-road vehicle users, horseback riders, and other trail enthusiasts can now more easily locate and enjoy the vast network of trails and other points of interest in northern Michigan by using the interactive website upnorthtrails.org, recently launched by the Up North Trails Collaborative.

The collaborative, a partnership of more than 50 organizations and agencies led by the Northwest and Northeast Michigan Councils of Governments and Department of Natural Resources, designed the new website to connect the public with more than 5,300 miles of motorized and non-motorized trails in the northern Lower Peninsula.

The Up North Trails website allows users to search for trails based on type of use and/or location, and also serves as a source of information on trail systems throughout the state.

"There are more miles of trails in the northern Lower Peninsula than the distance from Anchorage to Miami," said Kerry Wieber, DNR liaison to the Up North Trails Collaborative. "The website will help customers find information on all of these trails in one place, regardless of whether it is a state trail or managed by another organization or local unit of government."

The user-friendly features of upnorthtrails.org include:

• An interactive trails map that can be filtered for type of use and location

· Detailed information about each individual trail, including any changes in type of use for specific segments of trail

• Trailhead locations and points of interest near each trail

• A mobile-friendly design, which is fully functional on tablets, mobile phones and other devices

"We wanted to give users a onestop-shop for information about our trail systems," said Denise Cline, GIS specialist for the Northeast Michigan Council of Governments. "Up North Trails is a valuable new tool for everyone looking to get outside in northern Michigan."

The goal of the Up North Trails Collaborative in creating the new website was to promote northern Michigan's abundance of trails to all user groups, driving recreational and economic activity in the region.

"Up North Trails is the first website of its kind in Michigan, providing information about all trail systems in the region, whether you are a bicyclist, snowmobiler, hiker or horseback rider," said Matt Mc-Cauley, Director of Regional Planning and Community Development for the Northwest Michigan Council of Governments. "We hope it will provide a fun, engaging, and useful way for residents and visitors to locate new outdoor adventures."

Up North Trails Collaborative member groups include the DNR, NEMCOG, NWMCOG, Top of Michigan Trails Council, Land Information Access Association (LIAA), Traverse Area Recreation and Transportation Trails (TART Trails), Grand Traverse Regional Land Conservancy and Cheboygan County. The collaborative is supported financially by the Michigan Economic Development Corporation, Rotary Charities, and the U.S. Department of Agriculture. DNR expands grouse hunting in **Upper Peninsula**

Partnership with private landowners will benefit sharp-tailed grouse hunters

In an effort to increase public access to sharp-tailed grouse hunting opportunities, the Michigan Department of Natural Resources has expanded the state's Hunting Access Program to the eastern Upper Peninsula and is seeking private landowners to join the partnership program.

The Hunting Access Program (HAP) was created by the DNR in 1977 to encourage private landowners to allow public hunting access on their land under specific terms in exchange for a financial incentive. Until this year, HAP was primarily focused on southern Michigan, where public hunting lands are limited.

"We chose to expand HAP to the eastern Upper Peninsula to help hunters gain access to productive sharp-tailed grouse hunting lands, which are mostly found on private land," said wildlife biologist David Jentoft.

Sharp-tailed grouse hunting has been allowed in portions of eastern Chippewa and Mackinac counties sinc 2010 and is the only area of the state with an open sharptailed grouse season. "Sharp-tailed grouse numbers in the eastern U.P. have benefited from the presence of critical grassland habitat, but since most of that habitat is privately owned, hunters especially those from the Lower Peninsula or out-ofstate who don't have local connections - can have a hard time gaining access," Jentoft said. "Expanding HAP will provide greater opportunities for hunters, while also offering an incentive to eligible landowners who choose to participate." HAP-enrolled lands in the eastern U.P. will be open from Oct. 10-31 for sharp-tailed grouse hunting only, or from Sept. 15 to Nov. 10 for small game hunting (which includes sharp-tailed grouse). Participating landowners will select which timeframe they prefer to enroll in and the land will be designated accordingly in the HAP digest. Eastern U.P. HAP lands will not be open for hunting deer or other big game species. The DNR is partnering with the Chippewa/Luce/Mackinac Conservation District to implement HAP in the eastern U.P. Landowners who own 40 acres or more in the sharptailed grouse hunting zone are eligible to apply for the program; applications are currently being accepted.
