

EAST JORDAN CITY COMMISSION, SEPTEMBER 2, 2014 **Curfew siren makes a comeback in East Jordan**

EAST JORDAN-The city of East Jordan will be bringing back a community staple, as commissioners approved to reinstitute the use of the emergency siren for the 9:30 p.m. youth curfew at Tuesday evening's city commission meeting. Commissioners also tabled resolutions seeking the city to vacate a portion of the alley located between Lake and McKenzie Streets until the September 16 meeting and came to agreements concerning the resignation of the city administrator.

"The restored emergency siren that was previously on the roof

of the old fire station on Main Street has been re-installed on a new pole near the wastewater pumping station on Bridge Street," said City Administrator Chris Yonker.

Consumers Energy donated and installed the 45-foot long pole for the siren, and city mechanic Bob White coordinated the connection of the siren.

The city requested that the commission set a policy concerning the operation of the newly reinstalled siren, as commissioners had expressed interest at previous meetings to reinstitute the sounding of the 9:30 p.m. curfew. Yonker shared with the commission that there had been over-

whelming support on the city's FaceBook page to bring back the 9:30 p.m. siren call, including many comments that were reminiscent of the small town tradition.

Commissioners unanimously approved a policy to reinstate the

31st Charlevoix **County CROP Walk**

Come rain or shine! Area residents are gearing up to join in the Charlevoix County CROP Walk, Saturday, September 27 at 9:00 am. The Six-mile walk will begin at three Charlevoix County locations, including Elm Pointe in East Jordan, Whiting Park in Boyne City and Charlevoix Middle School in Charlevoix. Each location will conclude the walk at the Congregational Church in Ironton where lunch will be provided for all walkers. All church's and individuals are welcome to join the walk.

Organized locally, the Charlevoix County CROP Walk has set a goal of recruiting 120 walkers to raise \$25,000, which will work to combat hunger here in our community, as well as around the world. Twentyfive percent of all monies raised here in Charlevoix County will come back locally to The Good Samaritan of Ellsworth, Care and Share of East Jordan, the Charlevoix Food Pantry, Seventh Day Adventist, Boyne Food Pantry in Boyne City and Boyne Falls Food Pantry, Boyne Falls. Last year, over 125 walkers and volunteers raised more than \$26,000 of which \$6,500 was divided between our local food pantries. BOYNE CITY - A grand opening celebration and ribbon cutting was held Thursday, August 28 at the new Ridge Run Dog Park located at the north end of Boyne City off of Charlevoix Street. The event was a huge success with nearly a hundred dogs and their humans in attendance.

Refreshments were served including hot dogs which sometimes tested the canine's devotion to any non-hot dog carrying human. A couple vendors of pet products had informative displays set up and packets of doggie treats available to help persuade the pups to try the agility course. All in all the two large fenced in areas filled with dogs of all breeds was enough to make the canines happy. The dogs were visibly excited to be there and having a wonderful time. "After 8 months of real hard work, great leadership and a great committee, great support from the community and the city and phase one of Ridge Run Dog Park is done," said Scott MacKenzie, Executive Director of the Charlevoix Area Humane Society.

Volunteers have raised \$32,000 so far from corporate sponsors and individuals and the city donated the property the park sits on. "The community support was incredible," said Michele Carter, Ridge Run Dog Park Committee Chair.

The park is open for use but is far from complete. More amenities including drinking fountains/ wash stations, grass and tree plantings, a walking trail around both areas for humans, shade pavilions and benches are coming soon. "To celebrate Boyne City and the enthusiastic volunteers we have. It's over the top!" said Mayor Ron Grunch as he cut the ribbon. Then MacKenzie chimed in, "It's over the ridge!"

Darlene's Restaurant will open for dinner

EAST JORDAN - September's East Jordan Area Chamber of Commerce Business of the Month has been on the corner of C48 and Second Street in East Jordan for 23 years. Darlene's Restaurant has been able to retain employees from its inception because of its family atmosphere and satisfied customers because of their home baked goodies and friendly service.

The building that houses the business used to be a gas station and was converted to a restaurant around 1978. The Bolsers took over the building in 1991. "My husband and I both had worked at Dura Automotive before that. Rusty continued to work at the factory for 3 more years, to see how things worked out here," said the restaurant's namesake, Darlene Bolser.

Things worked out just fine for the couple then six years ago when the economy plummeted the restaurant was forced to cut its hours back. "That was the slowest we've ever been, we had to shut her down but with the help of the community and a great staff we have survived the best and worst of years," she said.

Many of the staff have been with the restaurant for over twenty years. "They keep us on track more than we keep them on track," she said. Both Darlene and Rusty are natives to the area Rusty graduated from East Jor-

dan and Darlene from neighboring Ellsworth. "We grew up here and chose to stay because the people around here are awesome and they've supported us through the years," she said.

Bolser attributes the home style cooking as the element that keeps the customers coming back. "We serve a great breakfast, homemade soups and breads and we can't forget our famous sweet rolls made daily from scratch," she said.

Now that the economy has turned around a little bit and two of the other downtown restaurants are closing Darlene intends to increase hours of operation to 6 a.m. to 7p.m. weekday keeping the 6 a.m. to 2 p.m. Saturday and Sundays. "I think we're the only Mom and Pop restaurant left in East Jordan," she said. With the increase in hours the restaurant will be baking more of the pies and other home made goods that weren't necessary when the restaurant closed at 2.



Dietary changes are an essential component of treating diabetes. Many of those with diabetes struggle with compliance with a restrictive eating plan, intended to minimize blood sugar fluctuations. When my husband, Tim Hagen-Foley, was diagnosed with diabetes in 2001, he completed a series of nutrition courses offered by our health care provider, but did not make changes to his eating habits.

As a result, by 2008, he weighed approximately 350 pounds, more than 150 pounds overweight. By 2010, had lost 70 pounds and refused the diabetes medication recommended by his physician. For the next three years, he made minor, inconsistent changes to his eating behaviors.

In 2011, the doctor insisted that he begin taking the diabetes medication Metformin. After approximately six months of daily Metformin use, he noticed that the numbness and pain in this legs had gotten worse. He stopped taking the drug and his symptoms were reduced. Then in 2012, the sensations in his legs returned and were sustained. For him, he made a major dietary change he made at that time - switching from regular cola to diet. He continued to eat ice cream, chips, and chocolate, although he attempted to reduce the quantity.

In April 2013, the signs and symptoms of diabetes were considerably worse. His blood sugar level was 8.7 and a new doctor insisted on Metformin. His cholesterol and blood pressure were also too high. He had extensive pain in many of his joints and muscles. Pain would increase with any activity.

In July of that year, his A1C test was 6.4, which is considered "managed," with medication. The doctor was not satisfied and increased the Metformin dosage. He also recommended a second medication, which Tim refused. His blood pressure was very high and required more frequent monitoring. He took a closer look at what he had been eating.

We watched the documentary

Forks Over Knives and he learned that others with various health problems, including diabetes, had successfully used a plant-based diet to improve their health and reduce the need for medications. He recognized that he was addicted to sugar and that processed foods were "like poison" to him. He started making better choices.

One morning in September 2013, he awoke to discover that his vision was significantly impaired. An optometrist found that his vision was 20/80, just within the legal limits to drive. His blood pressure was 196/135, despite taking the maximum dosage of three blood pressure medications. Before prescribing a fourth medication, his physician ordered an MRI to check for renal stenosis, a kidnev blockage that could lead to high blood pressure. Prior to the test, he discontinued the use of Metformin, on the recommendation of our niece, Lisa. The dye used in the test could interact with the Metformin.

The test was scheduled for a Thursday in October. He stopped taking the drug on Wednesday. Within two days, his vision had returned to its prior level. At that time, he chose to not continue Metformin and committed to a primarily vegetarian, whole food eating plan. There was no blockage.

After three months of following this eating plan, the A1C test was repeated and had improved to 6.1. The neuropathy in his legs, which had been midthigh and below was reduced to below his knees. He estimates that he was following the vegetarian/whole foods eating plan approximately 60% of the time. The doctor felt there was no longer a need for medication for diabetes.

A follow-up visit in August showed an A1C test result of 5.4 - under 5.9 is considered normal. His blood pressure was 122/70. He had almost no neuropathic pain. In general, he feels better, physically and mentally. He has embraced vegetarian cooking and eating, following the plant-based eating approximately 80% of the time. He eats unlimited amounts of plantbased foods. He finds this an

easy eating plan to follow, "Vegetarian eating is delicious and is just as filling as traditional (meat-based) dishes. I know that I'm not missing something by choosing healthier foods."

I transitioned to a largely plant-based diet in 2012 and encouraged Tim to do the same. Tim now says, "I should have listened to my wife earlier and I would have been much healthier sooner, but I didn't understand one important thing: I had to fight an addiction before I could move on to healthier eating. I was an addiction (to sugar) that I didn't know I had and that was the important realization that helped me make progress."

Is a vegetarian eating plan right for you? If you have diabetes, consult your physician before making a major lifestyle change. Tim's physician was amazed at his results. Many insurance companies are encouraging persons with diabetes to adopt a plant-based diet. Reducing intake of processed foods and incorporating more vegetables, fruits, whole grains are better choices for anyone seeking health improvements.

Juicy tomatoes, sweet peaches, sizzling hot peppers ... good summer produce is at its peak, just in time for you to get all the benefits that a plant-based diet offers! And here's the latest proof that it can help your heart grow younger.

In a headling graphing study



hearty whole grains, satisfying beans and heaping helpings of fruits and veggies.

It was a huge diet overhaul for the study volunteers, and an impressive 89 percent stuck with it. The results changed lives. A whopping 94 percent of those who stayed on the plant-power diet saw symptoms like chest pain reduced. Just one person from that group suffered a health event related to artery disease (a stroke). In contrast, during the course of the study 62 percent of those who didn't stick with the diet experienced an event, including stroke, artery-clearing or bypass surgery, and heart-related death. In the plant group, results from heart scans and stress tests found measurable improvements in one in five, leading the researchers to note that "farmstand feasting" can help some people reverse heart disease. (Note: Participants stayed on their

heart meds, making changes only as recommended by their doctors.) Volunteers also lost an average of 19 pounds apiece.

FIVE WAYS PRODUCE HELPS The plant-heart connection has been making headlines for other reasons, too. In midsummer, the incoming president of the American College of Cardiology blogged about his decision to become vegan (100 percent plant-based diet) to combat his own rising cholesterol levels. It was the No. 1 post on the site for a week.

Why does it work? Our friends at the Cleveland Clinic point out four big benefits:

No. 1: Artery protection. Cutting out processed foods, animal proteins and dairy reduces intake of saturated fat and cholesterol, both of which increase artery-damaging LDL cholesterol levels in the bloodstream. Removing them from your diet also protects the endothelial cells that line the walls of your arteries, and helps keep them from releasing compounds that make arterias

meat, eggs, dairy and other animal proteins reduces the effects of "bad" bacteria in your digestive system that churn out a compound called TMAO. TMAO creates inflammation that clogs your arteries.

No. 4: Better blood fats and blood sugar. A high-fiber, low-fat, plant-focused eating plan can lower levels of heart-threatening triglycerides (a blood fat) as well as homocysteine (another compound that can raise heart attack risk). It also helps your body absorb blood sugar more easily.

HARNESSING PLANT POWER To start reaping the delicious benefits of plant-based eating, start

with these small yet powerful

changes: Nix food felons. Banish foods packed with saturated fat, trans fats, added sweeteners and syrups, and sodium.

Get bean-y. Twice a week, replace animal proteins on your plate with hearty three-bean chili, a bowl of white bean and kale soup, or beans and brown rice. Pair beans with whole grains like quinoa, wholegrain pasta, wraps and barley, too.

No. 2: Revitalized blood vessels. Eating loads of leafy greens like kale, spinach and collards helps your body produce new copies of the cells that line artery walls. Healthy arteries, in turn, produce loads of nitric oxide, a beneficial compound that keeps your blood vessels relaxed.

No. 3: A better "good bug" mix in your intestines. Cutting out red

Have leafy greens every day. Salad, a side dish of sauteed kale, collards, spinach or chard, a green smoothie ... find new ways to fit in a variety of greens.

Start the day with oats and fruit. Oatmeal's packed with cholesterolclobbering soluble fiber. Top it with berries (and a splash of fat-free milk if you'd like), and you're good to go.

City Council takes Marina Expansion to the Next Level

CHARLEVOIX: Monday night, City Hall was abuzz as the large crowd gathered for the meeting of City Council anticipated sharing their opinions during the second public hearing held regarding expanding the Marina, and finding out what direction council would take.

Prior to Monday several public hearings had been held to consider an expansion of Dock A to accommodate more large boats in the Marina. After much public dissent however, the idea was rejected in favor of forming a committee to look into other options that would allow expansion but not to such a severe degree. After six meetings, that committee came back with new options which were the subject of a public hearing held August 18.

Those options included creating a new dock with five 80 foot slips and expanded shopper's docks or creating a new dock with seven 80 foots slips and expanded shopper's docks. At the August 18 meeting council chose to focus on the plan to add a new dock with seven 80 foot slips and expanded shopper's docks. In order for the plan to happen however, it needs to be reviewed by the Army Corps of Engineers and DNR.

Prior to public comment City Manager Rob Straebel expressed to council that he supported sending the plan to the two entities so that further direction could be given on this issue

"I think it would be appropriate to send (a plan) to reviewing agencies to get the experts to look at this...We need to find some closure on this issue...," said Straebel.

Straebel detailed the estimated costs that creating this new dock and shopper's docks would have. According to his estimates, \$363,000 would be devoted to the dockage itself and \$117,000 would go toward utilities, creating an overall sum of \$500,000.

The Charlevoix Public Library is pleased to announce their eLearning Lab. The eLearning Lab is a new option on the library's catalog. The eLearning Lab provides easy access to three resourceful training tools: Atomic Training, Mango Languages, and Learning Express.

Atomic Training is a comprehensive online database of how-to training sessions, covering popular software and applications, including tutorials for: Microsoft, Apple, Adobe, Google, and the Cloud, as well as social networking applications. Patrons of the Charlevoix Public Library will have unlimited access to tutorials in the library or at home. These tutorials help patrons of all ages improve job skills and become more proficient in

basic computer applications. Mobile device training is also available, allowing patrons to learn how to get the most out of their smart phones and tablets. NCMC staff updated on Title IX policy

DeWinter and Krajewski presented information to college staff and resident assistants on North Central's Title IX policy and how to help provide a safe and respectful culture on campus.

Colleges across the country are gearing up for the start of school and the return of students. North Central Michigan College is ensuring staff and resident assistants are prepared under the terms of Title IX. Title IX is a federal civil rights law that prohibits discrimination on the basis of sex in federally funded education programs and activities. All public and private elementary and secondary schools, school districts, colleges and universities receiving any federal financial assistance must comply with Title IX.

In 2011, the Office for Civil Rights (OCR) in the U.S. Department of Education issued a 'Dear Colleague Letter' (DCL) regarding student-to-student sexual harassment and sexual violence. The DCL explains a school's responsibility to respond promptly and effectively to sexual violence against students in accordance with the re quirements of Title IX. Essentially, the DCL put schools on notice that failure to handle sexual assault properly could cost them their federal funding. According to Bernice Sandler, known as the godmother of Title IX, the DCL was a game-changer. Sexual assault on college campuses is a critical issue. Nationally, 1

in 5 college women will experience a sexual assault by the time they graduate. According to an article on npr.org, the total number of U.S. colleges under investigation for potential Title IX sexual violence violations is 74.

North Central Michigan College is confronting the issue head on. Chris Krajewski, WRCNM Domestic Abuse and Sexual Assault Program Director and Naomi DeWinter, Vice President of Student Affairs at North Central provided training to North Central staff and resident assistants at the college this week. The training covered: - North Central's Policy on Title IX - Definition/types of sexual violence - The role of staff as it relates to bystander intervention and reporting incidences to the Title IX coordinator at North Central - Scenarios to help staff understand their role and responsibilities Over the years, Bernice Sandler has watched the Title IX legislation she pushed over 40 years ago evolve. In an interview on npr.org, Sandler described her perception of the advancements as, "The darkness is over."
