# Ramblers atop Lake Michigan Conference with wins over TCSF and Charlevoix

### Boyne City 64, TCSF 60

TRAVERSE CITY — The Boyne City boys basketball team didn't take their first lead of the game until just under five minutes to play in the game and then a back

and forth battle until the closing seconds of the contest as they pulled out a 64-60 Lake Michigan Conference victory over Traverse City St. Francis on January 20.

With the win, the Ramblers (7-1

overall, 5-0 LMC) stand in first place alone in conference play.

St. Francis jumped out to an early lead behind the three point shooting of Teddy Prichard (four triples in the first quarter), as the Gladiators took a 20-11 lead after one quarter of play. The Glads extended that advantage to 35-25 at the half as Prichard knocked down two more long range shots.

During that same time, Rambler senior, Kane McPherson helped keep them within striking distance as he scored 11 points during that same stretch.

Coming out of the half, Boyne picked up the defensive intensity, which turned into points as the Ramblers outscored TCSF 21-14 in the third quarter.

Boyne took the lead for good (62-60) with 25.9 seconds to go as Ethan Hewitt knocked down a pair of free throws after drawing a St. Francis foul on a rebound. After a missed three point attempt by TCSF, Rambler Jacob Ager was fouled with 12.4 seconds remaining in the game. Ager made the trip to the charity stripe and calmly sank both ends of a 1-and-1 for a 64-60 lead, sealing the Rambler victory as the Glads missed two tries at three point shots in the closing seconds.

"I'm so proud of our players for continuing to fight even when we were behind and finding a way to get back in the game and tough out a big road win," Rambler coach Nick Redman said.

McPherson finished with 17 points and three assists to lead the Ramblers, while Mason Gardner added a double-double with 12 points and 10 boards.

Hewitt added 11 points and Eric Carson chipped in with nine.

Leading TCSF was Prichard with 20 points, while Marek Laucky added 11 and Dan Passinaut had

BOYNE CITY — When it comes to rivalry games, it doesn't get much better than Boyne City and Charlevoix. It also doesn't matter what each team's record is, either.

Playing inspired ball behind senior Kevin Pearl, the short-handed Rayders (missing six players attending a school trip to Washington DC), played pretty even with the Ramblers over the first 10 minutes of the contest, before Boyne was finally able to create some room between the two squads.

Boyne City would earn the Lake Michigan Conference victory 64-44 on January 17 as the Ramblers held the lead at each of the quarter breaks, 14-12, 34-18 and 48-31.

A strong second quarter by Ram-

bler juniors Jacob Ager (seven points in the quarter) and Mason Gardner (five points) helped create the space BC was looking for.

The Ramblers however, had a difficult time containing Pearl as the Rayder senior netted 14 points through three quarters of play.

"I thought we shared the ball well offensively," Boyne City coach Nick Redman said. "Credit to Charlevoix they played harder than we did."

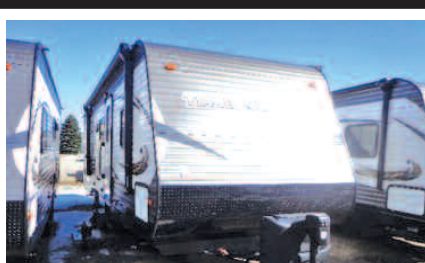

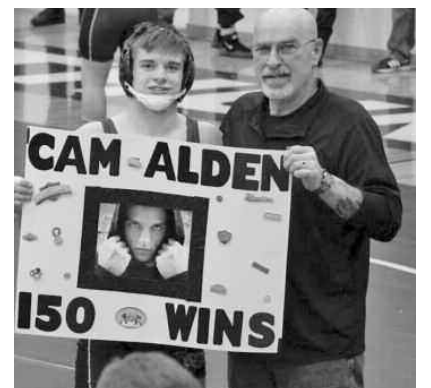

Section 1: Amendment of Section 46-77 Water Bills (b) When due and (d) Quarterly billing:

(b) When due. Water bills are due within 30 days of billing. Overdue charges are assessed a penalty as established by city commission resolution. Service shall be disconnected to customers who are at least 15 days past due and an additional amount prescribed by resolution of the city commission as an off-charge shall be levied. Members of the department of public works shall, without notice to the user or property owner, turn the water off until the bill has been paid in full, plus an additional charge in an amount prescribed by resolution of the city commission for turning on the water. The exception to this will be when the property owner requests the water to be turned on for a period of eight hours and back off for the purpose of a pre-purchase inspection. The fee for turning the water on and back off shall be paid in full prior to the service being turned on. The city shall incur no liability for any damages that may occur from having the water service turned on. During the winter months the property owner shall be required to have the snow removed from the meter pit and shall have the snow replaced after the service has been turned back off. The city will not be responsible for the meter freezing and the property owner shall be responsible to reimburse the city for all costs incurred as a result of a meter freezing.

(d) Quarterly charges. For the purpose of charging for water used, the year shall be divided into four quarters of three months each. Meters will be read at the close of each quarter. All users will be charged based on the amount of water used and at a rate established by commission resolution. Irrespective of and in addition to the amount of water used, each meter for each user will receive a minimum flat bill amount representing readiness-to-serve charges for the system. The minimum flat rate shall be determined by city commission resolution. In all cases where the water is turned off at the request of the owner or tenant or for nonpayment of water bills or violation of this article an additional charge to be determined by resolution of the city commission will be made and it shall be paid to the city before the water is turned on. In all cases where the water is turned off at the request of the owner or tenant or for nonpayment of water bills or violation of this article an additional charge to be determined by resolution of the city commission will be made and it shall be paid to the city before the water is turned on. No reduction in rate, discount or rebate shall be allowed to any user unless it is determined that the water meter has not registered properly through no fault or neglect of the user.

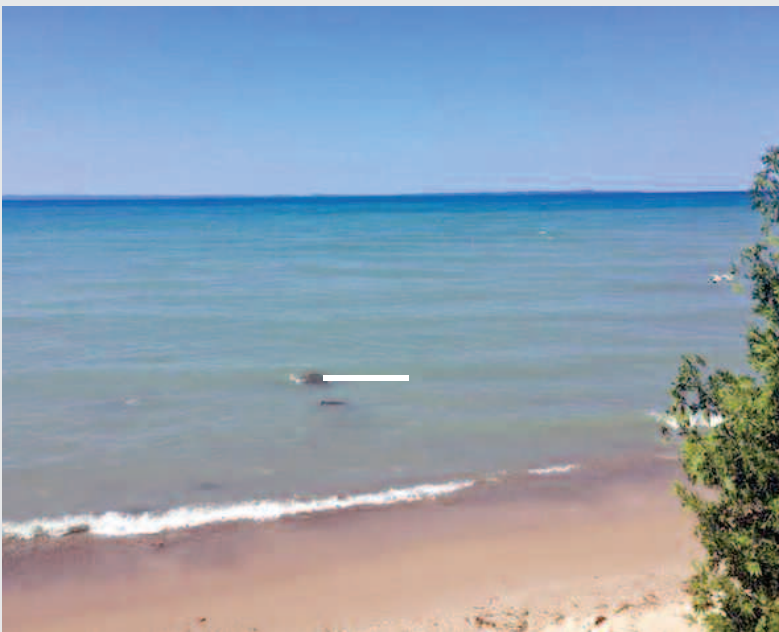
