BOYNE CITY — The Boyne City girls basketball team battled back from a nine point deficit in the fourth quarter to force overtime against the visiting Rams on December 19.

The Ramblers had an opportunity to win the contest late in regulation, but a pair of missed free throws in the last minute and then an errant pass on an inbounds play underneath the hoop with one second remaining would be too much for Boyne to overcome in the extra session.

Harbor on the other hand went 6-for-6 from the charity stripe in the extra period, and shot 23-for-29 for the game and the Ramblers were not able to match them down the stretch. The Rams were in control most of the night, leading 26-18 at the half and held a 33-24 advantage after three quarters of play and had to hold off a hard charging Boyne team, led by the defense of Alydia Cotton and some timely offense by Katie Hoth.

Cotton harassed the Harbor ball handlers each and every chance she got, making it difficult for the Rams to get into any type of offensive flow, forcing turnovers and errant passes.

Hoth led Boyne City with 11 points and five rebounds, while sophomore Brooklyn Fitzpatrick added eight points and seven boards.

The Ramblers slip to 2-3 overall, 0-1 LMC with the loss.

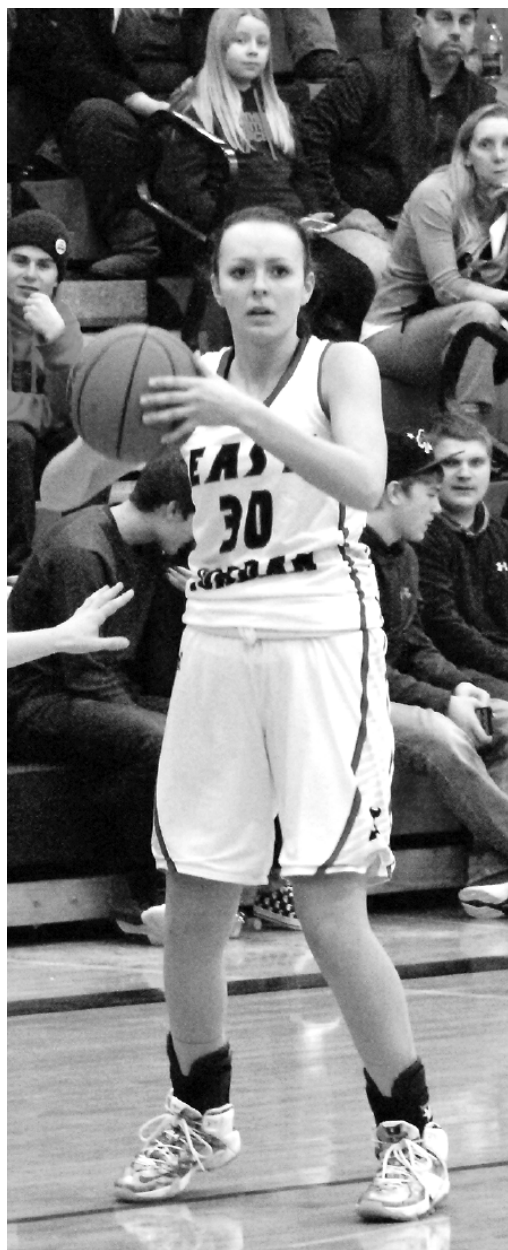

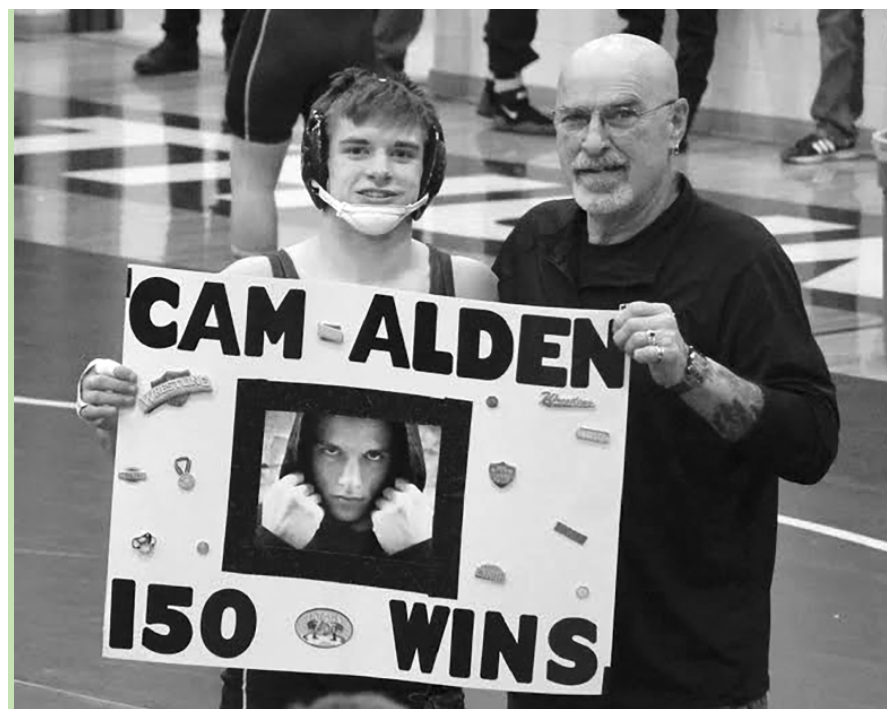
