MANCELONA — Next up.... The Boyne City softball team continued their dominance on the diamond in district play, winning their sixth straight championship in the process.

Boyne battled back from a 4-3 deficit following two innings of play in the title contest against Lake Michigan Conference rival, Charlevoix, to eventually pull out a 19-4 five inning victory as their bats came alive late in the contest.

The Rambler offense got things going in the third, scoring twice to regain the lead that they would never relinquish, as sophomore Brooklyn Fitzpatrick and freshmen Maggee Behling had RBIs in the inning.

Boyne would put the game away in the fourth and finish it off in the fifth, combining to score 14 runs over the two frames.

In the semifinal, the Ramblers went toe-to-toe with host

Mancelona as the two teams took turns scoring runs in the first couple of innings, before BC was able to pull ahead 5-2 in their portion of the sixth inning, only to see the Lady Ironmen come right back, cutting their lead to 5-4 headed into the seventh.

After Boyne was unable to add any insurance runs in the top of the frame, it would be senior pitcher Katie Hoth and the Rambler defense that would shut the door on any hope that the hometown team had of pulling off a stunning upset.

In the other semifinal contest, it was the Rayders advancing with an easy 17-1 thumping of Harbor Springs.

Boyne moves on to the Division 3 regional in Charlevoix on June 9, as they continue their pursuit of another title.

In the semifinal, Boyne battled Elk Rapids and pulled out a 10-1 win, while on the other side of the bracket, the Rayders advanced with a 6-1 victory over a tough Harbor Springs team.

Boyne City will face Gladstone in the regionals on June 9 in Charlevoix.

EAST JORDAN — Celebrating a district title is always a fun thing to do.

Celebrating it following a walk-off grand slam, makes it that much sweeter!

That would be the case for the East Jordan softball team on June 2, leading 15-9 in the bottom of the fifth, Chelsea Gibson stepped to the plate with the bases juiced, setting the stage for a second season memory as the Red Devil senior sent the ball over the fence for a 19-9 victory and EJ to the Division 4 regionals with one swing of the bat.

"We had a super great start, which took a lot of pressure off of us, and we had an amazing finish," said East Jordan coach Meg Kitson. "The middle innings were very stressful as Bellaire refused to give up and kept us having to keep scoring, this was one of my most fun victories today."

The win in turn gave Kitson her 400th career coaching victory.

EJ got things going early, crossing the plate eight times in the first, added a solo run in the second, two more in the fourth, before the team exploded for eight more in the final frame.

In addition to Gibson's 4-run blast, she also singled, while Maddi Steltzner had three hits, including a double and a pair of RBIs; Abby Peterson, Katelyn Crawford, Gabbie Cutler and Amber Gibson all doubled among two hits.

Karah Dunson had a tworun home run in the first inning, Kendall McNitt doubled and Jaden McCoy singled.

Peterson got the pitching win in the circle, with relief from McCoy as the two combined to allow seven hits, seven walks and strike out four. In the semifinal, the Red Devils advanced to the district title game with a 6-0 win over Ellsworth. Peterson picked up the victory, fanning nine, with allowing five hits. At the plate, she added a triple and a base hit and two RBIs. Cutler added two hits and an RBI, Chelsea Gibson had a home run and three RBIs. Dunson recorded two hits and McNitt singled.




He limited the Snowbirds to two first inning runs on a single, walk and two-run double, but was in control from there on out. Justin Barnett struck out the only batter he faced in relief.

Barnett finished with three singles, Bartig added two singles, Jared Piechan hit a long double that bounced off the fence, and Reid, Owen Diller, and Hayden Ferguson all singled.

"I am so extremely proud of these young men to keep fighting the way they did against a really strong St Mary's team who reached the semifinals last year!" East Jordan coach Tom Reid said. "Bartig was awesome for us as he has been all season. Our defense was spot on and we hit rather well off from an all-state pitcher. # Ager, Harmeling earn State Championships

City girls soccer team kept on rolling, as they notched their second-ever postseason victory over Cheboygan on May 31 behind the leg of freshmen, Jordan Noble.

Noble scored three times in the Ramblers 5-0 win over the Chiefs. All three goals came in the first half of the contest, with goal number one coming just two minutes into the Division 3 semifinal and her final goal found the back of the net just before halftime.

Taylor Noble and Jaelyn Jarema assisted on two of the scores.

With 20 minutes to play in the game, sophomore Rylie Woodall added a fourth goal for BC and freshmen, Megan Harmeling made it 5-0 with 10 minutes to go.

The Ramblers would fall 2-1 in overtime to Harbor Springs in the Division 3 district final on June 2.

Inanna Hauger would score the lone goal for Boyne.

COMSTOCK PARK — The Boyne City Track teams have been impressive all year and on Saturday, June 2, they did not disappoint as seniors Anna Harmeling and Jacob Ager became State Champions. Harmeling won the Pole Vault with a jump of 11' 6". Ager won the Shot Put with a new school record throw of 59' 10".

As a team, the Rambler girls finished 5th, which is the highest team finish in Boyne City school history, highlighted by seven girls that earned All-State honors by finishing in the top eight of their events.

Alydia Cotton took second in the 300M Low hurdles, being edged out at the finish line. She ran a personal best 46.41 taking the runner-up finish.

The 4x200M Relay team of Josee Behling, Cotton, Avery Stadt, and Yveloute Rea repeated their 2017 All-State run with a 3rd place finish this year. The team ran 1:46.09 to break their own school record time, which they set at last year's State Finals. The 4x100M Relay team of Harmeling, Molly Day, Maddie Matthews, and Rea finished 8th and broke the school record with a time of 51.44. Rea replaced Kaila Kuhn who was in the Qualifying relay, but is now at the US Olympic Skiing Training Center.

Stadt broke her school record in the 800M Run for the second time this week. She ran 2:17.95, which placed her 7th. Sophomore, Josee Behling repeated as All-State in the 400M Dash with a 7th place finish in a time of 1:00.46.

The Ramblers sent eight girls to the meet in 11 different events. The team scored in six of the events. Other girls qualified and running excellent events were: Rea 9th in the 100M Dash (13.02); Cotton 10th in the 100 High Hurdles (16.69); Harmeling 15th in the Long Jump (14' 6.25"); Eleri Giem 24th in the High Jump (4' 9"); and the 4x400M Relay team of Behling, Cotton, Giem and Stadt finished 15th in a season best time of 4:17.31.

For the boys, Ager unleashed his monster throw 59' 10" on his very last attempt. He was in second place behind last year's State Champion, Jack Boyle of Roscommon, going into his final throw. Ager has been steadily increasing his throwing distance after breaking the school record held by his throwing coach, Kevin Shaler, for over 40 years.

Ager also threw his personal best distance in the Discus (143' 9") to place 10th. Alex Serrano ran his personal best time of 40.63 in the 300M Hurdles to earn 9th place.
