Construction begins for Great Lakes Energy Headquarters expansion

A ground-breaking ceremony to celebrate the expansion of the Great Lakes Energy headquarters was held Wednesday, September 23, in Boyne City. Last spring GLE purchased adjacent property, formerly a Carter's Food Center, to accommodate the building expansion.

Joining the electric cooperative's board of directors, managers, and employees were distinguished guests, including Rural Utilities Services (RUS) Representative Pat Sarver, USDA State Director Jason Allen, and mayor of Boyne City Tom Neidhamer. Other local officials as well as representatives from Clark Construction and White & Liebler Architects also attended.

"This is a historic day for our cooperative and our employees. It symbolizes much more than the brick and mor-

tar that go into the actual building itself." Bill Scott states. "This building symbolizes growth, prosperity, and dedication to the community. It will take us into the future as we continue to serve our members with pride."

The new expansion will

provide much-needed infrastructure and space for the growth the electric cooperative has experienced in recent years. Truestream, GLE's new fiber internet and voice network, plays a vital role in the need to expand. Launched in 2018 in rural parts of Emmet, Charlevoix, and Cheboygan counties, Truestream brings highspeed internet, with speeds up to 1 Gig, and voice services to homes and businesses that have long been without broadband connectivity. Truestream has created local employment opportunities and with it a need for more office and warehouse space. The plans include the addition of offices and operations

tion of offices and operations vehicle storage as well as minor remodeling to the existing headquarters building. The first phase of the building addition will be constructed on the north side of the existing GLE headquarters and will house the utility's operations staff, equipment and vehicles. The second building addition will be constructed to the west, in the former Carter's building footprint, and will house GLE's 24/7 dispatch center as well as staff offices. The current headquarters building will sustain some remodeling to accommodate the growing utility workforce and Truestream internet network operations center and staff. The anticipated completion of the new facility is late 2021.

27, Petoskey, was sentenced to serve 10 to 20 years in prison for a crime spree committed in Charlevoix and Cheboygan Counties in October of 2019.

According to a police affidavit in the case, Pettersch committed 19 home invasions in Charlevoix County which were reported October 27 through the 30th.

The houses were clustered into groups in the Thumb Lake area and an area on the South Arm of Lake Charlevoix. Pettersch stole guns, tools and other personal items.

"The defendant targeted areas of mostly seasonal homes," Charlevoix County Prosecuting Attorney Allen Telgenhof said. "He went places where no one was likely to be around and gained entry breaking windows, screens or doors."

Pettersch was arrested after performing a similar crime in Cheboygan County which was seen live via security camera by the victim who called police. The 911 call led to a car chase and his apprehension.

Police located items stolen from the Charlevoix County crimes in his truck as well as his residence in Petoskey once police obtained a search warrant.


On August 28, Pettersch pleaded guilty to home invasion, first degree and two counts of home invasion, second degree and the remaining charges against him were dismissed.

The first degree home invasion charge related to one

Governor Whitmer Extends State of Emergency to Protect Michigan Families, Frontline Workers, and Small Businesses

Governor also extends four executive orders to protect vulnerable populations

LANSING, Mich. -- Today, Governor Gretchen Whitmer took further action to save lives and protect the health and safety of Michiganders by extending the State of Emergency until October 27. 2020 at 11:59 p.m. Executive Order 2020-186 will allow the state to continue to mobilize resources and take the reasonable and necessary steps to protect Michiganders and their families. The governor also extended four executive orders to protect Michigan families and our most vulnerable populations.

'We have saved thousands of lives in our fight against the COVID-19 pandemic, especially among our most vulnerable populations - people of color, seniors, and people with disabilities. Because we took swift action, the health of our families and our economy are faring better than our neighbors in other states," said Governor Whitmer. "This emergency will end, and it is a matter of months. But we are not out of the woods yet. Right now, the federal government and all 50 states have been under some form of state of emergency. We must continue doing our part to fight this virus on behalf of our families, frontline workers, and our small businesses."

Where Michigan was once among the states most heavily hit by COVID-19, our per-capita rate of new daily cases has plateaued at a level well below the national average. Despite gradually reopening our economy, Michigan's seven-day case positivity rate has remained between 3.0% and 3.7% since early July. Over the same time period, case growth has also remained within a narrow band of 61 to 71 daily new cases

Executive Order 2020-189 which extends through October 31 protections for prison and jail populations through enhanced cleaning protocols and implementation of testing protocols by Michigan Department of Corrections prisons and any jails that transfer inmates to MDOC prisons.

Executive Order 2020-190 which adds protections for workers and customers at food-selling establishments to the Workplace Safeguards order, including the requirement to maintain two hours a week of reserved shopping time for vulnerable populations.

'On behalf of the sheriffs, I am thankful that the governor worked with us to streamline the jails & prisons EO, and we look forward to continuing to work together for the safety and well-being of all Michigan citizens," said Matthew Saxton, CEO and Executive Director of the Michigan Sheriffs' Association.

"We are grateful for the governor's dedication to fighting COVID-19 and her ongoing work to protect Michigan workers and their families," said Andrea Acevedo, President of SEIU Healthcare Michigan. "There is no doubt that the governor's swift action has saved thousands of lives, particularly for our most vulnerable populations and health workers like ours who are serving on the front lines. We will continue to work closely with Governor Whitmer to ensure the health and safety of our members, their families, and those they serve."



A Tip Leads To The Arrest Of A Central Lake Man

ANTRIM COUNTY, MI. In early July 2020, the Michigan State Police (MSP) Gaylord Post requested the public's help identifying a suspect who had stolen construction supplies from a property owner in Banks Township. The property owner installed a trail camera and was able to obtain photographs of the perpetrator in action. The photographs were shared with the media in the news release.

A tip was received, and the suspect was identified as 70-year-old David Jules Vercammen of Central Lake. An arrest warrant was authorized by the Antrim County Prosecutor's Office. Vercammen was arraigned earlier this week in the 86th District Court in Antrim County for one misdemeanor count Larceny

for the benefit of our students and our school districts," explains Chip Hansen, president of the Charlevoix County Community Foundation.

A grant for \$130,000 from the Community Foundation will help the Health Department provide two full-time school nurses to serve in Boyne City, Boyne Falls, and East Jordan Public Schools for the 2020-2021 school year. **Charlevoix Public Schools** was able to fill the gap in health support on their own. Confirmed funding for the current school year will also provide time for the Health Department to engage with the school districts and other potential partners to explore collaborations aimed at sustaining the school nursing program for the longer term.

Young people see the value in health professionals located in schools. In fact, the Community Foundation's Youth Advisory Committee (YAC) led the way, deciding on a \$32,000 grant as part of the full commitment. "While a nurse mainly supports physical health, that person is also instrumental in supporting students' mental health. That might just be a caring conversation or it how to evaluate and treat health-related situations," says Pat Little, Boyne City Public Schools superintendent.

Beyond direct clinical care for students, "nurses work on policy, process, and systems change initiatives that benefit the entire school community," says Natalie Kasiborski of the Health Department of Northwest Michigan. This role might be especially relevant as the year continues. Schools have been in session - and in person – for a few weeks now, but the situation remains uncertain due to the COVID-19 pandemic. If schools close, the nurses will continue to serve as liaisons to the schools and support the COVID response. "Keeping health care providers in our schools for as long as school is in session is so important for our kids, and provides so much support for local educators," Mr. Hansen said, adding, "and, in the event that remote learning becomes the norm again, the nurses will continue to provide valuable advice and support to kids, families and our school leaders."

how to interact with debt collectors? Sometimes they are reasonable and easy to work with, but others are rude and pushy. Your advice would be appreciated. Paul

Dear Paul,

You'll run into all sorts of collectors, no matter what kind of debt you have. Occasionally they are friendly and understanding, while others can be downright mean and nasty. Whatever their approach is, you have to keep in mind they're all after one thing—your money.

Most debt collectors prey on a person's emotions and lack of confidence. If you don't know your rights, they can scare you by using bogus threats. Understand what I'm saying here, Paul. If you have debt, you have a legal and moral obligation to pay it. At the same time, you need to calmly and confidently control these kinds of conversations. You might have made some financial mistakes, but that doesn't mean you should allow someone to abuse you. When it comes to dealing

with debt collectors, keep track of all the calls and emails. Write down the names of anyone you talk to and when they called. A record of all contact is important, and it will make it easier to report them if they violate the federal Fair Debt Collection Practices Act. If the collector agrees to settle the debt, get it in writing and keep the document as proof in case they "forget" they made the offer.

Also, be completely up to speed on your accounts. Know what you owe, who you owe, and have a record of all the payments you've made. Knowing the facts gives you the upper hand in any situation. Don't be intimidated by debt collectors, either. Calmly explain your situation, the reason you're behind on the debt, and how you plan to pay it off. Don't get emotional and let yourself get drawn into an argument or shouting match. If they insult you, or yell or curse at you-yes, this happens sometimes—hang up immediately.

Financial troubles like debt can make every aspect of your life feel messed up. If you want to get back on track, start living on a written, monthly budget, and attack your debts using the debt snowball system. It's not easy, and it takes discipline, hard work, and sacrifices, but it's worth it! —Dave

Dear Dave,

I have \$11,000 in a mutual fund account that is not a retirement account. My wife has a retirement account through her job as a teacher, but I do not have one at all. We're in Baby Step 2, so should we cash out the \$11,000 in the investment account to help pay off debt? Chris

Dear Chris,

If this money is designated as non-retirement funds, I'd say go ahead and cash it out. Use the money to pay down debt, and continue to stay focused working the Baby Steps. Get that debt paid off, build an emergency fund of three to six months of expenses, then it's your turn to start investing.

The quickest way to build wealth is to get control of your largest wealth-building your income. When all your money is going out the door to other people, you don't have that tool at your disposal when it comes to important things like saving and investing. There's some math in there, but it's also about behavior and being intentional. Getting out of debt dramatically shortens the distance between you and wealth.

They're saying things like, "Never again will I be broke, never again will I have debt, and never again will I live with no savings to help take care of me and my family."



CHARLEVOIX — Familiar foe, great match, better results.



DOES YOUR INSURANCE POLICY COVER ROOF DAMAGE

The easiest way to know what's covered or what's not, is to contact your insurance provider. Coverage will often depend on the age of your roof, the area you live in, and many other factors, so it's important to know the specifics of your policy.

Most homeowner insurance policies will provide coverage for roof damage caused by unpreventable reasons such as vandalism or fire. Disastrous "acts of God" such as hurricanes and tornadoes are also usually covered. Although wind, rain, and hail are covered by your home insurance policy, there are many factors that determine if your damage will be covered, and if so, how much you will be reimbursed. The same basics that apply to your roof, may apply to your exterior property as well. Exterior property is considered anything that is attached to the outside structure of your home, such as siding and gutters.

Although wind, rain, and hail may be covered by your home insurance policy, there are many factors that determine if your damage will be covered, and if so, how much you will be reimbursed.

Some policies take the age of vour roof into account at the time it is damaged. For example, if your roof is under 10 years old, you may be covered for the full cost of repairing or replacing the damaged section of your roof at the time of the claim. If your roof is over 10 years old, you may only be reimbursed for the depreciated value of the damaged roof. The depreciated value takes the aging and wearing of your roof into account, meaning its value has decreased prior to any damage occurring. Depending on where you live, some policies will only offer roof damage coverage up to the depreciated value, regardless of the age of your roof. Other policies will cover the full cost of repairing or replacing the damaged section of your roof at the time of the claim, regardless of the age of your roof. In most cases, your insurance company will send an inspector to your home to investigate and verify your claim. If the damage is determined to be from aging, wear and tear, or poor

tenance, and will not be covered under your policy.

In some instances, water damage due to flooding or surface water, might have to be covered under an additional policy. Mold caused by continued water damage or leaking, for example, also may not be covered by your insurance policy. Preventing leaks and inspecting your property are crucial responsibilities of the homeowner and could help avoid unnecessary damage. If you are experiencing leaking due to a damaged roof, promptly remove any furniture or other belongings that could sustain water damage.

Replacing a roof or other exterior property can be a time consuming and expensive process. That's why it's important to take certain steps to prevent damage from occurring.

Get your roof inspected by a trained professional who can identify areas that may need immediate repair. Replace broken and worn shingles. Consider using impact-resistant shingles, which may be more expensive at first, but are designed to resist damage from hail, saving you money in the long run. Remove any dead trees from around your property that could potentially fall onto your home.

To ease the experience of the claims process and to help you receive proper settlement for your loss, take a set of "before" photos of your roof and exterior property. Update the photos whenever you have maintenance or repairs done. After damage occurs, take a set of "after" photos. Document and record the damage as well as any estimates, invoices and bills you receive. Having all of this information on file will help ensure a smooth and hassle-free claims process

Overall, it's important to remember that all insurance companies cover roof and exterior property damage differently. Even the same company can vary coverage drastically by state or the age of your roof or property. Policies also differ in coverage limits, deductibles and certain exclusions. The only way to be certain of what your policy covers, is to speak with
