Like most things 2020, Halloween may be a little different this year. Due to COVID restrictions, some communities may not have traditional trick or treat times posted this year. Check our News Brief section for information we have received about events or times, or your contact your local City or Township office to see if they are designating times this year.

Following is a look at ways to stay safe if you are trick or treating, as well as some non-traditional ways to make sure those young and old don't miss the treats and the fun of celebrating Halloween.

To help keep trick or treaters safe, the CDC (Center for Disease Control) offers the following tips for handing out treats:

Avoid direct contact with trick-or-treaters.

Give out treats outdoors.

Set up a station with in-

dividually bagged treats for kids to take. Wash hands before han-

dling treats. Wear a mask.

That last item should be easy. We are all used to wearing them, and after all, isn't wearing masks a major part of the Halloween tradition?

For those youngsters gathering goodies, the following recommendations come from our friends at the CDC:

Make your cloth mask part of your costume. A costume mask is not a substitute for a cloth mask.

# WHAT ABOUT TRICK-OR-TREATING?

- Look for outdoor events. But avoid crowds, wear masks, & keep safe distances.
- Give out individual treat bags & if your child collects treats, wipe them down or let them sit a couple of days before opening.

 Use cloth face coverings as part of a costume (think Superhero)! Do not paint them, though. Paints may contain toxins.

 And wash hands frequently!

Do NOT wear a costume

worn by children under the age of 2 or anyone who has trouble breathing

Stay at least 6 feet away from others who do not live with you

Wash your hands Bring hand sanitizer with you and use it after touching objects or other

people. Use hand sanitizer with

at least 60% alcohol. Parents: supervise young children using hand sani-

tizer. Wash hands with soap and water for at least 20 seconds when you get home and before you eat

any treats. The National Safety Council also reminds us that Halloween safety isn't just about following the rules of

the

pandemic. They cite a scary statistic: Children are more than twice as likely to be hit by a car and killed on Halloween than on any other day of the year. Lack of visibility because of low lighting at night also plays a factor in these incidents.

For trick-or-treaters, staying safe also means: A responsible adult

should accompany young children on the neighborhood rounds

If your older children are going alone, plan and review a route acceptable to you Agree on a specific time

children should return home Teach your children

never to enter a stranger's home or car

Instruct children to travel only in familiar, well-lit areas and stick with their friends

Tell your children not to eat any treats until they return home

and adults are reminded to put electronic devices down, keep heads up and walk, don't run, across the

Safety Tips for Motorists: Watch for children walking on roadways, medians and curbs

Enter and exit driveways and alleys carefully

At twilight and later in he evening watch for chil dren in dark clothing

Discourage new, inexperienced drivers from driving on Halloween

A group called Healthy Children.org observes there are some non-traditional way to enjoy Halloween this year.

Virtual costume parties & parades: Use video chats for an online party with friends and family and show off costumes and play games. Have fun with it! In cold climates, this may be the first time your child can wear a costume that

clock; as "fall back" and "spring forward" have become semi-annual catch phrases that give some direction to the process when Daylight Savings Time begins each spring and ends every fall. What's not always easy to remember is which Sunday morning in the spring and fall mark that transition.

Here is the reminder you may have been waiting for. Early Sunday morning, at 2am on November 1, Daylight Savings time for 2020 will officially end as millions upon millions of clocks across the country slip back one full hour to accurately reflect this annual event.

Daylight Savings Time has been touted as a crime deterrent, a reducer of vehicle accidents, and energy conserving practice, even a means of increasing voter turnout...yet the statistics in support of those benefits hasn't exactly held up since it's official inception over forty years ago. Residents of Arizona and Hawaii don't bother with DST at all, and it is a concept avoided in several continents and countries across the globe, including Asia, most of Africa, and about half of

## Health Department of Northwest Michigan COVID-19 Update

On October 27, the Health Department of Northwest Michigan is reporting 30 new confirmed cases in Antrim (6), Charlevoix (7), Emmet (7), and Otsego (10) counties. Case investigation and contact tracing are in progress, and relevant information will be shared when

Residents have expressed concern that schools are not reporting as public exposure locations. As a reminder, schools are typically not open to the general public and have records of everyone who has been in and out of their buildings. We continue to work directly with the school to do their case investigation and contact tracing, and we do not report details regarding school cases or outbreaks in our daily updates because schools tend to have a contained population and maintain records of entry into their buildings which allows us to complete case investigation and contact tracing efficiently.

"Unfortunately, we have notified an increase in cases and some school-related cases," stated Lisa Peacock, Health Officer. "We knew that we would eventually see cases related to the school population and our goal is to interrupt transmission as effectively as possible. To do this, we continue to work directly with schools to help slow/stop the spread through case investigation and contact tracing. Each school has reporting requirements and COVID-19 action plans in place when addressing COVID within the schools.'

We are approaching Hal-



loween weekend and with an uptick in cases locally we want to remind residents to celebrate safely. Because traditional Halloween activities tend to occur in large groups or community settings, guidance for safer activities has been created by MDHHS and the CDC. With community spread evident in our jurisdiction, continued masking, social distancing and regular handwashing are our best protection from COVID-

## Boyne City man arrested for assault with a dangerous weapon

CHARLEVOIX COUNTY, MI. On Wednesday, October 7, 2020 troopers from the Michigan State Police MSP) Gaylord Post responded to a report of a man threatening workers of a construction company with a handgun at a residence located on Tomkins Road in Boyne City. The victims called to report the incident from their place of employment after they left the scene. The victims stated they were installing fiber optic cable at a residence on Tomkins Road when the homeowner al-



legedly came outside wielding a handgun and threaten-

ing to kill them. The workers explained why they were there and the homeowner, identified as 45-year-old Nathan David Matts of Boyne City, calmed down, but became agitated again. The workers were allowed to finish the job, but Matts would have mood swings and they felt if they called police while they were there, he might harm them.

Matts was interviewed by the troopers and a report was submitted to the Charlevoix County Prosecutor. An arrest warrant was

authorized for Matts on October 21st. Troopers went to his residence and placed Matts under arrest without incident. Troopers also recovered a .45 caliber handgun from the home. Matts was lodged in the Charlevoix County Jail. He was arraigned in the 90th District Court in Charlevoix on October 23, 2020 for two counts Assault with a Dangerous Weapon. His bond was set at \$50,000 cash surety. His next scheduled court appearance is on November 10, 2020 at 2:30 p.m.

# **MDHHS** provides recommendations for voting safely during COVID-19

To ensure Michigan voters remain healthy and reduce the spread of COVID-19 during the Nov. 3 general election, the Michigan Department of Health and Human Services (MDHHS) has released recommendations for voters, poll workers and election officials.

"This guidance allows Michiganders to carry out their right to vote while doing it safely during the pandemic," said Dr. Joneigh Khaldun, chief medical executive and chief deputy for health. "I encourage registered voters to consider voting alternatives to limit the number of people they come in contact with and to help reduce the spread of the

"Michigan citizens can cast their ballots safely and with confidence in this election," said Secretary of State Jocelyn Benson. "All election workers are required to wear masks and all voters are strongly encouraged to do so. Voters who already have absentee ballots can drop them off at their city or township clerk's office or ballot drop box. Voters can also go to their local clerk's office through Nov. 2 to vote early by requesting and submitting an absentee ballot."

All registered voters may vote early by visiting their city or township clerk's office through Nov. 2. There they can request, fill out and submit an absentee ballot all in one trip, or take their ballot home to fill out and sign the envelope before returning it to one of their jurisdiction's ballot drop boxes by 8 p.m. on Nov 3. Election workers, who are required to wear masks,

will ask voters to show photo

Eligible citizens who are not yet registered may register, request and submit an absentee ballot at their local clerk's office through 8 p.m. on Nov. 3

When you vote or return your ballot, practice healthy behaviors to protect yourself and slow the spread of the virus. These behaviors in-

-Wearing a mask that covers your mouth and nose. -Washing hands before entering and after leaving the

-While in the polling location, frequently use alcoholbased hand sanitizer containing at least 60% alco-

polling location.

-Covering coughs and sneezes with a tissue or the inside of your elbow.

-Maintain at least 6 feet (about two arms' length) of distance from others.

If you are sick or concerned you have been exposed to COVID-19, seek medical care. If you don't have an absentee ballot, contact your local election office for guidance about voting op-

## Consumers Energy removes retired, de-energized cables in the Straits of Mackinac

Consumers Energy recently removed long-retired energy infrastructure from the Straits of Mackinac as part of its commitment to protecting Michigan's environment.

The company pulled up electric cables which were 46 kilovolt (kV)that had been de-energized since their retirement in 1990, along with concrete mats and grounding cables associated with the lines. Removing the cables improves safety in the Straits and enhances the state's waterways by reducing the odds of incidents such as an alleged tugboat anchor strike in 2018. Materials from the removed cables were salvaged and recycled to the extent possible to help offset the project costs and promote sustainable practices.

"Consumers Energy has long stood for the health and safety of the public and the protection of our state's waterways," said Dennis Dobbs, Consumers Energy's vice president of Enterprise Project Management and Environmental Services. "After learning of the 2018 alleged anchor strike on our cable, we began to investigate the best way to leave the Straits of Mackinac and the entire state in a better place."

In 2018, a tugboat and barge allegedly dragged an anchor through the Mackinac Straits, striking some of Consumers Energy's retired cables, as well as active electric transmission cables owned by American Transmission Company (ATC) and the Enbridge Energy Line 5 pipeline. No environmental damage occurred related to the Consumers Energy cables because they did not contain materials or fluids (mineral oil) that could have leaked.

The cables, installed in 1956, once supplied electricity to the Upper Peninsula.

Biodegradable paper bags are available locally at Ace Hardware and Boyne Co-op or can be purchased from any other source. Please put only leaves in bags as the bags are not strong enough to hold sticks, sand, or stones, and will tear upon lifting. Brush will not be picked up curbside, but may be brought to the North Boyne Compost Site. You may haul your own leaves, either bagged in biodegradable bags or unbagged, to the compost site on Robinson Street, open seven days a week for your convenience. They may NOT be left in traditional plastic trash bags. After the scheduled dates,

"The FBI and the Charlevoix County Sheriff's Office are actively seeking information leading to the location of Vicky Salisz, who disappeared more than 30 years ago," said Assistant Special Agent in Charge Douglas S. Depodesta. "Any information, no matter how seemingly insignificant, may be important to finding her. We thank those of you who have already provided information and urge others whether you remain in the

community or have left the area over time – to come forward."

Victoria Marie Salisz, also known as "Vicky," has not been seen since she left Pippins Restaurant at the end of her shift on April 15, 1988. Vicky was scheduled to work the next day but never showed up. A coworker reported her missing a week later. At the time of her disappearance, Vicky's son Stephen Salisz and his thengirlfriend, Beth Webb, were living in the woods at the back of the family farm. Neither one reported they had seen Vicky, whose car was found parked near her home with the keys still in the igni"We understand the communities that make up upper Michigan are small yet close-knit communities where what happens to one is felt by all. We asked everyone here today to request your help," said Charlevoix County Sheriff Charles Vondra. "This community, especially Vicky's family, deserve answers for what happened to Vicky."

There is a reward of up to \$5,000 for information leading to the whereabout of Victoria Salisz. If you have any information, please call the FBI in Michigan at 1-800-CALL-FBI or go to FBI.GOV/TIPS.

# Grants available for eligible teachers, support staff

Governor Gretchen Whitmer and State Treasurer Rachael Eubanks announced that eligible Michigan teachers and support staff who worked additional time and incurred additional costs during the 2019-2020 school year due to the COVID-19 pandemic can receive a grant through two new grant programs.

Under both the Teacher COVID-19 Grant and the Support Staff COVID-19 Grant programs, eligible teachers can receive up to \$500 and eligible support staff can receive up to \$250. The state of Michigan's Fiscal Year 2021 budget provides \$53 million for eligible K-12 classroom teachers and \$20 million for eligible support staff

"Our teachers and support staff have made incredible sacrifices this year to ensure our kids can get a great education while Michigan fights the COVID-19 pandemic. They deserve all of the support we can give as we continue working around the clock to keep Michigan families safe," said Governor Whitmer. "My administration will continue working hard to protect our educators and ensure our kids are learning the skills they need to grow this year. And as we continue to fight this virus, remember to mask up, maintain six feet of physical distancing, and get your flu vaccine.

"Teachers and support staff have put in the extra hours and time to ensure our children receive an education during the COVID-19 pandemic," Eubanks said. "We need to support our school employees as they continue to support our students and families during the pandemic. I thank them for all they are doing in these extraordinary times."

"Having been a classroom

teacher for nearly 20 years, I know that this past spring was a stressful time for teachers and support staff," said Sen. Dayna Polehanki. "The shift from in-person instruction to remote learning that occurred due to COVID-19 required additional time, costs, and energy to ensure learning continued, so I applaud Governor Whitmer and State Treasurer Eubanks for recognizing and supporting educators with these new grant programs."

"When COVID-19 hit our state, teachers and support staff across Michigan rallied to keep our children connected to learning and their school communities," said Rep. Sheryl Kennedy. "This meant learning a completely new skill set as they were simultaneously trying to keep students on par with their learning. This was and continues to be an effort that exceeds the 40 hour work week and consumed most of the non-student calendar days including spring and summer breaks. This grant will not replace or compensate that time hour for hour, but it is an effort for the state to say, 'We see you. We get it. Thank you."

"COVID-19 has challenged our communities and especially our schools, but together, as a state we have pushed forward. As a former high school teacher, I applaud the efforts of teachers and students as they work tirelessly to keep our education system the best it can be," said Rep. Nate Shannon. "This grant being made available to teachers will help continue to provide resources to the classroom, which is more necessary than ever. I am very happy today to echo a message to all teachers and students

that we stand with them."
"Michigan's teachers and support staff have gone

above and beyond during this health crisis to ensure all our students succeed despite the challenges we have faced," said Rep. Matt Koleszar. "As a teacher, I understand the sacrifices educators make for their students even during ordinary times, and the times we live in now are far from ordinary. Teachers have spent countless hours developing new ways to educate and support our students that fit our new reality, and I'm proud to stand with the governor to make sure they have what they need to support themselves and their families while they continue their critical work."

To help combat the spread of COVID-19, Gov. Gretchen Whitmer on April 2 signed an executive order that suspended in-person instruction of K-12 students and provided limited and temporary relief from certain requirements so K-12 instruction could continue through alternative methods during the public health crisis.

Teacher COVID-19 Grant Program

The Teacher COVID-19 Grant Program was created in state law to recognize the additional time and additional costs classroom teachers in a school district or nonprofit nonpublic school spent to ensure learning continued when in-person instruction was suspended in the spring.

Full- and part-time classroom teachers who taught K-12 students in a school district or nonprofit nonpublic school classrooms during the 2019-2020 school year prior to the suspension of inclass activities are eligible.

To receive up to \$500, teachers must have performed at least of 75% of their standard instruction workload in brick and mortar classrooms during the last school year prior to the suspension of in-person instruction on April 2.

Support Staff COVID-19 Grant Program

The Support Staff COVID-19 Grant Program was created in state law to recognize the additional time eligible K-12 support staff spent outside of normal working hours, hazardous conditions encountered and additional costs incurred to provide services to students when inperson instruction was suspended in the spring.

School support staff includes a full- or part-time paraprofessionals, aides or noninstructional staff who work in a public school, which includes local and intermediate school districts and public school academies.

To receive up to \$250, individuals must have performed at least of 75% of their workload in brick and mortar buildings during the last school year prior to the suspension of in-person instruction on April 2.

Additional Grant Program Information

The Michigan Department of Treasury is working with the Michigan Department of Education, school entities and other education partners to implement the programs. Eligible teachers and support staff should consult the school entity where they worked during the 2019-2020 school year to ensure they receive a grant.

Grant funding checks are anticipated to be sent directly from the state Treasury Department to teachers and support staff in February 2021.

# Feedback needed for Lake Charlevoix green stormwater infrastructure projects

If you are a resident, business owner, or local government official in Boyne City. Charlevoix, or East Jordan, we want to hear from you! Tip of the Mitt Watershed Council, in partnership with Drummond Carpenter, PLLC, and the three cities, has developed a website to solicit public feedback on potential green stormwater infrastructure (GSI) planning efforts. The site, which provides information about GSI and the Lake Charlevoix Watershed, can be accessed at: https://bit.ly/33bm82d. Links to the individual surveys for each of the three cities are also on the website.

Survey respondents may review pictures of potential GSI solutions proposed at locations within their communities and vote on the ones

they prefer.

Over the course of the last ten months, the project team has examined existing stormwater infrastructure

in each city and highlighted opportunities to adopt new GSI practices. GSI mimics the ways that nature helps stormwater flow back into the ground, which can keep water resources clean and protect public health. It uses native vegetation and natural processes to capture pollutants and minimize nutrient runoff. GSI can prolong the life of existing stormwater infrastructure and enhance stormwater treatment. Examples include tree box filters, rain gardens or bioretention basins, bioswales, application of permeable pavers, and green alleys.

According to the Watershed Council's Watershed Protection Director, Jennifer Buchanan, this project will be instrumental in "protecting coastlines and improving stormwater management in the Lake Charlevoix Watershed, especially in the face of climate change." Buchanan continued, "This project will ensure that each of the three Lake Charlevoix communities will come together to choose a greener, more sustainable future for their shared home by reducing stormwater runoff and eliminating potential pathways for pollutants like oil, heavy metals, bacteria, or sediments."

All survey responses are

All survey responses are due for consideration by December 1. Please share the link with friends, family, and neighbors who live, work, and play in the three Lake Charlevoix cities so their opinions can be counted. In addition to the survey, community members are encouraged to sign up online for a stormwater site assessment offered by the Watershed Council. Those interested will be contacted in the spring of 2021 to schedule a time for Watershed Council staff to visit their property, free of

charge, and discuss options for how stormwater management through GSI can help protect Lake Charlevoix.

Funding for this project was generously provided by the Charlevoix County Community Foundation, and the Coastal Management Program, Water Resources Division, Michigan Department of Environment, Great Lakes, and Energy and the National Oceanic and Atmospheric Administration.

# WINTER SPORT UPDATES FROM MHSAA

MHSAA Representative Council Confirms On-Time Winter Sports Start, Ap-

proves Precautions
The Representative Council of the Michigan High
School Athletic Association
confirmed during its meeting
Thursday (Oct. 22) that 202021 Winter sports will begin on
time, and also approved a series of guidelines for those
sports that schools must follow as they continue to work
toward limiting the spread of
COVID-19 while still providing opportunities for athletes
to compete.

Most high school sports traditionally begin practice during the first three weeks of November, with competition starting during mid-November and the first weeks of December. The starts of middle school Winter sports seasons are determined by local leagues and conferences; many are slated to begin dur-

ing the next few weeks. Sport-specific guidelines for all Winter sports will be posted early next week to their respective sport pages on the MHSAA Website at https://www.mhsaa.com/spo rts. A number of precautions have been put in place addressing competition limits, numbers of spectators allowed and wearing of face coverings, among a variety of topics. The guidance also specifically addresses equipment and facilities for each

"The Council believes it is safer to begin Winter practices on time, and keep athletes in school programs where safety precautions are always in effect," MHSAA Executive Director Mark Uyl said. "With the vastly different circumstances faced by schools in different regions all over the state, an on-time start still allows schools to decide when they feel most comfortable beginning activity, and allows all of them to slowly ramp up their frequency of activity and numbers of spectators attending competitions."

"But let's be clear: Our statewide COVID-19 numbers have to get better. In order for our schools to continue playing sports this winter, and in order for fans to be there to cheer them on, we must continue working to slow down this virus."

As with Fall sports, scrimmages will not be allowed for Winter sports to limit mixing of communities outside of official competitions. The numbers of teams at

regular-season competitions also will be limited, like during Fall, with a maximum of four schools/teams allowed in competitive cheer, gymnastics, swimming & diving and wrestling. Bowling and skiing competitions will be restricted to a maximum of 72 competitors at one event.

There are no school/team limits for basketball and ice

able to play each other at one time and those sports may play only one game per day,with fans leaving after their game is complete. Host sites must strictly enforce spectator capacity limits on a gameby-game basis. The Council approved as part of these guidelines an allowance of two spectators per participant at all contests to begin the regular season. This guideline could be reconsidered by the Council later in the winter season, with a possibility of allowing more spectators later while still staying within possible Emergency Orders from the Michigan Department of Health and Human Services

(MDHHS).

As per MDHHS requirements, face coverings must be worn by athletes practicing and competing in basketball, competitive cheer, ice hockey and wrestling. They are not required for athletes practicing and competing in bowling, gymnastics, skiing and swimming & diving, which all allow for appropriate social distancing,—but face coverings are required for those athletes when not involved in active participation.


Junior quarterback Caleb Stuck would add another Rayder score before the half on a short goal line run for a 13-8 advantage.


Ally Herrick was successful on six extra point attempts.





# A SHORT GUIDE TO REAL ESTATE LINGO AND ACRONYMS

Real estate ads are usually full of acronyms and terms that are unfamiliar to first-time buyers. Here's a cheat sheet to let you in on the lingo.

HDW, HWF, Hdwd -- hardwood floors

hi ceils -- high ceilings in-law potential -- potential for a separate apartment, subject to local zoning restrictions

large E-2 plan -- this is one of several floor plans available in a specific building

listing -- an agreement between a real estate broker and a home owner that allows the broker to market and arrange for the sale of the owner's home. The word "listing" is also used to refer to the for-sale home itself. A home being sold by the owner without a real estate agent isn't a "listing."

lo dues -- low homeowner's association dues. But find out how "low" the dues are compared to other dues in the area.

lock box -- locked key-holding device affixed to a for-sale home so real estate professionals can gain entry into the home after obtaining permission from the listing agent

Isd pkg. -- leased parking area. May come with additional

MLS -- Multiple Listing Service. An MLS is an organization that collects, compiles and distributes information about homes listed for sale by its members, who are real estate brokers. Membership isn't open to the general public, although selected MLS data may be sold to real estate listings Web sites. MLSs are local or regional. There is no MLS covering the whole country.

pot'l -- potential pvt -- private

title insurance -- an insurance policy that protects a lender's or owner's interest in real property from assorted types of unexpected or fraudulent claims of ownership. It's customary for the buyer to pay for the lender's title insurance policy.
