Charlevoix County mourns the loss of former commissioner Joel Evans

Charlevoix County suffered a big loss to the community last week. Former Charlevoix County Commissioner Joel Evans passed away on April 12,2021. Evans was 80 years old when he passed away in Traverse City. Evans, who has been a Charlevoix County resident for his entire life, spent most of it serving the public. Evans married his wife of fifty plus years Mary Jane LeCroix in 1969. Evans worked at the local lumber yard in East Jordan and Alden for 43 years and was the owner of Evans Building and Home Center. It was his

time serving the community that made the biggest impact.

Evans started with his community involvement by coaching East Jordan Little League in his younger years. Then would be a school board member for East Jordan Public Schools from 1990-1991. Evans would also serve as the South Arm Township Supervisor for 10 years. Evans would then become a Charlevoix County Commissioner from 2007 to 2018. The impact could easily be seen, especially when talking to people who knew him and worked with him.

Current Charlevoix County Commissioner Chris Christensen who worked with Evans on the Commis-

sion mentioned the impact he had on him. "Joel was always a good guy, he was always even keeled. He was always a guy who would ask you how you were doing and put you first. He will be missed in our community and Charlevoix County. He did a lot of good things as a Commissioner, resident and Business Owner," said Christensen

A person who worked very closely with Evans was a former Charlevoix County Clerk and County Financial Officer Chervl Browe.

'Joel was a wonderful person. His top priority was the people of Charlevoix County, everything that he did was for the benefit of others. I was very upset when I found out about the passing of Joel and I am worried about his wife Mary. He was a very kind person who cared about others way more than himself," said Browe.

Another person who

" I was hired here in 2010 as the board chair. so we worked on quite a few things pretty closely. He was one of the nicest people I have ever worked for, the kindest person I have ever met. We had a saying the first couple years I worked here, 'Just do what Joel would do'. He will be dearly missed. Everyone is a better person for knowing him and he always saw the best in people," said Shepard.

Charlevoix County Sheriff Chuck Vondra was around Evans quite a bit and also spent time working with him,







Construction projects begin in Boyne City

Starting on Monday, April 19th three (3) construction projects totaling \$400,000 in value will commence in the City of Boyne City.

1. An existing 12" diameter storm sewer will be replaced along Pine Street, from S East Street to S Park Street. A portion of the street will be re-paved upon completion of the storm sewer.

2. The existing asphalt pavement on Franklin Street, from S East Street to S Park Street, will be crushed & shaped with an asphalt pulverizer and then receive 3" of new asphalt. This treatment should add 10-12 years to the useful life with continued maintenance work. Concurrently, a 12" diameter storm sewer will be added along Franklin Street as well as along S Park Street, from Franklin Street to Morgan Street, and then along Morgan Street, from S

Park Street to S Lake Street. 3. The existing pavement on the Park Street Bridge over the Boyne River will be milled off and the concrete deck will receive a waterproofing membrane prior to resurfacing.

CHARLEVOIX CITY COUNCIL MEETING, APRIL 19, 2021 **McDermott to be the new Charlevoix Harbormaster**

CHARLEVOIX - The meeting would start off with a proclamation by Mayor Luther Kurtz to support the observance of National Arbor Day on April 30 and Earth Day on April 22. While encouraging residents to continue planting and protecting the young city trees. Also continuing to be a Green Community and support the City's certification as a Tree City USA. The Council would then have a presentation from Kent Knorr the Recreation Director about some of successes, challenges, partnerships, grants and recreation trends for the City of Charlevoix over the last year. While also presenting some new programs and opportunities for 2021. Knorr presented that they saw an increase in outdoor recreation participation in all areas. They only had three recreation events that were cancelled, which were Adult Softball, Vollevball and Tball. They found that with participation numbers up, so were revenue at the Golf course, Marina reservations, Ski Hill, Skate Park, Day Camp and Farmers Market. The Recreation Department also found that attendance was up at beaches, trails, bikes, hikes, candlelight hikes, sledding, snowshoeing, non-motorized water-

craft and parks.

In 2021, the Recreation Department looks to have team sports return with adding Kickball and Dodgeball tournaments. While having expanded hours at the Skate Park. There will also be a new Duffers league at the Golf Course on Wednesday nights. The department is continuing to look at other opportunities at the Golf Course such as Croquet Bocce Ball, Bird watching and Cross Country Skiing. The Recreation Department announced that the new Dog Park and the new Kayak Launch are almost ready to open. The presentation was finished with thanking all of the hard working staff. Two staff members were honored as they recognized Bo Boss for 45 years at Mount Mc-Sauba and Pat Klooster for retiring as the Harbor Master. The Council would then approve the motion to accept the bid from Bolle Contracting to demolish the existing DPW building at 229 Stover Road. This will usually include the removal of all existing structures and regrading the site to drain properly and install soil and grass seed. The City applied for blight elimination through the Redevelopment Ready Communities Program. The grant would help cover some of the \$43,669 cost of the project. After approving the bid, Council

talked about how they would like to get the public's input on what they would like to see done with the property.

The Council would then be presented with the

The meeting would wrap up by City Manager Mark Heydlauff giving some updates. The Master Plan which is required to be updated at least every five years, is currently being reviewed by the Planning Commission. They will be sending a survey to residents both in print and dig tally regarding topics to the Master Plan and the community. Heydlauff announced that they have announced Dennis McDermott to be the new Harbormaster. McDermott has 31 years of experience with the Michigan DNR. His latest assignment was the Supervisor of the Petoskey State Park. He has experience with the DNR reservation system that is used in the Marina. McDermott was the Harbormaster in Petoskev and most recently the Director for the City of Harbor Springs. The Lake Charlevoix EMS Authority board met for the first time on Monday, April 15. There will most likely be quite a few meetings going forward to help establish the Authority and get it going. The next City Council meeting will be on Monday, May 3 in person and on Zoom at six o'clock.

Health department has immediate clinic openings this week

Appointments are immediately available this week at COVID-19 vaccination clinics throughout the Health Department of Northwest Michigan four-county jurisdiction.

The health department is expected to administer more than 4,000 doses this week (see clinic schedule below). Although scheduling an appointment is requested, walkins are welcome. Scheduling an appointment ahead of time allows for health department staff to ensure enough vaccine is available at each clinic and reduces the appointment time. Anyone experiencing barriers with scheduling or receiving a vaccination should call 2-1-1 or their local Commission on Aging or Senior Services Center for assistance.

In addition to getting vaccinated as early as possible, Dr. Josh Meyerson, health department medical director, is reminding residents to continue to mask up, wash their hands, and socially distance. On Friday, the Michigan Department of Health and Human Services (MDHHS) extended its Gatherings and Mask epidemic order. According to MDHHS, the order is designed to balance day-today activities while controlling the spread of COVID-19 and saving Michiganders' lives.

"As we continue to get more people immunized, we all need to limit our gathering sizes and wear masks in public during this current surge with widespread viral transmission," Dr. Meyerson said.

CITY OF BOYNE CITY COMMISSION MEETING, APRIL 13, 2021 Cemetery contract becomes hot topic, after approving additional \$10,000

BOYNE CITY - As part of the consent agenda, the city would proclaim that April is Sexual Assault Awareness in the City of Boyne City. They would also proclaim that April 23 is Arbor Day in the City of Boyne City.

During the City Manager report given by Michael Cain, he announced that even with cases of COVID on the rise, City Hall will still reopen on Monday, April 19. Also, on April 23 as part of the Arbor Day celebration City Hall will be giving away free White Pine and Spruce seedlings at the Veterans Park Pavilion from 7:30 in the morning till 4:30 in the afternoon. As part of the City Manager report, Main Street Executive Director Kelsey King - Duff would announce that with some personal life changes that she would be stepping down from her position by July 2021.

The Commission would hold a public hearing for the FYE 2021/2022. This is necessary to complete the budget and appropriation process. The resolution is for adopting the General Operation Millage Rate, City Hall facilities Debt Service Millage Rate, General Appropriations Act for FYE 2021 / 2022 and adopting the Fee Schedule. There would be no public comment for the public hearing.

The meeting would mostly be around the budget, including approving the resolution to establish a General Operation Millage Rate of 15.51 for the budget. This Millage is for the operating expenses for all City Funds.

The next thing would be to approve the 2.20 millage rate for the City. This was approved by voters and when approved it was at 2.25 but with the recent COVID financial hardships, it was reduced to 2.20. This would be for City Facilities Construction Debt. A question would be raised by City resident Chuck Vondra about the possibility of paying down the debt with excess revenue. Cain would shoot down the idea that based on the agreement they made with the bonds lender they cannot make advance payments on the debt for a period of time. Cain believed that the period was ten years but would have to check at another time.

The Commission would then approve the General Appropriations Act Resolution which is necessary to defray the operating expenses and long-term debt obligations of the City. The next thing would be fee rates for the upcoming year. This includes fees for the City all the way down to making copies. There have been no changes in the prices from last year.

The Commission would spend quite a bit of time getting an update from the Boyne Heritage Center. They gave an update mentioning that they are recruiting and interviewing people for the board. The communication and strategic planning is currently in place along with an application for a national grant. The LeFrance / Clock room is in the first phase for final design, fabrication and production with the goal of beginning installation in early 2022. They are looking for storage options and locating and identifying items for the LeFrance and clock room.

The Center has received items from a few different people such as : the Litzenburger family of Harbor Springs, Thomas Sage of Petoskey, Shawn and Heather Whitehead of Jackson, Ed May of Boyne City, Mary Esper of Brandon, Missouri and the Boyne City Elementary School. The presentation would then go through some of the collection that they have already put together. Which include some amazing and very historic pieces. The council would then discuss what to do with storage of some items to make sure the weather is not affecting the pieces.

The Commission would

then review a message sent by Northern Michigan Escapes as they notified the City that they are losing money on the contract of \$25,000 for the Cemetery contract which was due to expire on November 30, 2021. In the contract it was given that each party would be able to cancel the contract with 60 day notice. Northern Michigan Escapes was the lowest bid at the time of the contract. The City could go out and rebid the contract but feel that the timing for the bids is difficult since it is the Spring season and Memorial Day holiday.

City Resident Tim Christensen and Chuck Vondra both expressed that the Commission needs to check on what the bids were when the bids were placed. Both Christensen and Vondra felt that it was not fair to the businesses because this might not raise the contract over a different company that bid just a little bit more previously. The bid was placed two years ago and

may not been relevant. The City did not look for other alternatives with the company to see if something could be done, other than the contract being cancelled or adding in the \$10,000. The Commission would have very slight discussion about it and would ultimately unanimously approve to spend an extra \$10,000 to the contract that was already agreed upon so the contract would not be nullified with Northern Michigan Escapes.

The Commission would approve the recommendation to award a Purchase Order contract with PK Contracting, Inc for the 2021 Pavement Marking Services in the amount not to exceed \$36,000. PK Contracting is the biggest pavement marking company in the State of Michigan. The list of streets were outlined and they hope to have it done by the busy time of the Summer.

The next City Commission Meeting will be held on April 27 at seven o'clock on Zoom.

The communities, who receive the grant funding from the MEDC, in turn award grants of up to \$25,000 to eligible businesses seeking support.

The grants are expected to create or retain 69 full-time

and 71 part-time jobs, and the projects are expected to generate a total private investment of nearly \$2 million.

Grants may be used by the business for eligible expenses that support technical assistance, interior building renovations, permanent or semi-permanent activation of an outdoor space, permanent or semi-permanent business infrastructure related to COVID-19 recovery efforts, and other working capital needs such as marketing needs and inventory expenses. Additional needs identified by the business and supported by the local community are also considered.

In June 2020, MEDC announced that 22 communities around Michigan were awarded a total of \$993,984 in grants aimed at supporting the COVID-19 economic re-





The property owner or any person having an interest in the property subject to the special assessment may file a written appeal of the special assessment with the State Tax Tribunal within thirty (30) days after confirmation of the special assessment roll, if that special assessment was protested at this hearing.

"Person" means an individual, firm, corporation, association, partnership, I imited I iability company, or other I egal entity.

"Township" means Evangeline Township, Charlevoix County, Michigan.

"Vehicle" means every device in, upon, or by which any person or property is or may be transported or drawn upon a highway.

Section 3. Parking Regulations.

No person shall park, or allow another person to park, any vehicle or motor vehicle on any portion of the highway known as Glenwood Beach Drive between Glenwood Park and Brook Place, as depicted in the Amended Plat of Glenwood Beach Resort.

Section 4. Evidentiary Presumption Relating to Parking Violators.

In any proceeding for a violation of this Ordinance, proof that the particular vehicle or motor vehicle described in the complaint was parked in violation of this Ordinance,together with proof that the defendant named in the complaint was, at the time of such parking, the registered owner of such vehicle or motor vehicle, shall constitute in evidence a presumption that the registered owner of such vehicle or motor vehicle was the person who parked such vehicle or motor vehicle in violation of this Ordinance.

Section 5. Notice of Parking Regulations.

The Township Supervisor, or his designee, shall erect signs on that portion of Glenwood Beach Drive described in Section 3 of this Ordinance that are sufficiently legible and at such intervals so as to be seen by an ordinarily observant person giving notice of the parking regulations contained in this Ordinance.

Section 6. Municipal Civil Infractions.

Any person who shall violate any provision of this Ordinance shall be guilty of a municipal civil infraction as defined in Public Act 12 of 1994, amending Public Act 236 of 1961, being Sections 600.101-600.9939 of Michigan Compiled Laws, and shall be subject to a fine of not more than Five Hundred and 00/100 (\$500.00) Dollars. Each day this Ordinance i s violated shall be considered as a separate violation.

Section 7. Enforcement Officers.

Deputies of the Charlevoix County Sheriff are hereby designated as the authorized officials to i ssue municipal civil infraction citations directing alleged violators of this Ordinance to appear in court.

Section 8. Impoundment of Vehicles or Motor Vehicles.

In addition to the penalties contained in Section 6 of this Ordinance, any vehicle or motor vehicle parked in violation of this Ordinance may be i mpounded by any police officer and removed from the highway where i llegally parked. After the police officer impounds a motor vehicle parked in violation of this Ordinance, he or she shall comply with the requirements of Section 252d(2) to (5) of the Michigan Motor Vehicle Code, being MCL 257.252d(2) to (5), or the regulations of Michigan Motor Vehicle Code then in effect relating to the i mpoundment of motor vehicles.

Section 9. Severability.

If any section, provision or clause of this Ordinance or the application thereof to any person or circumstance shall be invalid, such invalidity shall not effect any remaining portion or application of this Ordinance which can be given effect without the invalid portion or application.

Section 10. Effective Date.

This Ordinance shall become effective thirty (30) days after being published in a newspaper of general circulation within the township.


