\$300,000 for Boyne City's Open Space recommended for approval

Boyne City - The Michigan Natural Resources Trust Fund and the governor have recommended approval of Boyne City's \$300,000 grant request for improvements to the Open Space project. The grant would fund the development of Phases 1 and 4 of the Open Space Master Plan project on the waterfront across the street from Family Fare.

The improvements will include a 10 ft. wide nonmotorized pathway and two crosswalks along North Lake Street, a 6 ft. wide shoreline walkway, a naturalized shoreline garden, street trees, seeding



and landscaping. The project is included in the Parks and Recreation Master plan and scheduled in the 2022 Capital Improvement

Plan. The city will provide \$120,000 in matching funds from the Parks and Recreation budget in the 2022-2023 fiscal year. "The

walkways and other grounds improvements that this grant will help fund will be the most significant steps forward in improving the Open Space since Boyne City was able to purchase this Lake Charlevoix waterfront property in late 2018 with the help of another MNRTF grant," said Boyne City Manager Michael Cain. Legislative approval could take 4-6 months

The Michigan Natural Resources Trust Fund is a restricted fund that was established in 1976 to provide funding for public acquisition of lands for resource protection and outdoor recreation, as well as for public outdoor

recreation development projects. It is funded through interest and earnings on funds derived from the revenues of stateowned oil, gas and minerals. Over the past 45 years, the Trust Fund has granted more than \$1.2 billion to state and local units of government to develop and improve recreation opportunities in Michigan. "We look forward to the Michigan Legislature approving the MNRTF Board's recommendation so we can continue work on this next step of implementing the Open Space master plan as early as possible in 2022," said Cain.

record high numbers of COVID-19 cases, new data from the Michigan Health & Hospital Association (MHA) proves that the majority of Michigan residents severely sick with COVID-19 are unvaccinated. The Michigan Department of Health and Human Services (MDHHS) and MHA are pleading with residents to get vaccinated for their own health, the safety of Michigan's health care personnel, and to avoid additional strain on health care systems that are already stretched and struggling to respond. Locally, the McLaren and Munson health systems, which serve the Health Department of Northwest Michigan and other counties across the region, are experiencing similar problems with pressure put on limited bed availability, and an overburdened staff. "Vaccination is our most powerful tool," said Dr. Josh Meverson, Medical Director with the Health Department. MDHHS data from January 15-November 19 demonstrates that unvaccinated people account for 85.8% of COVID cases, 87% of hospitalizations, and 86.4% of deaths, Dr. Meyerson noted.



The data is clear: if you are unvaccinated, you are risking hospitalization or death, health officials said.

"Getting vaccinated keeps



you and your loved ones safe as we gather together this holiday," Dr. Meyerson said.

Based on recent data from most Michigan health systems. MHA has found that three out of four COVID patients are unvaccinated (76%), 87% of COVID ICU patients are unvaccinated and 88% of COVID ventilator patients are unvaccinated.

Michigan's number of hospitalized COVID-19 cases reached a new high this week, with 4,291 patients hospitalized. Recently, Michigan reached 70% of residents 16 and older who have received their first vaccine dose, but cases are surging in the unvaccinated population.

MDHHS and the local health department are monitoring for the COVID-19 omicron variant which had not been detected in the state as of the time of this release. Residents are advised that the presence of variants makes it even more important to get vaccinated, including the booster doses to increase protection, wear masks, and take other precautions.

In addition to getting vaccinated and wearing masks particularly indoors and in crowded areas - other things people can do to protect themselves and their loved ones include:

• Getting tested for COVID-19, especially before gatherings.

 Physically distancing from others and avoiding crowds.

· Washing hands frequently with soap and water and cleaning hands with alcohol-based hand rub.

• Covering your mouth and nose with a bent elbow or tissue when you cough or sneeze.

• Self-isolating until you recover if you develop symptoms or test positive for COVID-19.

MDHHS has issued a public health advisory that all Michiganders, regardless of vaccination status, should wear a mask in indoor public settings and those who are not fully vaccinated or who are immunocompromised should avoid large crowds or gatherings.





Charlevoix County Community Foundation awards over \$54,000 in Youth Grants, Mental Health Focus

The Youth Advisory Committee (YAC) of the Charlevoix County Community Foundation responded to requests from nonprofit partners in November. Thanks to donors who look to the Community Foundation to make a difference close to home, grants have been awarded primarily to nonprofits who will focus in the areas of youth mental health and academic stress. In all, over \$54,000 was awarded during the Youth Needs grant cycle.

YAC members and their peers are constantly feeling the stresses associated with school, family, and planning for their futures. As a result of feeling these stresses personally and also seeing the stress in their peers, the YAC were eager to use their grantmaking ability to help organizations offering solutions. These needs were also identified in the most recent Youth Needs Assessment that they conducted, a survey that is updated every three years and includes surveying all 8th through 12th graders in Charlevoix County public schools. The YAC has recognized the need for breaking down the stigma associated with asking for help with mental health and the need for better tools for coping with stress.

"This year's grant cycle was our second year in which we focused on grants that address academic stress and mental health, to prioritize the needs that have been brought to our attention by our research," stated Eden Vrondran, the current YAC President and Boyne City Senior. "I am

thrilled to say that the grants we have received were definitely what we were looking for, and I am certain they will make a big impact on the well-being of today's youth."

Through this cycle, the YAC funded projects like Northern Michigan Equine Therapy's HorseSense program for direct mental health therapeutic support; the CAPE Council's 2022 Conference, which will focus on education around youth mental health and academic stress as they relate to Covid-19 for area professionals working with youth; and stem-related tools for the middle school classrooms at Boyne City Public School, to assist with alleviating stress in the classroom. The YAC were also excited about a new social media component and youth voice added to Planned Parenthood's programming and the supports that the Women's Resource Center has in place for youth at their Child Advocacy Center, helping to decrease trauma inflicted on children who must report about a

traumatic experience. While the primary focus of this cycle was on the two priority areas, three other grants were also awarded including to the Charlevoix Area Community Pool, President Ford Division **DBA Michigan Crossroads** Council, and to PoWeR! Book Bags. These grants support swimmer's safety. mentorship, and early childhood literacy, respectively.

Looking ahead, the YAC are gearing up for their next Youth Needs Assessment, to be conducted in 2022, which will again assess the needs and concerns of Charlevoix County youth. The YAC will analyze and apply those results to their next three years of grantmaking decisions. Meanwhile, they continue engaging in conversations and projects around previously identified topics at the local level and regionally.

A charitable organization dedicated to improving and enriching life in the area, the Charlevoix County Community Foundation accepts gifts from individuals, families, businesses and civic

groups and manages them as permanent endowments. While a portion of the funds are utilized to support grantmaking, the principal of the endowment continues to grow, providing ongoing charitable capital to benefit Charlevoix County's residents-now and in the future.

The next grant cycle will focus on Environment, Land Use, and Recreation projects. Applications will become available in early January and will be due by Tuesday, March 1, 2022. The Veteran of the month of December 2021 is Gerald Lee "Jerry" Bingham.

Born in Boyne City Michigan September 29, 1932 to parents Merle and Alice Colder Bingham. After the death of his father in January, 1935, the family moved to the Colder farm in Elmira,

Michigan. Jerry would grow up there and attend Alba school through the 11th grade, and worked as a farm hand for Albert Colder, his Step-Father. At the young age of 17 years, on October 31 1949, Jerry enlisted into the United States Army in Traverse City Michigan. After his basic Military Training, he received Wheel Vehicle Mechanic training, and was assigned to duty in the Republic of South Korea. After 1 year, 22 days overseas duty, he was returned to the United States and reassigned to H&S Company, 472nd Engineer Aviation Battalion at Fort Leonard Wood, Mis-

Ortiz pleaded guilty on October 15 to possession of methamphetamine with intent to deliver, possession of fentanyl with intent to deliver and being in possession of a firearm during the course of a felony.



The Fish Lady Creating a Win-Win

East Jordan - In 2018 the city of East Jordan hired Kate Mowbray to operate and maintain the city's new wastewater treatment plant. The plant required someone with a class B certification to serve as the operator-incharge. Mowbray has a class A certification, the highest level in the state. She also holds degrees in criminal justice and occupational safety. The city felt they had found an excellent candidate for the job but she soon exceeded their expectations by combining her knowledge as a waste water operator and her environmentalist family values to use existing resources to create solutions for the plant. Mowbray has initiated a project that is reusing the old waste water plant lagoon as a walleye rearing facility.

The old wastewater treatment system was two, eleven acre lagoons. One lagoon is still used for sludge storage but the other was sitting idle. In the summer of 2018 she was on site working on aeration equipment and discovered the lagoons. "I thought I can't just let an eleven acre pond just sit here," said Mowbray. The lagoons are lined with a plastic membrane which means they continue to fill up with rain and snowmelt, but only lose water to evaporation. When they get too much water in them, water is sent through a series of slide gates and pumps back to the new wastewater plant. "Unfortunately, clean water entering plants that utilize biological treatment can cause upsets at the plant. This is one of the reasons why cities are actively searching for sources of storm water infiltration into sewers and trying to remove it. I had to find a way to add nutrients to the water to avoid the upset. That's where the fish came in, or their poop to be more specific."

DNR and got the ball rolling," she explained. After that the work began. "You can't just raise fish in any old puddle," she said. During the summer of 2019, East Jordan resident and Michigan State University student Rebecca Drenth worked with Mowbray at the plant. The pair set up a sampling plan and collected water samples weekly. Drenth tested the water for pH, dissolved oxygen, temperature, nitrogen and phosphorus levels, metals, volatile organic compounds, and PFAS. After they had collected several months of data, they sent it to the DNR for review. A site visit was conducted and once given a green light from the DNR, Mowbray presented her idea to the City Commissioners. The useless 11 acre pond could become a co-op rearing pond for the DNR. "I think raising fish is a great use for an obsolete treatment pond. This is a way to take a liability and turn it into an asset,"

said Mowbray.

As a co-op pond, the city basically is providing a safe place for the little fish to grow. "We keep eyes on the pond conditions and monitor water quality. The DNR determines how many fish they bring to the pond, when to harvest, and what lakes they get placed in at the end," said Mowbray.

In November of 2021 the first fish reared in the East Jordan lagoon were released into Intermediate Lake. The first batch of freshly hatched fish arrived in April 2021 and the plan was to net out the spring fingerlings at the end of May. "Unfortunately, the nets came up empty in May and we all thought the fish had died. The DNR wasn't ready to give up on us, so they brought us 30,000 fathead minnows to raise at the end of June. The plan was for us to raise minnows, and then they would bring us spring fingerlings to raise into fall fingerlings in 2022." she said. The minnows prospered in the lagoon. "This only confused us more as to why the minnows were thriving but the walleye died," she said. In October walleye were discovered in the pond and were netted out in No-vember. "They were really good at hiding," said Mowbray.

Intermediate Lake received 2,341 walleye from the City of East Jordan pond. "Our average length was 7.5" which should give them a much bet-

ter chance of surviving to legal size," she said.

Presently the project is in the experimental stage to see if will be feasible long term. "The fall fingerlings, which are what we ended up raising by accident, range in size from 6" to 9." We hope to have a better survival rate next year by having the minnows available to them sooner. We were very happy that we only lost 3 fish (approximately 1%) from the time of netting to the time of planting in Intermediate Lake," said Mowbray. She credited the successful transfer and low mortality rate to the volunteers that worked on the shore to weight, measure and transfer the fish faster.

The DNR is happy to use the East Jordan pond because of its proximity to Lake Charlevoix, Lake 27, Intermediate Lake and Lake Bellaire. They have wanted to stock these lakes with fall fingerlings for some time.

"Kate's dedication and experience has been a great asset for the City of East Jordan since completion of our wastewater treatment plant. Her work towards efficiency improvements and infrastructure assessment is valued for the city's sewer operations. Her leadership has won an energy savings award as well as efficiency grants for asset enhancements. While coordination of the walleye project with the DNR, proves Kate's resourcefulness will be a win-win for the city, DNR and recreational fishing," said East Jordan City Manager Tom Cannon.

Mowbray comes from a family deeply involved in stocking the lakes. Her family has been involved in raising fish for over 30 years. Her father is a founding member of and now President of the Mason County Walleye Association and her sister has joined him as a member of the board of directors. The Mason County Walleye Association is a group of volunteers who have been cooperatively raising walleye with the DNR in their rearing pond in Ludington. Charlevoix - Final touches were approved for the Junior Main Street program plan at the December 6 Charlevoix City Commission Meeting.

The Junior Main Street group was asked to return with a plan to address the gaps in their proposal to put four igloos in the downtown area for dining and socializing, an attempt to make the city more desirable during the winter months. The plan, presented by City Manager Mark Heydlauff, included 2 points. The first that it be considered a pilot or test program and the second that a date for the removal of the igloos be set. The proposed removal of igloos by Easter, could be a problem with a later than usual Easter holiday this year.

The four igloos will be located on the roof of the Harbormaster Building and partially utilize the outdoor furniture already located there. A great deal of discussion was held by the Council on the potential for the igloos to get blown away. "I think it's a good spot to try," said Council person Janet Kalbfell. "They came up with a good idea based on our feedback last time," said Mayor Kurtz. The Council passed a motion to have the pilot igloo plan removed by April 1, 2022.

The Charlevoix Airport did not endure any adversity due to the pandemic according to an annual report given by Matthew Wyman, Airport Manager. "Coming out of the 2020 year filled with so many uncertainties ended up being one of our busiest years. If

you would have told me 9 months into our year that we would have been up 35000 gallons of jet fuel sales....I would have thought that was a little bit of wishful thinking....It was a great year," he said. He described fuel shortages at other airports across the country and how Charlevoix did not suffer the same issues. "So to say we were inhibited or not inhibited, it was great for us," he said. Aircraft challenges this year not previously seen. "We've had more double blocked... sometimes aircraft will be blocked completely we have no idea they are coming...you really have to be able to think on your feet and I think our staff does a phenomenal job working with Pat," he said. One new hanger coming in the spring and discussion of another. Have seen more new people to the airport than in the past. The biggest potential challenges for 2022 could be complications due to the worldwide delivery and shipping issues. Wyman was commended for his work by the council. A Public Hearing was set

\$3 Billion in Refunds for Michigan Drivers

Michigan Catastrophic Claims Association adopts the governor's plan to lower costs for Michiganders by delivering \$400 refund checks per vehicle to driv-

LANSING, Mich. — In a move that will put money back into the pockets of Michigan drivers, Governor Gretchen Whitmer and the Michigan Department of Insurance and Financial Services (DIFS) today announced that the Michigan Catastrophic Claims Association (MCCA) has acted upon the governor's call to return surplus funds to Michigan policyholders and will immediately begin the process of refunding \$400 per vehicle to Michigan drivers. Drivers are expected to receive checks in the second quarter of 2022.

"These refunds and the recently announced statewide average rate reductions are lowering costs for every Michigan driver," said Governor Whitmer. "Michiganders have paid into the catastrophic care fund for decades, and I am

pleased that the MCCA developed this plan so quickly after unanimously approving my request to return surplus funds to the pockets of Michiganders. We are working together to put Michigan drivers first, and I am directing DIFS to ensure that the MCCA and Michigan's auto insurance companies accurately, fairly, and promptly issue these refunds.'

"The Governor and I called for these refunds because we recognize that this surplus money belongs to Michigan drivers, and we need to put it back in their pockets," said Lt. Governor Gilchrist. "These refunds are a major win for all drivers-especially Detroiterswho have paid the highest insurance rates in the nation for decades. There is still work to be done, and Governor Whitmer and I will continue to take action in the best interest of Michigan drivers."

"DIFS stood with Governor Whitmer in calling upon the MCCA to return surplus funds to Michiganders with

auto insurance, and we applaud the MCCA for taking the necessary next steps to deliver the largest refund possible to drivers while maintaining the viability of the fund," said DIFS Director Anita Fox. "In the coming months, DIFS will work to ensure that refund checks are issued to Michigan consumers as quickly as possible.'

In November, Governor Whitmer called on the MCCA to issue refund checks to consumers from its projected \$5 billion surplus, which the MCCA then voted unanimously to issue. The surplus and refunds are possible, in part, due to the historic bipartisan auto insurance reform signed into law by the Governor in 2019.

The MCCA's analysis determined that approximately \$3 billion of the surplus could be returned to policyholders while ensuring continuity of care for auto accident survivors. The refund plan submitted to DIFS Monday by the MCCA will return money to every Michigander with an auto

insurance policy in force as of 11:59 p.m. on October 31, 2021. Eligible consumers do not need to take action in order to receive a refund. The surplus funds will be turned over by the MCCA to the insurance companies operating in Michigan by March 9, 2022, and the insurers will be responsible for issuing checks to eligible policyholders. DIFS will direct insurers to issue refund checks to consumers as expeditiously as possible, but in no event later than 60 days after the transfer of funds. That deadline and additional guidance to insurers will be detailed in a bulletin to be issued by DIFS in the near future.

Additional information about the auto insurance reform law, including the uninsured driver amnesty period, which expires before January 1, 2022, can be found at Michigan.gov/AutoInsurance. Frequently asked questions, tips for shopping for insurance, and an insurance locator to help find licensed agents are also available.

Christmas tree tradition traces back to Germany

Did Martin Luther begin the tradition of decorating trees to honor Christ's birth?

Christmas trees have been around a while. They are known to have been popular in Germany as far back as the sixteenth century. Their branches, dusted with snow, shimmered in the moonlight. When he got home, he set up a little fir tree indoors so he could share this story with his children. He decorated it with candles, which he lighted in honor of Christ's birth.

In England, they became

popular after Queen Victoria's husband Albert, who came from Germany, made a tree part of the celebrations at Windsor Castle. In the United States, the earliest known mention of a Christmas tree is in the diary of a German who settled in Pennsylvania.

The tradition of Christmas trees in the U.S. can likely be traced to the German immigrants who came to Pennsylvania. Christmas trees have been sold commercially in the U.S. since 1850

ing states in the country. Michigan joins California, Oregon, Washington, Wisconsin, Pennsylvania and North Carolina as the top Christmas tree producing states. Oregon is still the leading producer of Christmas trees, typically between 7 and 8 million each year.

What is the best-selling Christmas tree? If you guessed Scotch pine, you're right. The best-selling trees are Scotch pine, followed by Douglas fir, Noble fir, Fraser fir, Virginia pine, balsam fir

and white pine.

Handel's Messiah concert next week

Northern Michigan holidays are rich with fellowship and tradition. A big part of that is the Great Lakes Chamber Orchestra's (GLCO) annual two-night run of Handel's "Messiah."

This year, the Messiah concerts will take place Thursday, Dec. 16, and Friday, Dec. 17, at 7 p.m. both nights, at Great Lakes Center for the Arts, 800 Bay Harbor Dr., Petoskey. Each event will feature pre- and post-concert receptions, featuring a cash bar, hors d'oeuvres and other light refreshments. The preconcert receptions begin at 6 p.m. each night. According to GLCO

Founder Robert Pattengale, the concerts combine two famous holiday oratorios,



which are large-scale musical works for orchestra and voices, usually a narrative on a religious theme. Unlike operas, oratorios don't contain scenery, costumes or action.

The Great Lakes Chamber Orchestra Chorus, led by Director André Strydom, will join the orchestra led by GLCO Conductor and Music Director Libor Ondras.

The concert's first portion will feature excerpts from Jo-

hann Sebastian Bach's "The Christmas Oratorio, BWV 248". The remainder of each performance includes segments from George Frideric Handel's famous "Messiah" oratorio.

"Handel's oratorios, of which there are about 26, generally involve Old Testament persons and biblical stories set to dramatic music," Pattengale explained. "Handel's 'Messiah' was written in 24 days and was first performed in Dublin (Ireland) on April 13, 1742, as a benefit concert for the Society for Relieving Prisoners, the Charitable Infirmary and the Mercer's Hospital."

Pattengale said the texts for "Messiah" are entirely from scripture and were different from the typical oratorio format in that there are no characters and the Messiah himself has no active part, nor are any of his words quoted.

Bach's "Christmas Oratorio" was penned eight years earlier, in 1734, and is divided into six parts for the Festival of Christmas. "The festival is celebrated on successive days, starting on Christmas Day and the two following days, then on New Year's Day and the Sunday after, with the sixth section on the Festival of the Epiphany," said Pattengale.

GLCO will perform three of the six segments, "Overture", "Christians Be Joyful", and "Prepare Thyself O Zion".

The Great Lakes Chamber Orchestra, located at 219 E. Lake St., Petoskey, is designated as a 501(c)3 nonprofit organization and has a 20year history of offering classical music performances in Northern Michigan communities.

\$45.6 million for Outdoor Recreation in Michigan

Governor Gretchen Whitmer and the Michigan Natural Resources Trust Fund Board recommended Wednesday to the Michigan Legislature that 117 recreation development projects and land acquisitions totaling \$45,592,200 be funded in 2022. The board this year considered a total of 136 applications seeking over \$59.1 million in funding. In a competitive process, all eligible applications were evaluated based on scoring criteria approved by the Trust Fund board.

"The Michigan Natural Resources Trust Fund continues to provide the significant investment that creates better, broader access to quality outdoor recreation opportunities for Michigan residents and visitors throughout our state," said Gov. Gretchen Whitmer. "Whether you're camping, enjoying a park close to home, exploring forest trails or just taking in a scenic view, all of these Trust Fundsupported experiences contribute mightily to local economies and our mental and physical well-being."

The Trust Fund board recommends funding to both state and local agencies for development projects and land acquisitions that will further access to public outdoor recreation.

This year, the board recommended \$22.3 million for acquisition grants and \$23.3 million for development grants. There were 18 acquisition grants awarded to local units of government for a total of \$14,249,700 while four acquisition grants went to the Michigan Department of Natural Resources for projects totaling \$8,050,000. The Trust Fund board also recommended a total of \$20,072,500 in 82 development grants be awarded to local units of government while 13 DNR projects garnered a total of \$3,220,000.

"As our state navigated a second year amid COVID-19 uncertainty, the importance of green spaces and public recreation facilities became a key focus," said DNR Director Dan Eichinger. "Time and again, Michigan residents and visitors turned to trails, parks, sports fields and other welcoming public places where they could get out of the house, soak up the sun and connect with family and friends."

The Michigan Natural Resources Trust Fund is a restricted fund that was established in 1976 to provide funding for public acquisition of lands for resource protection and outdoor recreation, as well as for public outdoor recreation development projects. It is funded through interest and earnings on funds derived from the revenues of stateowned oil, gas and minerals. Over the past 45 years, the Trust Fund has granted more than \$1.2 billion to

state and local units of government to develop and improve recreation opportunities in Michigan.

"Trust Fund grants, with the tradition of fundraising for critical match dollars, help local governments and recreation authorities acquire land and develop recreation amenities," said Trust Fund Board Chair Erin Mc-Donough. "This ranges from quaint neighborhood parks to larger, regional recreation areas and networks of multiuse trails systems."

The Trust Fund board's recommendations will go to the Michigan Legislature for review as part of the appropriations process. Upon approval, the Legislature forwards a bill to the governor for her signature. A list of the final recommendations made by the

mendations made by the Trust Fund board is available at Michigan.gov/MNRTF.

The suspect, 27-year-old Kenneth Orval Wingo Jr. from Boyne City, was arrested in the early morning hours on Monday, November 30th while hiding in the closet of their residence. He was lodged in the Charlevoix County Jail. Wingo was arraigned today in the 90th District Court in Charlevoix County on one count First Degree Criminal Sexual Conduct during a Felony, one count Domestic Violence Aggravated Second, one count Domestic Violence Third Offense, and one count Unlawful Imprisonment. His bond was set at \$250,000 cash. His next scheduled court appearance is on January 4, 2022.

Man Found Guilty of Making Terroristic Threats

A Charlevoix County jury found Jonathon Paul Stewart, 33, Atlanta guilty of making a terroristic threat and malicious use of an electronic communication device.

The trial took two days and the jury deliberated for less than an hour before rendering a verdict.

Three Charlevoix County employees testified that Stewart placed four phone calls to the Charlevoix County building on June 10, 2021, during which he berated and threatened county employees, used obscenities and vulgarities about the employees.

Stewart left a voicemail for one county employee saying, "I guarantee you're going to want to call a cop because I will be outside waiting for you after work to discuss this with you without a phone in between us."

In his final phone call of the day, Stewart told a county em-

ployee to "put a cop on the phone or I'm going to come down and start shooting," according to a witness. She testified that later in the call told her numerous times that he was going to come and shoot her.

The employees notified the security officers in the building who took the information from caller ID and were able to identify the call as coming from Stewart's address in Atlanta. A Montmorency County deputy made contact with Stewart within an hour.

"I want to thank the jurors for their time and consideration with the case," said Charlevoix County Prosecuting Attorney Allen Telgenhof, who tried the case for the prosecution.

"I also want to thank the brave women who faced the person who had terrorized them and told the jury about this harrowing experience and what they were put through. One person said she didn't know if she was going to make it home that night," Telgenhof said. "No person should ever be made to feel that way for just doing their job."

"The women promptly got information to law enforcement, they made written statements immediately while the facts were fresh in their mind and police quickly identified the person and made contact to determine whether he was on his way to Charlevoix. Everyone involved in the case did a tremendous job to avoid a greater tragedy, especially our courthouse security officers, Jim Spires and Pete Shrift."

Stewart will be sentenced at a later date by Judge Thomas G. Power who was assigned the case.

The crime of making a terroristic threat carries a maximum penalty of 20 years in prison, however, Stewart has been convicted of six prior felonies so he will be sentenced as a habitual offender with a maximum penalty of life in prison.

The malicious use of an electronic communication device conviction carries a maximum sentence of six months in jail. Stewart has been in jail since his arrest in June with his bond set at \$200,000.

House Bills 5549-5554, which are aimed at providing prompter service, better communication and greater transparency at the agency, were taken up today by the House Oversight Committee.

"One of the most common reasons people contact my office is for help with the dysfunctional unemployment agency," said Borton, of Gaylord. "This new plan is getting the ball rolling to clean up the agency and serve unemployed workers in need of benefits."

To improve communication with claimants, the plan would create an independent citizens' advocate to provide a point of contact to help jobless workers as their benefit claims move through the system. To ensure timely serv-

The plan proposes two changes to increase transparency. The agency would be required to provide publicly accessible information about the status of the unemployment trust fund. This information would be especially helpful for the businesses that pay taxes into the trust fund. Additionally, the UIA would be required to report to the citizens' advocate statistics how many unemployment cases the agency appeals and how long the cases pend. This will enable a review of the administrative appeals process to ensure cases are not needlessly delayed.

HBs 5549-5554 remain under consideration by the committee.




