Locally there are issues on the ballot for school millages in many counties. Bear Creek Township in Emmet county has a millage proposal for a Fire Station Bond.

Following are proposals in counties in our coverage

CHARLEVOIX COUNTY

LOCAL SCHOOL DISTRICT **Beaver Island Community School Operating Millage Proposal**

This proposal will allow the school district to levy its authorized operating millage rate on all property, except principal residence and other property exempted by law, required for the school district to receive its full revenue per pupil foundation allowance and restores millage lost as

a result of the reduction required by the "Headlee" amendment to the Michigan Constitution of 1963. The total operating millage levied will not exceed 15.7908 mills in any year. Shall the currently authorized millage rate limitation on the amount of taxes which may be assessed against all property, except principal residence and other property exempted by law, in Beaver Island Community School, Charlevoix County, Michigan, be renewed by 15.3905 mills (\$15.3905 on each \$1,000 of taxable valuation) for a period of 3 years, 2025, 2026 and 2027, and also be increased by 0.4003 mill (\$0.4003 on each \$1,000 of taxable valuation) for a period of 3 years, 2025, 2026 and 2027, to provide funds for operating purposes; the estimate of the revenue the school district will collect if the millage is approved and levied in 2025 is approximately \$1,675,384 (this is a renewal of millage that will

expire with the 2024 levy and a restoration of millage lost as a result of the reduction required by the "Headlee" amendment to the Michigan Constitution of 1963)?

LOCAL SCHOOL DISTRICT **Boyne Falls Public School**

Bond Proposal Shall Boyne Falls Public School, Charlevoix and Antrim Counties, Michigan borrow the sum of not to exceed Eleven Million Nine Hundred Fifty Thousand Dollars (\$11,950,000) and issue its general obligation unlimited tax bonds therefor for the purpose of: erecting, furnishing, and equipping additions to and remodeling, furnishing and refurnishing, and equipping and re-equipping the school building; and preparing, developing, improving, and

proposed bonds in 2024 is 2. 70 mills (\$2. 70 on each \$1,000 of taxable valuation) for a -0- mills net increase over the prior year's levy. The maximum number of years the bonds may be outstanding, exclusive of any refunding, is twenty-five

The estimated simple average annual millage anticipated to be required to retire this bond debt is 2.42 mills (\$2.42 on each \$1,000 of taxable valuation). The school district does not expect to borrow from the State to pay debt service on the bonds. The total amount of qualified bonds currently outstanding is \$615,000. The total amount of qualified loans currently outstanding is \$-0-.

The estimated computed millage rate may change based on changes in certain circumstances. (Pursuant to State law, expenditure of bond proceeds must be audited and the proceeds cannot be used for repair or maintenance costs, teacher, administrator or employee salaries, or other operating expenses.)

Bear Creek Township Fire Station Bond Proposal

Shall the Township of Bear Creek, County of Emmet, Michigan, borrow the principal sum of not to exceed Four Million One **Hundred Thousand Dollars** (\$4,100,000), and issue its unlimited tax general obligation bonds, in one or more series, payable in not to exceed twenty (20) years from the date of issue, to pay all or part of the cost of acquiring, constructing, furnishing and equipping a new fire station, including all site improvements, appurtenances and attachments? If approved, the estimated millage to be levied in 2024 is 0.5152 mills (\$0.52 per \$1,000 of taxable value) and the estimated simple average annual millage rate required to retire the bonds is 0.4315 mills (\$0.43 per \$1,000 of taxable value).

A Big Mess

Dear Dave,

I'm a single mom, and I opened my own small business last year. The business isn't growing at all, and my mom and dad are helping me with the bills. On top of all this, I don't receive any child support payments from my ex-husband. But my biggest concern is our home. I bought it four years ago, and when I opened my business, I did it with a home equity loan. Do you have any advice? —Tammy

Dear Tammy,

You need to close up your business, at least temporarily, and go find some money-making work. I'm sorry to be so blunt, but you've got a really big mess on your hands.

Long story short, the money you make at another full-time job is likely to decide whether you can stay in your home. If you've got a mortgage, home equity loan and business debts hanging over your head, the chances of this are slim. You probably need to consider the idea moving into a small, affordable apartment for a while, too. If you do this, get your debts paid off and your finances back in order—which includes living on a budget and saving—you might be able to buy a house again in a few years.

I know the idea of giving up your home and business is hurtful, but sometimes when you have a serious illness, extensive surgery is needed to fix the problem. And right now, you've got a very serious financial illness.

I want you to understand how I'm looking at this, Tammy. The house alone is not the problem. You borrowed money to open a business, and that was your first mistake. You also have no savings, which is another mistake, and now your business isn't making a profit. See how all of it combined adds up into one big mess?

I love your spirit, and the fact that you want to

be an entrepreneur. But you've got to get control of your money first. If you don't, this thing will eat you alive.

Dear Dave,

Our son has been married for about three years, and he and his wife are having financial problems. He wants to live on a budget and save money, while she hates the idea of budgeting, and always wants to buy expensive things. They make enough to get by, but they're not rich. How should we handle it when he asks us for advice?

Dear Stan,

If he can't get her to realize these habits are hurting them and their financial future, and if it's an issue they're going to continually butt heads over, it would be smart for them to sit down with a good marriage counselor or pastor. Something like this needs to come from a neutral and objective third-party.

Do you get what I'm saying here? The last thing he needs to do is go back to his wife spouting stuff like, "Well, my parents said..." Remember when you were first married, Stan? You didn't want your in-laws always hovering around putting in their two-cents worth, either, right?

I know you folks are concerned. It's only natural, because you love them and care about them. But if your daughter-in-law feels like her in-laws and her husband are ganging up on her, it could do way more harm than good!

Gov. Whitmer: Working Families Tax **Credit Checks Being Mailed This Week**

An average \$550 will be mailed to 700,000 Michigan households, with these larger refunds continuing in the years ahead

LANSING — Governor Gretchen Whitmer announced that eligible Michigan families will begin receiving Working Families Tax Credit supplemental checks this week as a part of \$1 billion in tax cuts. The checks will put an average of \$550 into Michiganders' pockets in more than 700,000 Michigan households.

"Last year, the majority in the Michigan Legislature and I quintupled the Working Families Tax Credit, which will put hundreds more dollars back in the pockets of 700,000 working families," said Governor Whitmer. "These checks that are starting to be mailed out this week will lift tens of thousands of people out of working poverty and directly benefit half the children in Michigan by helping their moms and dads pay the

bills, put food on the table, and buy school supplies. We got your back in Michigan as you work hard and support your family. Together, let's build a brighter future and a stronger economy."

Michigan's Working Families Tax Credit is based on the federal Earned Income Tax Credit.

To qualify, individuals must meet certain requirements and file a federal income tax return, even if no tax is owed or there is no requirement to file a return. If a federal credit is granted, the state of Michigan will provide an additional 30% credit when the taxpayer files their state income tax

For the 2022 tax year, eligible taxpayers were provided a 6% Michigan Working Families Tax Credit when they filed their state individual income tax returns.

A state law that becomes effective February 13 means those taxpayers will receive a supplemental check for the remaining 24% portion of their 2022 tax year Working Families Tax Credit.

On Tuesday, February 13, the Michigan Department of Treasury will begin issuing these checks to eligible taxpayers through the U.S. Postal Service. The checks will be sent over a 5-to-6week period.

The supplemental checks will be issued to the most recent address on file with Treasury. Treasury routinely updates taxpayer address records based on current tax

The Michigan Working Families Tax Credit for the 2023 tax year will be applied at the full 30% rate when taxpayers file their state tax returns this tax

"Michigan's Working Families Tax Credit at the 30% rate applies to the 2022 tax year and beyond," said State Treasurer Rachael Eubanks. "I encourage those who are eligible for this tax credit to explore filing electronically or connecting with a reputable tax preparer when filing a return this year. Thousands of dollars could be left on the table if these credits are not claimed."

Free Tax Help

Individuals with low income, disabilities or who are 60 years of age or older may qualify for free tax preparation help from IRS-certified volunteers. For information about free tax help, go to irs. treasury.gov/freetaxprep or dial 2-1-1.

WASHINGTON – Rep. 

City Government News for Boyne City

Commission chooses new City Attorney firm The Boyne City City Commission on Tuesday hired a law firm from Traverse City to serve as their new City Attorney. The city received four proposals in response to their request for legal services proposals. After a series of interviews, the Commission decided to hire Cummings, McClorey, Davis and Acho for the role. Commissioners cited the firm's familiarity with Boyne City and their lower hourly billing rate as some of the factors in the decision. The Plunkett Cooney law firm of Petoskey had served as the city attorney for many years but a change was needed when they notified the city they would no longer be offering municipal law services.

In other action, the City

Commission: • Approved the appointment of Skylar MacNaughton as a member of the Parks and Recreation Commission, declining to accept his resignation from the Planning Commission. 



Stanek also had six rebounds while Spate pulled down four boards and added three assists and three steals. Alger came away with three steals and Owen Hewitt two.




East Jordan railed by four, 16-12 at the end of one and each team scored 13 points in the second quarter which left the Red Devils behind, 29-25 at the half.

What is Escrow?

Escrow is a process that for a plumber, roofer or begins when the purchase offer papers are signed by both parties, and ends when the loan is approved and all the necessary requirements have been fulfilled by both the buyer and the seller.

The escrow holder is an intermediary, and an agent of both the buyer and seller.

The escrow holder is given the buyer's deposit, and holds onto all funds until the agreement is finalized. They notify the seller when the deposit has been received and if the check has cleared the bank.

The escrow holder also draws up a set of instructions, itemizing things that have to be done to the property before it is sold and the title is transferred.

For example, if the seller is required to supply a termite inspection, the escrow holder would track this obligation and make it is fulfilled before any funds are transferred to the seller. Findings in the termite inspection report must be corrected on or before the close of escrow. If the report calls


other contractor, the agent would advise the seller and get authorization for work to be done.

The escrow company is typically the title compa-

The escrow/title company provides a complete ownership history of the property and any liens on record in the preliminary title report. Anything that is out of the ordinary, such as condo liens, judgments, etc. against the buyer and the seller must be clarified prior to the close of escrow.

The escrow process can be any number of days depending on what is agreed upon between the buyer and seller. To assure a timely closing, the buyer should do things like inform, the escrow holder of the name and phone number of their insurance agent as soon as possible.

The homeowner insurance policy needs to be ordered early, so verification can be made with the lender. The lender will not fund a new loan without a homeowner policy. If there is a delay, the escrow process may be held up.


