## Boyne City faced first fire fatality in 13 years

Boyne City firefighters had their first fatality in 13 years when a six-month-old baby girl died from smoke inhalation and heat in the opening stages of a

house fire last Thursday.

Dead is Amy Turnbull,
daughter of Patricia and Mark Turnbull of 729 Wenonah St., Boyne City. She died during the night at Northern Michigan Hospital where she and her brother, Brad, 2, were taken after they were rescued by Fire Chief Nord Schroeder. Also taken to the hospital was Mark Turnbull with lacerations after diving through a window to save

The fire call was received by the city dispatcher at 10:50 a.m. and the fire crews and the police department were on the scene at 10:53. They were immediately informed there were children still in the house.

Fire Chief Nord Schroeder, the first fireman on the scene, was donning his fire protection equipment when he was informed of the two children still in the burning home.

He immediately entered the structure, along with another fireman, Captain Steve Erber, and, not knowing the layout of the house, made a wrong turn that turned out to be right as he entered the kitchen from the front door. As he was crawling in the dense smoke, he knocked something off the kitchen table and tried to find it before proceeding further. His hand brushed over the two-year-old boy who was found under the kitchen table.

Schroeder pulled the boy out of the house and the child started coughing when he was given fresh air.

Schroeder immediately went back inside the house along with Erber to search for the baby after being told she was in the middle of the living room. After searching, he found the child under the Christmas tree that was knocked over when the fire hose water sprayed on it. Schroeder pulled that child out of the house Fire Marshall and a private in-

and she, along with her brother went right into the ambulance to NMH.

The ambulance crew was met halfway by crews from Life—Link Ambulance Service and the paramedics took over trying to revive the baby.

Mark, the husband, was also taken to the hospital with lacerations on his face and chest. He and Brad were released from the hospital over the weekend.

The fire was largely confined to the back bedroom, but the smoke filled the entire house and was coming out windows and cracks in the structure when firemen arrived on the scene.

They fought the fire for four hours and started looking for clues as to how it started.

vestigator looked for clues as to Belford and Mrs. Hoover and they notified the fire department.

Because of the heat and the smoke, the family lost everything to the fire and two agencies have started collecting donations.

Donations can be directed to either the Free Methodist Church in Boyne City, or the Northwest Michigan Human Services, Petoskey. Cash donations can be made for the family at Northwestern State Bank.

Schroeder said it was sheer luck he found the children so fast. The fire was noticed by Mrs. and he-credited a recent change

in the department that requires the chief to carry his firefighting equipment with him at all times. The captain's equipment is loaded on the first truck out so the two officers can go directly to the fire instead of having to go to the fire barn first.

According to Schroeder, the community has been very lucky not to have had a fatality in a fire for the last 13 years. He said the average between fatalities is about three years. The last fire fatality was the Holley fire on Pleasant Valley Road.

## Planners discussing mini zoning areas

During a discussion about a proposed condominium project at the monthly Boyne City Planning Board meeting, City Attorney Bill McTaggart, told the board members they could have several options in order to decide the future plans for the project.

The first plan would be to do nothing, which would then cause the second would be to change the zoning to a multiple zone for the four lots, which could cause other problems with density and other factors, or the third option may be to create an amendment to the present zoning law that would allow smaller units to have a Planned Residential Development classification.

No matter which course the planners may follow, McTaggart said that each has problems.

One of the problems with changing the zoning to a smaller PRD plan would be that the change would open other parcels up to additional condominiums along the lakefront.

Most planning body members seem to think that would not be a "I don't think that it would be

a good thing," said Planner Dale Parsons, "It may open up the whole shoreline to possible developments." McTaggart agreed that it may

cause the opening of a Pandora's Box, but said that is one of the possible answers to getting approval for the proposed eight condominium project. The discussion was started

because the developer may have to install a sewer system if the project is approved by the planners. The Developer had come to the planning board meetings for the last two months seeking input on the proposal, but has not yet filed for a formal review of the site plan or asked for a

## Boyne grants industrial tax abatements to firms

City Commissioners gave the final approval to two Industrial Facilities Exemption Certificates during the noon Tuesday meeting, based on the recommendations of the Economic Development Commission and the Planning Board.

Approved for six years was the certificate for Trumco, Inc. and a twelve year certificate for Auget/Altair.

Both are building plants in the

new Air/Industrial Park area. The Commissioners also were given an idea to develop a proclamation that would start a concept of not holding city meetings on a Wednesday

evening as that would become a night for family, church or neighborhood activities that could be done with the family.

The concept was presented by Shelly Martin, the head of the Community Education Department of the Boyne City Public School System and Reverend Michael Conklin.

It is hoped that the governing bodies of the area will embrace the concept as it is felt by a great number of people that there are too many things that are drawing the family further apart. It was hoped that a concept such as this would help to bring the families back together for at least one day

While no action was taken at the meeting, it was decided that the city should look at the concept and try to comply with the

Martin said the school is also looking at the concept and will be bringing a formal resolution in front of the school board in January. She said it will take some time for all meetings to be rearranged from Wednesday nights, but she was working on the changes within the school system.

If all governmental units go along with the idea, it is hoped the idea will spread to other communities and eventually to state and national attention.



Boyne Falls will be giving out winter sports equipment next Wednesday, December 28 to those who wish to use school equipment from 4 to 7 p.m. at the school. This will give parents time to get the equipment adjusted prior to the recreational program starting at Boyne Mountain on Thursday, January 5.

The State Health Department has issued a warning on eating fish from inland lakes in Michigan. They say they have found traces of potentially toxic chemicals in some fish caught from some lakes and rivers. The chemicals most cited was mercury. They recommend pregnant women, nursing mothers, women who intend to have children and children under the age of 15 eat not more than one meal a month of rock bass, crappie, yellow perch over 9 inches in length, largemouth and smallmouth bass, walleye, northern pike or muskie. Vacationers, who only eat fish one or two weeks a year, can safely eat fish during their vacation. Others are urged to eat no more than one meal a week of these fish.

The advertising blurb presents the "an imcomparable coat as silhouette". Indeed it is.

Closer to home, K Mart ads don't feature any fur coats, but their ads plug the ungainly look in other apparel offerings. The blouses, sweaters and dresses hang on the models in carefree clumsiness. In case the floppy folds of the clothes don't emphasize enough that this, the "relaxed" style, is right for hardworking moderns, all sorts of patterns and surrealistic art work

appear on or in the fabric to make them look up-to-date. They only make the clothes and the people in them look bigger. To advance this further, the top part balloons down over the waistline not even acknowledging its presence. Instead, a stretchy band at the bottom of sweaters or blouses hits women at the widest part of the hips and clings there. "Incomparable silhouettes" here too, but K Mart wouldn't use such language.

To illustrate how little these styles differ from a more specialized line of clothes. yesterday's ad from K Mart heralding the usual assortment of duds, also showed a subdued pink pant set with only a spattering of glitter on it for decoration. A closer look at the picture of this unobtrusive outfit on a page showing equally wide but louder selections, revealed that it had "Maternity" printed across one leg. Even the advertiser felt that such must be noted to distinguish it from the others of similar proportions but not created especially for "ladies in waiting".

Perhaps women are conveying a message by wearing these big clothes. Maybe their loose fit is a metaphor for liberation or something. Of course, there's chance that women really like the droopy fashions. A "relaxed" fit after all allows them to rest on their oars, enjoy the freedom of not having to hold their stomachs in, which their mothers drummed into them from about their tenth year on. Wearing these clothes, even their mothers couldn't tell if they were tucking in their tummies or not. On second thought, probably dear old mom could but not anybody else.



rezoning the project would need in order to be approved.

The planners tabled the matter, asking that the developer work further with the neighborhood and the city to work up exactly what was going to be the

There have been meetings with neighbors, but the final agreement between them and the developer have not been finalized.

Planners also tabled a site plan review for a new hanger that is proposed to be constructed at the airport. Thomas Shaw from Cheboygan was to present the plans for a 40x35 foot hanger which will be located near the grass runway.

The planners then recommended the approval of two Industrial Facilities Exemption Certificates (IFEC) in the area of the Industrial Park.

The first will give a six year tax abatement to Trumco, Inc. who plan on building a 4,800 square foot building for the assembly of electrical components and some woodworking fabrication. The abatement will add about \$1,800 to the tax rolls instead of \$3,700 for the next six

The other IFEC was for the new Auget/Altair plant being constructed behind Carter's Food Center. That abatement would add about \$60,000 to the rolls instead of \$120,000 during the 12 years the certificate is good for.

Both abatements do not include the cost of the land the buildings are being built upon, so the actual taxes that will be coming to the city and schools will be higher.

The planning body also approved the changes that are being made in a condominium project located on South Lake The developer has Street. reduced the number of units from four to three and changed the roofline because of overhang objections from some of the
