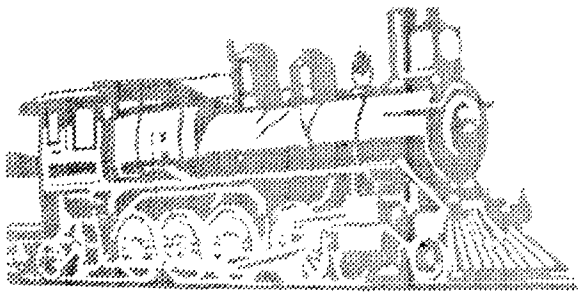


Weather

East Jordan School Board briefs - July 18 meeting

■ Superintendent of Schools Chip Hansen announced the facility review committee has been finalized, and the first meeting will be Wed., July 27, at 7 p.m. in the elementary school media center.

The purpose of the committee is to develop a building or site plan that meets the needs of the school district and community.

Each committee member was mailed a comprehensive booklet to review before the meeting. The booklet includes information on enrollment, facility usage and needs, and the financial situation of the district.

Hansen explained when the committee met two years ago, members spent five meetings going through the information included in the booklet. He believes having the information in advance will expedite the process.

■ The board conducted annual organizational activities, including the election of officers.

President will be Mary Jason; Larry Chanda will serve as vice president; Gary Ciszewski, secretary; and Herb Griffin, treasurer. All served in the same positions last year.

■ The school board awarded a bid for

re-roofing various sections of the high school and elementary school to Bloxson Roofing of Traverse City. The \$57,240 contract will provide for re-roofing of the kindergarten wing and elementary gym, as well as the high school band room and half of the auditorium roof.

"In terms of quality," said Hansen, "our roofs are in great shape." He said within two years, every section of both buildings will have a roof less than five years old.

■ The board authorized Hansen, along with office administrator Donna James and business administrator Ruby Dipzinski, to approve a bid up to \$35,000 for installation of a second Business Services Technology lab at the high school.

The new 15-station BST lab will be networked with a teacher station and the existing lab. It replaces the outdated Apple computer lab.

The Apple computers will be transferred to the middle school to augment that lab, so middle school students will no longer have to share stations during computer class.

The district goal is for students to accomplish keyboard skills before reaching high school.

EJ Schools choosing path to the future

Strategic planning, a method of affecting change through team work and resolution, rather than reaction, was the focus of the July 18 meeting of the East Jordan School Board.

Superintendent Chip Hansen explained that although schools have had to make many changes in the past five years, the changes of the future will be "the biggest ever."

Board members brainstormed a list of indicators of change affecting schools including: use of team concepts in the work place, employee involvement in planning, speed of communication, and computers and technology.

Hansen shared a video on pioneering

successful change and methods to become better at anticipating future changes.

The board then discussed specifics of strategic planning for the district, including a time table and engagement of a facilitator.

"We need an outside facilitator who can bring us new ideas and enthusiasm," said school board president Mary Jason. She recommended Dr. Jim Franco, a high school principal in the San Francisco area.

Of the many facilitators Jason and board member Laurie Hurwitz-McNeil interviewed, they found Franco best fit the needs of East Jordan.

"We wanted the plan to be our own," said Jason, "not a clone."

"He will lead us where we need to

go," agreed Hurwitz-McNeil. "I was very impressed."

An initial steering committee composed of a cross-section of community members will begin the process with Franco Nov. 10-13.

The group will develop a district mission statement, beliefs and strategic parameters, including objectives and strategies for action.

In January, an action team training session is scheduled, with an update on

the process following in March. Another meeting in May will be an exchange between action teams and the steering committee, with presentation of the full strategic plan to the school board in June, 1995.

"We've had lots of connected changes that improve our abilities to serve children," noted Hansen. "Now we're ready to tighten the connections and make change by design instead of by accident."

Jordan Valley Express: Dedicated to dancers

"I really wanted a place where families could be comfortable," said Fran Themm, who owns the massive new Jordan Valley Express. "They can come early and stay all evening."

The friendly entrepreneur, along with his wife Tina Malpass, has invested in this philosophy to produce the Express, over 28,000 square feet of entertainment center and dance hall on M-66 in East Jordan. The vaulted steel building houses a 10,000 square foot open dance floor, one of the largest in the country.

"Dancers everywhere complain about the size of the dance floors," said Malpass. "Couples and line dancers have to compete for space."

Themm, as a long time bass-player and member of country music bands, has seen the inside of many nightclubs. One of his many observations over the years was that bar owners typically do not want to sacrifice drinking space for dance space. He found this especially true for line dancers, who are there to dance all evening and reluctant to lose energy through alcohol consumption.

So Themm and Malpass planned a place specifically to attract the serious line dancers, as well as those who enjoy couple dancing, dancing to live music, and those who just enjoy watching.

And that's not all the Express offers. There are big name and up-and-coming country music acts. Already this summer, the Express hosted Becky Hobbs, Darrell and Don Ellis, Hank Law and Thunder Rose, with Gary Allen, John Conlee and Tom T. Hall still to come.

Not just country

Themm and Malpass aren't limiting themselves to country, either. Special Sunday shows are planned with jazz, blues, gospel and big band musical offerings. They will also book car and boat shows, as well as receptions and even conventions in conjunction with Boyne Resorts.

"There's room for everyone," said



Malpass.

The couple went a step further than most night spots by making the Express a non-smoking environment. Themm believes it will be required eventually anyway and adds to the family atmosphere. (A smoker himself, he steps outside when he needs to light up.)

Malpass noted that all the bands have commented on the fresh air.

"Everyone without exception said how nice it is to sing in a place with no smoke."

Parents don't have to worry about their children being exposed to the extreme behavior that often accompanies excess drinking, either. The Express

serves no alcoholic beverages other than wine coolers.

Themm said he felt the money involved in obtaining a license, bringing in a bar and supplies, insurance and damage costs were not worth it for the type of people that couldn't spend an evening without a drink. And without the alcohol, "The bathrooms stay a lot cleaner, too," he laughed.

A partnership with McDonald's

The couple didn't want to deal with food service themselves, so they opted for a contractual arrangement.

"We were fortunate to get the interest of McDonald's," said Themm. The franchise, owned by Tom Holka, offered a snack bar during Express hours only, until a few weeks ago. Now it offers drive-through service seven days a week, 17 hours every day.

Inside, McDonald's serves snacks and drinks from three locations of the huge room, offering everything from nachos and pretzels to the traditional fast-food menu. The restaurant and drive-through provide about 25 jobs to the area.

Three injuries in car-bike crash

Three people were transported to hospitals July 21, after two cars collided and one of the vehicles careened into a bicyclist. The Antrim County Sheriff Department is investigating the accident, which occurred on Rushton Road near Old State Road.

A car driven by Mary McKay, 74, of Central Lake, was turning left into a private driveway, when she struck a vehicle being driven by Robyn Brookins, 18, of Ellsworth. Brookins' vehicle then ran into a bicycle ridden by Marguerite

Themm and Malpass settled on the East Jordan area to build the Express for several reasons. The couple each maintain separate farms locally. Malpass, a native of East Jordan, has lived many places, but always came home to the area and family. When the parcel on M-66 became available, they thought it would be the ideal location.

"It's something for East Jordan," said Themm. "It brings people in from all over."

Though Themm had the dream and the experience, he didn't just rely on his own ideas for a design. The couple traveled, visiting dance halls and nightclubs, talking to dancers and country acts, to find out what "the experts" consider important.

After nearly two years of research, they began by making the location decision. Working with contractors, they developed the design, chose materials, color scheme - every detail. Themm said the building is particularly well insulated, and a constant room temperature of 73 degrees is easily maintained. Seating for 1,000 surrounds the floor on two levels.

The floor is a special achievement. The thousands of oak slats were installed over two-inch plywood, allowing flexibility and expansion that makes it beautiful to the step as well as the eye. From any point in the room, it is evident the floor is perfectly aligned. Themm credited Dan Bailey of Eastport with the extraordinary work.

The sound system, too, has drawn praise from traveling acts.

"They all are used to getting a lot less," said Malpass. "They are always surprised and really pleased when they find out what we have."

With so many superlatives, Jordan Valley Express may sound overwhelming. But the room is comfortable, even, strangely enough, intimate. Themm and Malpass are always there, circulating the room, greeting guests, and soliciting suggestions.

Finally, to make sure everyone who wants to can dance, they offer the services of instructor Lyn Ann Reid.

"She is so patient," said Themm, "and she has a real method. People that never danced are out there with the music in 45 minutes."

It seems the owners of the Express have thought of everything. Yet Themm said there is still plenty to do to make the place even better. He is hoping to attract more local customers.

"I think people just don't know what they have here," he said. "This is entertainment - it's a fun place!"

Young, 23, of Central Lake.

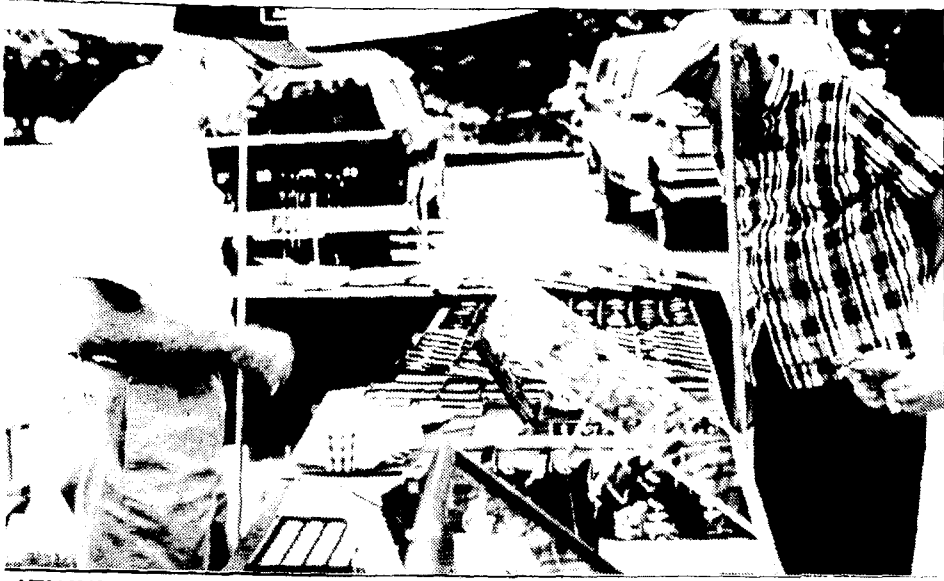

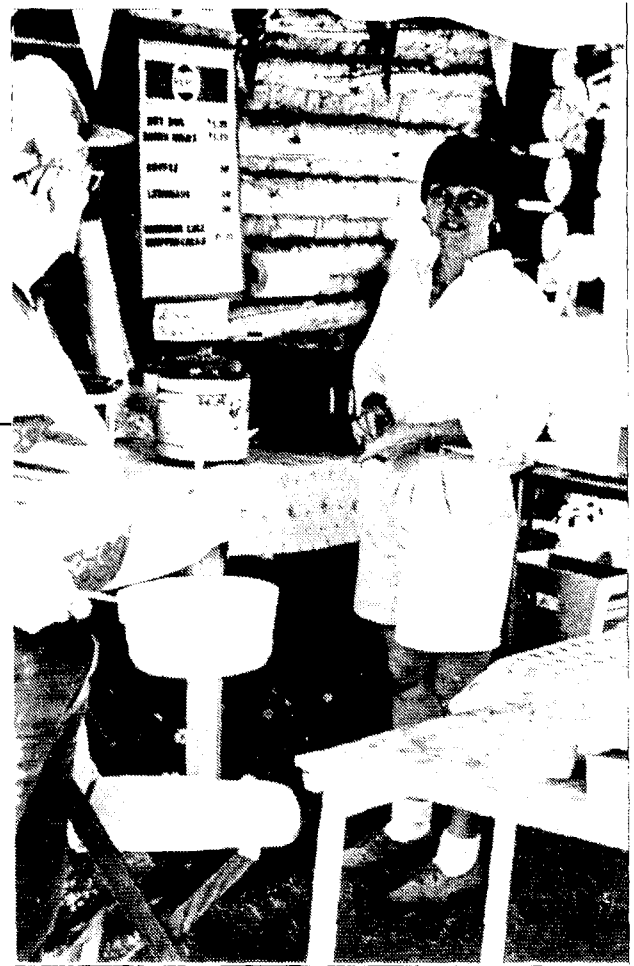

Our people are dedicated Christians sharing their lives and monies in the support of our local churches and missionaries, bringing good will and added growth to our community.

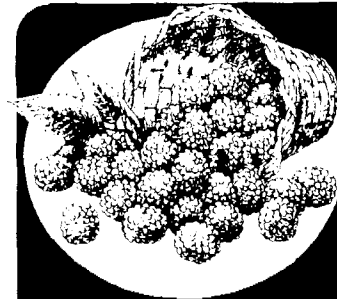
As the great summer influx of tourists continues to converge upon our communities, bringing added revenue to resorts and businesses, let us be gracious and

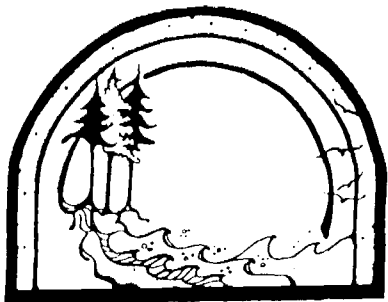

Charlevoix Hospital meeting

"This has been a momentous year in the history of Charlevoix Area Hospital. Not only is it our 75th anniversary, but we have also completed this beautiful and functional new facility," said Charlevoix Area Hospital Board Chairman Norman Perkins, at the hospital's July 19 annual meeting.

Approximately 30 people heard reports on the building program from Perkins and Richard L. Krueger, hospital president. In addition, Treasurer John

Buick reported total operating income for the hospital in fiscal year March 31, 1993 to March 31, 1994 was \$8,774,501. Wages, salaries and fees were \$4,878,566, he said.

"There was a small deficit with operating income less than operating expenses by \$27,227," Buick said, "but after contributions, interest, and other non-operating income, there remains \$536,768 available for plant and equipment needs."

Richard Krueger voiced concern about the future of small hospitals in view of proposed health care reform legislation that includes year-to-year cost controls plus cuts from the Medicare budget. "Unless there is a way to recover our costs for care and treatment, it will be difficult to survive," he said.

Rebecca Haney, Guild president, said there were 89 volunteers who assisted with various services including information desk, and patient services. "There were 200 members from Boyne City, Kewadin, East Jordan, and Charlevoix who supported the hospital

with time and dollars," she said.

Three board members were re-elected to new three-year terms on the board. Norman Perkins, Rebecca Haney and Arthur (Al) Ranger were elected by unanimous vote.


Perkins expressed gratitude to Dr. Rod Tinney for his service on the board during his tenure as chief of staff. "Rod's thoughtfulness, wise and gentle counsel was a great asset to the board and will certainly be missed," he said.



Belt your child – safety belt, that is

If you have a young child, it is acceptable to belt 'em – place them in the protective belt of a child safety seat. In reality, that is the most loving and best thing you can do to protect your child from death or serious injury. Parents worry constantly about childhood diseases and injuries from falls, as they should. However, the leading cause of death and injury for American children is traffic crashes.

Car crashes cause more deaths and injuries than any childhood disease or other type of injury, according to the American Academy of Pediatrics. Trauma from traffic crashes is also a major cause of epilepsy and paraplegia in children. This is particularly true for children under age 5.

In the four counties of Antrim, Charlevoix, Emmet, and Otsego, at least 25 children less than age 5 are injured annually in crashes. Car crashes injured 80 youngsters under age 5 in those counties from 1989 to 1991.

These deaths and injuries could have been avoided if the youngsters were given the protection of a correctly used child safety seat. During a sudden stop, swerve, or crash, all occupants of a motor vehicle need protection from impact with the car's interior.

They also need to be restrained to prevent ejection from the vehicle. If they are not restrained, infants and children are thrown around the vehicle like flying missiles. In a 30-mph crash, a child may be thrown forward with a force equal to 20 times their weight. That is like falling from a three-story building.

Young passengers are the most helpless. They are dangerously exposed to serious head injuries because they have disproportionately larger heads and softer underdeveloped bones. Remember children are not small adults; they are much more likely to be injured. In 1992 alone, the correct use of child safety seats saved 268 children under age 5, when 100 percent use could have prevented 450 deaths and 50,000 injuries.

Child safety seats can be readily purchased or obtained on loan from sheriff departments or hospitals. Placing infants or toddlers in the safety seats is simple and safe as long as you follow the instructions.

Many adults do not take the time to place youngsters in child seats especially on short trips. That is exactly when disaster could strike. Most fatal and injury crashes occur within 25 miles of home and at speeds of 40 mph or less.

The most perplexing occurrence during child seat use observations was the sight of small children riding unrestrained, many standing or jumping, while the driver and other adults in the car were snug as bugs in lap and shoulder harnesses.

Protect children's lives, make sure they are safely restrained in child safety seats from birth to four, or lap and shoulder harnesses if older. Make sure this happens every time they ride in a car, no mat-

ter who they are with.

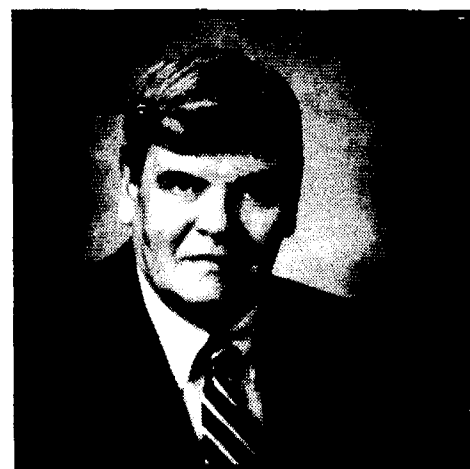

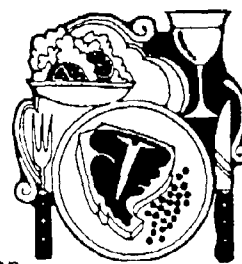

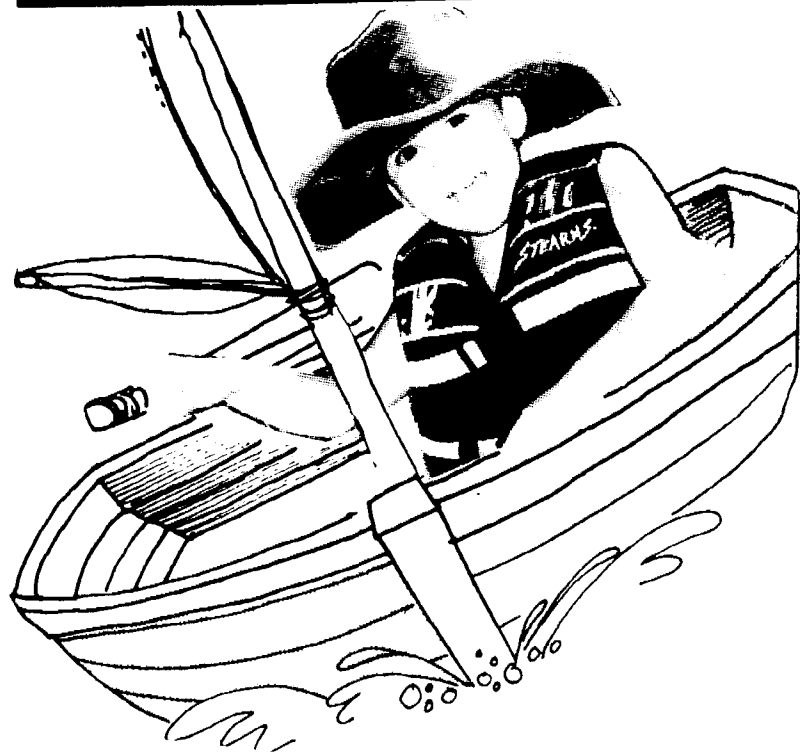

Hog farm case illustrates the importance of civilian input

The case of a Macomb County hog farmer who allegedly discharged hog manure into the Belle River, thereby killing more than 1,000 fish, exemplifies how people should report oddities to the appropriate officials, according to a recent press release from the Michigan Department of Natural Resources. The 1992 action originated from about

a dozen calls from people who noticed dead fish in the river, the DNR said.

"It is crucial when people observe something unusual in their environment, they notify the proper authorities," said Martin Hedges, DNR environmental quality analyst. Hedges was part of the team that investigated the hog manure

case.

The hog farmer recently agreed to pay more than \$15,000 in penalties and fines and change his farming practices in an agreement with the DNR and the office of Michigan Attorney General Frank Kelley.

Also in the agreement, the hog farmer owned up to no liability.

Of the dozen callers in the hog farm case, Hedges said, "Their calls enabled DNR to find out what killed the fish and take steps to prevent it from happening again."

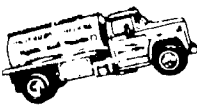

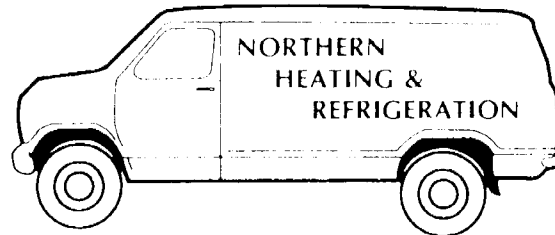

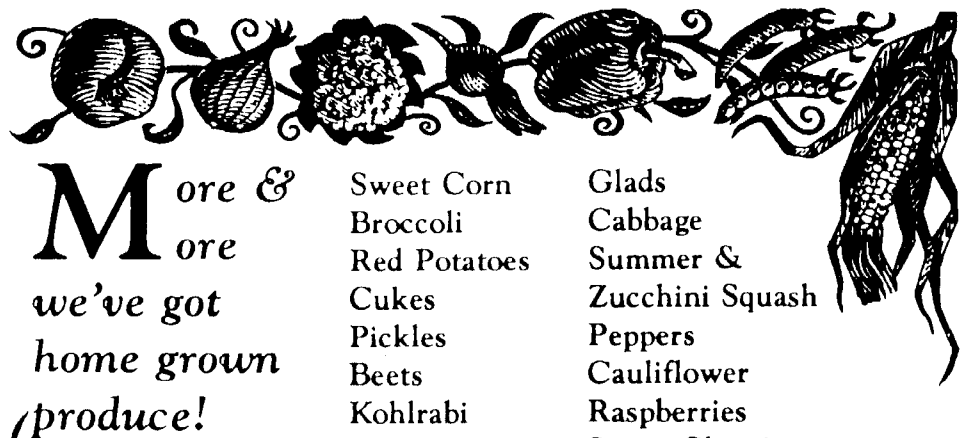

Beetles control invasive plant

As part of an effort to control purple loosestrife, a showy but invasive plant spreading through Michigan's wetlands, the Michigan Department of Natural Resources released 5,000 leaf-eating beetles at three sites: the Shiawassee River State Game Area (near St. Charles), the Crow Island State Game Area (near Saginaw) and the Nayanquing Point Wildlife Area (near Linwood).

The European beetles have been shown to be highly selective for feeding on purple loosestrife rather than other plants. The natural interaction of the leaf-eating beetles, along with other insects, effectively controls purple loosestrife outbreaks in Europe. The beetles attack the purple loosestrife by feeding on stems, flowers and leaves, which weakens the plants and allows com-

peting native plants to thrive.

Purple loosestrife is a perennial wetland plant native to Europe and Asia. It was introduced to the United States in the early 1800s and continues to spread. Purple loosestrife is easily identified during July and August by its reddish-purple flowers on a long spike. It is often seen in roadside ditches as well as wetlands.

Although the flowers are attractive to look at, what is done to wetlands is anything but pretty. Purple loosestrife plants have invaded thousands of acres of Michigan wetlands and degraded them by replacing the native cattails, bulrushes and other plants that wildlife use for food, shelter and nesting sites, and that fish use for spawning. Agricultural prob-

lems caused by the plant include blockage of drainage ditches and reduction of wetland pasture, because the plant is less palatable to livestock than native grasses and sedges.

Attempts to control purple loosestrife have included hand-pulling of plants, burning, discing, flooding and application of herbicides. Success has been very limited with these methods, which provide only a marginal level of control.

"We must continue to seek natural, biological controls," said DNR Director Roland Harmes. "The limited short-term effectiveness of herbicides, along with the related environmental concerns and expense, underscores the need to explore additional alternative methods of pest management."

File tax return extension by August 15

A taxpayer who applied for an automatic extension of time to file the 1993 federal tax Form 1040 or 1040A must file the completed return and pay any remaining tax due by midnight Aug. 15, according to IRS acting district director Charles Gilbert.

"If further time is still needed, a taxpayer may request up to an additional two months (until Oct. 15) by filing Form 2688, Application for Additional Time to File, before Aug. 15," Gilbert added. "However, the Form 2688 does not grant an automatic extension. The additional time must be approved by the IRS and if it is not, the taxpayer will generally be granted a 10-day grace period to file the completed Form 1040," he said.

information number 1-800-829-1040, Monday through Friday from 8 a.m. until 4:30 p.m.

Happy 50th Anniversary for G.I. Bill celebrated in June

The 50th Anniversary of the G.I. Bill was celebrated on June 22, 1994, by the U.S. Army and other military services. On that date in 1944, President Franklin Delano Roosevelt signed the original G.I. Bill.

"This is a very historic occasion. Over the past 50 years, education benefits have become a prime enlistment incentive," according to Lieutenant Colonel Richard E. Swisher Jr., commander of the Great Lakes Army Recruiting Bat-

alion, headquartered in Lansing.

"More than 20 million veterans have used the G.I. Bill since its inception. The present version, the Montgomery G.I. Bill is the most often cited reason for a young person joining the military. So far this fiscal year—since the first of last October—we have enlisted 2,551 soldiers from Michigan who will receive Montgomery G.I. Bill benefits.

"In addition," notes Swisher, "we have

enlisted 1,055 soldiers who qualified for the Montgomery G.I. Bill plus the Army College Fund, which offers up to \$30,000 for (an) education."

The bill is named after its congressional sponsor, Representative G.V. "Sonny" Montgomery of Mississippi, who went into effect on July 1, 1985. The bill requires a contribution by the service member of \$100 per month for the first 12 months of service and pays back

\$10,500 for a two-year enlistment or \$13,200 for three or four-year enlistments.

The Army College fund is a value-added benefit, enhancing the basic G.I. Bill for those enlisting in the U.S. Army. The Montgomery G.I. Bill plus the Army College Fund pays \$20,000 for a two-year Army enlistment, \$25,000 for three years and \$30,000 for a four-year Army enlistment.

Reduce required site plan maps from 7 to 2, allow Zoning Administrator to waive specific site plan requirement and Planning Commission to override waiver if necessary. Make optional the requirement for certain information, require designation of areas to be used for outdoor storage and display of materials. Require Zoning Administrator to deliver site plans to review agencies and reduce number of agencies and time each agency is given to review plans. 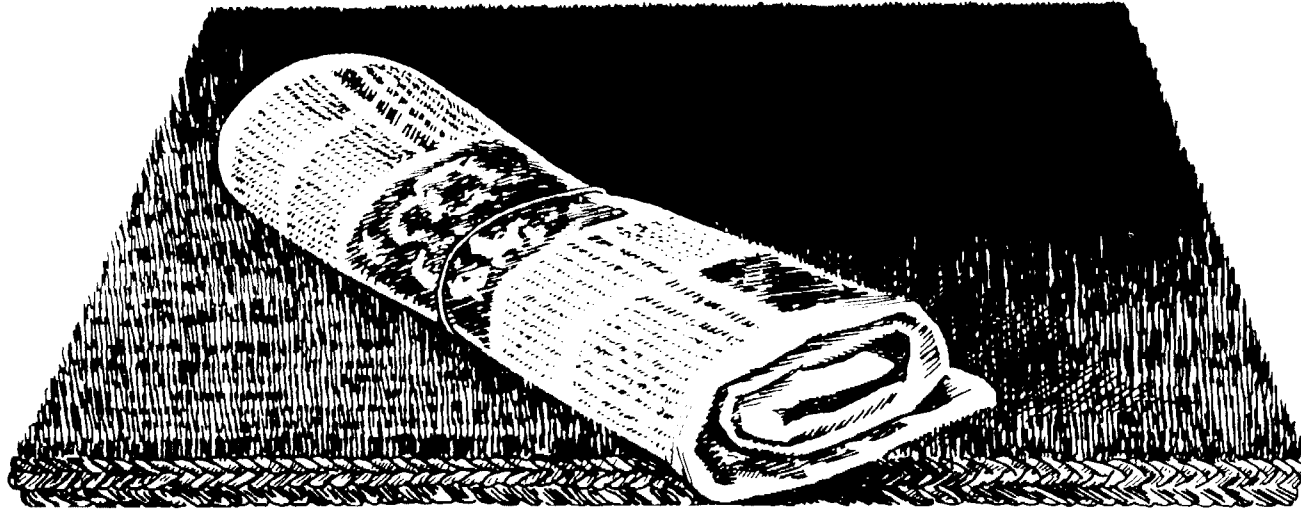

Foundation recognizes employee volunteers

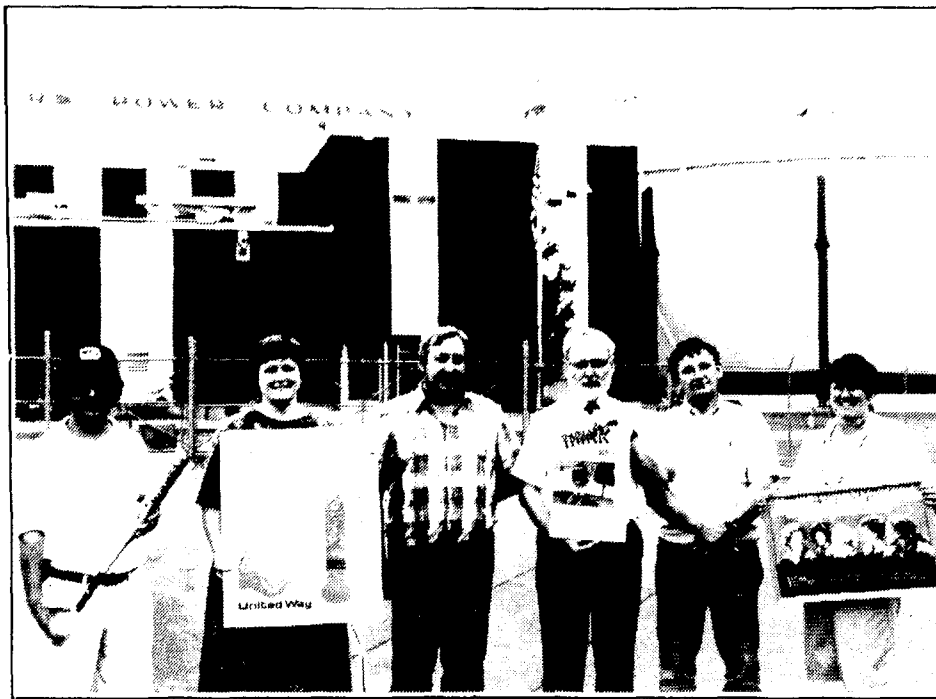
