Meeting slated to profile progress on city charter

The charter commission for the city of East Jordan will hold an informational meeting at City Hall, Tues., Sept. 27, at 7 p.m. The commission is taking the opportunity to share its progress in rewriting the city charter.

The elected commission, working since November of last year, has completed the review of a city charter draft, and is preparing it for the first submission to the Michigan Attorney General's office in October.

Public hearings for comments on the charter draft will be held in late October or November with the final submission to the attorney general early next year.

Once approved by the state, the charter goes to the city clerk with a resolution calling for a vote of the people of the city of East Jordan. The commission expects that election to take place sometime in April, 1995.

If the charter wins voter approval, it will be filed with the state and the commission will be dissolved.

The nine members of the charter commission are president Tom Sheridan, vice president Dennis Jason, secretary Connie Roberts, Dorothy Archer, Ray Fisher, Joe Hammond, Jeanette Norton, Harry Pearsall and Jack Vincent.

CROP 'harvest' will help the hungry

The East Jordan community will join in the annual effort to raise money for CROP, Sat., Oct. 1, beginning at 9 a.m. The Church World Service/Christian Rural Overseas Project uses the funds to fight hunger in the United States and abroad.

The fundraiser directly benefits local food pantries by returning 25 percent of collected pledges to be divided by the three Charlevoix County participants. East Jordan coordinator Mary Glenna Malpass said the EJ food pantry received a record \$937 from last year's CROP walk.

The Charlevoix County groups begin their treks simultaneously from Charlevoix, Boyne City and East Jordan, meeting at Ironton for a picnic finale. Walkers gather sponsors to pay a certain amount per mile walked (about six miles altogether), or accept donations. In 1993, 143 walkers collected \$11,238, for an average of almost \$79 per individual.

EJ Police Department has a new look

The East Jordan Police Department has a new look, thanks to a case of community cooperation.

The need for the change was evident to anyone who walked into the dark and crowded front office. The improved space is light and open, providing a welcoming and professional atmosphere.

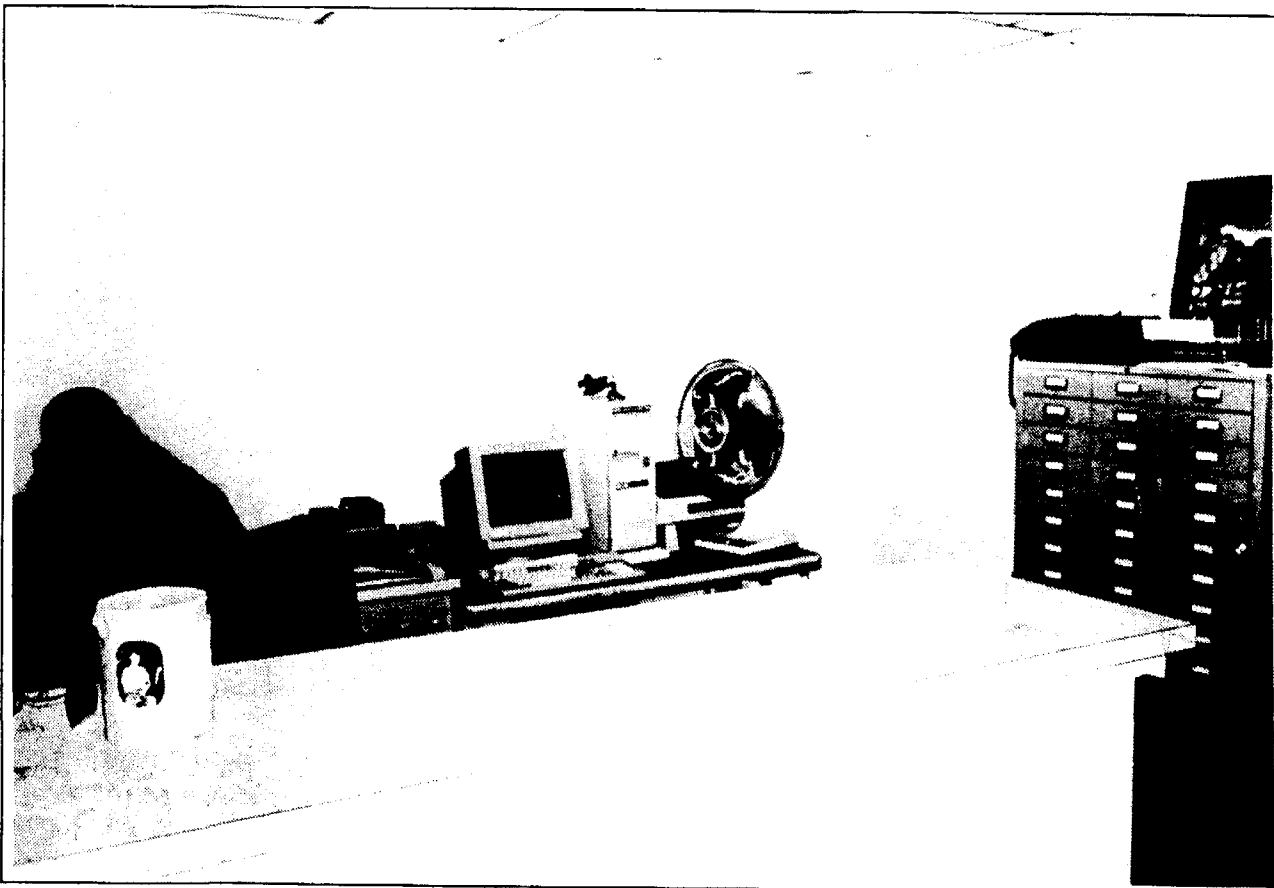
When Chief Jerry Alward joined the force last October, one of the first changes he made was to move the chief's office out of the dark cranny back in the garage to the more accessible front office. But that left the officers without a squad room of their own.

The renovation rectified that problem as well, with a comfortable and pleasant new conference/squad room that also keeps the officers available near the front of the department.

The building improvements, which began last April, are more than skin deep. A new furnace and some electrical improvements were also installed. Although those jobs required the expertise of contractors, Alward said most of the renovation work was done by officers and reserves on their own time.

"We did everything we could do ourselves to save on cost," said Alward. He noted that many area businesses contributed to the effort by either providing deep discounts or free advice.

Alward said the job is complete except for building some shelves and adding garage door openers. The chief and the rest of the department can now be proud of the face the EJPD presents to the public.

where Life & Art intersect

"The artistic energy is always flowing through her veins," said Jordan Valley artisan Jerry Aydlott of his wife Linda Beers.

His words turned out to be a metaphor of their style of conversation as well - constant creative energy flowing from speaker to speaker.

"I can't stop it," Linda admitted of her creative flow. Although she has chosen jewelry as the principal medium for expressing her talent, her abilities range from glassblowing to weaving and graphic arts. The studio she and Jerry share at their Mount Bliss home is filled with the many different materials and ideas required to bring such a variety of interests to fruition.

Her catalog is a graphic example. Lovely sketches of her jewelry designs are animated with poetry, drawings of animals, galactic bodies, flowing water - you can almost smell the incense and flowers.

Through her mother, Eva Beers, and a fortunate series of inspiring teachers, Linda discovered and began nurturing her creative instincts at an early age. By her college days at the Detroit Center of Creative Arts, she was already peddling her craft at art fairs. She did well enough with the weekend circuit to pay her tuition.

It was at one of those shows, in Milwaukee, that she met Jerry. He was apprenticing with metal sculptor Jim Millar. He could have been from anywhere attending the national show, but like her, he was living in Greater Detroit.

Such happy coincidences have guided the Aydlotts life together, and perhaps a greater force does navigate destiny, just as they believe. Certainly their most recent venture, Sacred Sparks, has fortune smiling upon them (see box).

The Aydlotts already had a brush with financial "success" a few years ago. Through the art show circuit, they began picking up wholesale accounts and by 1991, had about 120 customers across the country.

At a major east coast wholesale show, they found they had to close their booth and leave early because they had already taken more orders than they could

possibly fill within the year, even with two employees.

They discovered themselves at a tax threshold.

"The federal government, and having employees, created quite a burden," said Jerry, "both in taxes and paperwork."

When Jerry realized he was spending 3-5 hours per week just dealing with past-due accounts, he knew they had to make a business strategy decision. Seeking advice on upscaling the operation, he heard the word "manufacturing," and the mental brakes skidded on.

"We thought, wait a minute - this is art," said Jerry. The couple knew they would lose the handmade quality that makes their work special.

"We didn't want to lose the magic," agreed Linda.

So they downscaled instead, eventually letting their employees go and dropping back to the 15 customers they continue to supply. The shop is helping them to comfortably cut back art show weekends as well, to about eight per year.

During that time of exposure to the cold realities of federal and state regulations and business taxes, Jerry developed an interest in the political system that has since become a passion. Explaining his willingness to spend extensive time researching issues, Jerry said, "I'm compelled to do it."

He became a full-fledged political activist in 1992, as Libertarian candidate for the Congressional 1st District seat Bart Stupak now holds. He continues his involvement locally, keeping tabs on township, school district and environmental issues because he feels most politicians have lost sight of the interconnectedness of all aspects of the human condition.

Reaching out to others through their work and activities is the way the Aydlotts hope to inspire themselves and their fellow humans to feel and be better. Always discussing, always thinking, they aspire to keep control over their own attitudes in a challenging world, as well as helping others to also feel in control.

Linda with hearty laugh, Jerry with penetrating ideas, energetically choosing a way of life and never letting go of the magic.

A sacred spark on Mount Bliss

"I've always wanted a shop," explained Linda, relating how customers from art shows often sought the Aydlotts at their studio, wanting to browse through jewelry packaged for the road. With no good way to display the works, Linda's desire for a permanent solution grew.

Then last summer, through East Jordan carpenter Frank Hasseld (husband of artist Lori Bolt), the Aydlotts purchased an early 20th century Dutch shed for \$1.

"We went to a garage sale and bought a garage!" Linda likes to say. Hasseld and Jerry bartered time and skills, so Jerry learned enough about carpentry techniques to move and attach the shed to their studio, and remodel the inside. The work included installation of wood flooring and a charmingly eclectic combination of windows scrounged and salvaged over the years. Linda is proud that not just the windows, but most of the elements both inside and out of the shop are recycled materials.

She said her only regret was eliminating the basketball court used by son Aaron, 17, although she didn't really mind getting rid of the concrete.

"There's too much concrete in the world as it is," she remarked.

Open since the second week of August, Sacred Sparks stands conspicuously on Mount Bliss Road, both because of the bright colors it is decorated with and the non-traditional content. Linda has assembled her own work, along with that of other artists, that conveys spirituality, beauty and "conscious upliftment," in Linda's words.

While definitely not the mainstream, the shop reflects the more ancient traditionalist beliefs of the Aydlotts. Linda doesn't care for the "new age" label that their shop might be given, but she understands the desperate search that causes people to reach out toward the present new age trend. It saddens her that many non-spiritualistic people have jumped on the bandwagon to make a buck.

Customers entering the unique shop are greeted by stars scattered across the ceiling, the sun and moon, and in a position of honor befitting its beauty and strength, a cedar tree salvaged from the marsh across the road. Linda and Jerry are just delighted with their shop, seeing it as much more than an income - a place to share the things they care about; a place to share beauty and promote higher thinking; a place that attracts kindred spirits; and an opportunity to meet people.

"We've had a very good response," said Jerry. They've been surprised by the amount of customers who have come to their out-of-the-way location and are enjoying meeting neighbors and travelers.

"Jewelry with a message" is the Beers Aydlott trademark. Their shop is a place filled with messages of many kinds. Perhaps the most important messages are the ones the Aydlotts themselves convey - their love of life and hope in the future.

Playground equipment is still coming

It's coming a little later and costing a little more than expected. But playground equipment approved at the July meeting is still planned for installation this year.

"It should have been here a few weeks ago," supervisor Bob Pearsall stated. "It's been on order for more than a month."

Two pieces - a 10-foot Superwhirl manual "merry-go-round" and an 8-foot stainless steel slide - will cost an estimated \$2,600 including shipping charges.

While no limit was set on the amount to be spent, the board had hoped for something closer to the \$2,000 range. When quality became the issue, a decision was made to purchase the better product, officials said.

The township will be responsible for installation of the new equipment at Echo Township Park.

more in future, thanks to a unanimous vote raising their hourly pay from \$5 to \$6.

However, the increase will not affect the next election, since the workers were erroneously paid the new rate for 14 hours worked by each during the August primary. While conceding the raise is well-deserved, board members expressed unanimous dissatisfaction with the manner in which it was originally solicited, without formal approval of the entire board.

It was noted the election crew is composed of "excellent workers," who don't enjoy the meals or higher wages furnished by many townships in similar situations.

Also noted was the unpaid participation of clerk Shirley Folsom and treasurer Shirley Beal.

No action followed a lengthy discussion on the status of parking at Pleasant Valley Church, which adjoins township property. In spite of contact with board members prior to the meeting, church representative Doyle Willson was not in attendance, prompting the board to table the matter.

At issue: a request the township "put something in writing" documenting the church's permission to park on township property. The action was triggered by the need for the facility to "conform to conference rules" on parking established by the church's governing body, according to treasurer Shirley Beal.

Officials expressed a desire to cooperate, but noted that church traffic routinely parks on township land while the church lot remains underutilized. While reluctant to complain about the situation, the board balked at put-

ting a seal of approval on the practice by accepting it in writing.

The next meeting of the Echo Township Board will be Tues., Nov. 1, at the township hall on Six Mile Lake Road.

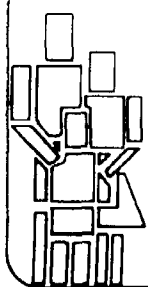

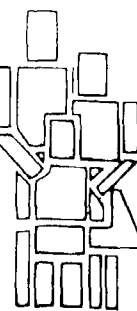

Thinking on reading and the availability of books, we must remember our libraries and the large storehouse of

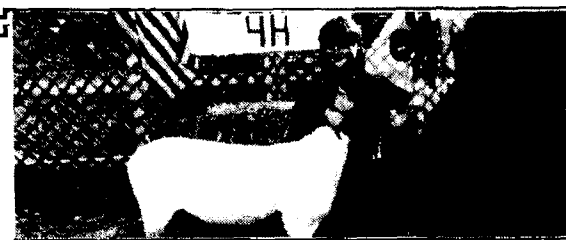
books, periodicals, talking books for the blind and videos available without charge. What a deal!

United Way campaign includes local input

The Grand Traverse Area United Way announced a goal of \$910,000 for its 1994-95 campaign today at the Sept. 15 kickoff event. This is a 5 percent increase over the actual amount raised during the 1993-94 campaign.

Funds will go directly to 23 member agencies and their 50 programs which serve people in Antrim, Grand Traverse, Kalkaska and Leelanau Counties. Local United Way agencies help people of all ages and income levels, from Girl Scouts to senior citizens.

"I think United Way is one of the most important community fund-raising efforts in this area," said attorney Mike Haley, campaign chairman. "My personal message to the community is that I do not see an option with respect to involvement. I think it's imperative that all businesses and individuals get behind this effort. The only question I see is the extent of an individual's commitment."

Each year United Way bases its annual goal on what

campaign volunteers in the four-county area say they think they can raise, said Bill Peck, executive director.

This year, each of the four counties will have its own board of directors, which will be in charge of soliciting money in the county and then deciding how it will be spent on program and services within the county.

Of the funds raised, 65 percent will be used to support services provided to county residents by United Way member agencies. The balance will be distributed in the form of annual grants to meet the special needs of each county, as determined by the county board of directors.

"Unfortunately, to those in the other three counties, Grand Traverse Area United Way has been viewed as a Traverse City effort," Haley said. "The development of these county boards helps take the message to the other three counties that whatever efforts or money

they contribute are going to be translated into more funds available, for more services, for more people in their own communities."

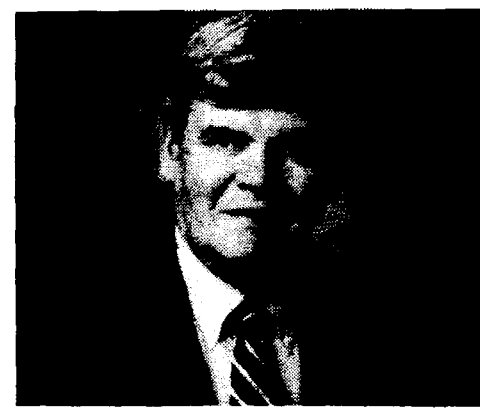

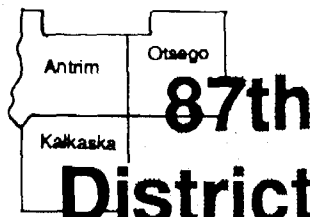

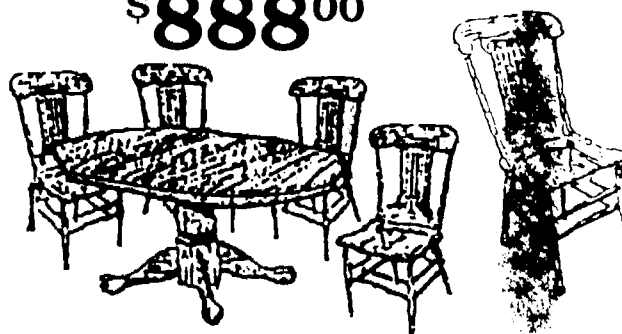

Ellsworth schools, teachers reach agreement

Ellsworth Schools ratified a new contract with both teachers and non-teaching support staff at their meeting Sept. 12.

The two-year deal provides for a 2.1 percent raise for all staff, which may be increased up to an additional 1.2 percent through a cost-of-living adjustment at the end of the school year.

"This is consistent with agreements made by other school districts in the region," said outgoing superintendent Rick Diebold, now an administrator with the Char-Em Intermediate School District.

An early retirement option will be offered to teachers for the duration of the new deal. Those who qualify will have taught for at least 25 years, and at least the last 10 years at Ellsworth Schools.

Though negotiations have been ongoing for months,

Diebold said contract talks between the school board, the teachers and the Michigan Education Association never featured the animosity that some school districts experience.

"We have had an excellent relationship," he said.

■ New superintendent signs on

The board also ratified the contract of their new school superintendent at the meeting. Patrick Bootz, currently principal at White Cloud High School, will start his new position on Sept. 26.

"He's taking a couple weeks to ensure a smooth transition for his old school," board secretary Thelma Chellis said.

The arrival of Bootz signifies the end of a more than two-month search for Rick Diebold's replacement by

the school board. The interview process further intensified recently, as the board narrowed its search down to three finalists. The board held six special meetings in two weeks before deciding on Bootz.

The new superintendent's contract calls for a base salary of \$57,000 and a \$1,000 moving bonus.

"His family has already moved to the area, and he has three children in our school system," Chellis said.

The next Ellsworth School Board meeting is scheduled for Oct. 10 at 7 p.m. in the high school media center.

Campus closed for Ellsworth seventh-graders

The Ellsworth School Board voted Sept. 12 to close the campus for seventh-graders this year.

The kids will no longer be allowed to leave school property on their lunch hour, unlike previous years. Older students will still be allowed to leave school grounds.

Next year, both seventh and eighth graders will fall under the closed-campus policy.

The board also voted to enter into an open enrollment agreement with the Char-Em Intermediate School District. The agreement, designed so the schools are following

new state education mandates, spells out the requirements for students to attend school at an institution outside of their home district.

In other action:

■ reported that their breakfast program, new this year, is gaining in popularity after a slow

start.

■ was pleased to see enrollment was up this year, with the biggest increase at the elementary

school.

ORDINANCE NO. 24

Effective Date: October 1, 1994
HAZARDOUS SPILLS EXPENSE

RECOVERY

THE VILLAGE OF CENTRAL LAKE ORDAINS that the following ordinance be enacted to read in its entirety as follows:

Section 1. INTENT

Surface waters, groundwater, soils, vegetation, and atmosphere inside the Village of Central Lake are susceptible to damage from the handling, storage, use, processing and disposal of hazardous material and the expense incurred by the taxpayer as a result of the Village of Central Lake or its Designee having to respond in an emergency to protect life, property and the environment when there has been a release of hazardous materials should be recovered from the person responsible for the emergency.

Section 2. DEFINITIONS.

As used in this Ordinance, the following terms shall have the following meanings, unless the context clearly indicates that a different meaning is intended:

A. CFR shall mean the Code of Federal Regulations.

B. Compressed gas shall mean any material regulated as a compressed gas by the United States Department of Transportation by regulations found in 49 CFR §173.300.

C. Designee shall mean the Northwestern Regional Hazardous Materials Response Team or such other public or private agency authorized in writing by the Village of Central Lake to respond to hazardous materials incidents within the Village of Central Lake.

D. Emergency action shall mean all of the activities conducted in order to prevent or mitigate injury to human health or to the environment inside the Village of Central Lake from a release or threatened release of any material into or upon the environment.

E. Explosive shall mean any material regulated as a class A or class B explosive by the United States Department of Transportation by regulations found in 49 CFR §173.53 and §173.88.

F. Flammable liquid shall mean any material regulated as a flammable liquid by the United States Department of Transportation by regulations found in 49 CFR §173.115.

G. Flammable solid shall mean any material regulated as a flammable solid by the United States Department of Transportation by regulations found in 49 CFR §173.150.

H. Hazardous material shall mean any of the following:

1) Any material listed in the list of toxic pollutants found in 40 CFR §401.15, as amended.

2) Any material designated as hazardous material by applicable state law.

3) Any compressed gas, explosive, flammable liquid, flammable solid, oxidizer, poison or radioactive material.

I. Oxidizer shall mean any material regulated as an oxidizer by the United States Department of Transportation by regulations found in 49 CFR §173.151.

J. Person shall include any individual, corporation, association, partnership, firm, trustee, or legal representative.

K. Poison shall mean any liquid or gas that is life threatening when mixed with air in small amounts, and shall also include all those materials regulated as poison class A by the United States Department of Transportation by regulations found in 49 CFR §173.326.

L. Radioactive material shall mean any material

required by the United States Department of Transportation to have type A packaging or other special protection or closed transport vehicles, under regulations found in 49 CFR §173.425.

M. Release shall mean any spilling, leaking, pumping, pouring, emitting, emptying, discharging, injection, escaping, leaching, dumping or disposing into or upon the environmental, which causes danger or harm to the public health or to the environment, including, but not limited to, the release of any material classified as hazardous material by any federal legislation or regulation, by any state legislation or regulation, or by any Village ordinance.

N. Threatened release shall mean any imminent or impending event potentially causing but not resulting in a release, but causing the Village of Central Lake to undertake an emergency action.

Section 3. NOTICE AND RESPONSE.

A. Any person who has damaged the surface waters, groundwater, soils or atmosphere by the handling or storage of hazardous materials, or who has violated any local, state or federal environmental laws with respect to hazardous materials, are required to immediately notify the Clerk or President of the Village of Central Lake.

B. The requirements of this Ordinance shall not be construed to forbid or forgive any person from using all diligence necessary to control a hazardous material release prior or subsequent to the notification to the Clerk or President of the Village of Central Lake, especially if such efforts may result in the containment of the release or the abatement of extreme hazard to the employees or the general public. Delays in reporting releases due to in-house notification of off-site owners or supervisors shall result in penalties. Nothing in this Ordinance shall be construed to exempt or release any person from any other notification or reporting required by any state or federal agency.

C. The Village, Central Lake Township Fire Chief or the Designee of either, is authorized to direct an emergency action and the clean up and abatement of any release, or threatened release within the Village of Central Lake.

Section 4. LIABILITY FOR COSTS.

A. Any person causing or contributing to the causing of a release or threatened release which results in an emergency action shall be liable to the Village of Central Lake for the recoverable costs resulting from the emergency action.

B. The following described persons shall be jointly and severally liable to the Village of Central Lake for the payment of all costs incurred by the Village of Central Lake as a result of such clean up or abatement activity:

1) Any person whose negligent or willful act or omission proximately caused such release, discharge or deposit;

2) The person who owned or had custody or control of the hazardous material or the material at the time of such release, discharge, or deposit, without regard to fault or proximate cause; and

3) The person who owned or had custody or control of the container which held such hazardous material at the time of or immediately prior to such release, discharge or deposit, without regard to fault or proximate cause.

Section 5. RECOVERY OF COSTS.

A. The Village of Central Lake or its Designee shall keep an itemized record of recoverable costs resulting from an emergency action.

B. The Village of Central Lake or its Designee shall submit a written itemized claim to the responsible person for the total costs incurred by the Village or its Designee for the emergency action and a written notice that unless the amounts are paid in full within thirty (30) days after the date of the mailing of the claim and notice, the Village will file civil action seeking recovery for the stated amount plus any amounts occasioned by such suit.

C. For the purposes of this Ordinance, costs of the Village of Central Lake or its Designee shall mean all direct and indirect costs and shall include, but are not limited to, the following:

1) Actual labor cost of personnel, including workers compensation benefits and fringe benefits;

2) Administrative overhead;

3) Costs of equipment operation;

4) Costs of materials;

5) Laboratory costs of analyzing samples taken during the emergency action;

6) Medical expenses incurred as a result of response activities;

7) Costs of any contract labor;

8) Costs to supervise or verify the adequacy of the cleanup or abatement by others; and

9) Legal expenses that may be incurred as a result of the emergency action, including actions for recoverable expenses pursuant to this Ordinance.

D. Costs recovered related to the emergency action incurred by the Village's Designee shall be transferred to the Designee as soon as possible.

Section 6. CIVIL SUIT.

The Village or Designee may bring a civil action for payment of the recoverable expenses against any and all persons liable under this Ordinance. All costs of such suit, including actual attorney fees, shall also be a recoverable cost within the same civil action.

Section 7. CONFLICT WITH STATE OR FEDERAL LAW.

Nothing in this Ordinance shall be construed to conflict with state or federal laws requiring persons causing or responsible for release or threatened releases from engaging in remediation activities or paying the cost thereof, or both.

Section 8. NONEXCLUSIVE REMEDY.

The remedies provided by this Ordinance shall be in addition to any other remedies available in equity or at law and such penalties as provided by law or ordinance.

Section 9. EFFECTIVE DATE.

This Ordinance shall become effective on the day of October ____, 1994.
