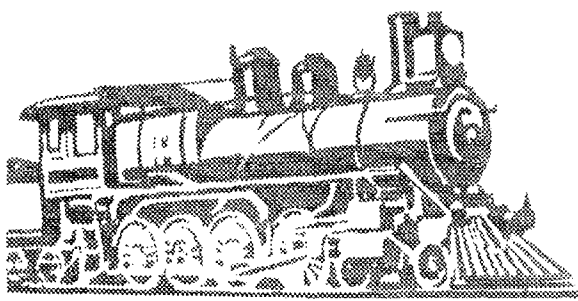


## Weather

## Drive-by shooting suspect arraigned

An East Jordan man allegedly involved in a drive-by shooting was arraigned in 90th District Court in Charlevoix, Sept. 20.

James Russell Roberts, of Roberts Road, East Jordan, faces two charges of malicious destruction of property and two firearms charges, stemming from an early morning shooting incident at the home of his estranged wife, Amy Roberts.

James Roberts is accused of shooting his wife's 1985 Plymouth Voyager, as well as the 1986 Chevrolet owned by Sanford Sweet. Both were parked in the driveway, and were unoccupied at the time of the shooting.

Officer Dan Reece of the East Jordan Police Department responded to a report by Amy Roberts that she had seen James driving near the vehicles at about 4:10 a.m., Sept. 19. Sweet reported hearing gunshots after viewing the accused near the vehicles.

James admitted the shooting to Reece and directed him to the 30.06 Remington he said he used.

Roberts, a native of the area who is employed at East Jordan Iron Works, is free on a \$2,000 bond.

Conditions of his release include making no contact with Amy Roberts in any form. The estranged

## Schools receive gift of property

East Jordan Schools became the official recipient of a gift of almost 38 acres of property at the Sept. 19 school board meeting.

The acreage, a gift from the Malpass Foundation, is adjacent to Boswell Field and the high school.

"This generous gift will help the district in long-term site planning," said superintendent Chip Hansen.

Hansen said the only buildings on the property are some trailers owned by John Russell which will have to be removed. Hansen reported the foundation has already begun researching methods of removal, but it will be up to the district to complete the process so the property is unencumbered.

The responsibility for paying for the removal is still in question, Hansen said.

### Math curriculum presentation

The board heard a presentation on the incorporation of the Chicago Math series into the middle and high school curriculum.

Math teachers Bob Panoff and Matt Inman were both enthusiastic about the program, which is being piloted this year in one class of eighth-graders and all ninth-graders.

Panoff said it is the best method he has seen in 14 years of teaching.

"Real world problems are presented in a real world way," he noted. Problems are related to sports statistics, business transactions, recipes and other subjects students generally don't associate with math.

Reading skills are strongly integrated into the series. Each new concept is introduced with common situations where the process might be needed.

"The series relates concepts to meanings, what they came from and how they relate to every day life," said Inman, who teaches the eighth-grade section.

Inman called the program student-oriented, explaining that many students will be able to proceed without much teacher assistance. Constant review and integration of the processes prevents students from forgetting what they previously learned.

The series is expensive — \$6,000 for this year's introduction. This includes texts and computer programs. Special training for teachers is also required.

Panoff said the results are compelling, with statistics showing an increase in college math success for students taught through the series. The district will introduce the series to one class per grade level initially, eventually including grades six through 12.

Board member John Kempton encouraged Panoff and Inman to "pressure your administrators," and speaking to middle school principal Shirley Bishop, "pressure your school board to get this program funded quickly."

## East Jordan man killed in accident

The Charlevoix County Sheriff Department is investigating a fatal car accident on Ellsworth Rd., approximately two miles west of East Jordan.

James Bradley Downey, 45, of East Jordan, was killed Sept. 21 when his 1992 Dodge pickup truck left the roadway and landed in a ditch. Downey was eastbound at the time of the accident, about 4:46 a.m. According to police, he was not wearing a seatbelt.

Downey was employed by the Charlevoix County Road Commission.

The sheriff department was assisted at the scene by the East Jordan Police Department, East Jordan Ambulance and a representative of the Charlevoix County medical examiner.

# East Jordan City Council approves rezoning request

For Bryan Noirot it was a long and sometimes frustrating process, but his perseverance was finally rewarded.

Noirot's prize was approval of rezoning for a 13-acre parcel from multi-family residential (R3) to central business district (C1). The East Jordan City Council took the action at the Sept. 20 meeting on a recommendation from the planning commission.

Noirot first petitioned the planning commission for the change in July. Through his family company Noirot Enterprises, Noirot plans to purchase 22 acres owned by Bill Drenth, and construct a road and bring in utilities for up to four lots for future development on a segment of the parcel. Noirot Enterprises intends to attract a hotel motel to the development.

The purchase contract between Noirot and Drenth included a contingency clause based on rezoning of the 13 acres. The property, located on the west side of M-66, adjoins the commercially zoned Glen's Market plaza.

The planning commission requested a guarantee that a hotel would be developed on the property. Noirot explained that although he had several interested developers, no one would consider a commitment until the parcel was rezoned.

On the basis of the lack of guarantee, planning denied the request, so Noirot appealed to council at the Aug. 16 meeting. On the advise of attorney Bryan Graham, council tabled the request until Sept. 6. An opinion was returned that the planning commission could not legally set conditions on a specific business before granting zoning changes.

"In zoning," city attorney Scott Beatty told council, "it's a question of appropriate use of the land." He explained if the city defined a parcel as C1, it should be appropriate to any type of business within C1 restrictions.

The council decided it did not have authority to reverse the denial, but requested the planning commission take note of the error if Noirot should apply again for rezoning. At the same time, several council members encouraged Noirot to pursue the issue.

At a Sept. 9 meeting, planning heard Noirot's application again and this time recommended the rezoning to council.

Council quickly dispatched the amendment to the zoning ordinance.

"We've discussed this to death," said council member Greg Chappuies, as he moved to approve the change. In a roll call vote, all members except Guy Vallance voted yes (Sherry Sineway was absent). Vallance opposed the change on behalf of some adjoining homeowners who wanted the parcel to remain residential.

Noirot was very happy with the decision and plans to expedite the land purchase agreement with Drenth. He said Noirot Enterprises hopes to begin construction yet this fall.

Noirot also thinks Hospitality Franchise Systems (franchisers of Days Inn, Park Inn, Super 8 Motel, Howard Johnson and Ramada) may still be interested. Meanwhile, his future plans are no longer on hold.

"I'm just glad to get on with my life," he remarked.

### Additional zoning change approved

The city council approved a second rezoning request at the Sept. 20 meeting - that of Larry MacEchem.

MacEchem asked that a six-acre C2 (heavy commercial) parcel at the south end of Fourth Street be changed to industrial (I). He plans to build a machine shop on about one-half acre of the parcel.

Because the lot is contiguous to other industrial zoning, council consensus was the change would not be disruptive to other property owners. The rezoning was recommended by the planning commission.

Council member Greg Chappuies noted that he did not object to this particular case, but is wary in general of introducing more industrial zoning within city limits.

Council members unanimously supported the change.

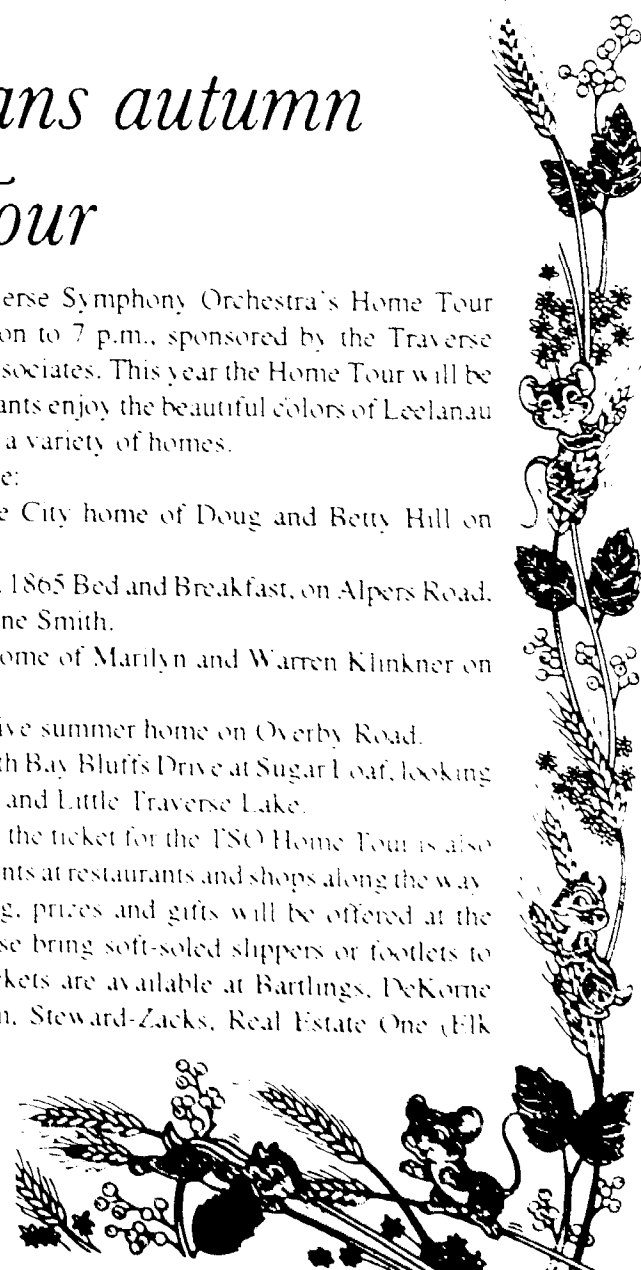
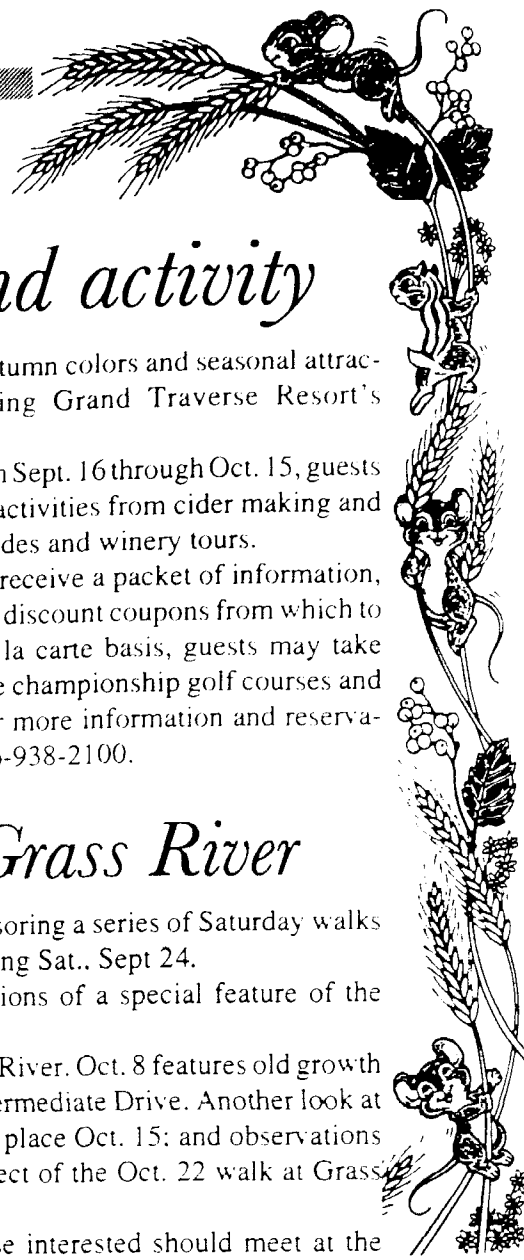

# Area men arrested on felony forgery charges

Two men may have tried the same stunt once too often at area banks, resulting in their arrests Sept. 22 on felony forged check charges.

"Basically, they went to a bank and presented a check that was not legitimate, and they tried to cash the check," said Chief Assistant Antrim County Prosecutor Mark Fett.

Jeremiah Fuller, 17, of Boyne City and Jeremy

Grutsch, 18, of East Jordan were at the Mancelona branch of FMB Northwestern Bank about 10 a.m. allegedly attempting to cash the check when an alert bank employee recognized the checks as being from a closed bank account.

The employee called the Mancelona Police Department, and Officer Rod Vesey made the arrests. Also arrested was Adam Jones, 18, of East Jordan, on charges of resisting an officer (a misdemeanor).

Several forged checks from the same account were cashed at other FMB branch offices and a warning

bulletin had gone out, said Police Chief Jeffrey Helmboldt.

"The subject (who had the account) had passed away. The signature was a forgery," he stated. Bond of \$3,000 personal recognizance was set on each of the three men, who are scheduled for arraignment in 87th District Court in Antrim County on Oct. 4 at 10 a.m. Fuller and Grutsch were arrested on charges of "uttering and publishing" the forged checks, a 14-year felony.

# Foundation youth group preparing new grants

Teens who make up the Youth Advisory Committee for the Charlevoix County Community Foundation are becoming experienced grantmakers. In June, the group handed out more than \$7,000 to various charitable organizations - and now, the high school students are ready to fund additional projects that help Charlevoix County kids.

The Foundation's youth committee is inviting interested organizations to submit grant requests through Oct. 31, 1994. Applicants should be nonprofit groups, educational institutions, or municipalities that serve children and teens in Charlevoix County. Applications are available at the Community Foundation office in the Walker Building in East Jordan, or by calling 536-2440.

Special consideration will be given to proposals that address high-priority teen concerns: drunk driving, lack of recreational activities, alcohol and drug abuse, child abuse, juvenile crime, teen pregnancy, and the environment. Other programming areas eligible for funding include health, social services, the arts and culture, community development, education, and civic affairs. Projects chosen for funding earlier this year included Charlevoix County LOVE for Children, the Raven Hill Discovery Center, and the Castle Farm project.




Money for the youth grants comes from a special

Community Foundation endowment called the Charlevoix County Youth Fund. Now at \$303,000, the youth fund is fed by a challenge grant from the W.K. Kellogg Foundation, which matches local donations 50 cents to every dollar. Over the next three years, the Community Foundation may receive up to \$700,000 in additional Kellogg youth fund money by raising \$1.4 million in local contributions.

The youth fund is set up as a permanent endowment earmarked for children and young adults, and only the interest income is used for grantmaking. Decisions about grants are made by members of the Foundation's Youth Advisory Committee - students who represent each of the six high schools in Charlevoix County. The committee meets monthly during the school year to discuss common concerns, develop community leadership skills, and seek solutions to community issues.

Making the future better for this area's young people is a big part of the Charlevoix County Community Foundation's mission. Started in 1992 by a group of civic leaders, the Community Foundation receives charitable donations, manages them in a permanent endowment, and re-distributes the income in the form of grants and scholarships to meet a variety of local needs. In the past year, the Foundation's assets have grown from \$200,000 to more than \$1.3 million.





**Grand Traverse Area United Way Questions and Answers with Bill Peck, Executive Director**

**Q: There is concern that local contributions will go to national United Way administrators. Do all donations stay local?**

**A:** Yes. Our United Way board passed a policy last year that 100% of campaign funds must stay in the area. We do pay United Way of America yearly dues. That amounts to 0.6 percent of annual contributions, or \$4,600 in 1993. The money to cover this annual fee comes from the proceeds of our raffle. It is also important to note

that in 1993, over \$110,000 in goods and services was returned to the area due to the affiliation with United Way of America.

**Q: How do you decide how much money a specific agency will get?**

**A:** Each year we ask our member agencies to outline the specific program for which the money will be spent.

Our focus is to fund programs that the community says are top priorities: funds for emergency living, food, shelter, clothing; and funds to prevent family violence. Substance abuse prevention and treatment is another priority. Child

care is also at the top of our list.

**Q: Out of each dollar donated to United Way, 18 cents goes toward campaign and administrative expenses. Why not just give money directly to your favorite organization?**

**A:** There are a couple of reasons. First, United Way runs one big campaign each year so that all 23 agencies which receive United Way funding don't have to run their own campaign. It would be expensive and people here would get tired of the onslaught of requests.

Second, these agencies get funded for specific programs so you know that your money will be used for that program and not for administrative costs.

If you want to give to a favorite organization, you can write in that agency on the pledge card.

**Q: What is the Pacesetter Campaign?**

**A:** A total of 37 area companies start their drive earlier than the formal starting point of Sept. 15 and end earlier to give us a chance to see how the annual campaign will go.

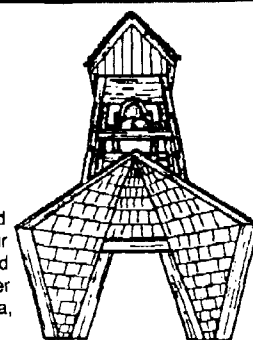

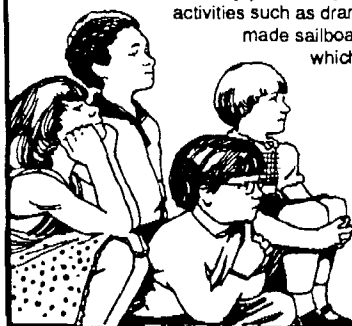

## Michigan's hidden craters prove ancient meteorite strikes

Two enormous craters, blasted out millions of years ago by meteorites from space, were recently found beneath southern Michigan, according to University of Michigan astronomer Richard Teske.

"The larger of the two craters was discovered in 1990 by four scientists from the Geological Survey of Canada," Teske said.

While studying magnetic and gravity maps of the area, the scientists discovered the crater more than a mile underneath the bed of Lake Huron - just north of Port Huron.

"While divers visiting the lake bottom will see no sign of its presence, its 30-mile size and 500-million-year age make it one of Earth's largest and old-

est impact scars," Teske said.

The second Michigan crater was found in Cass County in 1987 by Randall Milstein of the Michigan Geological Survey. He was examining information from about 100 test wells drilled in the area.

"This crater lies just south of a small village named Calvin Center and is buried about 100 to 400 feet beneath the surface. Now covered with farms and forests, it is five miles across and 440 million years old, and was excavated by an object about the size of a football stadium," Teske said.

Finding these buried Michigan craters has helped to teach two exciting lessons.

"First, recent technical developments of the kind

used by the discoverers make it possible to recognize the presence of buried craters.

"Second, study of the buried craters can let us look further back into the past record of how the Earth has been hit by large pieces of space debris," Teske explained.

Only large chunks of rocky material survive the plunge through our atmosphere to reach the ground. "It's good news for us that the bigger they are, the fewer there are in space; giant impacts are rare," according to Teske.

"Although one fist-sized object falls to Earth somewhere every two hours or so, chances of getting bopped by anything are very small," Teske said. "Only one person - Mrs. Annie Hodges of Sylacauga,

Ala. - is on record as being hit by a stone from the sky. Mrs. Hodges was napping on her living room couch in November 1954, when an eight-pound stony meteorite crashed through her roof and then through the bedroom floor beneath - finally bouncing off a radio before badly bruising her arm and leg."

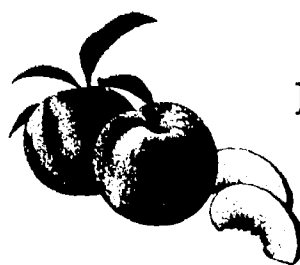

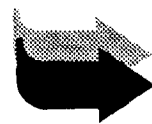

# Long, cold winters aren't only cause of plant damage

Residents of the upper Great Lakes Region are used to weathering long, cold winters, but plants often don't do so well.

When the last of the snow finally melts, it usually reveals some dead or permanently damaged trees, bushes and perennials.

Many believe midwinter sub-zero cold snaps are to blame, but a Northern Michigan University biology professor says that's not entirely correct.

Dr. Maynard Bowers, an internationally acclaimed botanist, has found that, although deep freezes do affect plants, some of the worst damage occurs in the fall and during midwinter thaws — and is not apparent until spring.

In Bowers' new textbook, *Plant-Environment Interactions*, he pointed out that sudden drops in temperature — even if frost does not occur — can cause damage, because plants must gradually acclimate to cold in order to survive harsh winter temperatures.

When the temperature does drop below freezing, water inside plant cells forms ice crystals and damages the plant, Bowers noted. This can result in stunted growth, low yield, and plant death. If plants

are able to adjust to the cold gradually, the amount of water in their cells is reduced in order to minimize ice damage.

North country residents think of midwinter thaws as welcome respite from the cold, but plants actually suffer from those rare above-freezing days in February. Early thaws "fool" plants into functioning as though the weather would continue to warm, Bowers said. In a sense, they let down their defenses against cold temperatures.

Each repeating cycle of freeze/thaw increases damage to plant tissue. Heavy "winter" damage can hap-

pen even after a mild fall and warmer-than-average winter.

How much temperature changes injure plants depends on how low, how fast, and for how long the temperature drops, according to Bowers.

To combat fall damage to plants, Bowers recommends covering plants early. "This slows down the rate at which they freeze," he said.

If frost occurs, one way to save your plants is watering just before the sun comes up. "It's not an old wives' tale," said Bowers. "It works."

# Watch for slow-moving farm equipment

As farmers begin rolling into the late summer - early fall harvest season, it's important for motorists driving in rural areas to be aware of the hazards of slow-moving farm equipment.

"The motoring public doesn't always realize that the farm implements they encounter on roads are moving so slowly," said Ron Nelson, legislative counsel for Michigan Farm Bureau. "In addition, the cool, drizzly evenings this time of

year can lead to poor visibility. Motorists and farmers should take special precautions."

Nelson suggests that motorists very cautiously approach farm equipment traveling on roads and be aware that some implements are extra wide. "Farmers can do their part by ensuring that their equipment has adequate lighting and displays Slow Moving Vehicle (SMV) signs. State law requires that a red light be displayed on the rear

of implements of husbandry, although this requirement can be met by a vehicle that is trailing the implement. Optional, flashing yellow lights are also helpful," Nelson said.

Tractors and other equipment sometimes track slippery mud from fields onto roadways. Several county Farm Bureaus have cooperated with county road commissions to minimize the hazard to motorists, according to Nelson.

# Waterfowl hunting seasons approved for 1994-1995

DNR wildlife biologists expect this year's continental fall flight of ducks to be up 20 percent from last year. Local duck production is estimated to be greater than last year, as well.

Biologists attribute the improvement in this year's predicted fall duck flight first to high numbers of ponds in U.S. prairie regions, created by abundant summer rains in 1993. The second factor is the 5-6 million acres of idle grasslands created under the U.S. Department of Agriculture's Conservation Reserve Program, where duck nest success rates have doubled in the past year.

This year, DNR Director Roland Harnes has selected a 40-day season with separate dates for each of the state's three duck zones. The regular duck seasons will be as

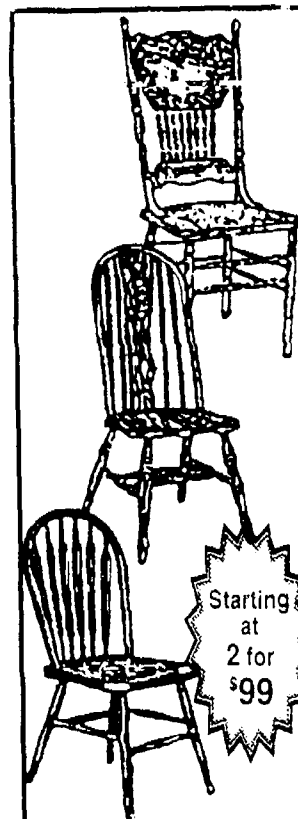
follows: Northern Lower Peninsula (Middle Zone), Oct. 1-Nov. 6 and Nov. 11-13; Southern Lower Peninsula (South Zone), Oct. 8 - Nov. 13 and Nov. 25-27.

The canvasback is included in the daily bag limit season this year for the first time since 1985. The separate daily bag limit for mergansers is again set at five, no more than one of which may be a hooded merganser.

Local giant Canada geese are at record high levels, however, and will make up over 50 percent of the total statewide Canada goose harvest.

Canada goose season dates and bag limits are: Northern Lower Peninsula (Middle Zone), Oct. 1-Oct. 23 (23 days, with a two-bird daily bag limit); Southern Lower Peninsula (South Zone), Oct. 8-Nov. 6 (30 days).

For all waterfowl hunting, shooting hours begin one half-hour before sunrise and end at sunset, as listed in the state *Waterfowl Hunting Guide*. The guide is expected to be available at all licensed dealers and DNR offices by Sept. 10.

# State snowmobile trail permit to provide additional funding

Beginning Oct. 1, anyone operating a snowmobile on public property in Michigan will be required to purchase a snowmobile trail permit in addition to having a valid snowmobile registration.

The new requirement is the result of an amendment to Michigan's Snowmobile Law, which provides a means to generate additional funding on a user-pay basis for the upkeep of the state's snowmobile trail system.

"The permit, which costs \$10 and is valid for one year, will help raise approximately \$2.5 million for the preservation of Michigan's premier public trail system," Department of Natural Resources Director Roland Harnes said. "These additional dollars are critical to maintaining safe, enjoyable recreational opportunities for snowmobile enthusiasts and others who use these trails."

The Michigan snowmobile registration fee will continue at its three-year, \$15 rate. This fee has remained the same since 1978.

Five dollars from each snowmobile registration fee collected is currently deposited in the state's Recreational Snowmobile Trail Improvement Fund (Fund). The amendment, (P.A. 99 of 1994), requires that \$9 of the new \$10 snowmobile trail permit fee be credited to the fund, with 50 cents retained by the DNR for administrative costs and 50 cents retained by the agent selling the permit.

The monies will be used by the DNR for the



purposes of planning, construction, maintenance and acquisition of snowmobile trails and areas, and basic snowmobile facilities.

"The additional revenue from these new trail permits will allow snowmobile grant sponsors to increase the grooming of these trails by 50 percent or more," Bill Manson, chairman of the Snowmobile Advisory Committee said. "It will also allow the future of Michi-

gan snowmobiling to continue and expand."

Permits were available beginning Sept. 1 and will be required for anyone operating a snowmobile in Michigan except when the snowmobile is: being operated exclusively on lands owned or under the control of the snowmobile owner; being used entirely in a safety education and training program conducted by a certified snowmobile safety instructor; or exclusively

operated in a special event of limited duration.

Persons whose snowmobile registration expires this year can purchase a snowmobile trail permit when renewing at any Secretary of State branch office or when renewing by mail.

Chapter VII (R-1 Residential) Allow churches, schools and certain publicly owned facilities including parks as Special Uses and delete setback requirement for these special uses.

Chapter VIII (R-2 Residential) Add core living area (20'x20') in section 8.03 B.

Chapter X (Village Zone) Delete 10.02 A 3 a. and replace with new language that requires a minimum 960 square feet for a duplex with each dwelling containing a minimum of 480 square feet with a core living area of 20'x20'.

Chapter XVII (Special Uses) Currently refers to a "Fee Ordinance which is attached." Change to read "Fee Schedule".

Next? TC St. Francis, fresh off a shutout loss, which should make them even ornerier than usual.

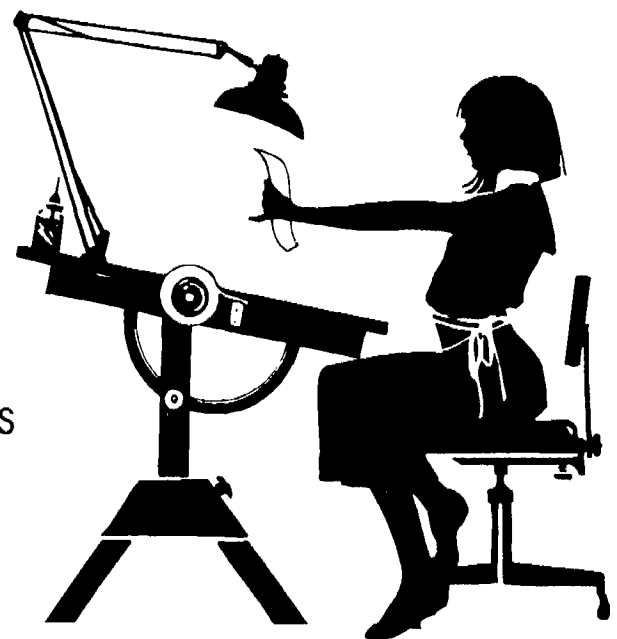
"I'm looking forward to the game," said coach Alar Peterson. "I'm pretty sure we can play ball with them."

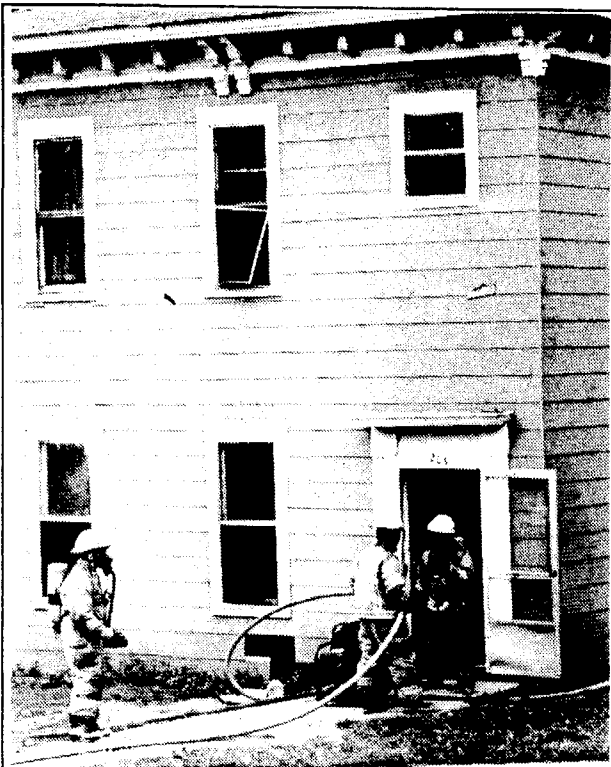

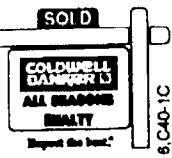
A preliminary hearing in district court to determine if a felony has been committed is scheduled for Thurs., Sept. 29.

## Fuelwood permits will be discontinued

Permits for fuelwood from state forest land will be discontinued once again for the period of Oct. 1, 1994, through March 31, 1995, the Department of Natural Resources announced.

Permits issued through Sept. 30 will be valid for 90 days after the issuance date and will entitle permittees to gather up to five standard cords of wood for a \$20 permit fee. Issuance depends upon the availability of wood suitable for fuelwood purposes. All fuelwood collected must be for personal use, be from downed or designated trees only, and is not to be resold or traded.

Individuals who would like to obtain a fuelwood permit prior to Oct. 1 should contact their local DNR Area Forest Manager regarding availability. Permits are issued for designated locations in which permittees must exercise care not to trespass on private property and must protect surrounding live trees from injury.

Permit issuance will resume on April 1, 1995, and continue through Sept. 30, 1995.
