## Domestic violence: not just a "women's" issue

Until 1978, there were no laws in the state of Michigan that prevented a man from beating his wife or partner. Michigan was only the third state in the union to enact such laws.

Women as property had a long history to overcome — the "rule of thumb," a modern cliché, was born of the old English law that said a man could beat his wife with a rod no larger than the width of his thumb.

Recent additions to the 1978 law have now made it a crime against the state to abuse a spouse. This means police are obligated to arrest anyone in violation — it also means a woman does not have to press charges for her spouse to be arrested for abuse. With these changes, Michigan has one of the strongest domestic laws in the country.

Yet, domestic violence continues to threaten many women in this corner of northern Michigan, according to the statistics.

"We can't minimize the effects of domestic violence," said Jan Mancinelli of the Women's Resource Center. "More women are killed at the hand of a partner or husband, than in any other act of violence."

Mancinelli shared this sobering information with the United Methodist Women of East Jordan at a recent luncheon. She pointed out that everyone probably knows someone in a domestic violence situation, perhaps without realizing it.

"It happens in every social and economic group," she added.

### Serving a community need

The resource center serves the on-going and crises needs of women and children throughout northern lower Michigan, and is especially designed to reach women in Antrim, Charlevoix, Cheboygan, Emmet, and Otsego counties. Although the center offers shelter, it has a variety of programs helping women who are struggling to free themselves from domestic violence.

But the shackles of violence are usually difficult to break. A woman who is abused often feels alone and at fault, so is easy prey to the intentional actions of the abuser seeking to gain power and control over her. If she grew up in an abusive home, she may not even realize it's wrong to be beaten.

Mancinelli said the woman is most at risk of death when she leaves the abuser.

"The risk increases because she is taking control of the situation," she explained.

The center offers support groups for such women, as well as shelter. Mancinelli said the discussion groups are key to helping the victim change — she must learn, and believe, that no one deserves to be beaten.

The resource center deals with many other "women's" issues, including counseling for rape, sexual assault, and sexual harassment victims; assistance for displaced homemakers, substance abusers, and single parents; and help in arranging tuition assistance, job placement, and day care.

But the shelter is the most utilized service — in the 15 years of its existence, over 3,000 women and their families have come to the shelter for safety. Many are in crisis, or even in danger, and may have no where else to go. Some of the women find it necessary to come to the shelter more than once.

"The repeat rate is about 10 percent annually. We've discovered that statistically it takes four to five attempts at leaving before the woman permanently leaves her abuser,"

said Mancinelli. "We provide counseling, referrals, and do all kinds of things to help her decide, but we can only offer choices — we are not there to judge a woman, and we can't make her leave her abuser."

The Women's Resource Center is funded through state and federal grants, United Way and other civic organizations, and through fees and contracts (day care and counseling is provided on sliding scale charges, according to income.) Other financing comes from the center's Gold Mine second-hand resale shop, which also provides clothing and other needs on a regular basis to fleeing families, needy children, and fire victims.

The center is supported by about 40 employees, 30 to 40 volunteers, and many organizations such as the United Methodist Women, who provide clothing, toys and games, bedding and linens, food, toiletries and monetary donations.

But with 10 programs, operating from six sites including the shelter, and serving such a large community, more help is always appreciated.

"Such gifts help us save our dollars for other work," said Mancinelli. "It also involves the community, and helps them understand what's going on."

The resource center also offers prevention programs through schools, leading discussions on relationships, power and control — teaching that when one partner is controlling the other, it is a sign of an unhealthy relationship.

## Sax says ...

Parker Seiler is a native of East Jordan. He spent most of his early life attending school, church, Sunday school, and working on his parents' Big Jug Dairy Farm on Boyne Road, at that time just inside the city limits. When World War II began, he enlisted in the Navy.

Seiler, 69, joined me at Houghton Lake in 1960 and taught at Collins and Prudenville Elementary Schools off and on. He not only made an indelible imprint on the youngsters he was teaching, but on the community as well.

It did not take Seiler long to get in the swing of things here at Tip-Up-Town, USA, by now the nation's largest and best known winter extravaganza.

It took the energetic Seiler two short years to become mayor of Tip-Up-Town in 1962.

His snow sculpting activity began in his home town about 1957. His 16 by 24-foot swan appeared in *Life Magazine* that year. East Jordan was known as the "Swan City" at the time, and his creation received nationwide publicity.

Parker didn't limit his snow sculpting to Michigan, where he worked at the Boyne

Mountain ski resort. His artistic sculptures have appeared in no less than 18 states, including nine years at the St. Paul, Minn., Winter Carnival, where he primarily constructed ice palaces. One of his creations there, "Clown in a Car", was part of a display promoting the carnival, which appeared in *World Book Encyclopedia*, from 1965 to 1985.

For three winters, Seiler plied his art at Wildcat Mountain, a ski resort in New Hampshire. Two other winters he spent at Winter Park, Colo., near Denver, in connection with a project by the University of Colorado.

Seiler has taught in elementary schools in East Jordan, Shepherd, Alba, Marne, Kalkaska, Houghton Lake and Lansing. He and his wife Darlene have three daughters and four grandchildren.

He retired recently, 13 years after I did, and might be back on the bum again if it were not for his charming wife (who incidentally was introduced to him by my late wife, Rea Rac.)

## Medusa reaches agreement

Charlevoix-based Medusa Cement Company has entered into an agreement with the Department of Natural Resources that addresses surface water violations of the Michigan Water Resources Commission Act (Act) at its facility.

Medusa agreed to a \$50,000 settlement package, including a penalty and environmental project at the Charlevoix quarry. A corrective program to improve wastewater treatment and reimbursement of department costs are also provided for under the agreement.

"The periodic evaluation and improvement of operations often represent reinvestment not only in the business itself, but in Michigan's environment as well," DNR director Roland Harnes said.

Between 1992 and 1994, Medusa repeatedly violated its Lake Michigan discharge permit. As a result, a facility-wide improvement program was initiated to focus on the reduction and elimination of certain waste streams, so that the company could operate in compliance with its permit and the Act.

## Camp Roy-El scholarships available

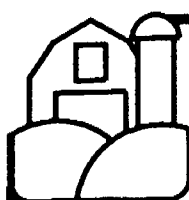

## Free child immunizations in Charlevoix

Preschool children and babies in Charlevoix and northern Antrim County will be able to receive necessary immunizations free on Sat., May 13, from 9 a.m. to 4 p.m., at Charlevoix Are Hospital, Lakeshore Drive, Charlevoix.

The one-day event is sponsored by Charlevoix Area Hospital and District Health Department No. 3 as a part of a statewide effort to bring all preschool children up-to-date with their immunizations. Most area schools do not allow children to begin kindergarten if their immunizations are not current. Last year only 90 percent of those entering kindergarten in Charlevoix were up-to-date resulting in loss of state funds to the schools.

"The hospital and health department have been working with citizen coalitions in both Antrim and Charlevoix counties to ensure that all babies are immunized before the age of two," said Nancy Ellison, hospital director of marketing and public relations. "We hope parents will take advantage of this opportunity to have their children immunized at no charge to them."

Appointments are requested, however walk-ins will not be turned away. Call 547-0295 or 1-800-432-4121 for appointments. Parents should bring their child's immunization record with them.

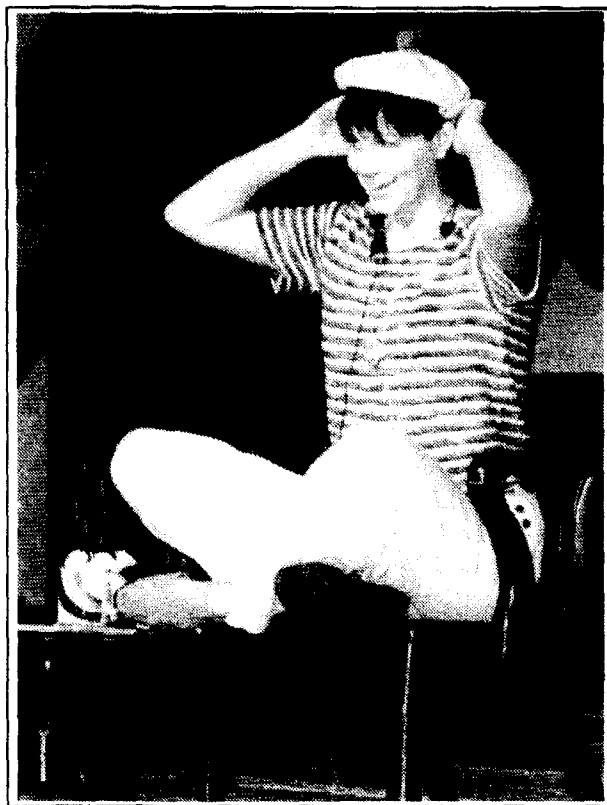

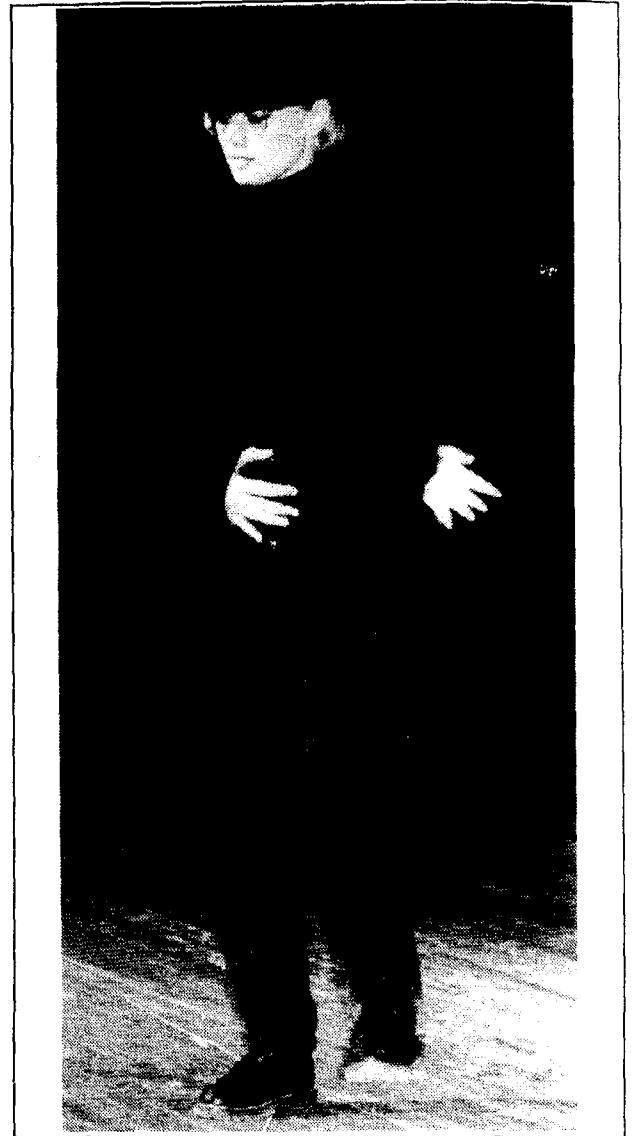

# Northwest Michigan gets Dairy Agent

Katherine L. Lee of Brattleboro, Vt., begins her duties May 8 as the Michigan State University Extension Agriculture and Natural Resources dairy agent for northwest Michigan.

She will be responsible for developing dairy education programs and providing dairy expertise to dairy producers in Mason, Lake, Osceola, Missaukee, Wexford, Manistee, Benzie, Grand Traverse, Kalkaska, Leelanau, Antrim, Charlevoix and Emmet counties.

This will include serving as an educator, an information provider, a needs assessor and a resource for problem solving. She will also create an information network between the local dairy producers, the industry, MSU dairy specialists and other Extension dairy expertise agents.

She is part of a team of 13 dairy agents statewide, funded in part by the Animal Initiative. The Initiative gives Michi-

gan a unique group of Extension agents, committed to providing the latest information to our dairy and livestock producers.

Lee graduated in 1977 from MSU with a bachelor's degree in dairy science. She received a master's degree in dairy science from Virginia Polytechnic Institute in 1979 and a doctorate in animal breeding from Iowa State University in 1983.

She was an Extension dairy agent in Virginia in 1983-87, and in 1987-90 was manager of Animal Breeding Services for the Holstein Association in Brattleboro, Vt. At the time of her appointment, she was the director of Animal Breeding Services for the association.

# jordan memories

From Jordan Township Chatter by Mrs. Vern Bundy

Mancelona Herald, April 19, 1956

Fifty-two years ago a young woman 23 years of age made the long ocean voyage from her home in Austria to America. It was another 18 years before she came to Antrim County. These years she spent in New Jersey, Colorado and Detroit. During that time she married and bore seven children.

For 34 years Mrs. Kotovich has lived on her farm in Antrim County, where she and her husband built their home and her youngest son, Steve, was born. It was from there she reared her family and sent them out into the world. After her husband passed away in 1937 she carried on, never sparing herself or hesitating when there was something to be done.

Three of her sons, Terry, Johnny and Steve, and one daughter, Mary, have answered the call of their country and served it well. They have now returned and are doing well in civilian life, too.

Teddy and Johnny are married and live with their families in East Jordan. They have a guide service and bait shop there. Steve also works in East Jordan, but stays with his mother. Mary is a nurse and works in a hospital in Detroit where her sister Olga and family also live. There is another sister, Helen, who lives in Boyne City and a brother, Fred, who is at present living in Traverse City.

Mrs. Kotovich is one who always seems to be able to find something nice to do for her neighbors and we are all sorry she has not been well for the past year. She has all our best wishes.

I hope I will be excused if I stray away from Jordan Township from time to time. You see, I have been getting mail from some of the old residents who have moved away and quite often they are interested in people and events in

other parts of the county. They have sent me many interesting facts I can use. Perhaps if I stick to this county, you won't mind too much.

For instance, I have at hand a letter from Mrs. Katherine Murdoch Keen of Athena, Ore. At one time, she lived in Alba and drove a team back and forth to Finkton (an old town nearly non-existent now), in Jordan Township, where she taught school.

It is a most interesting letter containing quite a bit of information and a few questions. Perhaps someone from Star Township could tell her the whereabouts of the Ed

Brown family or any descendants? She also says that a Mr. Dibble, merchant of that time, tells of a man who bought a grindstone in Mancelona and carried it to his home site in the Green River area. I would like to know who that man was, as my childhood home was also in that area.

Mrs. Keen tells me that in naming Star Township, several suggestions were made, including "Hardscrabble," by A.J. Clark and "Freedom," by Fred Feller. But Edson Olds came out with the winner when he suggested "Star."
