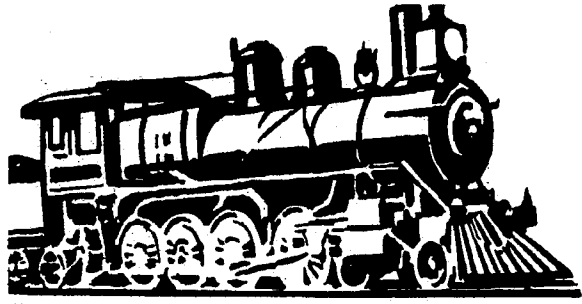


# Weather

## Elm Pointe — city asset or encumbrance?

Elm Pointe, a beautiful old estate on the shores of Lake Charlevoix in South Arm Township, has a variety of attributes to offer.

Those looking into the historical roots of East Jordan and surrounding communities may find help in the Portside Art and Historical Museum, housed in an old garage on the grounds. Many city and county residents, as well as visitors from across the state, enjoy the fine beach. Numerous area couples have taken advantage of the setting to exchange wedding vows.

Elm Pointe is also the site of the annual Portside Arts Fair, a very successful juried show that brings many visitors to the area the first weekend of August.

Despite its location well outside city limits, Elm Pointe, on M-66, between East Jordan and Ironton, is the property of the city of East Jordan — the only such situated city property.

The 11-acre estate, which includes a lodge and several outbuildings, as well

as Monroe Creek and a substantial amount of Lake Charlevoix frontage, was donated to the city in 1972 by Augustine and George Westgate.

The Westgates were friends with then-mayor Harry Watson. A city council resolution said that title to the property was "gratefully accepted" by the city.

That gratitude seems to have been tempered with time, as upkeep of the property has often been seen as a financial burden by city officials. Such costs moved the city to approach Charlevoix County a few years ago, but the county commission was not interested in taking on the property as a park.

"The problem is that the property is not self-sustaining," said city commissioner Brian Sweet at a July 5 discussion of Elm Pointe. "It costs the city a lot of money."

Sweet noted that Tourist Park, a campground and city beach on the corner of M-66 and M-32, pays for itself. He has suggested selling Elm Pointe because of costs.

"If it was managed properly, Elm Pointe would be self-paying," asserted Cyg Riley. Riley is a founding member of the Portside Art and Historical Museum Society, and a primary advocate of Elm Pointe.

Robert Veryzer, also very active as a supporter of Elm Pointe and the museum, agrees with Riley. He feels the estate home, with two large open rooms and picture window views of the lake, two kitchens and several bedrooms, is under utilized.

"We should be promoting this house for conferences and classes," said Veryzer during a tour of the home. Veryzer feels the facility would get more use if it was available year round.

The main kitchen needs to be modernized, another factor in attracting use.

Veryzer said it has been difficult getting the city to do any regular maintenance on the buildings, so they have deteriorated rapidly in recent years.

### Options for supporting the facility

For Veryzer, Riley, and other members of the Portside Art and Historical Society, as well as members of the Elm Pointe commission (a city-appointed committee that oversees the facility,) it has often seemed as though they have an adversarial relation with the city of East Jordan.

But the group recently got some support from the city commission for its campaign to get Elm Pointe named a state historical site, although it did not come without some conflict.

Sweet questioned whether any of the structures on the Elm Pointe property would qualify for historical status.

"It's a good example of a rich family vacation home," Sweet told Riley. Riley countered, calling it an "ancestral home," and said records support the eligibility of the house and garage.

Riley explained the property may eventually qualify for some grants if it receives historical designation. She is handling the research and documenta-

A former East Jordan School District bus driver charged with criminal sexual conduct has been bound over to the 33rd Circuit Court in Charlevoix.

Michael Wayne Reed, 39, of East Jordan, was ordered by visiting district court judge Joseph Deegan to appear in circuit court Thurs., Aug. 24, at 9 a.m.

Reed was arraigned Aug. 1, in 90th District Court in Charlevoix, on the felony charge of third degree criminal sexual conduct involving a minor, age

13-15. He waived his right to a pre-trial hearing Aug. 10, when he appeared before Deegan.

A request by prosecutor Mary Beth Kur for a suppression order has also been approved. Kur filed the request to close the courtroom during testimony by the victim, who is a minor.

Reed allegedly admitted to police that he had sexual intercourse with a 14-year-old girl between May and July, 1995. He was arrested on the complaint July 31.

Reed was terminated from his posi-

tion as a school bus driver for the district on July 25, the day after Superintendent Chip Hansen learned of the charge. Hansen said a state-required check into Reed's background revealed no prior criminal convictions or other reason to prevent the district from employing him.

Reed was released from custody on 10 percent of a \$2,000 bond, on the condition of having no contact with the victim. He faces a sentence of 15 years in prison, and mandatory AIDS/STD testing, if convicted on the felony.

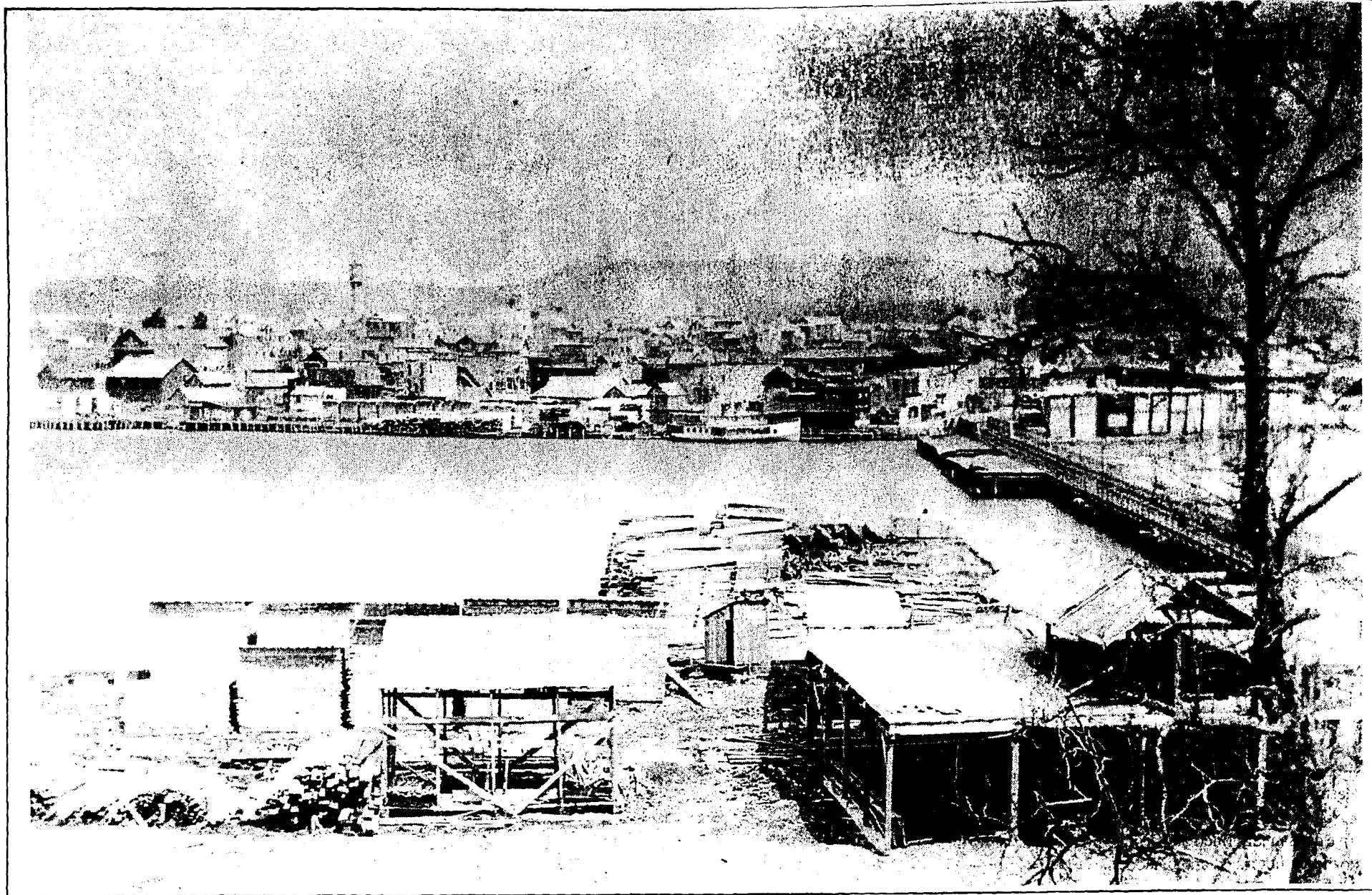
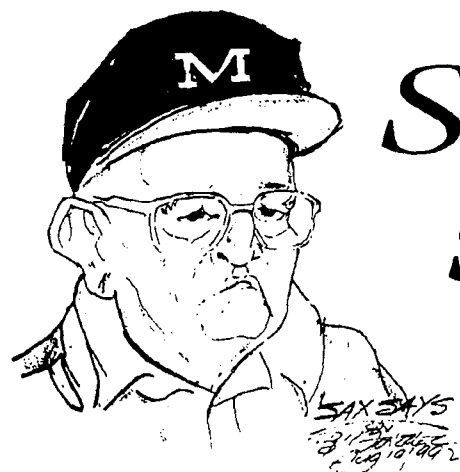

# Sax says ...

## Starting school

With the start of the school year less than a month away, parents and children are beginning to shop around for clothes for the coming year.

I can vividly recall the many times my dad and mom had to clothe six children – in the Depression years this was a tremendous chore.

But somehow, with the distribution of hand-me-downs, they managed to get us off to the first day of school in a presentable manner. There weren't all the fashions in those days that there are today – thus, many of the students in school were dressed alike. Through grades one to eight, I wasn't aware of the fact that there were any other kinds of shoes for boys than leather hightops. Besides, you got a free jack knife with each pair of new shoes, although you were not allowed to carry knives to school.

My dad believed in dressing us warmly. With the opening of school, we each got a pair of long johns, shoe rubbers, a flannel shirt, a sweater, a winter coat and a cap.

Being the oldest of the offspring, I generally received the new clothes. Brothers Richard, William, Charles, and Robert got the hand-me-downs. Seldom did the hand-me-downs make it to Charles or Robert, for they were worn out by that time.

After being associated with elemen-

tary children for 17 years, I have a little advice for parents purchasing clothes for school age youngsters. If at all possible, purchase clothing they like. Otherwise, all too often, the clothes wind up in the lost and found at the school. It seems that children have a way of losing their clothes if they don't like them, often using the excuse that someone took them.

At the end of any year in the elementary school, there might be as many as 100 caps, 50 pairs of gloves, several jackets, and even an occasional pair of shoes and boots that are unclaimed. A prudent parent will label his or her child's clothing, and if items come up missing will go to school and claim them.

If you have good clothing that your children have outgrown, call the school and donate them to needy children less fortunate than yours are. You'll not only be helping someone else, but you'll get a feeling of satisfaction for yourself.

## Estate tax reform supported

Farm Bureau applauded the introduction of a Senate bill (S. 1086) that would effectively reduce federal estate taxes levied on family-owned farms and businesses, and, for the smallest of these enterprises, eliminate the payment of these taxes entirely. A nearly identical bill is expected to soon be introduced in the House.

"Agriculture is a family enterprise-based industry. The bill would keep farms in the family, and help young farmers enter the business," said Al Almy, director of public affairs for Michigan Farm Bureau.

Key provisions of S. 1086 include eliminating the estate tax for each decedent's interest in a family business worth up to \$1.5 million, and cutting estate taxes by 50 percent if the decedent's business assets are worth more than the \$1.5 million

threshold. Under the current federal tax structure, a unified estate tax credit is provided that exempts \$600,000 from the value of an estate subject to tax.

The U.S. Department of Agriculture said about 45 percent of young farmers today either received their land as an inheritance or gift, or purchased it from a relative.

## Civil War hero

## Indian marrow donors are needed

For patients with certain kinds of leukemia, aplastic anemia, and other potentially fatal diseases, marrow transplants may represent the only chance of a lifetime.

Ethnic origin strongly influences marrow types. Normally a patient's best hope for a marrow transplant is provided by a donor of similar ethnic origin.

Northwest Michigan Gift of Life and Northwest Michigan Blood Program are seeking to recruit potential marrow donors from the local Native American community. When registered through the National Marrow Donor Program (NMDP), local donors may become lifesavers for other Native Americans who need marrow transplants. Native Americans 18 or older may be eligible to register as marrow donors.

A marrow donor recruitment program is scheduled for the "Celebrating Our Traditions" pow-wow at Peshawbestown. Information will be available at the Peshawbestown Health Department grounds on Aug. 18 from 8 a.m. to 5 p.m.; on Aug. 19 from noon to 6 p.m.; and on Aug. 20 from noon to 5 p.m.

Northwest Michigan Gift of Life so far has added more than 3,000 local people to the NMDP registry. Northwest Michigan Blood Program supports Gift of

Life efforts with administrative and technical services through affiliation with Michigan community Blood Center's Marrow Program.

Northwest Michigan Gift of Life and Northwest Michigan Blood Program are nonprofit organizations with a mission of serving community well-being. Part of the cost of donor testing and registration is covered by NMDP matching grants; however, additional funding is required to test and register local donors. Contributions are always appreciated.



## council briefs

### AUG. 1 MEETING

■ The East Jordan City Commission decided to list a city-owned house and property at 301 Bridge St. with the local branch of Charlevoix Properties at the appraised value of \$28,500.

The property, which came into city ownership through non-payment of taxes, has been the subject of much discussion throughout the summer. Recent inspections revealed the house to be habitable, but in poor condition. The commission discussed restoring the house before selling, but finally decided to sell as is, with a requirement of rehabilitation or dismantling of the house within a stipulated time frame.

"I don't think the city should be in the rehabilitation business," said commissioner Mike Dionne. "It would just be another distraction."

■ The commission discussed the lack of regular attendance at commission meetings by police chief Jerry Alward.

"Citizens attending the meeting may want his professional advice, insight, or a report on the progress on an issue," said commissioner Dan McKinnon. He expressed concern that Alward was not attending, but sending a representative instead.

"I'd like to see him here, too," said commissioner Ruth Gee. "But he is complying with our order (for department heads or a representative to attend the meetings.)"

The discussion turned to whether department heads need to attend commission meetings under the new form of government. City administrator Carolyn Sutter, attending her first commission meeting, said she would research the issue and make a recommendation in the near future.

■ Walter Olson of Maple Street requested the city do something about the park at Elm and Maple streets.

"It's very neglected," Olson told the commission. "Children use it all summer, but it isn't mowed, and there is a dangerous merry-go-round and exposed, broken cement."

Sutter promised to contact him to discuss the situation. As city administrator, she is charged with the day-to-day operation of the city and will handle such situations through her office.

Commissioner Brian Sweet also assured Olson that there are plans to renovate that park and others in the recently adopted city parks and recreation master plan.

## DNR denies agreement with Michigan militia

Responding to recent statements by the commander of the paramilitary Michigan Militia that an agreement has been forged whereby the Department of Natural Resources would train militia members to fight forest fires, DNR director Roland Harmes said today that no such agreement exists, and none will be entered into.

"The DNR deeply appreciates sincere motivations of individual citizens who offer to help in fighting wildfires," Harmes said. "Volunteers are carefully screened and trained on an as-needed basis. However, should an emergency arise where we need organized assistance, we will rely on the expertise of the State Police and Michigan National Guard.

"We have not - and will not - enter into an agreement which would further familiarize any paramilitary group with the specific operations, locations, equipment and capabilities of the state's forest firefighting arsenal," Harmes concluded.

Newly elected militia commander Lynn Jon Van Huizen has stated that he has forged an agreement between the militia and the DNR to train militia members to help fight forest fires, in an attempt to improve the militia's public image.

## Boating fatalities at all-time low

The U.S. Coast Guard recently announced the number of people killed in recreational boating accidents continued to decline in 1994, dropping to a record low of 784.

The Coast Guard said that it is encouraged since the decline in boating fatalities occurs when the number of boat owners and operators continues to grow. Almost half of all boating fatalities occurs when the number of boat owners and operators continues to grow. Almost half of all boating fatalities occurred on boats less than 16 feet long. Capsizings and/or falling overboard accounted for the majority of the fatalities.

While the number of fatalities was down, the Coast Guard's latest statistical report shows that the number of reported accidents increased in 1994. Two-thirds of all vessels involved in reported accidents last year were open motorboats and personal watercraft (PWC).

In assessing the 1994 data, the Coast Guard noted that the primary cause of boating accidents continues to be operator error as opposed to boat or environmental factors. Many boating accidents were due to operator inattention, carelessness and speeding.

This is further underscored when the same data showed that eight out of 10 reported fatalities occurred on boats where the operator had no formal boating instruction. This statistic highlights the need for continuing effective national, state and local boating safety programs.

Collisions with other vessels was the type of accident most reported in 1994 with an all time high of

2,685. The number of PWCs involved in collisions with other boats has increased significantly each year, while the number of other types of boats in these accidents has remained nearly the same. Last year, 30 percent more PWCs were in collisions with other boats than in 1993.

In 1994, there were 766 more PWCs involved in accidents than in 1993 resulting in 423 more injuries and 21 additional fatalities. Eight out of ten PWC accidents involved collisions with other vessels.

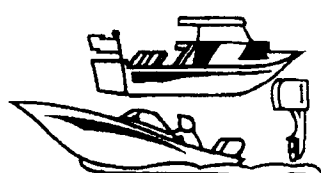
Although the latest statistics show boaters involved in accidents are using their personal flotation devices (PFDs) more often than in previous years, 75 percent of the victims involved in fatal accidents were not wearing them. Such a statistic is particularly disconcerting when noting that in 1994, PFDs could have saved the lives of 550 boaters who drowned. This includes approximately 30 children age 12 and under who could have been saved if they had been wearing PFDs. "A PFD won't work if you don't wear it," the Coast Guard advises.

In addition to keeping people afloat, PFDs also help to keep them warm. A greater percentage of accidents that occur during the fall and winter months result in fatalities. When waters are below 60 degrees Fahrenheit, hypothermia sets in quickly. The Coast Guard advises sportsmen who hunt and fish from boats, especially in colder weather, that they should wear their PFDs.

# MUCC calls for public hearing on order to split DNR

The Michigan United Conservation Clubs recently called on the legislature to hold public hearings on Governor John Engler's executive order splitting environmental responsibilities from the Department of Natural Resources.

The state's largest conservation organization sent letters to Senator Majority Leader Richard Posthumus and House Speaker Paul Hillemonds, asking them to schedule the hearings. MUCC said the Governor's order calls for drastic changes and was issued without any public input.

The order, signed by the governor July 31, creates a new Department of Environmental Quality by transferring the state's entire environmental protection program from the

DNR. The order will become effective in 60 days unless it is rejected by a majority of the legislature.

"Our preliminary review of the executive order gives us cause for grave concern," said Thomas L. Washington, MUCC executive director. "It appears that the order systematically destroys the DNR and casts aside principles that conservationists have sought to protect for the past 75 years."

"Our organization has always believed that natural resources and environmental protection are inextricably intertwined. We fear that wildlife, fisheries and habitat protection will suffer because they will be excluded from

important decisions that will be the responsibility of the new department."

Unlike the DNR, the new department will not have a policy-making commission. The head of the department will be named by the governor and report directly to him. Governor Engler named Russell Harding, currently deputy DNR director for environmental protection, to head the new department.

Washington said he suspects there is not a strong commitment on the part of Harding or the governor to enforce environmental regulations and that the new department will function with little public oversight or review.

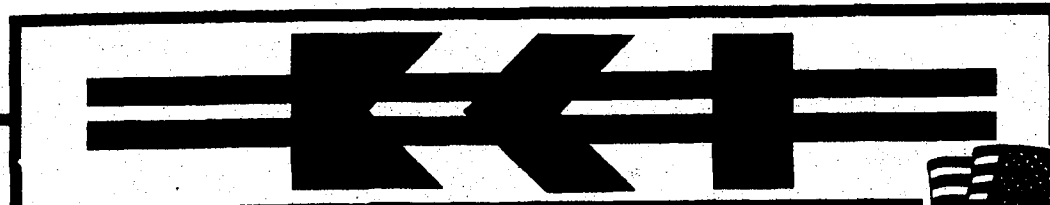

## Area programs receive \$14,800

Several of the area's nonprofit programs will be able to stretch their budgets and make their services go a bit further, thanks to some financial help from the Charlevoix County Community Foundation. The foundation's trustees recently voted to award 12 grants totaling nearly \$15,000 to a variety of worthy projects.

Those programs selected to receive grants and the amount of their funding include:

- The Char-Em Housing Coalition - \$500 to underwrite the cost of painting a home during the annual paint blitz.
- The Exceptional Riders Program - \$1,500 to purchase saddles and other equipment for use by the program's physically and mentally challenged equestrians.
- Raven Hill Discovery Center - \$2,500 to help equip the science center's chemistry and physics lab and for general operating purposes.
- The Women's Resource Center - \$1,500 toward the publication of a Domestic Abuse Resource Guide which will be used by abuse victims and area service providers.
- Charlevoix County Probate Court - \$500 to cover a portion of the cost of a recent seminar on gang prevention and intervention hosted by the 7th Probate Court.
- Charlevoix County Sheriff Department - \$300 to help purchase a special communications system that will like central dispatch and the department's K-9 officer.
- Northern Lakes Economic Alliance - \$1,000 to acquire a computer to assist area entrepreneurs and new businesses in writing business plans, making financial projections, and analyzing market data.
- The Little Traverse Conservancy - \$1,200 toward the purchase and preservation of the Little Sand Bay property on Beaver Island.
- Club 77 - \$1,000 to help the teen center hire a part-time youth director and coordinate programming.

In addition to these grants from the Charlevoix County Community Foundation's general endowment, trustees voted to award three grants from special endowments designated to support specific kinds of projects, or used to fund programs in accordance with donor wishes.

The Little Traverse Conservancy was awarded \$800 from the community foundation's Tunison/Garlock Memorial Fund, established to support educational and environmental projects in Charlevoix County. And, a special endowment held by the foundation on behalf of LexaLite International Corporation will help two programs - Club 77 will receive \$2,000; and the Charlevoix Friends of the Pool will be awarded \$2,000 toward the construction of a community pool.

This is the sixth group of grants made since the Charlevoix County Community Foundation began in 1992. To date, more than \$130,000 has been returned to the community in the form of program grants and scholarships.

A nonprofit organization, the foundation was established by area civic leaders to receive charitable donations, scholarship funds, and special endowments and hold them in a permanent trust to benefit the entire county. Donors, who receive generous tax credits for their contribution, may specify how their charitable dollars are to be used, or allow the community foundation trustees to decide which programs have the most pressing need.

Only investment income is used to make grants, so the foundation's assets continue to grow and become an ongoing source of revenue for the community good. Currently, the area foundation holds nearly \$1.8 million, the interest from which can be used to support a variety of civic, social, and human service projects.

# Antlerless deer applications are available

Department of Natural Resources application forms and guides for antlerless deer hunting licenses will be available in early August at more than 1,500 license dealers throughout Michigan. In order to be entered in the computer drawing for these licenses, applications must be submitted by Sept. 24.

An antlerless deer hunting license allows a hunter to take a deer without antlers, or with antlers less than three inches in length, during the regular firearm deer hunting season, November 15-30.

"Michigan's abundant whitetail deer resource has allowed us to again provide an increased level of participating in the antlerless hunt," DNR director Roland Harnes said. "Over the years the antlerless deer permits have allowed biologist to more finely tune deer herd management across the state."

Antlerless deer licenses not used during the regular firearm season will be valid for use in designated deer management units during the December 1-10 muzzleloading season in the Upper Peninsula and the December 8-17 muzzleloading season in the Lower

Peninsula, or the December 1, 1995, to January 1, 1996, portion of the bowhunting season.

This year, hunters will apply for an antlerless deer hunting application through the new Retail Licensing System. A mail-in application form will no longer be used. Applicants can apply for the antlerless deer hunting license drawing at any DNR office which sells licenses or at any of the 1,500 license agents throughout the state. Individuals may also apply by telephone with a credit card at 1-800-898-MDNR, although there will be an additional charge for that service.

Individuals can apply for an antlerless deer hunting license any time after Aug. 1 through midnight (or at the end of the business day) Sept. 24.

This year, hunters may apply for an antlerless deer hunting license without first having to purchase a regular deer hunting license. However, they must have a regular firearm deer hunting license in their possession to hunt antlerless deer during the regular firearm or muzzleloading season. They must have a regular archery deer hunt-

ing license in their possession to hunt antlerless deer with a bow during the Dec. 1 to Jan. 1 archery season.

To apply, hunters will need either a valid Michigan driver license, Michigan DNR sportscard, or a Secretary of State ID card. Applicants must apply in person and may only apply once. The \$3.50 non-refundable fee must be paid at the time of application.

The DNR holds a random drawing each fall to determine which applicants will be issued antlerless deer hunting licenses. By November 1, successful hunters will be mailed a back tag, allowing them to take an antlerless deer in a specific deer management unit.

A total of 295,524 antlerless deer hunting licenses will be available in 139 deer management units where deer numbers need to be stabilized or reduced. This is almost twice the 153,558 antlerless deer hunting licenses issued in 1994 in 90 deer management units. About 400,000 hunters are expected to apply for 1995 antlerless deer hunting licenses.

There are some deer management units, like #215 in southern Menominee




County, where all applicants will probably be successful in the drawing. In other units, like #079 in Missaukee County, less than 1 in 10 applicants may be successful.

An applicant's chance of receiving a license depends on the number of licenses available in a unit as well as the number of hunters applying. This year, the DNR has published a table in the antlerless deer hunting guide that estimates the odds of receiving a license.

tion process.

Commissioners wanted to know what restrictions the designation would place on park use, so tabled the issue until city attorney Scott Beatty did some research.

The commission came back at the July 18 meeting and approved city support for the historical society's petition, after Beatty reported no restrictions would be placed by the state. Reilly said she anticipates filing the required materials by the end of the year.

Once state designation is received, Riley plans to also petition for national historical status.

"There are a lot more opportunities through the National Registry," she said. She believes listing on the registry will bring more tourists to see Elm Pointe. "We can get a lot more national advertising through that."

## A historical legacy

Elm Pointe has been the scene of changes reflecting the history of the East Jordan area. The original homesteaders, on the creek that eventually bore their name, were John and Marceline LaLonde Munro, in 1847. The Munros sold the property to the Porter family, already well-established in the lumber business.

The Porters harvested first the white pines, then the

hardwoods off the property. The area was then used for storage, piling tons of unmilled lumber to wait for ideal "floating" conditions to send the wood down to East Jordan for milling. Elm Pointe, with its gentle slopes, was a perfect banking spot.

When the lumber era collapsed, John Porter, already diversified with his family into other businesses such as railroads, decided to build a summer home on the property. Begun in 1910, it was one of the first lakefront homes in the area, at a time when such locations were not considered valuable.

The all-wood home had no electricity, but the family had a generator. Roads were so bad at the time that boats were the most convenient method of getting to the property.

In the mid-1930s, the Porters sold the property to Robert W. Allen, a woolen and hosiery mill owner and businessman from Wisconsin. The Allens added the garage and studio that now houses the Portside Art and Historical Museum.

After Allen died, his wife Augustine was remarried to George Westgate, and made the gift to the city when the couple decided to leave the area.

The upstairs studio of the museum (a completely open space with rich wood flooring) is another source of frustration for Veryzer.

"The city won't let us open it to the public," he said, "Because we can't provide handicap access."

Veryzer has taken issue not just with the money the city doesn't spend on Elm Pointe, but also some of the money the city has spent, including the installation last year of a beach parking lot on the south end of the

property. He believes the new parking area, along with the lack of a full time caretaker, leaves the museum more vulnerable to vandalism.

That and aesthetics are Veryzer's concern about a recent suggestion of Sweet to consider developing a tent camping area on the property to help increase revenues.

"I wouldn't have thought of camping at the property either," said city commissioner Ruth Gee. "But I think we all need to listen with open ears."

She said she appreciates the hard work of the Elm Pointe commission and other advocates who "wring dollars out of nickels" in caring for the facility.

"But we all need to spend energy on finding viable solutions to raise money to keep and maintain the property like it deserves," she added.

Gee likes Veryzer's idea of promoting the lodge for more use, but noted expensive renovations would be necessary, including insulation (the building has none) and wiring upgrades. She would like to see a community forum to allow for a broad perspective offering suggestions on how to raise revenues for the property.

With lakefront property now at a premium, Gee definitely wants to see the city keep Elm Pointe.

"It's a beautiful place, and a piece of lake frontage every single person in the community can use and enjoy," she said. "I wouldn't want to lose that. It would be a shame for people living so near the lake to not have access to it. The people in our community should be able to know they have at least a little bit of lake frontage they can call their own."

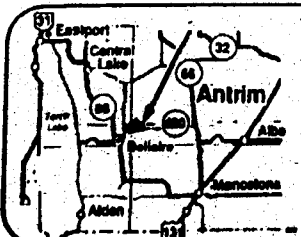
