

SERVICES HELD FOR MYRL FULLER

Services were held at 2 p.m. Tuesday, November 23 at Watson's Funeral Home for Myrl fuller, 73, of Boyne City, who died at Lockwood hospital in Petoskey November 21st. after a short illness. Rev. John Miller officiated and burial was in Sunset Hill cemetery.

Mr. Fuller was born August 16, 1892 in Tallmadge Township, Michigan. He lived there until 1934 when he moved to East Jordan. For the past three years he has lived in Boyne City.

On June 26, 1934 he married Sarah Allen at South Bend, Indiana. She died March 5, 1960, Mr. Fuller was a World War 1

veteran and a farmer. Surviving are five grandchildren, sixteen great grandchildren and eleven greatgreat-grandchildren. Also surviving are three sisters and two brothers: Kitty Cooper of Florida, Nema Bair and Effie Townsend of Indiana, Arnie Fuller of California and Kenneth Fuller of Grand Rapids.

Plan North Area School Vote

The Charlevoir Emmet Intermediate School District 18 member Reorganization Committee, after discussing the provisions of Public Act 289 of 1964 and reviewing the pertinent influences affecting the feadiness for major reorganization of school districts, decided by majority vote to study and recommend the annexation of non-high school districts to existing high school units.

The Committee observed that the intent of the act, namely, to place each child into a K-12 school district, would be more nearly assured under the proposed plan herein submitted. They further recommend that high school district's assess their own status and begin to explore the possibility of mergers with other high school

The accompanying proposed reorganization plan for the Charlevoix Emmet Intermediate School District was suggested by the following general procedure:

The Comittee systematically considered the several non-high school districts for study.

Area representatives were asked to make recommendations and to provide information of a local nature that would not necessarily be learned by studying maps and statistics.

Publicity was given through reports of Committee action and discussions immediately following each session.

In a real sense sectional hearings were held in-as-much as representative groups were asked to attend sessions of the Reorganization Committee when their district was under study to aid the Committee in getting complete information upon which to make recommendations.

In some instances general meetings were conducted in local districts under the direction of the local boards of education to disseminate information and to gather a consensus of local

Ambushed While On Convoy Mission

Twenty-three year old Specialist William J. Taylor III, son of Mr. and Mrs. William Taylor was killed in Vietnam action November 20th by a Viet Cong ambush with the "Big Red One" in Vietnam, the war department said in a telegram early Monday.

Taylor, married recently to Louise Hebdon. of Central Lake, had spent nearly two years in

The War Department said Taylor died while he was a member of a military convoy ambushed by "hostile forces." The telegram was signed by J. C. Lambert, Major General, USA--The Ad-

First Area Victim

A 1960 graduate of the East Jordan high school, Taylor worked in the family's IGA Grocery after attending a school for meat cutters. His wife, the daughter of Mr. and Mrs. John Hebden, of Central Lake, has been employed at Mac's Beauty Shop in East Jordan. He joined the service in June, 1964.

The War Department said the family would receive additional information and that they would be personally contacted by a member of the department. No funeral arrangements were set at presstime.

Taylor was the first American serviceman from this northern area to lose his life in Vietnam war.

Many East Jordan residents visited the Taylor home Monday expressing their sympathy.

The entire Taylor family is well-known throughout northern Michigan. They are pioneer East Jordan business people and community workers.

Surviving in addition to his father, mother and wife are:

A sister, Judy Holcomb, an Alpena teacher; grandmother, Mrs. Lydia Johnson, Charlevoix; an uncle, Fletcher Johnson, Mayor of the city of Petoskey.

Other relatives include: Miss Lee Johnson, of Petoskey; Mrs. Ernie Dietze, of Petoskey and Mrs. Allen Niswander, of Walloon Lake. All are aunts to the deceased serviceman.





Winter Sports Growing In This Area

The story of winter sports in this area is a record of phenomenal growth.

From a few scattered ski centers and winter parks a short generation ago, the winter recreation industry has expanded with no signs of a letup.

Predictions of a few years ago that winter business would contract to a few major areas has not been borne out as year after year the list of West Michigan centers has grown.

In the early 50's Hickory
Hills and Holiday Hills (now
Traverse City Holiday) made
their debut in the Traverse area,
with Missaukee Mountain at
Lake City and Mt. Mancelona
also joining the list. In 1955,
Harbor Highlands near Harbor
Springs, Lake Valley at Kalkaska and Manistee Ski Area (now
Big "M") started operations, followed in 1956 by Brady's Hills
at Lakeview, Ward Hills near
Branch, Glacier Hills at Bellaire
and Mt. McSauba at Charlevoix.

Boyne Mountain, the first complete public winter resort in the state, started operation in 1948. Inauguration of swank Shanty Creek at Bellaire was in 1963.

Last year saw fabulous Boyne Highlands rise on the site of Harbor Highlands, while Sugar Loaf was revived after a couple years of idleness. Timber Lee and Maplehurst also started operations in the Traverse area.

Growth of the winter industry has not been only in numbers. Most of the centers which have made a go of it have continued to expand with new lifts, snow makers, more slopes, better facilities and accommodations and better services. And the number of skiers has increased from a few thousand to tens of thousands. And there's no recession in sight.





Harry Watson gave a report on the Airport Commission. The East Jordan airport was classified as an emergency field, and is now classified as a limited service field.


The acute housing problem was brought up by Milt Meredith and discussed.

CITY OF EAST JORDAN - ORDINANCE NO. 109

ORDINANCE REGULATING THE OWNERSHIP, CUSTODY, CONTROL, SALE, DESTROYING OF DOGS WITHIN THE CITY OF EAST JORDAN; MAINTAINING DOG POND AND EMPLOY-MENT OF DOG WARDEN; PRESCRIBING PENALTIES FOR VIO-LATION OF THIS ORDINANCE, AND TO REPEAL ALL ORDINANCES IN CONFLICT HEREWITH.

THE CITY OF EAST JORDAN ORDAINS:
Section 1. It shall be unlawful for any person, firm or corporation to keep, possess, harbor, or have the care or charge of any dog, male or female, of the age of four months or over that does not at all times wear a collar to which is attached the license tag provided for by the laws of the State of Michigan, provided however, that this section of this ordinance shall not apply to any person, firm or corporation, transporting a dog through the City of East Jordan on any showing of the fact that such dog is being taxed at the residence of the owner.

Section 2. By this Ordinance, the City Council is hereby given the authority to appoint a city dog warden for the City of East Jordan, or assistant dog wardens, who shall hold office for the dog warden and assistant dog wardens shall be paid either on a fee basis or salary basis or combination of both at the from time to time determination as made by said City Council. It shall be the duty of the dog warden, assistant dog warden and city police officers to enforce the provision of this ordinance and, further, all sheriffs, deputy sheriffs, constable, Charlevoix County dog warden or assistant dog wardens are given the power and authority to enforce the provisions of this ordinance.

Section 3. It shall be unlawful for any person, firm or corporation owning, possessing or having charge of any dog known to be of an ugly disposition or dangerous to persons or property, to permit or allow said dog, whether licensed or unlicensed to be at large at any time in the said City of East Jordan; and further, permit or allow any dog, whether licensed or unlicensed, to run at large or stray beyond the premises of such owner unless under reasonable control of some person, and further, every dog shall at all times between sunset of each day and sunrise of the following day be confined upon the premises of its owner or custodian, except when said dog is otherwise under the reasonable control of some person or its owner. A dog shall be considered under reasonable control of some person or the owner, if on a leash or within the beck and call of said person or the owner.

Section 4. It shall be unlawful for the owner of any female dog to permit or allow such female dog to go beyond the premises of such owner when she is in heat unless such female dog is held properly in leash or is under reasonable control of some person.

Provided, further that every person in possession of any dog who shall suffer such dog to remain about his premises for a space of five (5) days, without notifying police or the dog warden, shall be deemed the owner thereof.

Section 5. No person shall harpor or keep any dog which by loud or frequent or habitual barking, yelping or howling shall cause a serious annoyance to the neighborhood or to people passing to and fro upon the streets. No person shall own or harbor a fierce or vicious dog, or a dog that has been bitten by any animal known to have been afflicted with the rabies. Any person who shall have in his or her possession a dog which has contracted rabies or which has been subject to the same or which is suspected of having rabies or which has bitten any person, snall on demand of a dog warden, police officer, sheriff or deputy sheriff or of the health officer of Charlevoix County produce and surrender up such dog to the said dog warden, police officer, sheriff or deputy sheriff, or health department of Charlevoix County to be held for observation as hereinafter provided. It shall be the duty of any person owning or harboring a dog which has been attacked or bitten by another dog or other animal showing the symptoms of rabies, to immediately notity the dog warden or the health department that such person has such a dog in his possession. Whenever a dog is brought to the pound for having bitten a person, the dog warden may, if deemed necessary and advisable and after holding such dog for sufficient length of time to meet the requirements of the health department for investigation, cause such a dog to be destroyed as a vicious dog.

Section 6. The city dog warden shall carefully keep a record of the breed, sex, age, color, and marking of every dog impounded, together with the date and hour of such impounding, and also a record of the date and hour of sale or of the death of said dog, including the addresses or localities of impounded dog's origin.

Section 7. It shall be the duty of the said city dog warden as soon as any dog may be received by him under the provisions of the ordinance, to serve notice in writing upon the owner or owners of such dog if such owner or owners be known; and further, that it shall be the duty of the said city dog warden to reasonably ascertain who the said owner or owners are.

Section 8. Owners of all dogs impounded under the provision of this ordinance may claim the same by properly identifying themselves as the owner of said animal and by paying the sum of One dollar and twenty-five cents (\$1.25) for each day or part of each day such dog is in the custody of the dog warden, and shall pay Five dollars (\$5.00) impounding fee, and such custody fees and impounding feeshall be returned to the East Jordan City Treasurer, who shall account for such funds according to the directions of the City Council as may be propounded from time to time; and provided further, that a proper license as provided in Section (1) hereof shall be produced before any impounded dog may be claimed by the owner or any agent of said owner.

Section 9. It shall be unlawful for any person to claim or attempt to claim any dog under the provisions of this ordinance when such person is not the legal owner of such dog or is acting under written authorization executed by the legal owner of said dog.

Section 10. The city dog warden when delivering a dog to the owner or to a purchaser shall make out a triplicate receipt describing the dog and stating the hour and date of its delivery and stating whether the receipt is for the sale of a dog or for the keep of a dog; provided, further, that said city dog warden shall keep one receipt, give one to the owner or purchaser and return one to the City Treasurer of East Jordan; provided further that the said city dog warden shall not less frequently than once a week pay in to the City Treasurer for the City of East Jordan, all monies received by him for the impounding, release or sale of dogs and weekly shall file with the Chief of Police a report showing the number and sex of all dogs impounded during the week and disposition of same.

Section 11. The Common Council shall provide a pound in which shall be impounded, all dogs that may be found running at large, or otherwise taken into custody by reason of the violation of this ordinance and contrary to the provisions of this ordinance and the dog warden or some other suitable person shall be designated as pound keeper and have charge of such pound; provided however, that if any such dog shall be taken into custody by the county dog warden, a sheriff or deputy sheriff, said county officer shall have the election of using the facilities as provided by the City of East Jordan or as provided by the county in manner similar to that used by cities or municipalities outside of the City of East Jordan, but within the County of Charlevoix, and provided further, that if said county official elects to use the facilities offered by the City of East Jordan, the fees collected from the owner of any said dog snall be turned over to the City Treasurer of East Jordan as provided in Section 8.

Section 12. All dogs placed under the custody of the East Jordan dog warden, under this ordinance, shall be kept by said dog warden for at least three (3) days after being impounded at any acceptable place as may be determined by the City Council, including the City dog pound, as may be necessary for the enforcement of this ordinance, and if the owner or owners cannot then be ascertained, the dog shall be disposed of in the following manner.

- (a) If the dog is deseased, crippled or injured and in the opinion of the Chief of Police, is not being held under provisions of Section 5 of this ordinance, the said dog may be immediately disposed of by killing in a humane manner.
- (b) If the dog is a mixed breed, it may be held for sale for a period of three (3) days and it not sold then, be killed in a humane manner.
- (c) If the dog appears to be a thoroughbred dog, it may be held for a period of fifteen (15) days and if not sold within fifteen (15) days, it shall be killed in a humane manner.
- (d) All dogs not claimed prior to 12:00 noon of the day next following the expiration of the time limits set forth in sub-paragraphs (b) and (c) shall be offered for sale by the dog warden at public auction to the highest bidder without other notice and at the place where such dog is impounded, and if such dog shall not then be sold, it shall be disposed of in a humane manner and at a time, place and manner as snall be within the exclusive determination of the Chief of Police, who is hereby authorized by this ordinance to establish, amend and control the administrative procedure for effecting the purpose of destroying said dogs.
- (e) If the owner of any dog coming within the provisions of this ordinance is known to the dog warden or the Chief of Police, the said Chief of Police on his own knowledge and belief or on information furnished to him by any member of the police department and under his sole discretion and powers under the administrative authority granted in Section 12 (d), shall have the power and authority to stay from day to day the killing of any dog pursuant to sub-sections (b) and (c) of this section, however, in such an event the fees chargeable against the owner shall accumulate at the daily rate provided said owner shall thereafter elect to claim said dog.

Section 13. The dog warden shall upon notice, have the duty of immediately picking up any dead dog that may be found lying or abandoned upon any street or elsewhere within the city limits and removing such dead dog to the dog pound.

Section 14. It shall be the duty of the dog warden to report violations of this ordinance to the police department of the City of East Jordan, and the Police Department shall then be charged with the duty of enforcing said ordinance; and provided that the City Council may delegate such police powers to the dog warden or any part of such police powers to the dog warden as the City Council shall deem desirable to effect the purpose of this ordinance.

Section 15. Public Act No. 339 of 1919, as amended and as hereinafter amended, which act is known and cited as the "Dog Law of 1919 of the State of Michigan," in those parts not inconsistent with this ordinance is hereby adopted by reference the same as if said Public Act No. 339 were set forth herein in full as to those not inconsistent with this ordinance.

Section 16. The City Council shall appropriate annually such funds as are necessary to effectuate the purpose of this ordinance and the City Treasurer shall carry the same in a special account with any surplus remaining in said special fund reverting to the general fund of the City at the end of each fiscal year.

Section 17. Any person violating any provision of this ordinance shall be deemed guilty of a misdemeanor, and on conviction thereof in any Court of competent jurisdiction, shall be subject to a fine of not less than \$10. 00, nor more than \$100.00, or by imprisonment in the County jail for the County of Charlevoix for a period not to exceed ninety days, or by both such fine and imprisonment in the discretion of the Court. Any person presenting a false claim under the provisions of this ordinance, or by receiving any money on any false claims hereunder, shall be deemed guilty of a misdemeanor and shall be punished as in this section provided.

Section 18. Nothing in this ordinance contained shall be construed as limiting the common law liability of the owner of a dog for damage committed by said dog within the City of East Jordan.

Section 19. As of the effective date of this ordinance, any ordinance or parts of ordinances covering and regulating dogs are hereby expressly repealed.


Section 20. If any provision of this ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not effect other provisions or applications of the ordinance which can be given effect without the invalid provision or application, and to this end the provision of this ordinance are declared to be severable.

Section 21. It being that a matter of public health, safety and welfare is concerned, this ordinance shall take effect immediately and shall be published in the East Jordan News-Herald within one (1) week after its adoption.




