Riding in the automobile owned by Maurice Kraemer at the time of the accident were: Douglas Raymond, Glen McKinnon, John Charles Kraemer, Maurice Kraemer Jr., and Charles Raymond, all East Jordan youths.

Riding in the other auto were Doris Day, of Boyne City and Dewey Giem, of Boyne Falls.

The Sheriff's department said Charles Raymond 13, lost his life because of the accident and that John Charles Kraemer, 15, was the only person without injury. It was reported that Maurice Kraemer Jr., was released from the hospital this week.

The head-on collision took place on a slippery, ice-covered hill and according to the Sheriff's department the driver of the Kraemer automobile was ticketed for violation of the basic speed

Charlevoix County ranks far above the statewide average of deaths caused by Heart Attacks, Dr. James B. Blodgett, president of the Michigan Heart Association, says.

In Charlevoix County 61.5 percent of all deaths were caused by cardiovascular disease, the statewide average was 55.2 percent. Percentages are based on the State Department of Health statistics of 1964.

One reasonable explanation advanced, Dr. Losh points out, is that the "star" reported to have guided the Wise Men may have been a conjunction or close grouping of bright planets.

"Some bright planets are visible now, and they are always promising and alluring.
In looking for a symbol of the reason, Venus well fills the bill."



Tougher Targets In '65

Michigan's second modern-day elk season, set for Dec. 8-16 in the Pigeon River area of the northern Lower Peninsula, is expected to be sportier than last year's hunt. Although the area's herd is estimated to be as big as it was a year ago — about 3,000 — 3,500 elk — indications are that most of its, easier-to-kill animals were picked off in 1964. Generally, that means this season's 300 licensees will have to move into the back country to find where these prized animals are. Even then, their shooting success isn't expected to approach that of last year when 269 elk were shot. Best guess of Conservation Department game men is that hunter take will be closer to 100 animals.





We do not seem to be at war. There are no great shortages of consumer goods, no rationing, no servicemen walking the streets on furlough. There is no great wave of war feeling in our midst.

Yet we are at war.

And our sons are dying half way around the world in an armed conflict while business is as usual at home.

This is the ironic part of tody's fighting over seas.

We know America is right in this struggle and yet we are wondering what it is all about. And the whole thing is rather vague to us.

That is the way most of us felt two weeks ago... until...

The sharp, fire-like relaization that WE ARE SERIOUSLY AT WAR struck East Jordan with a great wounding stab that shook this community to its very roots, spreading the feeling of alarm throughout all northern Michigan.

One of East Jordan's well-known native sons of well-known parents was struck down in action on the battle front. The death of William J.Taylor III shook all northern Michigan, sent hundreds of people in many communities into mourning and awoke them abruptly to the fact that United States is at war.

Specialist William J. Taylor III, son of Mr. and Mrs. William Taylor, was killed in Vietnam action November 20th by a Viet Cong ambush with the "Big Red One" in Veitnam.

He was the first northern Michigan serviceman to die in the present war with the Viet Cong. It has been more than 20 years since this community mourned so deeply for a native son.


Sympathy was extended to his wife and parents from throughout Michigan as every communications medium in the north spread the sorrowful news.

And now the burial with full military honors is over, with northern Michigan residents paying high tribute to a soldier son.

His wife and parents are left with the deep knowledge that Billy served proudly and with honor and with a sense of duty to his country and to his own home town.

William J. Taylor III was a good soldier, a real American. And he did not die in vain.

Yes, the United States IS deeply at war.



Senior Citizens Tax Exempt.

The Senior Citizens Homestead tax exemption law, enacted by the 1965 Michigan Legislature, will become effective January 1, 1966, and will be applicable to the 1966 tax year. The main part of the law reads as follows:

"The homesteads of persons 65 years or over who have been residents of this state for at least seven consecutive years immediately preceding, and whose gross income, as hereinafter defined, combined with the income if any for the immediately preceding calendar year of a spouse and co occupant and concurrent owner of the homestead shall be not more than \$5000.00; and whose real property, taxable under the general property tax act, does not exceed \$10,000.00 of state equalized valuation, shall be exempt from taxation to the amount of \$2,500.00 of state equalized valuation. For the purpose of this act the word "resident" means a person who resides in the State of Michigan for at least 6 months in each 12 months period. For the purpose of this act the word "persons" means concurrent owners, where 1 of such owners is 65 years of age or over.

Persons eligible must file with the local assessing officer a claim for exemption, which shall be in affidavit form as provided by the state department of administration. The claim for exemtion shall be filed during the period beginning with the tax day (Dec. 31) of each year and ending at the time of the final adjournment of the local board of review.

The claim for exemption shall thereafter be open to public inspection. Any person knowingly and wilfully making a false affidavit for the purpose of exemption from taxation under this act shall be guilty of a misdemeanor punishable by imprisonment in the county jail not more than one year or by a fine of not more than \$500.00, or both."

These tax exemption affidavits may be filed at the City Clerk's office by East Jordan residents after Jan. 1, 1966, and must be filed before March 10. Any eligible taxpayer who will be out of the city between these dates should file his affidavit before Jan. 1st. Proof of age is required by a birth certificate, or other acceptable evidence. Proof of ownership of the homestead on the tax date, Dec. 31st., is also required.

A statement that the total income for the past year did not exceed \$5000.00 is required. This income must include the adjusted gross income as used for Federal Income Tax purposes, plus income from Social Security, pensions, etc.

RATE REDUCTION AT TOP O'MICHIGAN RURAL ELECTRIC COMPANY

A rate reduction of \$76,000 annually by the Top O'Michigan Rural Electric Company, Boyne City, has been announced by Harlan E. Ruback, Manager of the Rural Electric Cooperative.

The Cooperative serves 16, 500 members in 12 counties in north west lower Michigan. Over 3,000 miles of line and service facilities are valued at about 8-1/2 million dollars.

"Rate Studies", said Ruback, "have been under consideration for a period of two years." The savings affects all members in both residential and commercial classifications.

This is the first of two additional rate reductions planned over the next two years.

'The present reduction, effective January 1, 1966, is one more step, "said manager Ruback, "towards 1 cent per kilowatt hour electricity for rural residents.


