Those attending are asked to dress in summer party attire. The cost is a \$20 donation. For more information, call Jerry Kelts at 582-5974.

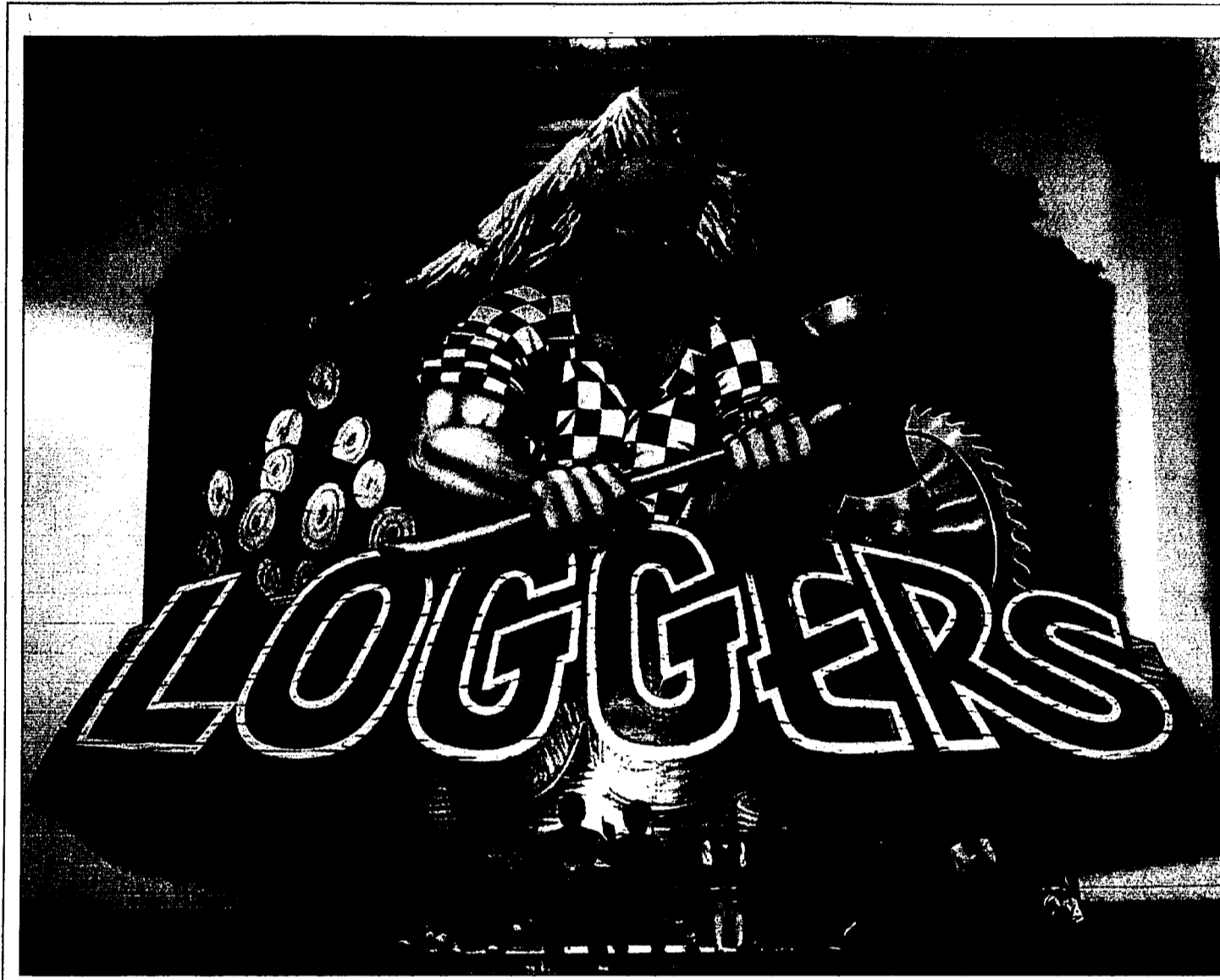

Library's new look is most impressive

Some area folks got a chance to take a look at what all the excitement is about at a special "Sneak Peek" event held last Friday, with proceeds going to help build the library's newly-formed endowment fund.

In conjunction with the event, Boyne District Library has announced that the newly renovated and expanded library building on the corner of Park and Main Streets will officially open for business on Monday, April 9.

According to library director Nannette Miller, the library will close its doors at the temporary location in the Honeywell Annex on North Lake Street on Monday, March 26, in order to prepare for the move. The location will be closed for a full two weeks before opening again at the Main Street location.

During that two week period, books cannot be returned; books currently being checked out are not due

back until April 9. In addition, the library will offer fine amnesty during the month of April, to avoid having patrons getting "caught" in that time period and accruing overdue fines.

The reopening will be the culmination of a project which began in September of 1998, when representatives from the Mary K. Peabody Foundation approached the library about the possibility of contributing to a major expansion and renovation.

The Peabody Foundation later committed to funding the project, including planning, construction, and furnishings, for a total cost of about \$2.2 million. With the addition, the library is increasing in size from 3,300 square feet to 12,800 square feet, and will hold up to 31,000 books. Previously, the library housed about 15,000-16,000 volumes.

An endowment fund has been set up for the library as part of the agreement with the Peabody Foundation,

in order to provide a means of support for funding future operations and programs at the library. The fund is currently selling personalized pavers

as a fund-raiser for \$100 apiece. The pavers will be placed outside of the entrance to the new community room and will be part of a landscaped out-

door sitting area.

SPECIAL MEETING IS OPEN TO THE PUBLIC

Boyne school board evaluating superintendent

A special meeting of the Boyne City Board of Education has been scheduled for Wednesday, March 21, at 7:30 p.m., to conduct the annual evaluation of school superintendent Dana Compton.

The evaluation was originally on the agenda of the board's last regular meeting on March 12, but after some discussion regarding process, the item was tabled with the intent to proceed with a new evaluation.

At the March 12 meeting, the board passed a motion stating that the personnel committee must meet with

Compton to agree on a method for evaluation and then call a special meeting to approve the method and proceed with the evaluation.

Though the motion originally indicated that a second meeting might be called to complete the evaluation, the agenda for Wednesday night's meeting includes the evaluation as an item on which action will be taken.

Compton's contract, which runs through June of 2002, is a two-year contract reviewed annually. The board approved renewal of the superintendent's contract last June.

Compton was hired in July of 1999, to replace retiring longtime superintendent Bob Nakoneczny. Prior to coming to Boyne City, Compton spent nine years as the superintendent in Morenci.

Wednesday night's public meeting will take place at the Boyne City High School media center.

THE BOYNE CITY Public Schools is accepting nominating petitions for four seats on the Board of Education up for election this year.

The district has one opening for a

one-year term which will expire at the end of the 2001-02 school year; one opening for a three-year term which will expire at the end of the 2003-04 school year; and two openings for four-year terms which expire at the end of the 2004-05 school year.

Two of the positions are currently held by elected board members Jim Stackus and Anne Thurston, while the other two are seats vacated earlier this year with the resignations tendered by Jerry Kelts and Jon Gerster.

Ken Schrader and Janet Froats-

Shepherd were appointed to fill those positions temporarily, until the election in June. All four incumbents will be running for those seats.

Nominating petitions for these positions may be picked up in the superintendent's office located in the back of the high school.

All nominating petitions and an Affidavit of Identity must be received in the superintendent's office no later than 4 p.m. on Monday, April 9, 2001, in order to be placed on the ballot for the June 11, 2001 election.

A meeting you should attend

On Wednesday, March 21, there will be a special meeting of the Boyne City Board of Education to approve the process for evaluating school superintendent Dana Compton, and consider the renewal of his contract.

Though to most folks that might seem routine enough, and not a reason to give up a Wednesday evening at home with the kids, all citizens in the district should attend that meeting.

The truth of the matter is there may be much more at stake than one might think. While the actual evaluation may not take place until a subsequent meeting, the process is one that will ultimately affect the entire community. The leadership of our schools is the real issue here, and it's one that none of us can afford to sit by and watch mutely as others make decisions in our name.

Admittedly, Compton got off to a rough start here in Boyne City, hired under a split vote from the board in 1999 and enduring some private legal troubles of his own. Adverse circumstances to be sure, and not likely to make the ideal first impression. And there are those in the community who continue to assert that those factors are all you need to know.

Still, those few bare facts say nothing about the job that Compton has undertaken over the last two years, nothing of what he's accomplished in terms of doing what he was hired to do; in a word, run a business. Or beyond that, his success in becoming a visible, available member of the educational community.

Whether or not his contract should be extended, the bottom line is that in considering the extension, all the pertinent facts, and only the pertinent facts, must come into play. What's more, the appropriate process must be followed.

What's most troubling about recent developments concerning the evaluation are signs that the school board, or some portion of it, may be spending too much precious time engaged in efforts that are both negative and counter-productive. Time that could, most certainly, have been used in a more forward-thinking fashion.

With the budgetary woes the district is currently addressing, not to mention being in the middle of a major construction and renovation project, it's clear that there are serious issues at hand which require professional attention and knowledgeable leadership.

The single most important factor, then, in deciding whether or not to extend Compton's contract is to determine if he is someone that's capable of giving those areas the attention they require.

The special meeting is at 7:30 p.m. at the high school media center. You should be there.

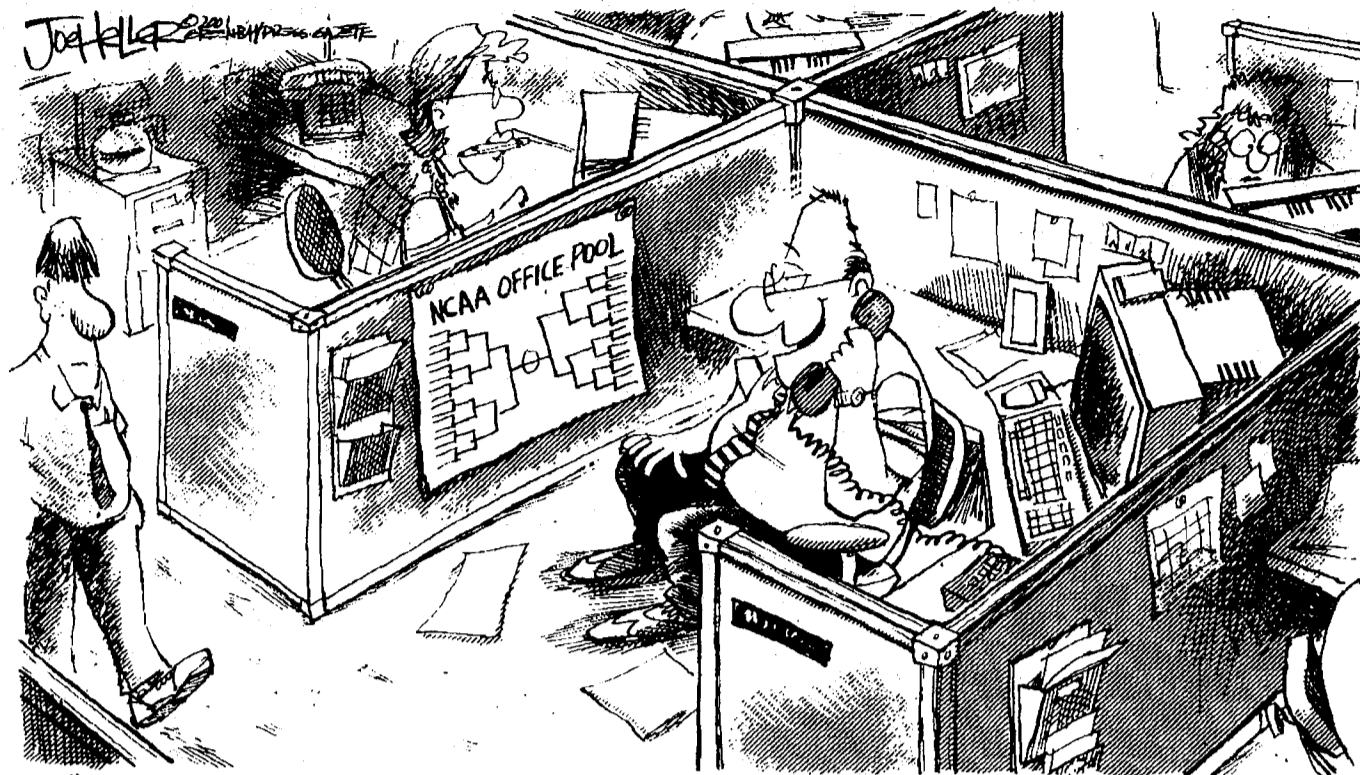

Crunching the numbers

■ Boyne City government working on new budget

The City of Boyne City recently began review of the proposed annual budget for the fiscal year 2002, which runs from May 1, 2001 to April 30, 2002.

Parts of the budget were discussed at a recent commission meeting, with the remainder of the budget to be reviewed at an upcoming meeting.

According to the written message included in the budget from city manager Eric Strahl, "In preparing this budget, the City's staff attempted to meet current needs for ongoing improvements to existing facilities, undertake the planning and construction of new facilities to meet the demands of growth and development, and to start the planning process to address two of the City's primary amenities,

the lakeshore and the marina."

Revenues for all funds in the proposed budget total \$3,501,235, with expenditures totaling \$3,667,995, leaving a revenue shortfall of \$166,760. According to Strahl, the shortfall will be funded by using unappropriated General Fund surplus.

Proposed projects in the budget include the beginning of the construction phase of the Downtown Development Authority's River Walk project; restoration of Peninsula Beach; upgrading and remodeling of City Hall facilities; and expansion of the building housing the airport terminal; continued work on the Rotary Park improvements including renovation of the existing restrooms and further work on the uncompleted

fields; and a new major water main in the Court Street/North Lake Street area.

Based upon the proposed budget, the City's total millage rate will decrease slightly by .79 mills, with the City levying a total of 17.85 mills, with 17.0 mills devoted to general operations and .85 mills devoted to debt service on the 1987 and 1989 infrastructure bonds.

Although the proposed budget contains a decrease in the total millage rate, the millage dedicated to general operations is increasing by one mil from 16 to 17 mills, as well as an increase in water/wastewater rates of 2.8 percent, to keep pace with inflation.

In an overview of the 2001 Fis-

cal Year, accomplishments in the city included beginning construction on Phase II of the City's Air Industrial Park; a substantial revision of the City's zoning ordinance; dredging at the marina, shopper's dock, and mouth of the river; development of the city's first web page; continued work on Rotary Park; and various street and sidewalk improvements. The City also sold the first two parcels in Phase II of the Industrial Park to Federal Screw Works, a Michigan manufacturer that is constructing a new plant valued at \$13,000,000.

The plant is expected to be operational by early summer.

The city commission also decided to hire a full-time director for the volunteer Ambulance Service.

A new chapter begins for Boyne girls basketball

This fall, a familiar face will head up the varsity girls basketball team as junior varsity coach Michelle Deming will take one more step up the coaching ladder.

Deming is taking the place of longtime coach Tom Neidhamer, who recently announced that he will step down as varsity head coach.

"When the season ended, I knew it was probably a good time [to step down]," said Neidhamer.

With his twin daughters Kate and Ellie graduating this year, and his oldest daughter Megan away at college, coaching would not be quite the same.

"Coaching has always been a family affair," he said, with daughter Ellie playing and Kate doing the stats. "It would no longer be a total family event."

"It's time for a new chapter in my life," he said.

Neidhamer's coaching career at Boyne City has spanned 17 years, and has included head coaching stints in junior varsity football, junior varsity boys basketball, and girls varsity basketball, as well as assistant coach duties in varsity boys basketball.

A graduate of Alma College, Deming coached junior varsity at Alma High School while playing college ball. Having coached at freshman and junior varsity levels at Boyne City for the last five years, she is ready to continue the work that Neidhamer started.

"Tom has done a great job of turning the program around," she said.

The next step for the program is to "get younger kids involved," a goal that Deming is already working towards, having co-founded a youth league this winter with Maurie Tomkins.

"It will have a great impact on the program," she said.

Having been an integral part of the program for five years, picking Deming to fill Neidhamer's shoes was an easy choice, according to Boyne City athletic director Steve Beyer.

"We're very excited about Michelle [taking over the varsity squad]," Beyer said. "She's been with the program for a long time. The girls have all played with her," which will likely make for an easy transition.

Neidhamer agrees that Deming is the right person to take the reins.

"Michelle is more than capable, more than ready," he said. "She's a tremendous asset to the program. She's going to not only continue [the program], I'm totally confident she will improve it and take it to the next level."

Still, for Neidhamer, leaving isn't easy, and he's not ruling out the possibility of coaching at a lower level.

The last seven years as varsity coach has left him with plenty of memories. "I've had a really good staff for seven years," he said. "That's what makes it fun."

He's proud, too, of what the staff and players have accomplished.

"We made the program competitive, made the program well respected among the league, among officials, and among the other schools," he said. "I think we've done it the right way. We've won with class, and lost with class."

For Neidhamer, though, coaching has amounted to much more than just playing a game.

"It's been so much fun coaching female athletes," Neidhamer added. "There's so many opportunities for female athletes right now. Hopefully we set the stage for them to go onto bigger and better things. High school athletics, for basketball, is nothing more than a vehicle to teach about life."

Downstate man killed in snowmobile mishap

The Charlevoix County Sheriff's Department is investigating a fatal snowmobile crash which occurred over the weekend in Eveline Township.

According to the sheriff's department, William Baisch, 44, of Fenton, was driving a 1997 Arctic Cat ZR600 on private property near the intersection of Ridge and Wurn roads. Baisch, along with his son and a friend, were traveling on a private easement trail from his property out

to Ridge Road when he left the trail and drove across a pasture/cornfield area and struck a two-strand electric fence.

Baisch suffered face and neck injuries and was treated at the scene by Boyne City Ambulance EMTs. He was transported to Northern Michigan Hospital in Petoskey, where he was pronounced dead.

The death was referred to the Emmet County Medical Examiner's Office.

Assisting at the scene was the East Jordan Fire Department Snowmobile Rescue Unit.

The investigation is ongoing.

EARLIER IN THE WEEK, a local man was injured while snowmobiling in Wilson Township.

According to the Charlevoix County Sheriff's Department, Gerry Argetsinger of East Jordan suffered a severely bruised right leg and a torn ligament in his left thumb on March

14 when his 2000 Arctic Cat snowmobile hit a ditch while traveling across a field near M-32 and Carson Rd. Argetsinger was thrown from the snowmobile.

He was transported to Northern Michigan Hospital in Petoskey where he was treated and released. The snowmobile received no damage and was driven from the scene.

The accident remains under investigation by the Charlevoix County Sheriff's Department.

Even after tough winter, Boyne school construction staying close to schedule

Though harsh winter weather was tough on construction crews at times, work on the new Boyne City High School continues to move forward.

"Winter was a little bit harder than what they anticipated," said Boyne City school superintendent Dana Compton.

"It slowed things down a bit, but they're close to [being on] schedule."

The actual building part of the process is "just about 50 percent" complete. Workers are currently completing work on fascia blocks "so they can continue to move forward," according to Compton.

Work on the gymnasium and media center require that fascia blocks be on site, "so that's the next task, moving on those."

Exterior colors for the building have been recently finalized, and the blocks have been ordered. The conceptual rendering posting in front of

the construction project will be updated soon, "so people can see what the final product will look like," Compton said.

As the high school construction is progressing, the focus is now also on anticipating the renovation of the current high school into a middle school. Bids are currently being put together, and are anticipated to go out in mid-April, to be returned by the first week in May.

Compton is hopeful that a package for bid approvals will be presented at the May meeting of the Board of Education, with renovations to begin in the vocational wing this summer.

Technology specs for the schools are also being compiled, with the hope of putting out technology bids in the fall, along with loose furnishing bids.

A good first season

■ Young wrestlers learning the sport and a whole lot more

With the first season of 4-H wrestling drawing to a close, coach Tom Haley couldn't be happier with both the turnout and the performances put in by the kids.

"The kids have been doing excellent," said Haley.

Haley, along with several other local residents including John Jasinski, Steve Baker, Ray Stolt, Randy Kruzel, Denny Kruzel, and Lance Pankratz, got the program off and running after becoming aware that there might be an interest in the community.

"I basically gathered these guys around," said Haley, who noted that they first took the ideas to the schools. When they discovered that the schools weren't ready to take on the program, someone suggested that they try taking it to 4-H. "We wanted to make this fly," Haley said. "We knew there were kids in the community [who were interested]."

The folks at 4-H welcomed the idea with open arms. "On behalf of 4-H wrestling, I want to thank the women at 4-H (Sue Shenk, Kathy Sulak, and Kim Stevens)," Haley said. "I want to really give them a hats-off."

"I take things to 4-H and they do the most marvelous job, more than you could ever imagine."

According to Shenk, who is the 4-H youth agent for the Charlevoix County MSU Extension office in Boyne City, it's not unusual for the organization to sponsor activities for local youth, noting that they've done the same in recent years for swimming, sailing, tennis, and soccer.

The 4-H office takes on the tasks of screening volunteers, processing monies and registrations, mailings, and some public relations.

With 4-H on board to take care of much of the practical considerations, Haley acquired some mats and set up a location at Boyne City Elementary School for practices. The group held their first registration, with about 25 kids signing on to participate. By the end of the first week of practice, though, Haley said that the group was "pushing 50" members.

With just about a dozen practices under their belt for the season, the team has competed against organized school teams from around the area. So far, the kids have tried their hardest and even brought home some medals. "We're real proud of that," said Haley. At a recent tournament in Charlevoix, eight of the 29 kids from the 4-H program medaled, including Trevor Kruzel, Garritt Moeke, Nathan Haley, Adam Karpatian, Travis Lapeer, Stephanie Fortune, and Eli Hoaglund.

Though other teams have topped them in most competitions thus far, "all the other teams are more established," said Haley. "We're brand new. I feel our kids have been doing excellent."

While winning more matches would be great somewhere down the road, for now the focus is on learning the basics. "Basically, we're trying to teach them about sportsmanship, fun, respect, and determination, along with the fundamentals of folk-style wrestling," Haley said.



About 50 kids grades one-eight turned out this year to take part in the new 4-H youth wrestling program in Boyne City. Most of the wrestlers are new to the sport, and, according to program organizer To Haley, the program has concentrated on sportsmanship, fun and the fundamentals of folk-style wrestling.

The sport seems to fill a niche. According to Shenk, "for those kids who just don't have an interest in some of the other recreational activities, this seems to fit." Wrestling "helps build self-esteem," she added, "and provides a physical activity."

Gauging by the turnout the program enjoyed this year, Haley envisions a bright future for the sport in the Boyne area. "I've had a lot of good feedback from the parents," he said. "The kids are really enjoying it, and it's an inexpensive sport to do in the winter months when there's not much else going on."

"Many kids of different sizes, shapes, ages, and abilities can do this," he said.

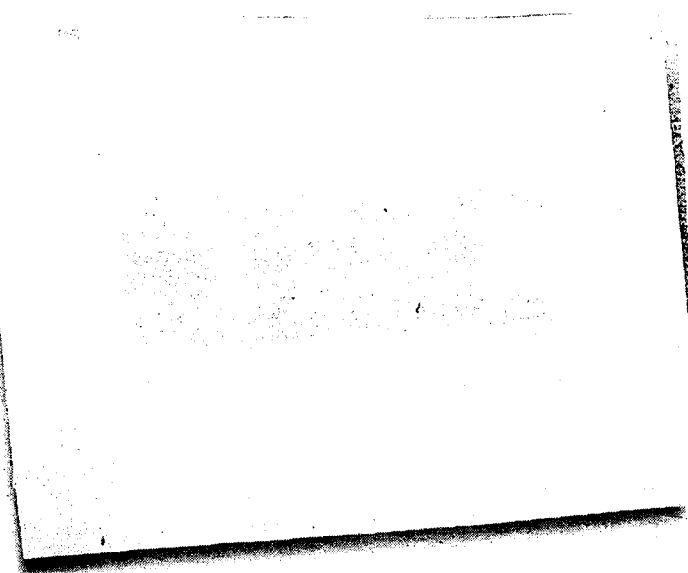
The main thing, though, Haley said, is fun. "[The kids] are having a lot of fun at it," he said, "which is really the main thing. The people we have helping out as coaches are doing a marvelous job. Everybody's got their head in the right place, everybody's there for the kids."

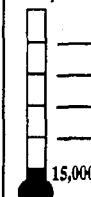

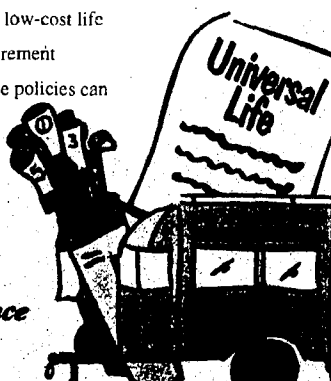

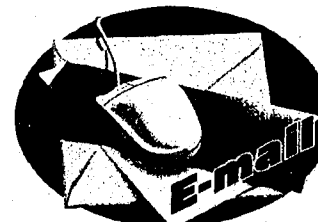

Red Cross hopes to raise both money and awareness

March is Red Cross Month and in addition to raising money, the Red Cross is aiming to raise people's awareness of the organization and its activities. A humanitarian service organization, the Red Cross operates on an annual nationwide budget of \$2.7 billion.

The money is used to mobilize relief to the victims of more than 63,000 disasters nationwide as well as supply almost half of the nation's blood for transfusion and one fifth of the tissue for transplantation.

Michael Edwards of Gaylord, chapter chairman of the Northern Lower Michigan Chapter of the American Red Cross, said the organization receives no government funding either on the local or national level.

"It (local funding) is an outright gift from neighbors across northern Michigan," he said.

This funding enables the Red Cross to provide local disaster relief, among other services. Edwards said the most common disaster in which the Red Cross is involved locally is single-family fires.

In the event of such a fire, the Red Cross assesses the needs of the family and provides appropriate shelter,

food and clothing. There were 78 single-family fires last year in the 12-county area served by the northern Michigan chapter.

In addition to disaster relief, the Red Cross trains people in disaster preparedness, cardiopulmonary resuscitation (CPR), Automated External Defibrillators, first aid, water safety, HIV/AIDS prevention and lifeguard

training. Red Cross centers across the nation are staffed by volunteers, with paid staff assisting as needed. Applications for those interested in volunteering are available at Red Cross centers in Gaylord, Petoskey and Alpena.

How Often Should People With Osteoporosis Have A Bone Density Test?

Osteoporosis is a bone disease in which bones become thinner and more porous. This increases the risk of fractures. If you have been diagnosed with osteoporosis your bone density should be rechecked in two years. If you are taking steroid medications, rechecks should be done every six months. This will let you know if your treatment is working or if you are continuing to lose bone. Women over age 65 should consider having a bone density test.

During the week of March 12-16 Raven Hill hosted the second of four invitationals for middle and high school students from the Charlevoix-Emmet Intermediate School District. Felter Suzanne Pufpaff showed students how to roll fibers in soapy water to tangle them and make a felt pouch. In addition, participants conducted scientific experiments to test

the tensile strength of various fibers.

The students also viewed the media boxes that are on display at the Center to see all the steps involved in creating works of art. At the first Invitational in February, Ed Gray worked copper with students.

Subsequent invitationals will be held Sept. 17-21 with glass artist Lynn Dinning, and Sept. 24-28 with potters David Otis and Chuck Koucky.

Four Summer Art Process Workshops are also scheduled: June 25-29 with felter Suzanne Pufpaff; July 9-13 with coppersmith Ed Gray; July 23-27 with potter Chuck Koucky; and Aug. 13-17 with glass artist Lynn Dinning. Interested high school and college students will immerse themselves in the details of the featured media for a full week.

The art media boxes are currently on display at Raven Hill. The 2001 Connections program will conclude with an open house on Sept. 30, 2001 where participants from the summer workshops will display their work and give a short presentation.
