EJ commission requests \$150,000 in budget cuts

As budget talks continue in East Jordan, working towards an April 2 public hearing on the issue, city commissioners have called for city staff to make significant cuts to this year's proposal.

At last week's regular city commission meeting, commissioners asked city administrator David White to get working to reduce the general fund expenditures by \$150,000, in order to boost what they consider to be a dwindling fund balance.

As proposed, the budget for the

2002-03 fiscal year contains a general fund balance of \$365,760, down from last year's \$668,855.

At the meeting, White outlined several "large ticket" items included in the proposed budget, totaling \$256,000 in expenditures. Those items included: \$76,000 in matching funds for the planned bike path at Community Park; \$100,000 from local streets; \$30,000 from major streets; \$30,000 from sidewalks; \$6,000 painting of the Civic Center; and \$4,000 for new windows at the

Senior Center.

Said commissioner Jerry Cihak, "I don't think we need to chop everything, but we need to trim [the budget] back."

Though commissioners did not agree on a specific area presented by White, commissioner Bernie Hammond suggested the possibility of eliminating the annual city-wide spring cleanup. "I don't know if it's feasible to have the city-wide cleanup every year," Hammond said, suggesting that perhaps the cleanup could be

held every two years instead. The proposed budget allows \$14,000 for the cleanup.

Commissioner Lee Symonds hesitated to support the idea, noting that the cleanup "makes the community look better [and] enhances curbside appeal." Said White, "I see Mr. Hammond's point, but it is one thing the citizens like." White also said that since this year's clean-up has already been advertised, it would be too late to cancel it, adding that the \$14,000 set aside in the proposed budget for

the upcoming fiscal year will cover the cost of the cleanup slated for this spring.

Said Hammond of the discussion as to where cuts should be made, "it all goes back to each of our priorities." Commissioner Shane Williams suggested that there are several smaller items that could be considered.

The commission came to a consensus to send the budget back to staff, charging White with the duty of finding the necessary cuts.

FOR BOYER CITY'S KURT AND JENNA ROLAND, HOCKEY IS

The family game

For some teen athletes, having their dad as a coach may be more a burden than a blessing. Not so, however, for Boyer City's Jenna Roland. With dad Kurt taking over the head coaching position for the Bay Home Medical "Habs," her Traverse City-based hockey team this year, Jenna sees the situation as only positive.

Especially when the dad and daughter team have the opportunity to share in a state championship, as the Rolands recently did.

Though the underdog win would have been enough, "it felt a lot better winning the state title with my dad as coach," Jenna said. "We finally won it together." Still, coming from behind to wrap up the win is always sweet, and with wily rival Bell Tire (out of Detroit) favored to take it all, the Rolands and their team had an especially tasty victory. Having met up six times over the season, they'd lost four times, meaning that going into

that final match-up "We didn't know what to expect," Kurt said. The team, though, stepped up like they never had before. "Our team came out and they were just awesome," he said. "You could see it in the first couple of minutes." Scoring their first goal by the two-minute mark, the team propelled themselves along with a momentum that couldn't be checked, ultimately taking the upset win.

The state trophy is just the most recent triumph in a longtime family commitment to hockey, starting back when Jenna was just a tot. At the time, Kurt had teamed up with fellow Boyer City resident Mark Perry to start what is now Boyer Area Hockey, in response to Perry's son's desire to play. It wasn't long, however, before a young Jenna was bugging her dad to take her along.

"Jenna wanted to go so I took her down," Kurt said. Older sister Emily soon followed, along with Perry's daughter Kara, and, he said, "the next thing we knew we had the girls

hooked on this."

The early years, Kurt said, found the kids dressed in snowsuits and figure skates, with mismatched and outsized equipment. "It was almost like a Mighty Ducks thing," he laughed. "Scraggly kids with no equipment, sticks a foot over their heads." Still, the girls, and especially Jenna, weren't discouraged, motivated only by a desire to play. "They played with the boys for a few years," Kurt said. "Then we came up with getting a group of girls together and said, 'let's see what we can do with this.'"

Plenty, as it turned out. The girls program found plenty of local talent; at some point, though, Jenna and Emily and others became advanced enough to require more of a challenge to continue improving. "I grew up playing hockey," Kurt said. "I knew that if we wanted the kids to progress, they'd have to play indoors." The

Proposed BC budget outlines new projects

■ Budget set to be adopted by city commission on Tuesday, April 9

Budget discussion continues in Boyer City, as commissioners consider a proposed budget for the fiscal year 2002-03.

The budget is set to be adopted by city commissioners at the commission's regular meeting on Tuesday, April 9.

As proposed, the budget projects \$3,799,001 in revenues for the general fund, and \$3,867,010 in expenditures, resulting in a shortfall of \$68,009.

The deficit will take the projected fund balance down from \$1,124,038 to \$1,056,029.

According to city manager Eric Strahl's written introduction, the city's total millage rate will decrease slightly by .65 mills.

As proposed in the budget, the city will levy a total of 17.2 mills, with 17.0 mills devoted to general operations, and .2 mills devoted to debt service on the 1987 and 1989 infrastructure bonds.

The decrease is the result of an increase in state equalized valuation and the use of debt fund reserves to reduce the funds needed from property taxes.

In Strahl's introduction, several major projects proposed for the year ahead are reported, including completion of the River Walk project this fall; completion of the process of upgrading the ambulance service to the Advanced Life Support designation;

construction of a walkway along Veteran's Memorial Park; improvements at the municipal airport; and the completion of the Downtown Development Authority's market study and the city's marina/boat launch study.

If state funding is secured, the proposed budget includes a new water transmission main to be constructed on East Main Street from Park to Broadway.

One proposed project that's already received some attention is the construction of an addition to City Hall to provide secured garage space for the police and ambulance departments, a secured evidence storage area, and additional office and meeting room space.

The proposed project, which would take place at City Hall's current location on Lake Charlevoix, came under scrutiny at a recent meeting of the Downtown Development Authority, which passed a motion to officially oppose the addition at its proposed location, citing several city goal-setting sessions that have resulted in citizens voicing a desire to move city services off the waterfront.

Budget discussions were scheduled to continue at the commission's regular meeting on Tuesday.

The next regular commission meeting is scheduled for Tuesday, April 9, at noon, at which time the commission is scheduled to consider adoption of the new budget.

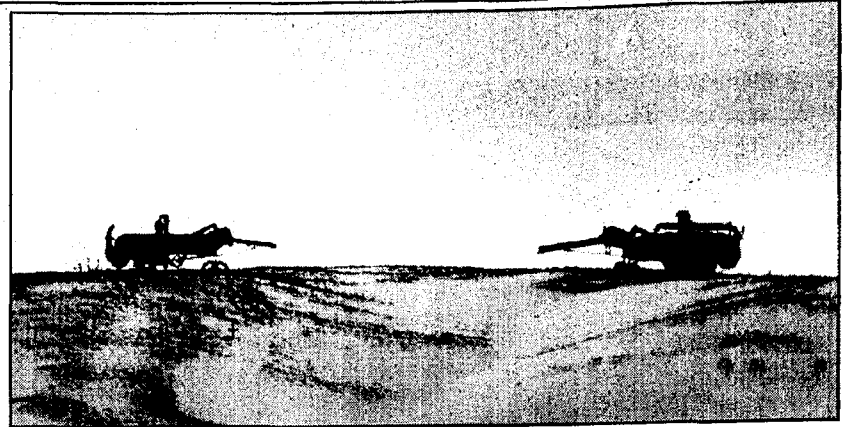
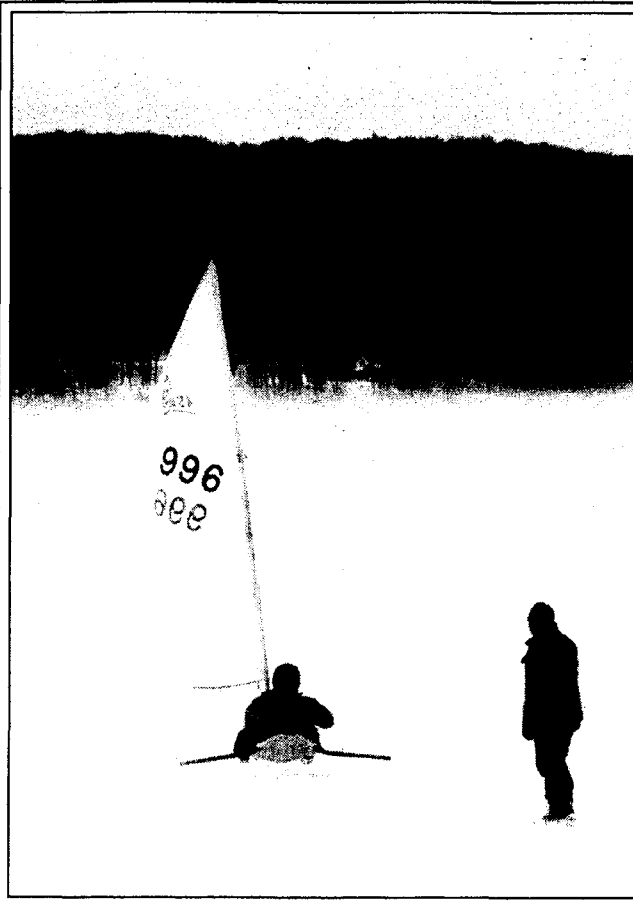

Are you aware that members of the Eveline Township Board have expressed an interest in obtaining the Wolverine Power Plant property?

I attended a town meeting sponsored by the Eveline Township Board on March 18 where the consensus of those people present was to obtain the property and preserve it for community use for generations to come.

One of the many things the entire group agreed upon that evening was that they did not want to see the property sold to a private developer. In light of the way our lakefront has become saturated with condominiums over the past 25 years we can all too easily envision that a private developer's only concern would be his or her own profit.

For us (as people who revere Lake Charlevoix) this translates into no consideration of preserving the existing open space but rather building condominiums packed so tightly together that people would never be able to SEE the lake again from this property, let alone have access to

enjoy it!

I remember riding past the Tannery as a child and having to hold my nose because of the stench. It was not that long ago that most people didn't want to live on the lake because building materials had not yet been developed which could stave off the harsh winter cold.

I have lots of pictures of how natural the shoreline used to be - there were many more trees than houses dotting the landscape. Over the years I have heard community members grouse because the view corridor on the Tannery property was lost forever to condominiums. People are still bitter about it today! Those feelings were recently stirred up again when even more condominiums were built at the end of Main Street.

I know that there are many people in our community who do not want to see the Wolverine Power Plant property turned into a mini "Bay Hollywood" (sic). I'm sure you've all heard the adage, "Three strikes and you're out!" This is the last time there will ever be a 25-acre chunk of property available on Lake Charlevoix.

I came away from the March 18 meeting with a height-

ened sense of hope that we CAN work together as a community to preserve the Wolverine Power Plant property as a piece of Lake Charlevoix frontage which can be enjoyed by our community for generations. Those of us present at that meeting have a goal - and we are united in our vision!

There's another adage that comes to mind, "If you're not part of the solution you're part of the problem." Let's not allow history to repeat itself this time. There is strength in numbers, and I know that there are many more community members who share our feelings than were present at the March 18 meeting.

We need your help in order for this goal to be realized. CHICKENPOX VACCINE WORKS

A new study in JAMA tracked chickenpox rates in three different regions of the US and found an 84% decline in cases of the disease since the vaccination program began in 1995. The vaccine scheduled is a single shot for children 12 months to 12 years old. Researchers found that the shot should not be given within 30 days of the measles, mumps and rubella (MMR) vaccine because this lessens the effectiveness of the chickenpox vaccine. Everyone over 13, including adults, requires two injections given 4-8 weeks apart.

Town meeting turns up favorable opinions about public use of Wolverine plant site

About 50 folks turned out recently to put in their two cents about the potential of the Wolverine Power Plant property in Advance.

With a committee made up of Eveline Township residents as well as concerned members of surrounding communities already in place with the goal of pursuing the purchase and development of the property, discussion centered around just what exactly people would like to see happen there.

Most, as it turned out, shared a similar vision, imagining a combination of public beach, marina, and commercial space. "It's amazing that a lot of the elements are very similar," said Tip of the Mitt Watershed Council's Wil Czwikel, who, along with committee leaders Deb and Nate Jason, facilitated the meeting. Other possible elements suggested include an ice rink, museum, and boardwalk. Some discussion was made regarding residential usage, though the degree of agreement was harder to come by in terms of type and amount.

While the degree of consensus surprised committee members, Deb Ja-

son, who is also the Eveline Township treasurer, had some inkling going in as to what direction ideas were running. Earlier this month, Jason had conducted a mail survey of township residents, sending out more than 1,000 surveys. With approximately 20-25 percent of the surveys returned, results turned out to be overwhelmingly in favor of a park/natural habitat use, with a full 50 percent of the informal vote. Other results included 18 percent in favor of use by a developer; 17 percent in favor of a park/village area; and 10 percent in favor

of taking no action at all. Still, the outcome of the meeting, in which attendees listened to an introduction and then broke into groups to brainstorm plans, was encouraging for the committee. "These are not unrealistic expectations," said committee member Scott MacKenzie. "If we can collaborate with like-minded people, people that share our vision... we can make it happen."

"Though the project seems monumental, the idea for the township to seek ownership of the property started out simply enough, with Jason's desire to see the power plant property returned to some form of public usage.

Closed by owner Wolverine Power in 1994, the plant has sat unused for several years, occupying 25 acres of what could be considered a prime piece of Lake Charlevoix frontage, abutting Porter Creek. The pricetag in the vicinity of \$6 million would be, in Jason's vision, funded primarily through grants and private donations.

Though it may sound insurmountable, it has in fact been done before.

Committee members cite a similar situation in Alberta, Mich., in which a grassroots committee "did almost the same thing on Lake Michigan," according to MacKenzie. "It's a huge task, but it can be done," he said.

FOCUS ON NATURE

Spring courtship of ruffed grouse a treat for birders

As March comes to a close and we near the arrival of April, a sound of a peculiar sort can be heard in the woods: a long, drawn-out drumming sound that can be heard from up to a quarter mile away. When a male ruffed grouse seeks to defend his territorial domain or to attract a female grouse he will perform a wing flapping that generates this "drumming" sound, produced by the cupped wings of the grouse striking the air as he flaps them forward and upwards. If you have ever witnessed this spectacular site in the wild it truly is something to see!

A male ruffed grouse will either use an old fallen log to perch on or maybe a small hummock at the edge of a field or just inside the woods. Either way he will use this same spot year after year to attract a female or to defend his territory.

I've sat in my photo blind for hours watching this bird go through his ritual, and to see this bird "strut his stuff" is amazing. The idea that he will start this at 3 or 4 a.m. and continue on through the afternoon, well, hey, I give the bird a lot of credit trying to attract a willing female. As he approaches his perch he will strut around some looking things over. Then slowly he walks up and gets on the log and starts a slow methodical wing flapping, as he accelerates with rapid forward and upward strokes the drumming sound can now be heard for all to hear. As he decelerates his wing movement he will erect the crest and neck ruff feathers, and fan his tail and strut, all the while continuing this throughout the day, only taking breaks occasionally to forage for food.

I have had the pleasure of being in the woods to observe the sound of three male grouse working to defend their territories. As I placed my blind to photograph one male grouse the day brought on two others drumming in the background. Actually, when I was photographing this bird another grouse came in right by him. My thoughts were either it was a female coming to his call or an aggressive male coming to claim this as his territory. Either way the bird did not stay -- it walked on by and the other male grouse continued his routine.

Females and egg laying

As females get ready to lay eggs they will usually find a spot at the base of a tree under some branches or in a hollowed old log. They lay anywhere from 9-12 eggs with one laid each day until the clutch is complete. The nest is lined with most any available material, leaves, pine needles and preened feathers also.

The female takes all the responsibility for incubation. Males are promiscuous and there is no pair bond between the male and female. When nesting, females are very defensive of the nest -- if disturbed to a point of being flushed she will run around the intruder displaying a broken wing defense, or she will chase an intruder and actually try to attack with hissing and wing flapping. But for the most part, she is rather hard to push or scare off her nest, relying on her camouflage to hide her from any intruder. I can attest to the effectiveness of their camouflage. Trying to show someone a spot where a female is nesting, they may look and look and tell you there is no bird there. But the glint of highlight of an eye soon shows them that yes a bird is there.

Hatching and survival

After 21-24 days the young are hatched. The young birds are mobile, have downy feathers, will follow the female and are shown food. These birds are literally on the move from hatching! The female will locate food for them, and they will search the ground in search of food, too. After about 10-12 days the young are most likely ready to fly, though they will continue to stay with the female until early autumn. Most likely the female will shy away from the young to encourage them to go out on their own. On a walk through the woods one may encounter a loud crashing noise, as you have scared a brood of young grouse with the female and they scatter all over the place. As you gasp for air and your heart rate slows down, you realize just what happened.

When April comes around I make it a point to check all my "drumming" sites, as my curiosity has the best of me to see if the male grouse has survived another long winter or not. With a good pair of binoculars in hand I cruise the woods in search of them. As I walk I will stop to listen to hear that familiar sound in the distance. As the drumming begins, a smile comes to me and I know this one has survived. I look forward to this each year. So take the time this year and go out and see if you can locate one of these interesting birds. Good luck and good birding!

decision to leave Boyne hockey was hard, he said, but necessary for Jenna and Emily, and so the girls made the move to play first for a team in Gaylord, and later to St. Ignace. Those years gave the girls not only indoor experience, but the chance to play a multitude of different teams from all over, including the Detroit area and Canada. After Emily graduated last year, she left for the University of Michigan, where she continues her hockey career on the university's club team; meanwhile, Jenna made the move to the Traverse City team to continue pursuing those growth opportunities.

She's not the only one - the TC team has gleaned players from all over northern Michigan, boasting girls from Gaylord, Central Lake, Elk Rapids, Sutton's Bay, Leelanau, Traverse City and Interlochen, all with the same goal: to play with girls of equal talent and ambition.

"Look how far [this team] had to go to pick up individuals looking for the same thing," Kurt said. They all want, he said, "to play with others who play like they can."

The commitment to pursuing that kind of team can be a big one. For the Rolands, it's meant traveling to Traverse City two nights a week for practice, arriving home around midnight, as well as weekend travel for games to either Traverse City or, in most cases, much farther. Out of 52 games this season, running from September through March, Jenna's team only had 15 home games. Other games were as far away as Detroit and Canada. "We're pretty tired," Jenna said of herself and her father.

So how does schoolwork compete with such a grueling athletic schedule? It's all a matter of making the time, according to Jenna, who typically carries a 3.8 or 3.9 grade-point average. On practice nights, for example, Jenna said that she sleeps in the car on the way down, and after practice, when she's more geared up, she does her homework on the way home. But, she concedes, "it's tough" to maintain the academics. "It's really hard, but I want to get good grades," she said.

Dad Kurt, too, has made a huge time commitment as coach and father to traveling, practice, and game times, a fact that hasn't escaped Jenna. "He drives me everywhere," she said with some wonder.

While playing with a team outside her home community is challenging, Jenna also relishes the friendships she's made there. "They're a lot of fun to be around," she said. "We seem to get really close and tell each other a lot." And though her coach is also her dad, the two have, she said, always been able to balance those relationships. "He doesn't treat me any different [than other players]," she said. "He'll still get firm with me."

Kurt concurs. "I treat her like any other player," he said. "I don't make anything special, make it easier for her."

He does admit, though, that "I try to separate [our relationship] as much as possible, but your own child is the hardest one to coach. I'm probably harder on her, only because I'm her dad and she'll question me while the other kids won't."

Jenna, for her part, is always looking for his input. "One of the things about her is that she'll always ask me after we play, what I thought, and I've always been able to tell her right up, she played well, or needed to do this, have more jump or speed."

"She's always taken criticism and wanted to know, not just good things, but what I really think... I've always been able to be honest with her."

Though this season is officially over, that doesn't mean the Rolands will be leaving the ice for any period of time. "I'm begging my dad to let me play with the spring league boys in Traverse City," Jenna said, adding that she and Kurt also play informally once a week in Petoskey.

As for the future, Jenna plans to continue on her current course, hoping, however, that a few more of her Boyne City friends will turn out to cheer her on. "They never come and watch me," she said. "They don't want to go to Traverse City... It's kind of a bummer." Playing for a Division I college team might soften that blow, though, if things go as planned. And then there's always the Olympics. Though she knows the odds are astronomical, Jenna can't help but dream of a chance to skate in the big show.

"That'd be so awesome," she said with a grin. "Maybe people would come watch me then. I always tell them, you can always watch me for free now, or pay later."
