Wait & see

■ State budget woes forcing area school districts to consider all options

Though area schools are bracing for the worst as preparations begin for the upcoming fiscal year, for now, it's a wait-and-see proposition.

With state budget woes calling for cuts in almost every area, per-student foundation grants will surely be among the casualties. Gov. Jennifer Granholm is recommending a prorated cut of 3.8 percent for the current year, and a much larger cut for the 2003-04 fiscal year.

Locally, the impact of such cuts could be far-reaching. "For next [school] year, everything will be open again" as a potential area to cut, said Boyne City schools superintendent Jim Cooper. "We're going to try to look at things as far removed from the classroom as we can.'

For Boyne City schools, the foundation grant cuts are especially frustrating, coming as they do on the heels of the district's own budget woes that required, in the last fiscal year, significant cuts in order to ensure the financial health of the district. "It's a

Future of BC little league depends on volunteers

With spring just around the corner, many area families are looking forward to signing kids up for their annual round of little league play. In Boyne City, though, that annual tradition is not necessarily a sure thing; according to current board members, if volunteers don't step up to the plate, the local ballfields might not see much action this season.

As it currently stands, there are four committed Boyne City Little League board members, leaving the organizauon painfully short of the volunteer manpower it needs to function. "It's at a crisis point now," said longtime board member Pam Price, in her eighth year of little league involvement. Even with the four members, the board is short of a president and league have moved on. Unfortu-

vice president, two key roles needed to continue to move forward. "Even if we have 30 board members," Price said, "with no president or vice president," the league is not allowed to be active, under Little League regula-

nately, the natural turnover one might expect has not been happening; parents of the younger players are, simply, not getting involved. "For the last year or two," she said, "we've actually had board members whose kids were too old to be playing," for lack of other volunteer help.

It's not that there's a lack of interest in playing, to be sure. According

to Price, in recent years more than 300 area kids have signed up to play each season. With only a handful of volunteers, however, the logistics of-continuing to serve those players' needs is difficult.

It's at a crisis point now."

"It's not just board members," Price said, "it's coaching, concession workers. We came to the conclusion that if people don't step up, we can't do it

The benefits of Little League reach beyond those experienced by players, according to Price.

'During All Startime, we host tournaments in Boyne, which bring a lot of people to the community," Price noted.

Already this year, the area has missed a big opportunity, with the league forced to turn down the hosting of a state tournament, due to

the uncertain future of the program. 'We were supposed to hold a state tournament this year," Price said, "but we told them we couldn't do it." The event would have brought players. and families, from all over the state

Townships asked for input on possible ambulance merger

City and township officials from Charlevoix County gathered in Boyne City last week, along with emergency services representatives, to take part in an informational meeting regarding the possiblity of creating an ambulance authority in the area. Organized by Boyne City commissioner Chuck Vondra, the meeting was the first of what proponants hope will be an ongoing dialogue about the possibilities of merging two or more of the county's four ambulance services into a single ambulance authority.

"This is the grassroots of the concept," Vondra said, opening the meet-

The concept is a long way, he admits, from fruition.

"We have talked about the issue," he said of his own perspective from Boyne City. "No decisions have been made." The idea, however, stems from a desire to assure the long-term sustainability of not only the Boyne City Ambulance Service but others in the area who face the same logistical and budgetary constraints. Exploring

the possibility was likewise endorsed by East Jordan Ambulance director Jay Peck, who has gone on record with concerns over the ability of his own service to financially sustain the Advanced Life Support care it currently provides.

"We need to find ways to increase the number of paramedics and increase the number of volunteers," Peck said. An ambulance authority, he said, may be a way to reduce costs and share resources.

While the meeting was primarily informational, representatives from ambulance services in Boyne City, East Jordan, Charlevoix, and Beaver Island all stated that they were open to taking part in further research on the authority model.

"I don't know why Charlevoix wouldn't want to look into it," said Charlevoix city manager Mike





little frustrating," Cooper said. "We made some pretty difficult decisions last year, and positioned ourselves so that we were comfortable that we were putting the district in as sound financial shape as possible." Now, he said, "through no fault of ours, we'll be told, not asked, to cut X amount of dollars," somewhere, he speculated, in the vicinity of 11.8 percent.

Part of the problem, he said, is that any amounts are, at this point, purely speculative. Though the governor will present her proposed budget in March of this year, legislators technically have until September to finalize it.

With the "difficult decisions" they're going to have to face, Cooper said, "I honestly don't see that happening before September."

In the meantime, school districts must present their own budgets in June. "We'll be proposing a budget without knowing what the revenue is going to be," he said. "Everyone is conscious of that.'

In East Jordan, schools superintendent Chip Hansen is, along with staff, addressing the same issues, though from a slightly more comfortable vantage point. For the current year, the East Jordan School District expects to maintain a balanced budget, even with the prorated cuts.

"We had a surplus \$65,000 built into this year's budget anyway." Hansen said. "We typically budget revenues conservatively, and expenditures liberally.

That kind of proactive thinking is good news for East Jordan schools, but, Hansen said, that doesn't mean that for the upcoming year there won't be some tough issues as the budget process moves forward.

"There's no question there's going to be belt-tightening," Hansen said. The plan, he added, is to keep cutbacks confined "to areas that don't have a direct impact on the classroom. That is the highest priority for East Jordan Schools.'

Though Hansen is confident that the district is in a good position to deal with the situation, it's certainly not the scenario he hoped to see going into the 2003-04 budget

process. "[Previously] we were expecting that next year it would be highly likely that the foundation grant would be frozen," he said. 'Obviously, our fixed expenses would go up, and we'd have to tighten our belt to some degree." Now, Hansen said, a simple freeze "could be our best case scenario." And one that's not likely to come to fruition. "Either way," he said, "we'll certainly do our best to keep our programs and keep our people from being affected directly.'

For Boyne Falls School, a 3.8 percent prorated cut for the current fiscal year would mean a reduction of funding to the tune of about \$31,000 for the school, with a future cut of 11.8 percent translating to \$91,000 less than the current year for 2003-04. "That's very significant," said Boyne Falls superintendent Mark Parsons. "A lot of schools are going to have to be very creative in how they calculate out next year['s budget].

For his part, Parsons is looking at holding open planning sessions with the school board in order to get community input, as well as hosting town meetings to "explain where we're at and prioritize things.

"Everything," he said, is "being considered now. It has to be.'

In Boyne City, Cooper said that while various routes of action are being considered, last year's round of cuts put the district in a position of making a decision about "how much further do we go with cuts.

how much do we try to rely on fund equity?"

"Fortunately, we do put money in a fund equity to rely on for these times," he said. "I think every school district in Michigan is facing [the possibility of tapping into that equity]."

While in the coming months, the budget process will examine "absolutely every line item" for possible cuts, in reality, Cooper concedes, "in some areas, you can only cut so much without affecting programs.

Ultimately, he believes, the district's proposed budget will be a "fine balance" between cuts and tapping into fund equity,

East Jordan, too, is in a unique position, having last fall passed a \$7.9 million bond issue for expansions and renovations of their three existing school buildings. Consequently, areas such as capital outlay may be easily reduced in the coming years, with the bond issue covering things like building improvements without drawing dollars out of the General Fund. "We'll be able to capture a lot of capital outlay dollars right out of the get-go, without affecting the upcoming year.'

Hansen also has other hopes for the future of his district, based on encouraging signs from previous years. "The advantage we will have is that our district is a growing district," he said. "Hopefully, our district will continue to increase.

Earlier in the week, the Red Devils traveled to Glen Lake and it might have been the long trip that had an impact on their play as they lost 68-47.





"It is a lot of money for the community," Price said of the revenue generated by the tournaments. "Last year we held three [in Boyne City]. We had people from Traverse City, Grayling. Some stayed in town. A lot of people camped. It did impact the community."

"What does the City of East Jordan have to gain and the townships [who are already served by East Jordan EMS] have to gain?," said Bob Christensen. "We have a good ambulance service over there.

"Basically," answered Peck, "it's sustainability. We have two full-time paramedics. To continue operating ALS, we need more full-time staff. We have the same concerns as Boyne

Ultimately, though. Vondra told those attending that we "don't have

all the answers tonight." East Jordan commissioner Jerry Cihak, who has been appointed to represent the City of East Jordan on a committee to research the ambulance issue, added that the only committment they're looking for now is whether or not all involved parties want to take the next step in researching the possibilities. 






Sound performances


