Motel a possibility for downtown EJ

When snowmobilers ride the Jordan Valley Trail, many of them must start and end their day someplace other than East Jordan.

Although the trail runs through the community, which welcomes the sport, there are currently only 19 overnight rooms available at two small motels and one bed and breakfast, according to the East Jordan Area Chamber of Commerce.

A group of local investors is hoping to change that. They have a purchase option on downtown property with plans of constructing a 50-room motel. A professional feasibility study says it can be done.

The vision involves building a locally-owned motel where people can stay for an affordable rate and still enjoy amenities such as an indoor pool, a view of Lake Charlevoix's south arm, in-room jacuzzis, a warm and friendly common space where multiple guests can visit in front of a fireplace, conference and banquet facilities, and a catering kitchen.

The property under option by the group is 4.5 acres at the end of Main Street, between the East Jordan Coop and B.C. Pizza, and at the head of the Jordan Valley Snowmobile Trail. Known as the Thorsen Property, the land once housed a lumber company and has been vacant since the aging building was demolished. The main question involved in developing the land is: Can it hold the weight of the new structure? The property is wet and has a marsh-like quality as it reaches out where Lake Charlevoix's

Melrose fire hall plan finds support

Melrose Township officials presented a proposal for a new township fire hall at a special meeting last week. The plans, said township supervisor Mike Webster, met with resounding approval from the 35 or so residents present.

The proposed fire hall would build upon the current fire hall, located on M-75 in the village of Walloon Lake, including a 5,900-square-foot addition, which would bring the total square footage to about 8,300. The addition would include two new firetruck bays, a 55-foot by 25-foot meeting/training room facility, basic kitchen facilities for small community functions, two offices for the township and one for fire service. The plans also include space for the Walloon Post Office to continue operation until a permanent location is secured.

In total, the plans will require the township to take out a low-interest loan for \$987,000 to be paid over 30 years with a voted millage, anticipated to be a maximum levy of 1 mill. This, Webster said, would translate to about \$50 per year for a taxpayer with

\$100,000 of taxable property value. The amount, he added, may be reduced further depending on additional grant money, and possible project cost reductions. The tax levy is evaluated annually, and only levied to the extent necessary to service the debt.


The need for an expanded fire hall, according to Webster and township fire chief Dennis Howard, is undeniable. "We were in need mode," Howard said, even before the post office took up residence in one of the bays after losing the lease on its own building last year.

Currently, the fire department is storing fire apparatus off-site due to lack of space, and the existing meeting/training room doesn't provide adequate space for many of the group activities required by emergency services, including homeland security training and usage. Additionally, the township is currently without an actual meeting hall, which has been designed into the fire hall plans being



Van Dam Wood Craft's first apprentice completes program

Chad James was 14 years old the summer he started working at Van Dam Wood Craft in Boyne City. He swept floors, oiled jackstands, sanded boat bottoms, and did all the things no one else wanted to do. If there was a dirty, no-fun job, Chad was the man.

He worked after school that year, and was back full-time the next summer. After a while the jobs got more fun, and in his sophomore year at Boyne City High School he built his first boat, an eight-foot classic pram, in his spare time for an industrial arts project. The boat won the Grand Award in Grand Rapids at the State Competition of the Michigan Industrial Technology Education Society.

Chad continued to work for Van Dam throughout high school and during the summers, and after a year away at college he decided to come back and enter full-time into the Apprentice Program at the facility. The four-year, 8,000-hour apprenticeship includes basic woodworking and machinery skills, as well as skills specific to wooden boatbuilding, such as design and lofting experience and cold molding techniques. Outside education classes are also included in such things as metalworking, welding, drafting, etc. Several texts specific to boatbuilding and American Standards for Boatbuilding are required reading as well. Students are ex-

pected to show proper use of shop equipment including safety, and build a project each year on their own. The first project is a "proper" tool tote, and

the student is expected to equip it during the four years with hand tools

Besides building his pram, Chad

has built some exquisite furniture for his own home, and a tool tote that is admired by all who see it. He is now considered a skilled boatbuilder, and manages a "team" of apprentices who are building a 35-foot custom cruiser, one of three projects going on at Van Dam's.

Chad also has the distinction of being the first apprentice to complete the Apprentice Program. Several years ago company president Steve Van Dam was searching for skilled employees, and had a difficult time finding qualified people. He decided it was time to train his own work force and spent many hours researching and developing the Apprenticship Program for Boatbuilders.

At this time there are six trainees working with the skilled builders, each at a different stage in the program. Van Dam hopes they will stay with the company afterwards, but feels that it is important to the craft of boatbuilding to plan for its future needs.







Many hands

They say many hands make light work; in the case of the Boyne City drama department, a solid core of longtime volunteers combined with an evergrowing crop of new ones ensures, at least, that the work will be fun. As students prepare for the rapidly approaching opening night of their spring production of Peter Pan, a group of hands-on volunteers toils behind the scenes to create, well, the scenery.

According to long-time volunteer Anne Thurston, the weeks of labor are anything but work. A retired art teacher, Thurston, who works on the sets alongside husband Ed, calls the experience her "vacation."

"We just have a ball," she laughed while munching a doughnut on a welldeserved moment of leisure last weekend. There aren't, too be sure, too many leisurely moments as set-builders undertake the monumental task of creating a multitude of fanciful scenes for the Broadway tale of a boy who refused to grow up. Indeed, behind the stage on Saturday morning, as cast members rehearsed scenes under the direction of drama department head Bob Wollenberg, every comer of available space was buzzing with activity, from painters to builders to seamstresses, all focused on the task at hand. Retired art teacher Chuck Britton quietly directs the activity, moving from one task to the next, making suggestions and giving instructions where needed. Britton has been responsible for many a set for the high school drama crew, creating miniature models of his artist's visions months in advance of the actual production.

This year, Britton's vision has been given a much bigger canvas, with the opening of the 600-seat Boyne City Performing Arts Center, complete with professional sized stage, flown rigging for raising and lowering sets, and plenty of space backstage for set construction and storage. Said Thurston, "This year, we're building sets to last. In the past [when the productions took place at the elementary school cafetorium], we just had to throw them away."

The volunteers' hard work doesn't pass unnoticed. "We have a wonderful group of volunteers," said director Wollenberg. "We couldn't do it without them."

Tickets are still on sale for the production, with shows scheduled for March 14, 15, 21, and 22. Prices are \$5 each, or \$10 for patron tickets which include a donation to the drama department.

On March 11, at 7 p.m. the Boyne City Commission will be holding a meeting at the city hall to discuss Greg Krueger's right to encroach on Boyne City riparian rights. most southern section ends.

Recent results of the final phase of the feasibility study show that the investors can move forward. They plan to use a technique being utilized across the street at the Main Street Center to stabilize the building. The method involves drilling eight-foot-long screws into a deeper, firmer section of the earth to serve as a base for the foundation.

With professionals telling the investors that the community can support a 50-room motel, as long as it is tied into a national chain reservation service, and soil borings showing that development challenges are surmountable, the investors are planning to increase in number and financial commitment. Until now, each has contributed \$1,000. To purchase the property, the ante will increase to about \$10,000 each to help cover the down payment on a project that's expected to cost about \$3.5 million. The core of the investors group was formed three years ago with hopes of putting a theater downtown. However, preliminary research showed that small, hometown theaters struggle when competing with multi-screen facilities, such as those located in Gaylord and Petoskey.

Since the investors' goal has always been to invest in the downtown, Worgess said the members were refocused when hearing of the community's need for overnight accommodations.

"We all want to contribute to the overall growth of the community," Worgess said. City manager David White believes a new motel would do just that.

"The motel would change the whole complexion of the community," he said. "It's going to allow people to stay in town and help other businesses. It would be a great addition to the renaissance of the downtown."

East Jordan Economic Development Coordinator, Rod Benson, has been working with the investor group.

"The success of putting together the Main Street Center project bolstered our confidence that we could put together something in terms of a motel on that property," he said. "A successful motel will be extremely beneficial because of the number of new dollars it brings into the community." Benson estimates that a 50-room motel with a 60 percent occupancy rate could generate \$2 million a year

The plan, to be sure, has been carefully thought out. The process, said Webster, began more than a year and a half ago, with research being done on several locations in the village as possible sites for a new fire hall. With an initial site on the waterfront rejected by community members, officials "pulled back from that and regrouped," Webster said, focusing then on potential improvements at the current fire hall location.

One priority, Webster said, was to keep the fire hall within the village limits. "You want the fire department close to the most dense population," Webster said. Additionally, Howard noted, "you want it visible, to encourage mem-

If all goes as planned, the new fire hall proposal will go in front of residents as a bond issue, tentatively set for May 13. If the bond passes, work on the hall could start as early as July. "A lot depends on getting bids in from builders," Webster said, adding, however, that the goal is to start construction this year and be in operation by the spring of 2004. "It's definitely a front-burner issue."

Melrose Township residents and businesspeople are invited to take a look at the proposed plans at the current township fire hall. The office will be open through Friday, March 7, Monday through Friday from 8-10 a.m. The plans, additionally, will remain in the office until the bond issue. For more information, call 535-2310.





Middle school skiers wrap up the season




