### EJ to host sidewalk sales this weekend

East Jordan merchants will welcome the summer season with the annual Memorial Day Sidewalk Sales, scheduled for Friday, May 23, and Saturday, May 24, from 10 a.m.-5 p.m. each day.

The Harvest Barn Church will be on hand cooking hot dogs and brats downtown on Friday, May 23, from 11 a.m.-1 p.m., and Good Times Amusements will bring family fun to town on Friday and Saturday.

In conjunction with sidewalk sales, the Jordan Valley Freedom Festival will have a booth set up downtown on both Friday and Saturday, selling commemorative buttons and Festival 500 raffle tickets. Both Friday and Saturday are also Freedom Festival Canister Days, with local businesses competing to see who can collect the most donations to benefit the festival.

The East Jordan Rotary will get in on the action of the weekend with their annual garage sale, to be held Friday, May 23, and Saturday, May 24, from 9 a.m.-5 p.m. each day at the East Jordan Tourist Park beach house.

Proceeds from the sale will benefit local scholarships.

Rounding out the weekend, of course, is the annual release of the Nijjiwa Floats — glass globes bearing the names of local veterans — at the bridge in downtown East Jordan, courtesy of Jordan Valley Glass Works, which will take place throughout the Memorial Day weekend.

## Offering choices

### Boyne City Elementary to offer half- and full-day kindergarten options

Having received support from the Boyne City Board of Education last week, officials at Boyne City Elementary are proceeding with plans to offer both full- and half-day kindergarten options, as well as a Young Fives program, for the 2003-04 school year.

The plan, the result of interest surveys of parents conducted in recent years, was presented to the board by Boyne City Elementary School principal Fred Sitkins, with support from schools superintendent Jim Cooper, who noted that from a fiscal point of view, the program is feasible. To implement the program, the addition of one staff member will be necessary, utilizing an even split from Title funds and General Fund dollars. With that one staff member, Cooper said, "we'll be able to cover the Young Fives and the kindergarten programs."

"Strictly from a budgetary standpoint, it will work," Cooper said. "The question is, is it the direction we want to move in? Educationally," he added, "it's sound."

Sitkins noted that several other lo-

cal schools, including East Jordan, Charlevoix, Concord Academy Boyne, and Boyne Falls, offer all-day kindergarten programs, an option that's become more and more desirable for families with single parents or two-job households. "There is an expressed need in the community," Sitkins said. "We've heard this for years."

In speaking with other districts that offer the full-day program, Sitkins noted, "every district who has it very strongly supports how much it does for kids and how much it helps families."

Still, Sitkins acknowledged, full day kindergarten may not be the right option for everyone; keeping that in mind, the district will continue to offer the traditional half-day afternoon kindergarten program. "This program will serve as an alternative for parents who may feel that the full-day kindergarten experience does not serve the best interests of their child or family," Sitkins said.

GARRETT'S ON WATER STREET BRINGS  
FINE DINING, AND MORE, TO BOYNE CITY

## Making it new

For Chef Garrett Scanlan, proprietor of the now-open Garrett's on Water Street, it was love at first sight.

"When I saw the building, it immediately told me I can do [all of the things he wanted to] under one roof," Scanlan said of the former Stafford's One Water Street.

With a low-key opening last week, Scanlan's dreams have been realized; the current incarnation, however, is just the beginning.

Diners at Garrett's can enjoy an eclectic global menu in two rooms at present, either in a cozy Irish pub atmosphere or the breezily inviting Bistro room. Opening in June is the high-scale Commodore Room, which will offer fine steak and lobster dining in

a reservations-only atmosphere.

Exclusivity, however, is not what Garrett's is about. In fact, in the pub and the Bistro dining room, reservations aren't taken.

"Whether you're a prince or a pauper, if you get here late, you stand in line," Scanlan said with a laugh. The aim of the restaurant, both in atmosphere and pricing, he noted, is to be "inclusive to all. It's important that the people of the community accept this as theirs."

Inclusive, of course, doesn't mean that the restaurant aims to serve just its home community. Scanlan, a classically-trained chef who's trained the world over and worked in some of the

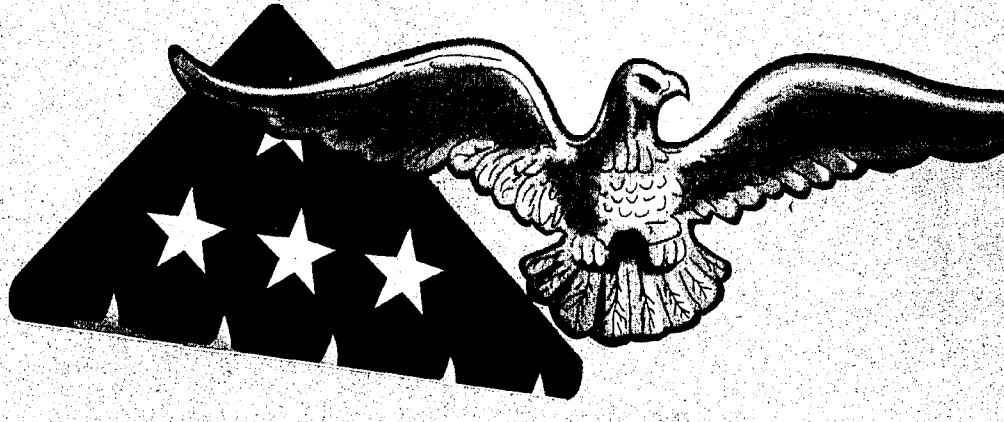

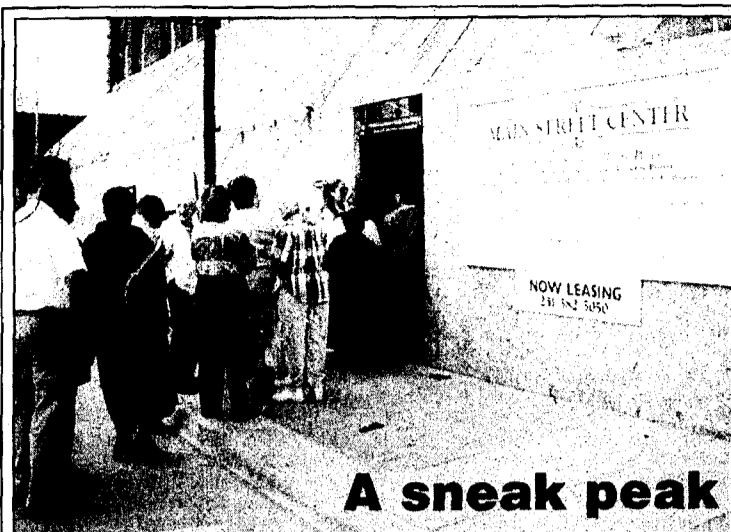

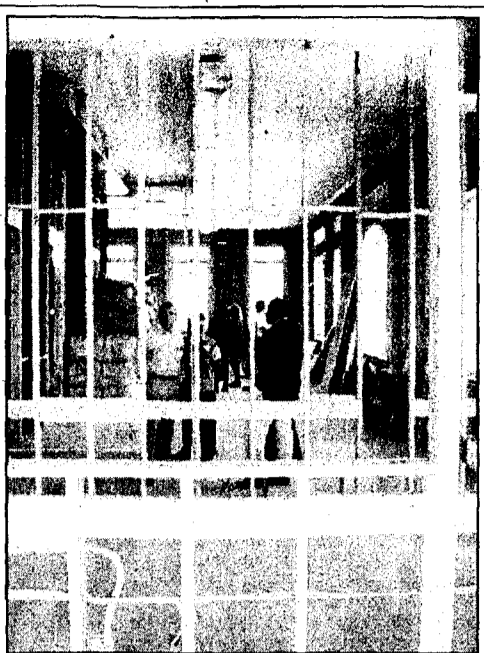

## Main Street group presents to MEDC

### Boyer City representatives head to Lansing in bid for state assistance

With the competition for Main Street program assistance narrowed to 10 communities, representatives from Boyne City were feeling the pressure as they left early one morning last week for Lansing to present to the Michigan Economic Development Corporation's Michigan Main Street selection committee.

According to city man-

ager Mike Cain, who was one of the six individuals chosen to represent the City in Lansing, the group had an hour overall, which included a 40-minute Power Point presentation, and 20 minutes to answer queries from the committee.

"They were peppering us with questions," Cain said. "We did pretty well, we thought."

"They seemed interested. They asked a lot of questions relevant to our presentation."

The trip to Lansing required some quick preparation on the part of the committee, made up of Cain as well as DDA chairperson Jodie Adams, Boyne Area Chamber director Scott MacKenzie, city commissioner Vicki

Standen, and local businesspeople Mary Campbell and Bruce Jansen. All members of the Main Street program effort initiated in recent years in Boyne City, the group had just completed its application for the state Main Street assistance last month.

Having made the first cut from an initial 17 applica-

tions, Boyne City is one of 10 communities currently being considered for the help, which comes from the new State of Michigan Main Street Project in the form of technical assistance.

Other communities up for the grant include Calumet and Calumet Township (joint submission), Clare, Escanaba, Linden, Marshall, Mount Clemens, Muskegon, Niles and Portland.

Four communities will ultimately be chosen in June to participate in the program.

Main Street is a downtown revitalization program, offering intensive, year-round training in downtown revitalization strategies designed to create more jobs and investment in Michigan's downtown communities.

The program was initiated in 1980 by the National Main Street Center.

## BC Kiwanis to hold rose sale

Just in time for graduation, Boyne City Kiwanis is holding its annual rose sale. Roses in red, pink, white, or yellow can be ordered from any member of the service club until May 23; roses will be ready for delivery on June 5.

The cost is \$20 per dozen.

In the four years since the local club began they have sponsored and supported a Builders Club in the middle

The official flower of the 2003 BCHS graduating class is the yellow rose.

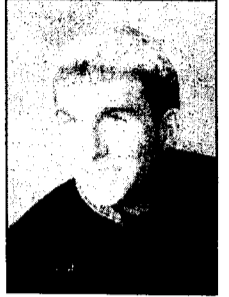

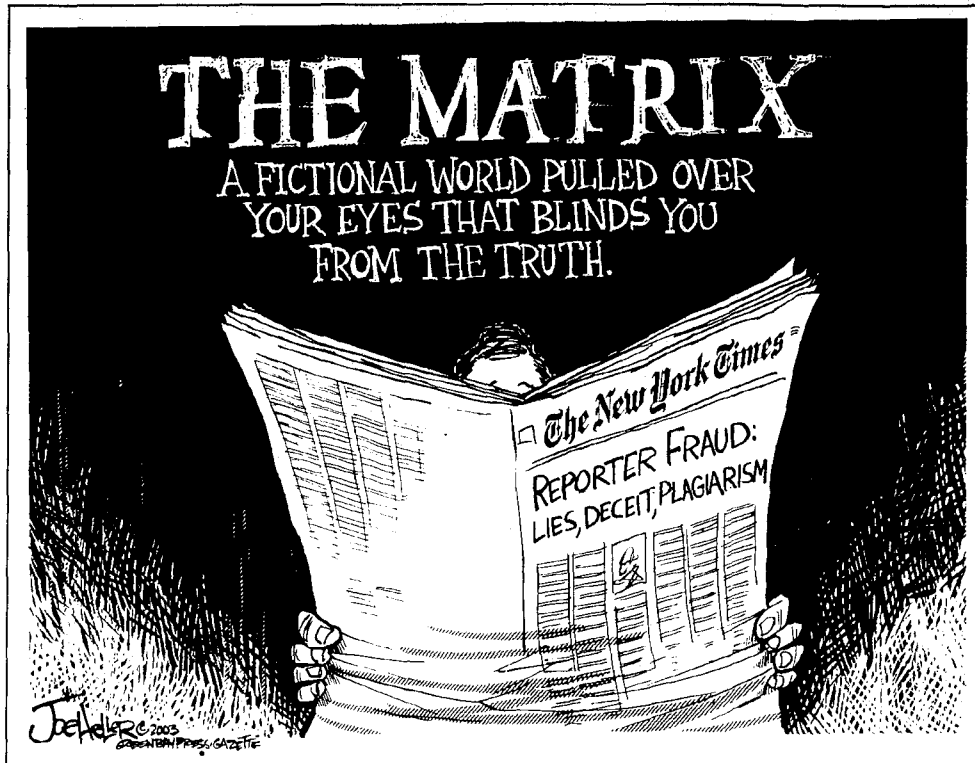

cially underway.

The auditorium, said schools superintendent Chip Hansen, "will undoubtedly become a community centerpiece." The structure will include in its foyer a special seating area, featuring six of the original wrought iron and leather seats from the Old Temple Theater, donated by the City of East Jordan.

In addition to the 500-seat auditorium, the construction project, which is expected to be completed by the fall of 2004, includes additional classroom space and infrastructure upgrades at the elementary, middle and high schools, to accommodate increasing enrollment as well as a desire to increase offerings to students.

A \$7.9 million bond issue to support the project was passed by voters in September of 2002.

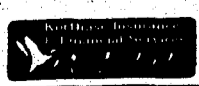

## A close second

■ Rambler girls two points out of first in regional track meet

The Boyne City girls track team came within two points of winning a regional championship last Saturday when Manistee edged out the Lady Ramblers 66.75 to 65 to win the title at East Jordan.

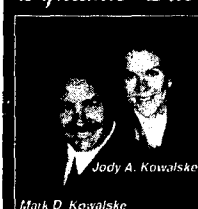

**CITY OF BOYNE CITY COUNTY OF CHARLEVOIX ENACTMENT OF AMENDED FIREWORKS ORDINANCE**

At a regular meeting of the City Commissioners of the City of Boyne City, County of Charlevoix, Michigan held on May 13, 2003, at 7:00 p.m., an amendment to City of Boyne City Ordinance A-60, Fireworks Ordinance, was enacted. The following is a synopsis of that amended ordinance:

**Amendment to the FIREWORKS ORDINANCE CITY OF BOYNE CITY, MICHIGAN**

An Ordinance to protect the health, safety and welfare of the in-habitants of the City of Boyne City by regulating the sale and use of fireworks within the City: To fix penalties for violation hereof: And to repeal ordinances in conflict herewith.

**THE CITY OF BOYNE CITY ORDINANCES:**

**Sec. 1. TITLE**

This Ordinance shall be known as "The Fireworks Ordinance" and the short title of this Ordinance shall be "Fireworks Ordinance".

**Sec. 2. FIREWORKS DEFINED**

The term "fireworks" as used herein means any device made from explosive or flammable compositions used primarily for the purpose of producing a visible display or audible effect, or both, by combustion, deflagration or detonation.

**Sec. 3. FIREWORKS PROHIBITED BY STATE LAW.**

No fireworks shall be sold or used within the City of Boyne City which are at any time prohibited to be sold or used under the provisions of any law of the State of Michigan.

**Sec. 4. PERSONS UNDER 18.**

No fireworks, whether or not permitted by State Law, shall be sold within the City of Boyne City to or by any person under the age of 18 years.

**Sec. 5. USE OR POSSESSION ON PUBLIC PROPERTY.**

No fireworks shall be used, possessed or carried upon any public property by any person regardless of age within the City of Boyne City, including but not limited to streets, public parks, and beaches except "public fireworks" which have been authorized by special permit from the City Commission under the authorizing provisions of the Michigan Fireworks Act, MCLA 750.243a, as amended.

**Sec. 6. USE ON PRIVATE PROPERTY.**

Only those "fireworks" defined in Section 2(c) above may be used on private property. No fireworks shall be used on any private property by any person regardless of age without the permission of the owner of the property if the property is unoccupied or by the legal occupant of the property if the property is occupied by a legal occupant.

**Sec. 7. HOURS PROHIBITED.**

The use of fireworks shall be prohibited within the city limits of the City of Boyne City between the hours of 12 midnight and 7 a.m., except any "public fireworks" displays which have been authorized by special permit from the City Commission under the authorizing provisions of the Michigan Fireworks Act, MCLA 750.243a, as amended.

**Sec. 8. POSTING ORDINANCE.**

No person, firm or corporation shall sell, offer for sale or give away any fireworks in any store or other sales place unless it shall post a copy of this Ordinance in a conspicuous place clearly visible to and readable by customers.

**Sec. 9. REPEAL.**

This Ordinance shall be deemed to repeal any ordinance in conflict herewith.

**Sec. 10. EFFECTIVE DATE.**

This Ordinance shall be effective on May 28, 2003.

**Sec. 11. PENALTY.**

a. Any person who violates any provision of this Ordinance is responsible for a municipal civil infraction, subject to payment of a civil fine pursuant to the City of Boyne City Municipal Civil Infraction Ordinance, as amended, plus costs and other sanctions, for each violation (as authorized by Section 24 of Act 184 of the Public Acts of Michigan of 1943, as amended, the City of Boyne City Municipal Civil Infraction Ordinance, and other applicable laws;

b. Repeat offenses under this Ordinance shall be subject to increased fines, as provided by the City of Boyne City Municipal Civil Infraction Ordinance, as amended;

c. Each day in which any violation of this Ordinance occurs or continues constitutes a separate offense, subject to separate sanctions. The paying of a fine or sanctions under this Ordinance shall not exempt the offender from meeting the requirements of this Ordinance;

d. To the extent any person violates any provision of Michigan's Firework Act, MCLA 750.243a concerning Class B or Class C fireworks, or any provision of MCLA 750.243a, et. seq., as amended, that person shall be guilty of a misdemeanor, punishable pursuant to the provisions of Michigan's Penal Code, as amended.

country's finest restaurants, is looking to make the venue a "destination restaurant," not only for folks all over the state, but beyond. Boyne City, he said, is the right place to do it. A longtime resident of northern Michigan, Scanlan and, particularly, his wife Stella, are no strangers to all things Boyne. Both natives of Ireland, Stella was born in Beaufort, a town on the River Boyne.

With his culinary career taking them to various points, including London, Paris, and Switzerland, Scanlan eventually landed in charge of the kitchen at the Charlevoix Country Club, as executive chef and food and beverage director. In northern Michigan, the

Scanlans found home. "We fell in love with it immediately," he said.

After parting company with the country club, Scanlan knew it was time to find a place to foster his own vision.

Reviewing several opportunities, including locations in Florida, Arizona, and Chicago, "a friend approached me and said that [the Water Street restaurant] was available."

"I cobbled together every penny I could," Scanlan said, smiling. In the process of piecing together his vision for the property, Scanlan has created 60 new jobs, employing mostly local residents for positions from waitstaff to management.

Certainly, Scanlan's vision included customers accessing the restaurant from the water, via docks proposed by property-owners Greg Krueger and Joe Thomas.

As most area residents are well aware, the dock proposal, which originally involved an encroachment into city riparian area,

caused an uproar among some residents, and is under review. Though the dock construction has been delayed, Scanlan hasn't abandoned his hope for water-driven business. "My expectation is that those docks will be realized," he said.

"My long-term feasibility will certainly be realized somewhat on that regard."

The furor, which might have spooked a more cautious soul, left Scanlan unruffled. "I'm a believer," he said.

That belief is, so far, paying off. Despite a May 13 opening decidedly devoid of hoopla, Scanlan said that on the restaurant's second day, "we did more than 200 dinners."

With a menu featuring plenty of seafood, pasta, and global flavors, Scanlan is proud of the fact that "everything is made in house, the pate, the terrines... we bone our own ducks."

It's just one of the ingredients, he said, to creating what he intends to make the "best restaurant around."

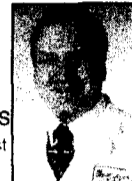

Still, it's clear that the subject is an emotional one for many parents. With parent surveys coming back showing 60 percent in favor of full-day kindergarten, and 40 percent in favor of the traditional half-day program, Sitkins said "the comments were very emotional on both sides." Offering both full and half day programs was a cause for concern for some, too, at last week's regular Board of Education meeting, regarding the potential discrepancy in student performance if some students are attending full days while others are attending half-day kindergarten classes. "You can't be everything to everybody," said school board trustee Marty Moody. "You can hurt yourself if you

give too many choices." "If we're leaving in the half-day [option] just to phase it in and save a couple of dollars, [maybe] we're not approaching it in the best possible way we could. I'd hate to see a huge discrepancy down the line because we tried to appease everyone at the same time."

Performance discrepancies going into first grade, however, have not been a major factor for other schools giving the full- or half-day options, Sitkins said, noting that most who choose the half-day are those with a parent home during the day, who is typically providing the social interaction the full-day students receive.

In addition, in this, the second year of the elementary school's Extended Day kindergarten program (which of-

fered an extended school day at a cost to parents), students entering first grade haven't been seen "achieving at a much greater rate" than their counterparts who chose not to utilize the extended day program.

The full-day, half-day choice, Cooper added, is built into the program because surveys did not indicate an extreme preference one way or another, but were rather more evenly split. In a survey taken four years ago, Cooper said, the interest was 50/50. "Now it's 60/40. This way, we meet everybody's needs," he said.

The full-day program, Sitkins emphasized, does not include a more intense curriculum but rather more interaction time for teachers and students, a point which the school's two kindergarten

teachers echoed. Said kindergarten teacher Sheri Fitzpatrick, "The thing I like about all-day kindergarten the most is having more time to just listen to the kids." Full-day kindergarten, said teacher Julie Hase, "is not just skills all day... it's not our goal to ditto those kids to death," but rather include "more of the hands-on things we're finding we cut [with a half-day program]."

In the interest of providing families with even more options, the district also presented plans to implement a Young Fives kindergarten program, designed as a developmental year for children not yet ready for kindergarten.

According to Sitkins, that can mean either children whose birthdays fall later in the year, or those who simply need more time to develop the academic, so-

cial, emotional, or fine motor skills necessary for success in the traditional kindergarten program.

Students for the Young Fives program will be selected based on recommendations from preschool, Be-Four or Head Start teachers, assessments and observations during Kindergarten Round-Up, and/or parental choice.

Ultimately, the board decided, choices are what parents want in the increasingly competitive world of school enrollment.

"If we don't have a full-day [program]," Moody noted, "that's where we're losing students." Though the board did not take official action on the proposal, they reached a consensus to support moving forward with the plan. For more information, call Sitkins at 439-8300.
