Early-morning fire damages BC home

A major structure fire roused Boyne City firefighters from their sleep early Saturday morning, when they were called to put down the flames at 410 Hemlock

Carol and Ken Bartley live in the house, but were gone at the time of the fire. It is believed they were vacationing in the Upper Peninsula.

"The house was fully engulfed when we arrived," said Fire Chief Dennis Amesbury, "It was a major fire."

A passerby called the house fire in just after 2 a.m. Saturday and the Boyne City Volunteer Fire Department personnel responded, with mutual aid called in from Boyne Valley Township Volunteer Fire Department. Amesbury said the help was useful because it was a warm evening, causing the fire-fighters to grow weary throughout the nearly four hours it took to extinguish the flames.

"They helped us with the manpower, putting out the hot spots," Amesbury said.

Once the fire crews arrived, Amesbury said several fire-fighters entered the burning home for an internal attack on the fire, and also to determine if anybody was home. He added that no people or pets were found inside.

Neighbors reported that at least one car was missing from the driveway and officials later learned that the family was vacationing in the Upper Peninsula.

No firefighters were injured while battling the house fire, which resulted in a "substantial" loss," Amesbury said. Half of the roof was destroyed and the inside of the home was gutted, he added.

The fire crews cleared the scene at 5:45 a.m. Saturday.

"From the looks of it when we arrived, we thought we were going to be there longer than we were," Amesbury said.

The fire appears to be caused by an electrical malfunction, Amesbury said, but the investigation is still ongoing.

MARY JASON RESIGNS FROM EJ SCHOOL BOARD

The end of an era

Mary Jason spent the last quartercentury at the helm of the East Jordan School Board, but resigned last week to end an era of Porter-family

leadership in the school district. "It was just time to do this," Jason said.

Jason is the fourth family member to serve as board president, following her father, William A. Porter, her grandfather, Howard Porter, and her

great-grandfather, William P. Porter. During the board meeting on July 19, she said her resignation was nec-

essary because of ongoing conflicts with her position as the director of alternative programs for Boyne City

Public Schools. Her tenure would have ended in June 2005.

"She's been an outstanding public servant in our community, always looking out for our students and doing what's best for them," said East Jordan Superintendent of Schools Chip Hansen, adding that she would

Kevin Keane was elected president of the board later in the meeting, with Debra Bartlett as vice-president, Deborah Manville as treasurer and Korinna Holt as secretary.

Jason said she will miss the dayto-day contact with the happenings in the East Jordan School District, but is confident that the new board president will do the job well.

"It's been a good board," she said. During her time as president, the district built a new high school and made major renovations to the middle school and elementary building. Jason said that all this was done without stable state funding and yet in a fiscally responsible way.

"It's been a challenge to keep the numbers in the black," she said.

Jason said that beyond upgraded facilities, the technology now available to students and faculty propels education in ways she would never have guessed when she was first elected to the board 27 years ago.

"Over that period of time, there have been a lot of students to graduate and then go off into the world to be successful," Jason said.

Hansen said the district was already advertising the position, adding that he is confident there would be seyeral qualified and dedicated community members interested in filling the vacancy on the board.

■ Voters head to the polls Tuesday for primary election

The primary election on Tuesday, Aug. 3 will bring an end to the hotly-contested GOP race for the Charlevoix County Prosecutor, as well as nailing down the Republican and Democratic candidates for state representative in the 105th District.

Republican candidates John A. Jarema and incumbent Mary Beth Kur are facing off for the county prosecutor's position, which has no Democratic candidate vying for the job. The GOP candidates are wellknown to each other, with Jarema being fired as an assistant prosecutor under Kur, followed by a lawsuit and out-of-court settlement.

Jarema and Kur's biographical information can be found on page 5.

In the primary race for the 105th District seat in Lansing, six candidates are seeking their party's nomination.

On the GOP ticket, Jack Apol, Kevin A. Elsenheimer, Bonnie Nothoff and John Ramsey are all running, while James A. McKimmy and Greg A. Dean are the only Democrats seeking the seat, which is now held by Gaylord Republican Ken Bradstreet, who cannot run for re-election because of term limits.

Apol is a professor at Michigan State University College of Law and lives in Charlevoix, while Elsenheimer is an attorney who lives in Bellaire. Nothoff works as a dental hygienist and lives in Kewadin, and Ramsey, of Charlevoix, is a former businessman. Ramsey is best known as the father of six-year-old JonBenet Ramsey, whose murder was a major national news story in the 1990s.


McKimmy, of Rapid City, retired from public education in 1997 after 37 years as a teacher, principal and superintendent. Dean is a business owner who lives near Boyne City.

Main Street ready to put market study into action

The Boyne City Main Street program will hold a celebration rally next week to tout the completion of the Downtown Boyne City Market Study and kick off the action phase.

Kelly Larson, program manager of Boyne City Main Street, said the rally would focus on the first steps for the plan's implementation. The "Jump Start Rally" will be from 6:30 to 7:30 p.m. Tuesday, Aug. 3, at the Wolverine Dilworth Hotel, 300 Water St.

"Boyne City Main Street committees and volunteers are already springing into action, getting a head start on various projects and strategies promoted in the plan," Larson said.

Jay Schlinsog of Downtown Professionals Network will assist at the rally, as well as a representative of Batavia, the Illinois-based consulting firm that helped Boyne City Main Street complete the study.

"The rally is intended to facilitate the transition from planning to action," Schlinsog said, "We'll review the study's implementation strategy and discuss its relationship to current Boyne City Main Street committees and projects, with an emphasis on first steps toward both short and long-term goals that are advanced in the study."

Schlinsog said that the strategy looks up to 10 years into the future, while some projects would be more quickly achieved. He added that it is important to promote an understanding of how today's actions would impact longterm downtown revitalization goals.

"We all understand that we cannot, and probably should not, change things overnight. But we must begin to take action now to build on downtown Boyne City's strengths, promote quality design and recruit quality businesses that will incrementally help the community produce longterm, sustainable improvements," Schlinsog said.

"We were inspired by the high level of participation, ingenuity and creativity that Boyne City residents brought to the market study process," Schlinsog said. "That same spirit and a heightened commitment will be required now, and for the long term, as Boyne City dives into the implementation phase."

Larson said volunteers in Boyne City are taking the approach to heart.

"Our opportunities to make positive change happen and to realize success will be directly dependent on our continued ability to involve community leaders, business people and residents in the important decision-making process and throughout all phases of implementation," she said, adding that they will work to keep the community informed and attempt to get more people involved.





- the Wolverine-Dilworth Inn. The couple recently moved to Boyne City, bought the historic landmark in the downtown area and opened the Library Bar and Grille this month to a warm welcome Famularo said. from the community.

"We want to bring this place back. It's been neglected for too long and we're very happy to be here," Christensen

The three-story brick building was constructed in 1911 and opened on Feb. 1, 1912 as The Wolverine Hotel, serving as a popular gathering place through the 1920s and '30s. It was purchased in 1935 by Wesley Dilworth and renamed The Dilworth, where the annual Smeltania Ball was held for many years.

Today the site is registered as a National Historic Building and basks in the claims that famed writer Ernest Hemingway frequented the hotel, even spending his second honeymoon in one of the suites.

Today the new owners live upstairs with their pets, including their 11-year-old golden retriever Lucy, often found sleeping comfortably on the cool tile floor of the

Famularo, 35, is originally from Waterford, near Detroit, while Christensen, 30, comes from a small town near

San Diego. He said that northern Michigan suits him per-

"I love it. It reminds me a lot of home – a small town with great people," Christensen said.

Neither of the new proprietors has ever owned a business before, but both say they enjoy the challenge of re-

storing the site and rejuvenating the historic building. "We love this building, just like everyone else,"

For now, the restaurant and bar are open from 11 a.m. until close, Tuesday through Sunday, for lunch and dinner. Famularo said they're happy to have several repeat customers, especially in their first week of business.

"It's been a little slow, but we expected that. But we couldn't be happier, slow or not slow," Famularo said.

The banquet room is nearly ready to be reopened, they said, and some hotel rooms should be ready in time for the autumn colors, perhaps in October.

The hotel rooms will be redesigned to reflect more of a bed-and-breakfast atmosphere, the couple explained, without televisions in the rooms but with a common sitting room on both of the upstairs floors. They now have 10 employees working in the restaurant and bar, but expect to hire more as they make progress toward opening the hotel rooms and the pub-style tavern on the basement




"It's a nice parade for a small town. We have a little bit of everything," Kondrat said, adding that there are usually between 80 and 100 entries for the parade each year.

Your vote is important

A local person said recently that voters in the area always give their support to two demographic groups — "kids and senior citizens."

Knowing this, some important millages on the Aug. 3 primary election ballot should find strong support from those casting the ballots.

The Boyne District Library is seeking a millage increase of .35 mills, in perpetuity, to support library operations, maintenance, and programming. Following the extensive renovation and expansion project funded by a \$2.3 million gift from the Mary K. Peabody Foundation, the library has been faced with an endowment fund that's been crippled by a sluggish economy, and state budget cuts at every turn. Struggling in recent months to figure out just where the money's going to be coming from, the library board has cut staff and book purchases, and, in March, cut hours of service to the public. And that was just to break even.

You can argue all you want about why the library should or shouldn't need more money, but the fact is they do. And they need it because they perform a vital function in the community. There are preschool storytimes and summer reading programs for kids; Internet access; workshop programs; not to mention a plethora of books of all types, periodicals, newspapers, videos and reference materials. The downstairs community room has filled a void by providing comfortable and ample meeting space, that is, by the way, almost always in use. And all of it is FREE to the public, or nearly so, supported primarily through tax dollars; do the math, and you'll see that, if you use the library even only once or twice a year, it's paid for itself.

Even if you don't use the library, your elderly neighbor or neighborhood schoolkids probably do. Vote yes on the Boyne District Library Millage Proposal.

ANOTHER IMPORTANT issue on the ballot includes a senior citizen services millage renewal, which supports a wide variety of services — from housekeeping to health care — available at little or no cost to county senior citizens, many of which have a huge impact, undoubtedly, on the lives of area seniors, many of whom live on a fixed income. And, as we all know, even if we're not now, we will all be seniors one day. We should support these services now as we'll no doubt want the community to do when we need them for ourselves.

FINALLY, the Boyne Valley Township request for 1 mill to establish an ambulance service. Though clearly the township has had a positive relationship with Boyne City Ambulance, with whom they contract for ambulance transport services, with 150 runs anticipated for this year alone it seems as though it's time for the township to have its own transport vehicle. And that's exactly what this millage will provide — an on-site transport vehicle and trained volunteers that can, potentially, cut response time and provide, ultimately, a quicker trip to the hospital for patients in the township. One more ambulance to serve the needs of a growing number of area residents just makes sense.

WHATEVER YOU decide, however, just don't forget to vote on Aug. 3.

Dreaming of summer theatre

The summer of 2004 is careening towards autumn at a rate no one likes to acknowledge, and the new school year will soon be upon us.

Paula Vollbach, affectionately known as Miss V, will commence teaching art at the East Jordan Elementary School, delighting a batch of new students and welcoming returning artists-in-training. She is also making a home for two new roommates, adopted Chihuahuas, whom she rescued soon after the death of her beloved (and famous) Eva—a model dog to many of her sculptor students. These things are hugely important in Paula's life, but undoubtedly the thing that looms largest in the minds of the East Jordan community is the annual Spring Musical, performed by the EJ Thespians, under the able direction of the intrepid Miss V.

Next spring's musical is still a secret, but—shh!—it won't be Music Man. And that's all you get for now, for that is not the subject of this column.

Paula Vollbach has a dream. She has a dream of a summer community theatre in East Jordan, and when Paula dreams, things happen. And Paula is dreaming of East Jordan having a premier role in the northern Michigan Theatre scene.

"We will have open auditions," she says, "It will not be limited to former EJ Thespians." It will in fact not be limited to East Jordan residents or even Charlevoix County residents. "Ours will be a community theatre that anyone can be part of," she says, "any age, any level of experience, any community." Through her 13 years at East Jordan Public Schools, working closely with students and community on the spring musical as well as other events, such as the Miss East Jordan pageant, Paula has had an epiphany (or two). Alumni want to return to the stage some will plan their summers around it. Adults who have participated behind the scenes have a craving for the open stage. Home-schoolers hear a new opportunity knocking at their doors. Most of us have some untapped Mittyesque urge to stand in the spotlight, and Miss V is all about making that dream come true.

She wants her troupe to have a "nucleus of people with a whole repertoire of theatre experience: acting, backstage crew, lighting." Paula insists that anybody can do any aspect of it - and wants to lead the way by getting involved in more ways than just direction herself. She wants to direct one show each summer. And act in one. She'd like to have the opportunity to work the lights for one show, or be a stagehand, help with costumes, design sets, do all the things her students have been doing for all these years. Some of the alumni have never been on the stage during a performance. But every year you will see them in the audience, reliving some of the best weeks of high school. Miss V thinks it would be wonderful if the experience didn't end with graduation.

Paula is a little uncomfortable with one part of her dream. She wants it to be her troupe. Oh, it doesn't have to be named the Paula Vollbach Players, or anything, but she knows that she wants this to be her baby. She wants a committee to help with the process, but would like to be the project coordinator. It's not that she feels she has to run the show, but that she knows what she wants to give the community, and she believes that she is equipped to give it, given the chance. Many would concur. What Miss V can do, what sets her program apart, and her skills apart, is that she is visionary and that she has the gift of inspiration. Two years ago, reading the Annie Warbucks script, Paula's mind skipped forward to when she would have the use of the new auditorium. A dream come true. "Cinderella!" And swiftly on the heels of that thought, Miss V saw the set: A giant storybook whose pages opened to reveal set backgrounds. That's the visionary part. Miss V also envisions the characters as she believes they are. She imagined that Cinderella, who was enslaved, unloved and abused, and whose best moments were the moments when she was alone, should be a shy child, young, untried. She wouldn't fall in love as quickly as the Prince, who would be used to adoration. Here's the inspiration part: Paula Vollbach coaxed that Cinderella out of a shy 8th grader and made her live on the stage in the new East Jordan auditorium this past spring—and every one of her musicals has seen a similar transition.

"There is some of every character in all of us," she says. She can recognize it, and she can make it live. But she says once the ball is rolling, it often takes on a life of its own. "When that happens," she says, "it's beyond me. I get excited about helping people be successful." She'd

On most military bases is a PX = Post Exchange which is similar to a super market, where personnel may purchase goods. Our troops in Iraq, Afghanistan and other locations must supplement GI materials with purchases from their PX.

Unfortunately for them, neither GI nor PX supplies all their needs. The PX's are run by private companies which are in the business to make a profit. Some of the very things our troops need are not available, either not GI or stocked in the PXs (for example small work gloves for women, flea collars, etc.)

That is why there is such an effort on the home front (BC) to send packages to our troops. American Legion Post #228 in Boyne City is spearheading an effort to send supplies to our six Legion members who are serving in

The response from the community has been tremendous! And we, their fellow Legionnaires, on their behalf, thank you. Please keep up the effort—there is no firm word yet when any of them are coming home. Lists of things they need are available in the American Legion Post, which is open every Tuesday afternoon and evenings for Bingo, the Boyne City Library, and in the box at

the Advance Store.

MEET THE CANDIDATES

2004 PRIMARY ELECTION

To better inform our readers before they head to the polls on Aug. 3 for the primary election, The Citizen-Journal sent a questionnaire to candidates running for Charlevoix County offices.

The candidates answered questions regarding their background, reason for running, qualities they bring

to office and what separates them from their opponents. Their answers are printed in their entirety.

Profiles for the candidates for U.S. representative and state representative were printed last week. Not all candidates returned the questionnaire.

Charlevoix County Prosecutor

John A. Jarema

Position you are seeking: Charlevoix County Prosecuting Attorney

Party affiliation: Republican

Your background: "I graduated from Central Michigan University with a bachelor's degree in psychology. I graduated from The Detroit College of Law with a Juris Doctorate Degree in 1995. I moved to Charlevoix County in 1995 and started in the prosecutor's office. I married Krista Martin in 1997 and have two girls, ages 5 and 3. I have close family ties to the area as my relatives have been long time residents in Boyne Falls and Boyne City."

Why are you running? "I am running because I know that I can make a difference. I am a trial prosecutor who will seek justice in the courtroom. The prosecutor should also be pro-active ie. educating the youth on the ramification of alcohol and drug use and the seniors on identity crimes. I will only charge crimes that I can prove and I will take the cases to trial in the interest of justice."

What skills will you bring to the office? "People skills. Trial skills. I conducted the Career Days education programs at Boyne City Schools to educate the youth. I have personally tried over 100 trials in seven years with an over 80 percent conviction rate. By comparison, the current prosecutor has tried two cases in four years. I will be a hands-on, in-court prosecutor ensuring the safety of our community."

What separates you from your opponent? "The willingness to take a case to trial and fiscal responsibility. Charlevoix County currently has more criminal assistant prosecutors than Emmet County, Otsego County and Antrim County: Why? Because in those counties, the prosecutor handles their fair share of the caseload. In Charlevoix, we are paying more staff, the criminal "assistants," to handle the caseload and still paying the prosecutor. Since I will actually be in court handling the cases, I will staff the office accordingly and save the taxpayers money."

Mary Beth Kur

Position you are seeking: Prosecuting Attorney Party affiliation: Republican

Your background: "I have been married to my husband Steve for 19 years and we have two children. I am a graduate of the University of Michigan and the University of Detroit School of Law. Following my admission to the Michigan State Bar I worked in private practice. I began my work in prosecution over 12 years ago.

"For the last nine years I have served as the Charlevoix County Prosecutor. Prior to this I served as our county's chief assistant prosecutor. I have successfully tried numerous capitol offenses (capitol offenses are crimes which carry a penalty of up to life in prison) including rape, murder, and safe breaking. "I am a member of Board of Directors of the Prosecuting Attorneys Association of Michigan, the Straights Area Narcotics Enforcement Team, (SAXE) and of the Northern Michigan Child Abuse Council. Why are you running? "I want to continue my service to the public because we make a difference. While we cannot undo the effects of a violent crime, a conviction can give victims some peace of mind and allow them to move ahead with life. Being a part of that process is very gratifying to me."

What skills will you bring to the office? "I have extensive felony trial experience. In my last term I successfully prosecuted two of the highest profile cases in recent memory in Charlevoix County. One involved the attack with a shotgun on our Sheriff George T. Lasater and the East Park murder of a 25 year-old boater who was visiting Charlevoix. Over the entire course of my career, I have tried in excess of 100 cases.

"Not one conviction obtained by my office has ever been reversed by an appellate court - translating to a 100 percent success rate on appeal."



SAFETY IN **THUNDERSTORMS**

like to see good repertory theatre—with a musical to open, the next night a drama and the third night a comedy. (Musicals are the most expensive to put on—the scripts and scores of each are purchased separately and cost is commensurate with the number of tickets sold.) Sets must be constructed to be dismantled and stored and replaced with the set for the next evening's performance. She plans to recruit alumni to direct a children's theatre production.

Paula is a visionary, a dreamer and—a realist. She knows that her gifts, and the enthusiasm of the many people who have encouraged her to get this idea off the ground, must be coupled with a more prosaic asset: As-

The auditorium that the school built is the natural home of a summer theatre program. Miss V recognizes how wonderful it is to have this auditorium available to the community. But, she points out, she works with the EJ Thespians, but she does not own the set materials, the costumes or the auditorium personally. These will all need to be purchased or rented, as will copyrighted scripts and

scores. There will need to be grants written, patrons found to support the theatre — "seed money," Paula calls it. She believes eventually the program will support itself through ticket sales and fund-raisers. But first there will need to be money raised for publicity — not just for productions, but for auditions — funding for all the things the troupe will need to have a first season. Paula says that word of mouth will be critical to the success of the summer theatre group — she says she tries "to generate a lot of conversation.'

If this thing is going to happen in less than a year, the conversation has to start now. So far the Walter Mittys are doing most of the talking, and there's a need for Daddy Warbucks. The divine Miss V is a resolute soul, though, and she will bring this wonderful thing to pass in East Jordan in good time. "I hope my reputation will be the reason people become a part of it," she says, "but it won't be the reason they stay. The experience of theatre will make them stay."

from eating away more of the exterior. The machine is not used for much work at his home in Petoskey, Hibbler said, explaining that he usually just "plays in the woods"

Many of the owners polished their tractors and answered questions as people walked by, investigating the old farm equipment. Up the hill from the tractor display area, dozens of vendors and crafts people had wares for sale, ranging from rusted tractor parts and trinkets to handmade candles and carpets.

Hilda Fenstrum of Copemish had one of the busiest stands in the market area, where she was selling rootless Bromeliad plants, which are related to pineapples and Spanish moss. The tropical-looking plants hung from her tent and many people stopped to ask exactly how the plants grow suspended in air.

"If you put them in dirt, you'll kill them," Fenstrum said, explaining that the plants get all the nutrients they need from the air around them.

She had about 20 types of the unusual flowering plants for sale, adding that she also sells at the Traverse City Farmers' Market on Wednesdays and Saturdays.

Other events included blacksmithing and woodworking demonstrations, musical entertainment and primitive camping.







Playing with an All-Star cast

■ Paul Simeri is first Rambler to ever suit up for East-West football game

Paul Simeri has accomplished a goal no other Boyne City High School football player in the history Boyne City Schools has ever accomplished - playing in the Michigan High School Football Coaches Association's East-West All Star Football Game.

The game was played Saturday, July 24, at the University of Michigan stadium in Ann Arbor. Pregame announcements and introductions were at 1:35 p.m. and the game began at 2 p.m. The event was sponsored by the MHSFCA, the UAW, and General

Eighty-eight 2004 high school graduates took part, being divided according to school size. The East All Stars were selected from nominees coming from schools in Wayne, Oakland, Monroe, St. Clair, LaPeer, Sanilac, Macomb, Huron, and Tuscola counties, which represent 229 high schools and about 269,300 student athletes. The West All Stars were selected from nominees in schools in all other counties in

Michigan not mentioned above, representing 418 high schools and 277,900 student athletes.

Each team consisted of 44 players – Class A through D – with some players selected regardless of school size. A player's coach had to nominate a player to the MHSFCA to be eligible for selection. Each player received his game jersey, a set of All Star T-shirts and shorts, an equipment duffle bag, an All Star cap and a 2004 All Star Program.

The players practiced seven days, first reporting to Michigan State University the morning of July 17.

They started with three practices per day at the Spartan sports facilities, learning the basic plan for the game as quickly as possible. The day before the big game, the team members were treated to a All Star Banquet for the parents of the players, All Star coaches and the board of directors.

for the East. Simeri's team led 33-0 at half-time.

"He enjoyed being on the field with such good athletes, some of whom will be playing Division 1 next year. He held his own and the coaches involved were extremely impressed with Paul's work ethic and playing ability for his size. He was one

of the smallest players on the field."

The game is usually played at Spartan Stadium in East Lansing, but due to stadium construction the All Star game was played in Ann Arbor. The players were bused to the game from East Lansing on Saturday morning.

Shooters take aim on national title

Four area boys brought home awards from the 2004 4-H National Shooting Sports Invitational in Columbia,

Nearly 800 young 4-H participants competed at the recent event, carrying everything from bows and arrows to pistols, BB guns, rifles and shotguns.

Among the young people involved were four local shooters competing in the shotgun events. Team captain Matthew Haver, his younger brother Jon Haver, from Charlevoix County, along with their cousin, Chris Haver, and also Ethan Heiden, both from Lenawee County, competed in three days of substantial competition in the areas of skeet, trap and sporting clays, which determined the nation's top overall individual and team shooters in the 4-H organization.

Michigan shooters would find themselves taking fifth, placing behind Georgia, Texas, Virginia and Pennsylvania - no small accomplishment as these same teams tend to battle it out year after year for the highest team placing.

In the 4-H'National Shotgun Invitational, state teams consist of four members. Each member competes with 100 targets in each discipline. The top three scores are then tallied to give the team a final total.

Recognition is given to both the top individual shooters and combined team scores. To provide equality among the teams in case of poor weather conditions, equipment malfunctions, scorers, pullers and other variables, the competitors are separated into squads with only one member from each state shooting on a random squad. This way the competitors are able to meet and shoot with different 4-H participants from other states.

Jon and Chris Haver contributed 97 and 96 hit clays of the 283 total that placed the Michigan Team second in the nation. Jon at 97 earned fourth place individually. Chris at 96 was in a three-way tie, and after a shoot-off placed

On the trap field, Chris's score of 95 hits out of 100 put him in a five-way tie for fifth place. Heiden, with a score of 92 out of 100, was in eighth place. After a 10-shot shoot-off elimination, Chris moved to ninth place, and Heiden was bumped out of the top 10. Matthew Haver added 80 points to the team's score of 267 out of 300, placing Michigan in ninth place in the nation for the trap

The final day of competition found the young men at the sporting clays course. With a shotgun start and squads spread over 14 different stands, the Michigan team racked up 227 out of 300 birds possible, placing ninth for this division. Jon was right on target again that day, and with his score of 85 out of 100, placed seventh individually in

Crow tests positive for West Nile

Officials from the Northwest Michigan Community Health Agency, the health department that serves Antrim, Charlevoix, Emmet, and Otsego counties, have announced that a crow submitted for testing from Charlevoix County on July 14 is positive for the West Nile virus.

West Nile virus is a mosquito-borne virus that can infect birds, horses, and humans.

"West Nile virus cannot be spread directly from birds to people," said Joshua Meyerson, MD, medical director for the health department.

"However, increased sightings of dead jays and crows can sometimes predict an increase in human cases of West Nile virus. We're asking people to report dead birds at www.michigan.gov/ westnilevirus."

People who do not have access to the Internet can telephone their local health department office to report dead birds.

By tracking the locations and numbers of dead birds, the health department can keep the community informed about any increased

risk of West Nile virus. After reporting a dead bird, it is important to dispose of it properly. Meyerson recommends wearing heavy gloves or using tongs to double-bag the dead bird directions. and throw it out with other • Reduce exposure to

household garbage. According to the Michigan Department of community Health, one human case of West Nile virus has been reported in the state so far this year, in Kalamazoo County.

To reduce the risks of becoming infected with West Nile virus, Meyerson recommends the following precautions from April through October, the West Nile virus "season:"

• If outside when mosquitoes are most active, wear protective clothing and an insect repellent containing DEET. Avoid applying it to children under two years of age and always follow the manufacturer's

mosquitoes around the house and the yard by making sure that doors and windows have tight-fitting screens and drain all standing water from mosquito breeding sites like flower pots, pet bowls, clogged gutters, and pool covers.

• Help remind neighbors to eliminate mosquitobreeding sites on their property.

Furthermore, it is the intent of this ordinance to, through the preservation, protection, maintenance and management of the community's existing forest resource, and the planting of trees to en-

hance the quality of life in Boyne City. The ordinance further addresses the definition of terms; Arbor Day designation; establishes a City Forestry Manager; protects from Dutch Elm Disease; prohibits tree topping; prohibits certain species of trees from being planted in the public areas of the city; requires tree planting as part of new developments; requires trees to be protected by barriers during construction; regulates tree maintenance and plantings in public areas; regulates trees on private property whose branches, limbs, roots or other parts extend into or over the street right-of-way. 
