# Food service worker faces charges

Former Boyne City Public School employee Wendy Juday was arrested March 16 on criminal complaint charges of embezzling more than \$100,000 from the school food service.

On June 1, 2004, the Boyne City police department was contacted by the Bovne City School District regarding the apparent ongoing theft of funds from the food service department. Because school food services are subsidized by the United States Department of Agriculture, federal investigators were contacted and a joint

investigation began

Mark McClutchey, a special agent of the USDA Office of Inspector General, issued an affidavit in support of a criminal complaint alleging that Juday stole funds from the Boyne City Public Schools lunch program over the five years of her employment with BCPS.

According to McClutchey's interview with Kathy Frugé, food service director at Boyne City schools, the food service department grossed approximately \$30,000 during the 1997-98 school year. The following year

Juday began working as a cashier. That year the gross revenue dropped to \$15.000.

By the 2002-03 school year, the food service department at BCPS was losing approximately \$20,000 annually, according to the complaint.

The losses were blamed on students, who were believed to be stealing food from the school cafeteria. Food prices were raised to help compensate for the losses, according to the complaint.

However, Jim Cooper, superintendent of Boyne City schools, said that

in fact the school did not raise food Frugé began comparing recorded from students and then not register the sales. Frugé observed Juday at the end of the day as she closed out her register, and she saw her hit the "total" button first, which allowed Juday to know the amount of sales registered during that day.

A deficit averaging \$125 occurred on the days Juday was working.

Based on this information, McClutchey's affidavit alleges that Juday embezzled about \$106,700 dur-

ing her five-year employment with

BCPS.

### Spring arrives with another burst of winter

# Still at odds

### Jordan Valley library board can't even agree on an agenda

The Jordan Valley District Library held its regularly scheduled meeting last Tuesday.

President Chris Curtin requested a motion for-approval of the agenda. Member Harry Watson moved that the agenda be approved with the addition of an item to remove the president and vice president of the board. President Curtin said that she would not entertain such a motion, which

was "deleterious" to the library. Member Bob Sherman said that it was the right of a board member to request an addition to the agenda, and he moved that the agenda be revised to include discussion on the officers' removal. Curtin again refused to hear the motion.

Watson presented a typed motion that enumerated the alleged offenses

The sheriff's department and state police have worked together on patrols in years past.

'We meet together beforehand," Lasater said. "It is a very cooperative team effort. We even use our auxiliary members to transport to the jail so that we don't lose our on-duty troopers.

"One thing we did differently this year was to take two deputies off the road and put them in civilian clothes on the mountain to work on drug-related offences," Lasater added.

The results of the combined law enforcement efforts were a total of 27 arrests, most of which took place on Saturday.

These included 10 drunk driving, nine controlled substance, two disorderly, one minor in possession, one transport with open intoxicant, two fugitive warrants, and one weapons arrest.

There were no personal injury or property damage accidents in the area related to the Boyne Mountain carnival.

"To me that says we're doing our job," Lasater said.



### EJ board suspends student for bomb threat

The East Jordan Public School board met in closed session last week to discuss expulsion proceedings for one of the students involved with last month's bomb threat.

The session was closed at the request of the student's family. The name of the student is not being released. The board gave the student a long-term suspension of 150 days for misconduct and for violation of the code of student conduct.

Expulsion proceedings are pending for another student involved in the scare, which emptied the high school.

The threat was made in the form of a hand-written note left in one of the high school's restrooms.

After investigation, the threat was determined to be a hoax, but consistent with the school's procedures, the high school staff and student body were evacuated to the middle school while fire, law enforcement and emergency medical service crews responded.

We take these kinds of things very seriously, and will do all that we can to make sure they don't occur," said superintendent Chip Hansen.

# **School finances** dominate BC board meeting

The Boyne City school board meeting last week was dominated by a discussion of school finances all over Michigan.

Superintendent Jim Cooper said that Boyne City schools were in fairly good shape financially, due to careful budgeting and cuts, but cautioned that the money would be gone in three years if there are no changes in the way things are financed at the state level.

This, he admitted, puts BCPS in a much better position than many other districts, but he characterized all Michigan school districts as being in a line heading for a cliff. Some have gone over; all are moving closer, he said.

The problem, according to Cooper and member Debra Noblett, who represented the board at a meeting between 11 districts to discuss the school funding crisis in Michigan, is Proposal A.

The schools all are willing to bear responsibility to control expenditures and generate revenue. But with land value increasing, the amount of funding from the state is decreasing and almost every district in the state is in a crisis, according to Cooper.

"What needs to be done with the funding crisis in Michigan?" Cooper said.

"In each district we need to ask, 'What are we doing to control costs? What are we doing to generate revenue?""

In 1994, Cooper said, Proposal A passed with overwhelming voter support. Its purpose was to take reliance off property tax and to close the gap between the rich and poor school districts.

"It accomplished both these things," Cooper said. "But legislatively it has been tweaked over 70 times since then. Those 70 tweaks have cost the school aid fund over \$550,000 a year.

"We are not asking for new money or more money. We are just asking to fix Proposal A," he said. Cooper said that many special interest-type groups have received tax breaks due to the changes in Proposal A. He said this is money the schools are entitled to, based on the will of the voters with Proposal A.

But he also noted that school administrators and boards have little impact on legislators.

"If citizens and communities demand it, it'll get done," he said. "Is education a priority in your community or not?

"(We have to) create a grassroots process to make change or every district in Michigan is in danger of losing the educational process beyond recognition - or shutting doors, and I don't know which is worse," Cooper said.

The board discussed how best to proceed with educating the public about the funding crisis and how to get people involved in an effort to affect policy changes in Lansing. They agreed to meet next month, with each member bringing several guests. The purpose of the meeting will be to create a plan to raise public awareness and support of fixing Proposal A.

The next regular BCPS board meeting will be Monday, April 18, at 7 p.m., a week later than the regular schedule due to spring break.





It started because Howell had heard that the hospital was upgrading its computers and she called to find out what they were going to do with the old ones "And then I begged for them," she

said.

"It was going to cost the hospital between \$5,000 and \$7,000 to get rid of them," said Kowalski. "That's where we came in. We'd take as many computers as we could get and get them up and running."

CAH agreed to give the students about 80 computers.

First the boys requested a truck and an enclosed trailer from superintendent Bill Aten, but that didn't work out. Instead they were able to borrow a step-van from the Charlevoix Intermediate School District, and janitor Tim Robach picked up the computers and drove them back to Boyne Falls.

Aten lent a hand again, calling Boyne Falls Storage, who generously agreed to allow the students to store the computers at. that facility, free of charge, until all the computers are "up and running."

The boys have taken on the responsibility for getting each and every one of the donated computers back in working condition. But it was their decision of what to do with the refurbished machines that is particularly noteworthy.

The boys wrote a survey, which was Emailed to each classroom teacher, to determine which students do not have a computer in their homes. Students who qualify will be given a refurbished computer

to keep. If there are leftover computers, Howell hopes to be able to establish a "lending library," where students can borrow computers when their own are out of commission.

The boys are committed to repairing the computers themselves. They have learned problem solving skills, basic knowledge of computers and some technical skills that will help them complete that end of the project, which they expect will take the rest of the school year.

Another skill: "We have our resident computer geeks, and (Crego and Kowalski) know when to ask for help," Howell said. There is a work station set up in the

classroom to work on the CAH computers. Any time computers are involved there are

problems, and loading software is creating a little havoc for the project.

In the classroom, students can be heard anthropomorphizing their computers: "This computer is being stupid," said a frustrated

"resident geek." But it is a benign remark, heard in various translations throughout the session, made by students who love computers.

"I'm glad I chose this project," Kowalski said. "It's nice doing something for people - giving (the computers) away. It'll make some people's lives easier."

The boys are not yet sure how distribution will go, "It will depend on how repairs go," they said. But they do not want to do any computer distribution until all the machines have been serviced. They had a completed donor list at the end of last week.

"We will start distributing as soon as all the systems are ready to go," Kowalski said.

Crego is the more hands-on member of their team in terms of computer servicing. "I'm not so much of a computer geek," said Kowalski, "But I'm willing to learn."

The students of Boyne Falls High School and Ms. Howell's Independent Computer Project class would like to thank the Charlevoix Area Hospital and Boyne Falls Storage for their generosity and contribution to making this project a success.

personally. Curtin said none of the offenses alleged constituted a basis for removal, and requested a name and address for Watson's attorney.

"I will entertain a motion to accept the agenda or I will adjourn the meeting," said Curtin

"I feel there needs to be forward motion, and sometimes that means there needs to be a new person at the helm," board member Sara Schroeder said. "I don't see it as a negative thing.

"If we are here for the good of the library, we need to each look at ourselves and see what we're doing and how we are affecting the library."

Wardwell read a statement "in the hope that it (would) put things in perspective and stop ... confrontation." The statement said that the previous board had acted on a vision, that it saw a new library, paid for by grants,

not by raising bonds, and that the board had worked together toward reaching that goal. She said that it became divisive only in the

last year as the make-up of the library board changed. She cited examples of current board members voting on things and then rescinding those votes.

She concluded by saying that the leadership of the board had been proven over its years of working with the vision of the previous board, but that the vision may need to be looked at.

"I ask the majority, what is your vision? To spend yet more taxpayers' money merely deconstructing a foundation you helped to create?" Wardwell said. "Bring to this table a great vision. Make it every bit as visionary as the one preceding and I will support it 110

percent."

"The auditor's report has said repeatedly that (library director Dawn Pringle) shouldn't be doing all the (accounting) work, but we are told there's no money to hire someone to help," she said. "Now there's money to spend on web-based software, new facilities - I am afraid that there won't be a library for my kids to use.'

"If the money isn't there (for the webbased software) then we didn't plan properly or we are rushing into something," Schroeder

added. She said that there are many issues facing the library board, much smaller than a big building project, that it can't afford.

"Keeping up with the Jones, every wish list — if you question these things, you are considered 'anti-library'," Schroeder said. "Doing nothing should be an option. We need to recognize that this may not be the time to incur the expense.'

After an hour of contentious discussion, Curtin closed the meeting, but everyone on the board and most of the audience stayed in their seats. At that point, audience members took the opportunity to address the assembled board.

"As a citizen I encourage the rest of you, as a quorum, to continue the meeting and get on with the business you have neglected for months," said Mark Robinson. "Re-open what the probable former chairperson closed. The community expects you to move forward and let the chips fall where they may."

Board member Linda Robinson said that she had been approached by Curtin prior to the meeting and had been told that Curtin intended to remove her from the position of treasurer and replace her with Sara Schroeder, because, according to Robinson, Curtin said she had worked with Schroeder previously.

According to Robinson's account, Curtin requested her resignation, which she denied. Curtin stated that she intended to remove Robinson anyway, and Robinson requested that she give reasons to the board, to which Curtin responded that she did not have to. Curtin also asked Robinson if she would like to be the secretary, a position currently held by member Diane Boyer.

After another hour of debate, the board an agreement that Curtin hear a motion to remove her and Wardwell at the next meeting, if the attorney agreed to it. Watson stated that she should consult her own lawyer, because the board would not approve any additional taxpayer-funded legal fees.

Juday's employment was terminated on Feb. 19, 2004, but she had not reported to work since Jan. 9, according to Boyne City Assistant Police Chief Jeffrey Gettel.

On June 24, 2004, McClutchey interviewed Juday, who issued a written sworn statement.

"Within two to three months of starting work, I began taking money from the cash register," she wrote. "I would intentionally not input food sales into the cash register, so that extra cash would be available at the end of the day.

"At the end of each day, I would total the food sales inputted into the computerized register, and keep all the cash in excess of that amount," she said.

According to her statement, Juday was taking the money when she transported the lunch money to the bank for deposit. She also stated that the amount varied every day depending upon what was being served in the lunchroom, but that she estimated that she was taking between \$40 and \$80 a day.

She also admitted to taking some money from football admissions before "handing over the money bag.

She estimated that her total theft amounted to approximately \$60,000. "I may have taken more than \$60,000, but that is my best guess," she said in the statement.

Juday also said that she used the money for living expenses and to pay for her children's activities.

"It was a big mistake allowing any cashier to take money to the bank," said Gettel. "I'm sure they like to trust people, but sometimes you trust too much and it ends up being too great a temptation for some people."

Cooper agreed. The school, he said, will implement greater internal and external checks and balances, utilizing software better and making sure that more people are responsible for accounting oversight, as well as providing additional training.

"We think the process is working, we do internal auditing just to keep a running total so that we know where we are budget-wise," Cooper said. "But our awareness level is raised that much more.'

Juday was arrested at a private residence in Boyne Falls on March 16 and appeared in federal court in Grand Rapids on a complaint of stealing federal program funds.

The charge carries a maximum penalty of up to 10 years' imprisonment, a fine of \$250,000 and restitution.





Schroeder acknowledged that she was one of the board/members who had "flipflopped" on votes and issues.

I got frustrated. I wondered what he was doing that I wasn't. I wanted to know what I was doing wrong. I needed to be better. Then, the Phantom stopped, paused at the end of the pool, pushed up his goggles, shook out his arms, hoisted himself up to sit on the pool's edge, and *took off his flippers*. I was stunned, angered, and relieved all at the same time. The Phantom was a fake. A cheater. He was using performance-enhancing equipment. He obviously had no respect for the secret tournament I was hosting in my head. So, I did what any respectable athlete would do—disqualified him for cheating and declared myself the tournament's champion.

Finding the competitive edge in jogging was more difficult. I didn't have anyone to race against, so it was me against the clock. Here, I didn't strive to go faster. Instead, I aimed to go longer: first 20 minutes, then 45, and eventually over an hour. One day, I told myself I was going for two hours. After an hour, I was halfway done and feeling both good and uneasy. Nevertheless, I kept going and made it.

It was both the worst and best feeling ever, I was beaming with pride but also queasy and aching. Eventually, all the aches went away and I had an immense sense of personal satisfaction. Later, I entered a 10K race, I knew I wouldn't finish at the top but I had a goal. Then, I saw my competition and picked out all the people I absolutely had to beat.

# The Graveyard of Sunken Ships

Webster defines a 'hazard' as a source of danger, a chance, a venture or risk. Navigating Oyster Bay can pose a hazard.

There are six ships that have been laid to rest on the bottom of Oyster Bay from a 206-ton schooner to a 57-foot steamer.

This past summer, 2004, an incident involving a 20foot pleasure boat was reported. While navigating Oyster Bay, the pleasure boat struck part of one of the submerged vessels: raking the bottom of the boat and causing damage to the pleasure boat's outdrive. The passengers in the pleasure boat were thrown forward, falling down. Luckily for the passengers, only bruises were incurred. It could have been much worse.

The Charlevoix County sheriff was notified of the incident. The U.S. Coast Guard was also informed of the incident and asked why there is no marker placed above water to identify this submerged boating hazard area before someone is seriously injured. The Coast Guard indicated that the sunken/submerged vessels are marked on the Lake Charlevoix navigational chart and also that "everybody knows about them."

This does not appear to be sufficient marking or hazard warning of the submerged vessels. Where there is a definite navigational hazard, why not have a marking buoy placed and secured to identify the area for the safety of all boaters?

Most snowboard instructors never even attempt to achieve Level III status. Of the few who do, fewer succeed. Of those who become Level III instructors, fewer still are over age 30. Duane Miller of East Jordan is a notable exception.

Being notable, and exceptional, runs in the Miller family.

Dusty Miller, an eighth-grader at East Jordan Middle School took home a third place finish in the United States of America Snowboard Association slope-style competition at Nubs Nob in late February, riding in the highly competitive junior men's division.

Slope-style, according to Dusty's dad, Duane, is the best of two runs on a course made up of big air jumps, small "hits," or jumps and rails.

"The competitors are judged on the difficulty of tricks, amplitude and landing," said Duane. "This event is a qualifier for the USASA Nationals held at Copper Mountain in Colorado in April.'

Dusty is not the only Miller progeny with boarding skills. His older brother Hunter, a senior at East Jordan High School, took third place in the Chevy Truck - Evolution Tour Boarder Cross at Boyne Mountain on March

"The Boarder Cross is like Roller Derby on snow," Duane said. "The course is made up of table-top jumps, speed bumps, rollers, step-up jumps and bermed turns.

"Competitors from 14 states and Canada competed for a spot at the Junior World's in Switzerland," he said. "Riders compete four at a time and the top two advance to the next round. Body armor and full-face helmets required." A lot of dads would be speaking Greek, referring to "table-tops" and "rails," but not Duane. His sons are a chip off the old iceberg, though Duane rejects the very concept of "old" anything.

He turned 50 last Wednesday. He would rather not make

an issue of it, but it makes his own recent accomplishment even more extraordinary.

Miller has been a snowboard instructor at Boyne Mountain for nine years. The first year, he obtained his Level I ing seems to come naturally - something he didn't know

certification, the second year he earned Level II. For the past five years he has been working toward Level III.

The American Association of Snowboard Instructors study guide describes it this way: Level I is your high-school diploma, Level Il is a college degree, and Level III is the Masters. It goes on:

"Your demonstration (riding) skills must be nearly perfect. You must be able to change the timing, intensity and/or duration of any movement. You must be able to make your board perform equally well on a wide variety of terrain and snow ... Level III demands mastery.' "It was very stressful," said

Miller, who took his Level III exam in Redwing, Minnesota early in March

"One big motivation was proving that I was not too old turns," he said. to do this," he said, describing an exercise regime that took the form of wake-boarding and working out on a trampoline during the summer.

"Level III is tougher for snowboarding than skiing. We have to be able to do big jumps, rails and half-pipes," he said

The exam is not all about riding, though. It is a twoday exam, with three components each day: riding, teaching and technical knowledge. A candidate can miss one piece and still pass, so five of six tests is acceptable, as long as the failing section isn't in teaching skills. An instructor must above all be able to teach

. .

Fortunately for Miller, teaching is a strong suit. He has been a scuba instructor for nine years, and teach-

when he was younger.

"You have to be patient, not easily frustrated and able to adapt to a variety of learning styles," he said. "You also have to be able to gain the trust of the student and have good communication skills.<sup>3</sup>

He passed the teaching portions with high marks and strong comments such as "...good use of concise explanations."

Miller enjoys teaching all different age groups.


"Kids are visual learners," he said, "so you have to be able to demonstrate. I am careful to teach in progression - you can't walk before you can crawl. People get hurt trying to do things they're not ready for.

"Adults are fun. They can understand and relate to technical things - what joints are flexing when on

At Redwing, students watched each other ride on video, and did analysis on body movement and weight distribution. Teaching people to ride requires a great deal of technical knowledge. Miller had taken Level III before and passed the written, but failed the demonstrating end of the exams, and was told that he would not have to retake the written portion. As a result, he practiced his riding, watching and evaluating videos of himself, and didn't worry too much about the written portion.

He had been misinformed. He went into the written portion, largely those essential technical knowledge ques-

Miller's wife Nancy teaches, too. She is a Level I Nordic cross-country ski instructor, a Level I ski instructor and a Level I snowboard instructor. She sees Duane as an inspiration to the young ... and not-so-young. She said she is proud of his attainment of Level III, and even more so because he did not let perceptions about age stand in his way.

Hunter is a Level I snowboard instructor, and the youngest instructor ever to earn Level I at Boyne Mountain.

"Very rarely is someone unteachable," Miller said. "The hardest ones are the ones that are physically unprepared, with a sedentary life-style. It's a balance sport. If you have good balance, chances are you can do it."

Miller said that anyone who skateboards, wakeboards or works out on a trampoline has an edge in learning to snowboard. The trampoline is especially helpful in learning to do spins, and gaining body control while in the air.

Miller will be on the educational staff at Boyne Mountain, which he credits for giving him time off to train for the exam. He will be able to do clinics and certify Levels I and II.

And beyond that, he will compete.

"Next year I am going to go for the national championship in my age group," he said. "My goal is to participate in all five events."

Last year he only entered two events, slope-style, where he placed 12th, and Boarder-Cross, in which he placed sixth

But he's riding better than ever, and next year he enters a new age group. As the AASI said, Level III is the Masters degree - but there's always more to learn. Looks like Miller's working on his PhD.

As for Hunter and Dusty, one look at their parents, who are both active, interested and always learning, and they can see that there is no limit to what they can accomplish.



"Some of these incredible boats are capable of speeds well over 125 mph," said event organizer Howard Newkirk.







hicles, which by reason of dismantling, disrepair, lack of licensing or other cause are either incapable of being propelled under their own power or are prevented by law rom being propelled on a public highway.

C. "Dismantled and partially dismantled motor vehicles" are defined as motor vehicles from which a part or parts integral to the operation of such motor vehicle, or part or parts required by an law or regulation to be present on a motor vehicle, has been removed or is missing.

D. A "person" means an individual, firm, corporation, partnership, association, limited liability company, limited part-E. "<u>Public Road</u>" is any road or thoroughfare for vehicular

traffic that is publicly owned and maintained. F. "Private Road" is any road or thoroughfare for vehicu-

lar traffic that is privately owned and maintained.

#### Section 2 Prohibition

No person shall park or store, or knowingly allow another person to park or store for a period of thirty (30) consecutive days, two (2) or more dismantled, partially dismantled or inoperable motor vehicles outside a building such that the dismantled, partially dismantled, or inoperable motor vehicles can be seen from any public or private road or seen from any adjoining land owned by another person. This section shall not apply to farm equip ment.

#### Section 3 Nuisance

A violation of Section 2 of this Ordinance is hereby declared to be a public nuisance, a nuisance per se and is hereby further declared to be offensive to the public health, safety and welfare.

#### Section 4 Penalty





# Honk? eggstravaganza a delight

hen Ugly, played by Taylor Carlston, first burst onto the stage with a joyful and vociferous "Honk!" the scene had already been set for his discomfiture. He was preceded by four darling ducklings, a disengaged dad, a doting mama duck, a conniving cat and a barnyard full of prejudiced poultry.

His size, his color and his voice immediately exempted him from membership in the darling ducklings club, and it seemed the only ones who cared what happened to him were his-faithful mother - and the cat, who had designs on him.


The show was a modern adaptation of Hans Christian Andersen's "The Ugly Duckling," and its updates and comedic twists did nothing to take away from the original storyline. In the end, it is still a story about a misfit who overcomes negative circumstances and thrives --- and this one sings and dances

Ugly, the duckling, wanders away from home in the company of the cat, and has many experiences on his journey home that lead him to self-realization, which does not end when he discovers that he is a swan.

He finally discovers that what has always set him apart can't keep him apart from a family who loves him. He rises above the pettiness of the farmyard to bring about changes - which in his case means a little integration of some migrating birds.

With vibrant costumes, a chorus of fabulous voices, wonderful special effects (who wasn't a little nervous when the peas first disappeared into the bubbling cauldron at the cat's house?), and incredible sets. Stacy McGeorge's debut into high school directing was a huge success.

The sets are worth a second mention. Chuck Britton's artwork and designs in conjunction with McGeorge's vision were magical. Every set was believable, from the diving lessons under sparkling waters to

flurried snows under black lights.

The bohemian frogs were a total delight, not only because of their upbeat attitude. The song, the costumes and the tadpoles were a great addition to the play, and must have hooked a few little people who will be familiar with the stage for years to come.

There was not an actor that does not deserve credit and recognition for his or her part in Honk. The voices really were outstanding, the delivery of lines and the ability to stay in character (even with character changes) was wonderful.

But two were missing last weekend: Jenna Raber, a senior who was to appear for the first time on stage, and had worked so hard to find her "inner chicken;" and Ethan Knott, whose roles were missed as Drake, the father swan and the farmer. Both were injured in a car accident during a winter storm last week. They were strong supporting roles, and the

understudies had less than a week to recreate the characters, with much switching of roles to accommodate the cast gaps.
