Maple Ridge Dental of East Jordan uses the Biolase Waterlase unit in their office. According to Dr. Brian Sladics, the Waterlase is a laser, which received FDA approval for use in the dental field in 1998. The advantage of laser dentistry over other units is its efficiency, precision, and ability to reduce the need for local anesthesia

The Waterlase is an invisible laser with a small red light, which operates as an aiming device for the dentist.

"When the laser is working, there is absolutely no vibration or friction on the tooth or soft tissue. Therefore, many procedures can be done with little and sometimes no local anesthetic. This means that

beam. "There is a water spray, which interacts with the laser beam creating a release of energy, which works on the hard or soft tissue. This is why the unit is called a Waterlase, because water is a critical part of how this laser unit works," Sladics said.

The laser has multiple uses in dentistry including: gum surgeries, fillings, root canals, bone cutting, tooth whitening, and desensitization of tooth surfaces. "Speaking from personal experience, it is best utilized to clean small cavities that do not have previous silver fillings already in place. Eighty-five percent of the time, no local anesthetic is needed." Dr. Sladics said "early detection of cavities to insure work with a laser, and therefore avoid the

# drug overdose deaths

BOYNE CITY Charlevoix County's drug death investigative team worked with the Boyne City Police Department on a case recently, when the case involved a suspected drug overdose death.

The department and EMS responded to a call on Jan. 14 from 911 Central Dispatch, stating a woman was believed to be dead in her apartment. Roberta King had died and the county medical examiner determined the death was from an overdose of drugs. Results of an autopsy are still pending.

The investigative team is called in by the prosecuting attorney when a death is unattended or when a drug overdose is suspected.

With a team of experienced investigators of different jurisdictions, it provides a consistent and more rapid investigation, said Boyne City Police Chief Randy Howard.

"It's a proactive approach, not a reactive one," Howard said. "It provides a uniform investigation and prosecution." He explained having the team on scene means numerous leads are followed up by several investigators.

The team was developed

and instituted by county prosecutor John Jarema in early 2005. Its purpose is to provide a thorough investigation of all drug related deaths in Charlevoix County.

Six investigators from various law enforcement agencies make up the team: one from the Michigan State

Police, two from the sheriff's office and one from each of the county's cities, Boyne City, East Jordan and Charlevoix.

"My goal is to have a swift investigation, to get the best possible investigation we can and hold people accountable," Jarema said.

Federal law and a new Michigan statute provide for prosecution of anyone who supplies drugs to a person who dies from those drugs. The Michigan statute is MCL 333.7401, known as "delivery of controlled substance causing death." The

# *ISEA* speaker introduces newest sea invaders

bring-in-more-chairs crowd greeted speaker Tom Kelly Thursday, Jan. 25, at the Central Lake Government Center. Usually he is educating fifth to eighth grade youngsters, over 70,000 of them, since he founded the Inland Seas Education Association to excite children about science and encourage them to commit themselves and their families and friends to scientific exploration.

Thursday night's audience consisted of adults whose concerns about the invasions of sea life which threaten our lakes ranged from those of rank newcomers to those of long term members of the Three Lakes Association. Kelly addressed them all in his presentation and the question period which followed.

Kelly began with a history of the invasions. Most of these invasive threats begin in the Caspian Sea, and since the opening of the St. Lawrence Seaway in 1959 have been arriving into our inland seas in the ballast water from foreign ships and even more recently in non-ballast ships which still bring in unwanted invaders.

The sea lamprey, the first invader, began attaching themselves to trout, nearly destroying that population in the Great Lakes. The 60's brought the alewives which became, at their worst, 98 percent of the fish population in Lake Michigan. Salmon was deliberately introduced to compat the alewives and did, but a new invader, the zebra mussel, arrived in Lake St. Clair and the St. Clair River in 1988, and spread throughout the great and the inland lakes and rivers and is still with us. In 1999, one of the invaders was first discovered in West Traverse Bay by a boatload of middle school kids on one of Kelly's sailing schooners. The quagga mussel later joined its water-filtering zebra cousin, and all mussels present a whole new threat because of their ingesting and spewing out of the waters in which they live. They clarify the water while ingesting one cell plants as food, but that also allows sunshine to penetrate farther into the water depth and grow new botanical threats such as stonewort which decay, float to the surface, and foul the shorelines. This process allowed botulism to grow in the tempting fare on the beaches which recently has killed many waterfowl in Michigan. In Peru a few years ago such botulism killed thousands of people, always a possibility elsewhere. A newer invader, a little shrimp called an amphipod, consumed thousands of square meters of the favorite food of the whitefish which literally began to starve and die in great numbers. The adaptive whitefish, however, has begun eating its new food, the zebra mussel, and is staging a comeback, al-

CENTRAL LAKE - A though smaller than its ancestors. So some of these earlier hunters are becoming the hunted, but new predators keep arriving.

One of the newest critter invaders, the 184th by expert count, is the goby, a voracious eater of fish eggs, a potential destrover of all fish varieties. Another is the rusty crayfish, a particularly aggressive creature. Science News just two weeks ago warned, on line, the probable dangers of the newest, the hemimysis, the "red shrimp" which reproduces rapidly and abundantly. Although what it will attack is yet unknown, its rapid reproduction alone is a threat.

Other ballast water dangers are botanical. Phragmites are grasses that rapidly rootspread on shores and require a dedicated three year program before being destroyed rather than destroying. A recent lovely sunset picture printed in a local newspaper identified these just as sea grasses, not as a plant that can destroy everything in its path.

Some threats have been introduced by man to overcome a known threat and then become an even worse threat. Man-introduced Asian carp is the most recent and most threatening of all, something Kelly asked all in the audience to help stamp out by phoning our Congressmen. We need to back up a bill that has passed the Senate and the House and will be going into the compromise sessions within weeks. Go on the internet www.michigan.gov to get your Representative's local or DC phone number. Senate Bill #770, National Aquatic Invasive Species Act (or NAISA) stresses prevention. Funding the creation of barriers would turn back the would-be invaders. 

The plan included hiring Jeff Manning as chief marketing director and the Webber/ Shandwick agency from Chicago. Both gained fame as authors and implementers of the national "Got Milk" campaign.

The marketing effort begins with a juicy kick off in New York, but is a year-long campaign that ties into many health-related themes. The Food Network is involved, and prime spots on the morning shows are planned, along with print media, including magazines like "Good Housekeeping" and "Prevention". It also includes a new Web site both informative and promotional (www.choosecherries.com).

At King Orchards in Central Lake, response is very positive.

Sales and marketing coordinator Mike Berst said, "We have been farmers, not marketers up until now. This program gets us into the health benefits discussions that have included cranberries and blueberries."

Customer service manager Patty Hill said "We have all known about the benefit that cherries offer for a long time. Every week we hear testimonials from customers. It will be great to have this awareness spread throughout the year and across the country. Something good has been happening.'

"Testimonial" is probably one of the descriptions of the new marketing push. There is no shortage of backing for the message being carried out. In New York, the "Cherry Nutritional Report", a long-awaited composite of expert analysis, will be released. Whether it be USDA studies that conclude to the positive about cherry use or thousands of people who are not shy about touting the relief that cherries have provided for them from the discomforts of gout, or heart disease, cancers or arthritis. Words like antioxidants, anti-inflammatory, melatonin, and nutritional are all over the information that many say they have known about for decades. Nutraceuticals is the new industry buzz word for our tart cherries. You have loaded them into your pies and consumed them in juice concentrate form.

New York will get a good taste of Antrim County at the kick-off thanks to the shrewd marketers at King Orchards. Those attending will receive a little treats bag filled with cherries in many of their most delicious forms directly from the King farm.

For farmers, retailers, and wholesalers, the small family farmer and the larger agribusinesses, the program will have to prove itself. The results will most probably be different for each, and certainly remain to be seen, but there is no doubt that the cherry industry has entered a new era.



#### THE MONTH VETERAN OF

The Veteran of the Month for February is Clarence Bernard Meldrum.

Born Jan. 21, 1918, in Marine City, Mich., Meldrum left school in January, 1933 to work in the family ship building business and later for Chris Craft Boat Works in Algonac and then Universal Products in Dearborn as a gauge inspector. On May 22, 1942, he was inducted into the Army in Detroit and assigned to the III Fighter Command, Communication Company, 501st Signal Aircraft Warning Regiment.

On June 6, 1942, Meldrum was Temporary Duty to the Administration Department, Aircraft Warning Systems School, Drew Field, Florida and on July 4, 1942 he completed instruction in "General Clerk" and resumed basic training including attendance at "Radio Operator-



School" in January, 1943. On Aug. 10, 1943, Meldrum departed the United States, arriving in the Pacific Theater of Operations on Aug. 25, 1943, and was assigned to the 691st Signal Aircraft Warning Company stationed at Fort Greely, Alaska, and later was transferred to the 707th Signal Aircraft Warning Company in the Aleu-

### tian Islands, serving as the supply noncommissioned officer.

On Nov. 2, 1945, Meldrum departed the Pacific Theater of Operations arriving in the United States on Nov. 9, 1945. On Nov. 19, 1945, he received an honorable discharge at the Separation Center, Fort Sheridan, Ill., having attained the rank of Technical Sergeant and was awarded the following decorations and citations: the Victory Medal, the American Theater Medal, the Asiatic-Pacific Theater Medal, the Good Conduct Medal, four Overseas Bars and one Service Stripe.

Returning to civilian life, Meldrum was employed as maintenance/engineering by the Southgate School System, and on Jan. 21, 1947, he married Iline Martha Passino in Detroit. After retirement in the 1970's, he City at 6:15 p.m.

moved to Cheboygan, and following the death of his wife in 1998, Meldrum remarried on Aug. 24, 2002, to Janet Rae (Munson) Smith and made his home in Boyne City. Meldrum enjoyed working with stained glass, painting pictures, playing the organ, building furniture, fishing and spending quality time with family and friends.

"I'll try to hold my breath ... just until we get through this next transition" ... "If I just push a little further, I can rest later" --- but later never comes. If you provide care for a friend or family member, these strategies sound all too familiar.

The amount and cost of the informal caregiving being provided today to elder Americans is staggering. AARP and the National Alliance for Caregiving conducted a survey in 1996 that showed almost 6 million households were providing 20 to 40 or more hours a week of unpaid, informal assistance to older relatives. This included transportation, grocery shopping, household chores, helping with medications and preparing meals. This same care would have cost our nation \$45 to \$75 billion a year if these needs were met by hired home care staff. Furthermore, it is probably safe to assume these numbers have increased rather than decreased, today.

Unfortunately, according to the Family Caregiver Alliance, caregivers are less likely than noncaregivers to get enough sleep, eat healthy, exercise, stay in bed when sick or keep up with their own medical appointments.

If you are one of the generous individuals giving of your time, money and energy to care for an older relative, but find yourself pushing your needle past empty on a regular basis, consider the effects of your priorities. When caregivers neglect their own needs, the result is often two people in need of help, rather than just the one initial care recipient. If your motivation is to provide the very best care, remember that keeping yourself physically and emotionally strong is a responsible and loving choice. You are the conduit of care -- keep the lines in good shape.

### **5 Ways Self-Care Promotes Better Care of Others**

If you are a caregiver:

- 1. Care recipients often reflect the stress of their caregivers. Caring for the Caregiver, a publication sponsored by Parke-Davis, suggests organizing routine respite into your schedule. This will help you feel balanced and reduce stress overall, rather than waiting until you are overwhelmed, and creating a crisis for you and the person you are caring for.
- 2. Time you spend in meditation or prayer at your place of worship will help you remember why you have made the commitment to provide care, and how much of the result is out of your control. Your job is to be the best possible companion on the journey.
- 3. Exercise helps protect you from injury, especially when the care recipient needs physical help such as assistance transferring to and from a wheelchair.
- The Family Caregiver Alliance suggests preparing a list of things that need doing. This makes it easier to 4. delegate when someone offers help. By letting others help, you are providing a web of support rather than a single lifeline.
- 5. Joining a support group to vent feelings can also connect you to information and resources about your care recipient's condition. This kind of information helps you anticipate certain needs and ask better questions of medical professionals.


Voice also contributed five assists and five steals, while Cody Mittig chipped in with eight rebounds and four assists. Moore added five rebounds and Remsberg had four boards.


"I think our players learned from this game and despite the loss, I think we might have learned some important things about ourselves as a team," said Hertel.





Visitors can tour the palace and the gardens, getting a good look at the crystal ceiling of the 30-ton main dome, stained-glass windows, inlaid marble floors and walls, hand-carved teakwood furniture imported from India and, of course, the 22-karat gold that seems to virtually cover the buildings.






