

School "Leap Frog Program" reconized

BOYNE CITY — Boyne City Elementary School received an Education Excellence Award recently for developing an innovative program to improve student achievement. The Michigan Association of School Boards bestowed the award Gov. Jennifer Granholm, state Sen. Jason Allen and state Rep. Kevin Elsenheimer issued an honorary proclamation to the school.

As Michigan struggles financially and many school districts face cutbacks, school administrators and staff have created and implemented a system that has dramatically enhanced student performance without requiring additional



funds, materials or staff. Dubbed "Leap Frog" because students may move in, out and among various groups, elementary school principal Fred Sitkins ex-

plained that support staff travel to each grade level for two 30-minute sessions throughout the day creating student-teacher ratios sometimes as low as 3 to 1. ## Man charged with arson of house

BOYNE CITY — A man is accused of setting fire to a house in which he lived by the Charlevoix County Prosecutor's Office, following a determination by the state fire marshal that the fire was intentionally set.

Cordell Lester Cambric, 53, of 2082 Timber Ridge Trail was arrested by the Charlevoix County Sheriff's Office on May 22, and charged with three counts. Count one is arson of a dwelling, a 20-year felony; count two is arson of insured property, a 10-year felony; and count three is a charge of habitual offender. Past convictions are for burglary and possession of controlled substances.

A preliminary examination is set in Charlevoix county for June 5, when it will be determined if probable cause exists to try Cambric on the charges in circuit court. A \$200,000 bond was set.

The April 22 fire destroyed the house and spread into the surrounding wooded area. No injuries were reported. Boyne City Fire Department, Michigan Department of Natural Resources, Charlevoix Township Fire Department and Boyne Valley Fire Department were all involved in fighting the blaze.

## Case against Boyne dismissed

BOYNE CITY — A lawsuit filed by developer Devlon Properties, Inc. Against the city of Boyne City in August 2006, was tossed out of court on May 18.

Devlon Properties had claimed money damages when the city revoked its permits that allowed construction of a residential hotel and restaurant known as "Boyne Beach Club."

The city revoked the permits in May 2006, because they had expired, according to former planning director, Dan Reed. A city ordinance states that construction of a project must commence within one year from the date of the issued permits. The city claimed that no such construction had begun. According to city ordinance, Devlon was therefore required to reapply if it planned to pursue its lakefront project.

"Learning is a function of time," Sitkins said. "With this program, students receive a second dose of instruction. It's like an elementary school version of a SWAT team. We target specific areas of difficulty for intense focus and work toward eliminating discrepancies between students without placing them in a particular group for their educa-

Since implementing the program in the fall of 2005, the results have been striking. Tracking their progress throughout the school year and beginning with 53 percent of the students working at or above standard and 47

percent below, by the spring semester the percentages had adjusted to as high as 80/20. The number of students scoring below average on the district's assessment was reduced by half.

"The combination of Leap Frog periods and after-school support have produced the greatest academic gains we have ever experi-

enced," Sitkins said. "This program has also provided the opportunity for enrichment periods for students who are performing above grade level and traditionally under served."



#### Omega-3 Fatty Acid & Dementia

The omega-3 fatty acid DHA (docosahexaenoic acid) that is found in fish oil may lower the dementia. Scientists followed 900 people with an average age of 76 for nine years After accounting for other risk factors, the participants with the highest blood levels of DHA were 47% less likely to develop dementia than those with lower levels. The nigh-DHA group reported eating fish an average of three times a week. Fatty fish like salmon, herring, mackerel, and sardines are good sources of DHA but it is also available in supplement form. 





## Senior center to burn mortgage

Sunday, June 10, Boyne area seniors are inviting the community to Sunday dinner to celebrate burning of the mortgage. The dinner is also a fundraiser to create an endowment fund for future maintenance and an irrigation system. Dinner will be held 12 to 2 p.m.; cost for adults will be \$8, with children under 12, \$4.

Fundraising began in January 2001 when Boyne Area Seniors became a 501(C)(3)tax-exempt foundation. The new senior vides staffing and center represents à \$980,000 investment. ## Hospice of Little Traverse Bay breaks ground

PETOSKEY-Hospice of Little Traverse Bay broke ground last week for the construction of Hiland Cottage, a sevenbedroom hospice residence and community grief and loss center. Community members were invited to attend the groundbreaking ceremony held at the future site of the hospice house with a reception following at the Bay View Inn.

"You're all here today taking part in a historical moment," fundraising chair Roger Lintz during the Hiland Cottage groundbreaking ceremony last Thursday. "I want to thank them (campaign committee) personally and those who have been so generous in their giving, through monetary means and through their time."

Named for long-time hospice advocate and board member Hiland Hall, the 18,000-squarefoot, two-story building will house all hospice operations on the first floor, including administration, counseling staff and volunteers. The second floor will have seven patient bedrooms, a

kitchen, a meditation room, a family/children's play room, a beauty shop, a library and an office for nursing staff. Hiland Hall's wife, Joedy Hall, was in attendance at the groundbreaking with her son and daughter-in-law.

Hiland Cottage will be located in Petoskey off of Balsam Avenue near the Northern Michigan Hos-Lockwood-MacDonald campus. It will provide a place of comfort for patients and their families as they experience the endof-life transition together.


The facility will also house all Safe Crossings Community Support Services, which includes community support services such as bereavement programs for children and teens, adult grief support groups and individual counseling.

These programs are offered free of charge to anyone in the community who has lost a loved one regardless of their participation in hospice services. Funding is provided by grants, memorials and other community gifts.

Hospice care is available to anyone, of any age who has a life-limiting illness. Those who would benefit from a hospice facility are those whose caregivers are unable to maintain care for the patient at home, for those without a caregiver available or those whose symptoms are such that they need 24hour care to maintain their level of





front of a farm house.


That moment, was an instant I was glad to be living in a small town.

## It's important to be prepared

Be prepared.

That's the motto of the Boy Scouts.

"Be prepared for what?" someone once asked Lord Baden-Powell, the founder of Scouting.

"Why, for any old thing," said Baden-Powell.

That advice still rings true. As a former scout, and now serving as a state senator, I've always believed in the value of being prepared. In an age when terrorism and natural disasters continue to make headlines, it makes more sense than ever to be ready for emergency situations.

By investing a few moments now, you and your loved ones can have a strategy in place. Homeland Security Secretary Michael Chertoff put it well: "By simply taking a little time to sit down together and make an emergency plan, families can help answer important questions, such as where to meet, how to communicate with each other and what to do in the event of an emergency."

This extra layer of safety can come by taking three sensible steps: be informed, develop a plan, and make a kit.

Be informed. Find out what kind of disasters, both natural and man-made, are most likely to occur in your area. Inquire about emergency plans at places where your family spends time, such as work, daycare and school. If no plan exists, volunteer to help create one.

Develop a plan. It may be easier to make a long-distance phone call than to call across town, so an out-of-town contact

may be in a better position to communicate among separated family members. Be sure that every member of your family knows the designated phone number and has a prepaid phone card to call the emergency contact.

Make a kit. When preparing for a possible emergency, think first about the basics needed for survival: fresh water, food, clean air and warmth.

An emergency supply kit should have at least a three-day supply of non-perishable food and one gallon of water per person per day for at least three days, for drinking and sanitation. Experts also recommend a first aid kit, flashlight, extra batteries, and a battery-powered radio.

Depending on your family, additional items to consider are: prescription medications, infant formula and diapers, food and water for pets, and important documents, such as insurance policies and bank account records in a waterproof, portable container

Another handy tool is chlorine bleach. When diluted nine parts water to one part bleach, household bleach can be used as a disinfectant. Or in an emergency, you can use it to treat water by using 16 drops of regular household liquid bleach per gallon of water.

Blankets, fire extinguishers, matches and personal hygiene items are also wise choices.

Disasters come in all forms. Blizzards, power loss, floods, tornadoes, even acts of terrorism. Make sure your family knows what to do in case of an emergency.

It always pays to be prepared.



## Sea lamprey control planned for Bear and Jordan Rivers

US Fish and Wildlife eas near stream mouths. at the time. Sea lampreys invaded the Great Lakes in the 1920s and have been a permanent, destructive element of the fishery ever since. Sea lampreys attach to fish with a suction cup mouth, rasp a hole through the fish's scales and skin, and feed on blood and body fluids. The average sea lamprey will destroy up to 40 pounds of fish during its parasitic phase. Sea lamprey larvae hatch from eggs laid by

adult lampreys in gravel nests, and drift into silty bottom areas where they burrow and live for several years. Also, larvae sometimes drift out of streams and settle in the immediate offshore arFailure to detect and subsequently eliminate larvae allows the lampreys to transform into parasitic adults and kill Great Lakes fish. Infested tributaries and offshore areas must be treated every three to five years with lampricides to control sea lamprey popula-

Most stream treat-

TFM, but in deep waters offshore of stream mouths crews use Bayluscide 3.2 percent Granular Sea Lamprey Larvicide, another lampricide approved by the US Environmental Protection Agency and Health Canada Pest Management Regulatory Agency. This lampricide is specially formulated onto sand granules and covered with a time-release coating. The formulation is sprayed over a measured surface area of water by boats where it sinks to the bottom, rapidly dissolves, and causes the larval sea lampreys to leave their burrows and swim to the surface where they can be collected to verify the extent of the infestation and assure their destruc-

The US Environmental Protection Agency

and Health Canada Pest Management Regulatory Agency have reviewed human health and environmental safety data for lampricides and in 2003, concluded that the lampricides (Lampricid and Bayluscide) pose no unreasonable risk to the general population and the environment when applied at concentrations necessary to control larval sea lampreys. However, as with any pesticide, the public is advised to use discretion and minimize unnecessary exposure. Applicators are trained and are certified by Michigan regulatory agencies for aquatic applications of

pesticides. The program is contracted through the Great Lakes Fishery Commission to the US Fish and Wildlife Service and Department of Fisheries and Oceans Canada. The Commission initiated chemical control of sea lampreys in 1958. Since that time the highly successful program has contributed significantly to the maintenance of the \$4 billion Great Lakes sport and commercial fisheries. Without continued control efforts these fisheries again

would be in jeopardy. The Commission is committed to delivering a sea lamprey control program that practices good environmental stewardship. To support the continued safe use of lampricides the Commission recently conducted a series of studies at a total cost of \$6 million to assess the effects of the lampricides on human health and the environment. In addition to these studies the Commission has implemented a research program to develop alternative control techniques. US Fish and Wildlife Service and Department of Fisheries and Oceans Canada are currently evaluating the release of sterile male sea lampreys as a control measure in the St. Mary's River. The Commission also is developing a strategy to increase the number of barriers on lamprey-producing streams, and is conducting research into barrier design, traps, at-

### Red Cross completes disaster readiness exercise and evaluation

PETOSKEY - The Northern Lower Michigan Chapter of the American Red Cross recently completed their first Chapter Disaster Readiness Exercise and Evaluation. On Tuesday, April 17, the chapter was visited by representatives from National Headquarters who administered the drill, assessing the chapter's preparedness and responsiveness to a potential disaster in our area. The "tabletop" exercise used a time simulated environment mimicking the timeline forecasted in the case of an actual event. In response to the tornado, the chapter set up a mock Red Cross headquarters, contacted volunteers, external partners to obtain permission to use their facilities as shelters, and obtained other support in the form of mass feeding, to name a few.

Staff and volunteers came together, performing in roles they had not played before and working as a team to coordinate resources, shelter, feed, and raise funds. Overall the chapter discovered they have great competency in a number of areas and were praised for their ability to think outside the box.

Dave Guiterrez, a Red Cross representative from the Great Lakes

ministrator of the drill, praised the chapter for thinking of things they had not forseen, saying, "The volunteers and staff of the Northern Lower Michigan Chapter have extensive knowledge of their area and resources. We as drill administrators had not considered that the actual Wal-Mart store could also be affected, limiting our feeding resources. The chapter quickly realized this potential eventuality and
