EAST JORDAN - The city's offer of early retirement made to three employees was rejected by all three. Administrators and the city commission will now look at other options to balance the budget.

City administrator, David White, reported to commissioners at a June 19 meeting that the U.S. Army Corps of Engineers is taking public comment on harbor dredging until June 29. A permit may be issued following that date, but White noted that the time might not allow dredging, because of the season's fish population.

East Jordan's public marina cannot use 12 of its 60-some slips because of sand that has gathered in the area.

Summer is blooming at the farm market

BOYNE CITY - When the first vendors pull into line at Old City Park, it's a sign that summer is really here. From tents and tables lining the sidewalks on the corner of River and Park streets, local farmers, bakers, craftspeople and horticulturists bring the best of the season to Boyne City every Wednesday and Saturday from 8 a.m. to 1 p.m. During peak season, there are approximately 60 venders that participate.

Visiting the farm market is a festival of abundance and an exercise in temptation. From the riotous displays of perennials, annuals and cut flowers to the homemade baked goods, preserves, arts and crafts and fresh local produce, it 's an irresistible assemblage of earthly delights.

"Without a doubt, it's the best farm market in Northern

Michigan," Boyne Area Chamber of Commerce Executive Director Scott MacKenzie said. "All products and produce are grown or manufactured within a 30 mile radius of town, unless there is a niche that isn't filled. Exceptions are approved by the farm market board.

"Not only do local shoppers get healthy, quality products, but they're also helping to preserve a traditional way of life and the natural beauty and open space that we all value in Northen Michigan."

Dave Siegrist of Siegrist Farm and Greenhouse in Boyne Falls echoed MacKenzie's statement that it is the best farm market in the area. Seigrist has been selling plants, flowers and honey at the market for 22 years and he recalled that at that time not many venders made the trip to town with their produce.

"There were just a few stand holders then," Seigrist said.

"and we used a bench or a little card table, or we'd just pull in and sell off of the back of the truck."

Anyone who has ever sampled the mysteriously piquant concoction, Sweet Creamy Mustard, from Washburne's Tasty Treats, knows just how long the winter can be when, in mid-February, the knife clinks against the bottom of the last jar in the pantry. Mike Washburn of Charlevoix is the creator of this addictive condiment and his woebegone caricature adorns the label.

Gerber's Homemade Sweets from Charlevoix make it difficult to settle on just one of the many flaky-crusted pies, breads and sweet rolls that fill their table. Laureen Gerber began baking with her mother when she was a little girl, and it's her mother's pie crust recipe that is used in the hand rolled pastries.

One of the crowd of shoppers on Saturday, Kristin Bates, owner of Lost and Found Antiques and Unusuals on Water Street, pulled a basket of strawberries from her bag to admire them.

"Look at how shiny they are." Bates said, holding the berry by its long stem. "This market is one of the best things about summer."

Shoppers move from booth to booth, sampling and asking, "Is your crust..."

"Homemade? Yes."

nual basis at the boat launch. When dry, all material gathered would be relocated to an offsite upland area. according to the U.S.Army Corps of Engineers public notice of June 15.

The purpose of the project is to increase navigation opportunities within the South Arm of Lake Charlevoix and to allow larger boats access to the public boat launch and marina.

In other matters at the June 19 commission meeting, reconstruction is planned for the intersection of Mill and 4th streets after work on M-32 caused overuse at that intersection.

White said a contract would be signed with a contractor to remove the corner market. The city expects a report from an environmental consultant before proceeding with the project.






Twister Joe, northern Michigan's favorite balloon artist, performs his magic just before the parade begins.




Jill Jack opens concert series

On Thursday, June 14, the MSU Extension Office transported 48 Charlevoix County students and chaperones to Mackinac Island for the Lilac Festival as part of their Master Gardner Program. The group toured the Mackinac Island Butterfly House, the new Insect World, as well as the Stuart Museum.

The Junior Master Gardener Program is geared towards third to fifth grade students who wish to be instructed on topics involving soil, flowers, vegetables, fruits and food preservation. The classes run for about eight to 12 weeks, and following the completion of ten hours of community service, there is a graduation ceremony where students receive official Junior Master Gardener diplomas. Each year the program takes a group of the gardeners to visit a garden facility. Over the years they have been to garden facilities in

of the world's most beautiful and rare insects.



Sheriff warns of fraud


CHARLEVOIX - Sheriff George T. Lasater advises that a fraudulent mailing is going out to citizens of Charlevoix County stating they are required to complete an electrical inspection.

This mailing fraudulently uses the Building Department of Charlevoix County's name and address on it and claims that records indicate a failure to complete home inspection. 

Proposed gravel pit will detract from area

To the Editor:

I read with interest the East Jordan high school journalism students' editorials in last week's paper. I think it's great that the kids did research and submitted their work to the local newspaper. I am very concerned, however, about several statements made in the editorials that are not true, and would like to bring them to the attention of your readers. I live in South Arm Township and am a member of Neighbors United, a group of local people who are opposing MDC Corporation's (Manthei) application for a special use permit to operate a sand and gravel mining and crushing operation on

Ellsworth Road (C48) at Ranney Road. I have attended both Township Planning Commission meetings that have had this issue on the agenda, and have copies of all the applications and correspondence MDC has filed with the township.

township.

MDC is not putting up a fence to keep wildlife out. MDC was very misleading by stating they would put warning signs on the "fence posts", inferring that there would be a fence. Posts with signs on them are called sign posts. When questioned by a planning commission member, the MDC lawyer admitted that there would not be a fence.

There is no guarantee that new

jobs will be created by opening this pit. In MDC's presentations, verbally and in writing, to the township regarding this enterprise, there has been nothing promised to that end.

It is true, we do have three sand and gravel pits in a four mile stretch on Ellsworth Road. We feel another mine will multiply the noise and dust pollution exponentially and it is not a reason to allow yet another one. Enough is enough. We are already oversaturated.

I disagree that a sand and gravel mining and crushing operation will be healthier for the earth than what people individually do every day.

I also disagree that the noise on site will only be as loud as someone talking. In defense of the student who wrote that statement, I believe he researched this information from the statements made at the public hearing by MDC's lawyer. The lawyer had the audacity to tell the commission and local residents in attendance that the sound of a concrete, asphalt and rock crusher would be the same decibel reading as his loud voice, even the same as a babbling brook. What a ridiculous statement! How insulting to our intelligence! Don't forget the noise of all the heavy equipment operating on site, back-up beep-



ers, double tandem semi's accelerating up a large hill to leave the pit and jake-brakes applied to slow these huge vehicles downhill to enter the pit.

Regarding the 6' berm that MDC will build for a buffer, you must understand that on the north edge of the property (bordering Ellsworth Road,) they are tearing down a high (perhaps 20' tall by our visual estimates,) natural, beautiful hill covered with

mature trees. What they will replace it with is a 6' high soil berm. This doesn't make sense.

A twelve hour work day for an operation that has told our planning commission they will have minimum crushing activity and only several trucks in and out all day, doesn't add up. A mine of the same acreage looking for a permit in Norwood Township has indicated they will have 30 trucks in and 30 trucks out per day. Quite frankly, we

don't believe MDC's estimate. A twelve hour industrial operation day is too long.

We have many more issues, problems, and effors uncovered in our diligent research regarding this special use permit application. If you would like more information, have ideas or suggestions to share, or want to get involved, please feel free to call our family.

Rotation being set

ATLANTA—Andrew Miller's North Carolina Tar Heels are back in the College World Series championship game, the same place they were a year ago. Miller is a fulltime Major League starter, a long way from Chapel Hill in a year's time.

Beyond the trade of Mike Maroth, the Tigers also set their rotation for the near future, with Miller in it. After the Maroth deal opened a spot for Kenny Rogers, Chad Durbin is moving to the bullpen to make room for Nate Robertson next Tuesday, leaving the 22year-old Miller in his spot after Sunday night.

It's the next step for the Tigers' first pick in last year's First-Year Player Draft, who began the year at Class A Lakeland and progressed swiftly up the ladder over the past month and a half. But it's not something he expects to change his mind-set.

Manager Jim Leyland has made a point throughout Miller's stints here not to expect too much, too soon, emphasizing that Miller will have his ups and downs while he learns to use his talent at the bigleague level.

Miller hasn't dominated in his two starts since being called up from Double-A Erie a second time, but he has shown enough to convince Leyland and club officials that he gives the team a shot at a win when he takes the mound.

It's enough of a shot

that it's worth taking a chance.


"I think the worst thing you can do," Leyland said, "is to win and sit still and pretend that you'll never have any problems again. So I'm giving Andrew Miller a shot. I don't know how it's going to work out. I'm not that smart. But it's talent, and there's no pressure on him.

"It's an ongoing process," Leyland said. "But like I said, if you send Andrew Miller out there, somebody who's got that kind of crude stuff, you've got a chance."

It's the potential of that chance that sent Durbin back to the bullpen, where he was originally slated to start the season before Rogers' arterial bypass surgery opened a spot in the rotation. Durbin is 6-3 with a 4.37 ERA in 14 starts, during which the Tigers have gone 8-6. His last start was a six-inning, one-run performance last Tuesday at Washington, ending a personal two-game losing streak.

His next outing will be out of the bullpen, possibly as soon as Saturday.

"I want to make this perfectly clear: He didn't do anything wrong," Leyland said. "Chad Durbin did not pitch his way out of the rotation. We've been put in some situations recently where we had to make some very important decisions. He was really a victim of the situation."

The Detroit Tigers announced the club has traded left-handed pitcher Mike Maroth to the St. Louis Cardinals for a player to be named later on or before September 15, 2007.

Maroth started 13 games for the Tigers in 2007, compiling a 5-2 record and 5.06 ERA (78.1IP/44ER).

Acquired by Detroit in a two-player deal with the Boston Red Sox on July 31, 1999, Maroth posted a 50-62 record and 4.81 ERA (880.0IP/ 470ER) in 147 games (143 starts) during his career with the Tigers.

Additionally, prior to Robertson's return tonight's game in Atlanta, the Tigers have reinstated left-handed pitcher Kenny Rogers from the 60-day disabled list.






Above, Rambler Jessica Nichols sprints for the finish line in the 100 meter dash finals at the regional track meet.

Rookie wins on road course

SONOMA, Calif. — Juan Pablo Montoya had to work for his money Sunday at Infineon Raceway.

Facing a level of competition that surprised him with its quality, Montoya conserved fuel at every opportunity during the final 41-lap greenflag run and made it to the finish line first in the Toyota/Save Mart 350.

It was the first NASCAR Nextel Cup victory for the much-publicized rookie from Formula One, who joined Mario Andretti and Dan Gurney as the only drivers to win in F1, IndyCars and NASCAR Nextel Cup.

In his No. 42 Ganassi Racing Dodge, Montoya also posted the first Car of Tomorrow win in a car other than a Chevrolet. Montoya, of Colombia, is the first driver born outside the United States to win a race in NASCAR's foremost series since Canadian Earl Ross triumphed at Martinsville in 1974.

The Richard Childress Racing trio of Kevin Harvick, Jeff Burton and Clint Bowyer stretched fuel mileage to claim positions two through four. Believing Montoya might run out of gas, Harvick raced conservatively over the final 10 laps and crossed the stripe 4.097 seconds back.

Greg Biffle was fifth, followed by Tony Stewart, Jeff Gordon, Kyle Busch, Boris Said and Denny Hamlin.

"I was very surprised at the level of driving here on a road course," said Montoya, who made up for Friday's 32nd-place qualifying effort. "The top five or six cars were really strong, but them, the top 20 was like — whew! — I definitely worked for the money.

"We worked hard for it, and the whole team deserves this."

Before Montoya's victory, no Cup race winner at Infineon had started deeper in the field than the 13th starting spot.


Montoya, who won the Busch Series road race at Mexico City in March, battled polesitter Jamie McMurray over the closing laps of the 110-lap race and finally took the lead through turn 2 on lap 104. McMurray ran out of fuel on lap 109, coasted into the pits and fell to 37th place at the finish.

Asked whether the victory was more satisfying than his wins in Formula One or IndyCars, Montoya, 31, said it would be difficult to compare his successes.

"It's hard to say this is bigger than that," said Montoya, who won seven F1 races in addition to winning the 2000 Indy 500 and the CART championship in 1999 as a rookie. "I would say right now this is the biggest thing I've done. It's unbelievable. In openwheel, that's what I was meant to be winning in. In stock cars, I wasn't.

"To get our first win in our first year is huge. We know we're a little behind at some of the ovals, and we still need to work hard, but I think this is a big boost for everybody working in the shop."

The victory wouldn't have happened, however, had Montoya been unable to get the most out of his gas tank.

Tip on playing in the wind

Have you ever heard the saying, "When it's breezy; swing easy?" It's an old golf cliché that has been around forever. But it's very good advice.

What will swinging more easily do for you when the wind is up? Well, for one thing it increases the chances of solid contact, which will create a more penetrating ball flight. Conversely, swinging harder, in an attempt to fight the wind, decreases the chances of solid contact for various reasons (wrong muscles in the wrong sequence, loss of balance, increased grip tension, the list goes on...). Another benefit of swinging more easily is that it compresses the ball less, which causes it to spin less, creating a more penetrating ball flight.

Notice the theme: solid contact and keeping the ball down. Swinging harder when the wind is blowing is a powerful instinct to overcome. But if you can discipline yourself to use more club and swing easier (like all the textbooks, great players and great teachers have been recommending forever) it will have a wonderful effect on your ability to control the ball in the wind. Give it a try.

DNR WEEKLY FISHING REPORT

The following is the weekly fishing report, as provided by the Department of Natural Resources:

Petoskey - In Little Traverse Bay, good numbers of 2- to 5pound smallmouth bass have been caught and released as the fish were still on the beds.

were still on the beds.

Charlevoix - Is
where most of the
chinook salmon have
been caught on spoons,
dodgers and flies. Lake
trout have also been
caught. Check water
temperatures daily as
they tend to fluctuate
quite a bit this time of
year.

Lake Charlevoix -Panfish are close to shore in the weedbeds while smallmouth bass are right along the drop offs. Walleye are biting at night along the west end of the lake and in the channel.

Walloon Lake - Bass fishing for both large and smallmouth has moved out to waters 10 to 20 feet deep. Shallow running baits and spinners work best. A few walleye are being caught using crawler harnesses or rapalas. Try 10 to 30 feet deep in the early morning or late evenings and deeper waters during the day. Perch and bluegills have also been caught on worms, minnows, flies or small

spinners.

Thumb Lake (Lake Louise) - Splake anglers are trolling near the island on the east half of the lake and close to the Saddle on the west half of the lake. Minnows or spawn in 40 to 80 feet of water was the ticket. Both large and smallmouth bass are hitting on tube baits, poppers, minnows, crawlers, crankbaits and spinners in waters anywhere from 5 to 40 feet deep. Bluegills were caught in the backwater areas around the island and in the northwest margins of the lake. Perch and rock bass have been caught and bullheads are starting to show up in the shal-

Elk River - Has excellent smallmouth bass fishing when using leeches and crawlers at the dam.

Torch Lake - Fishing

for pike and walleye has been good in the early morning or just before dark. Try working the visible weed lines with jigs or trolling close to them. Both ends of the cuts where they open up into the two lakes have been productive. Smallmouth bass are being caught on minnows and soft plastics in 6 to 10 feet of water off the rocky shoreline.
