

Boyne citizens to vote on parking space issue

BOYNE CITY — The controversial parking boundary zone in the city's downtown area will go to a vote of the people on the Jan. 15 primary election ballot, or at the first election in

That was the unanimous decision of the city commission at a Nov. 5 special

meeting, called in response to a petition drive against the commission's previous decision. On Sept. 11, four of the five city commissioners voted to adopt a parking boundary zone that some business people and residents opposed.

The major reason voiced in opposition to the parking boundary zone was that the designated area included the proposed One Water Street development. This allowed the developers to forego the construction of approximately 90 parking spaces, which opponents said would cause a shortage of downtown parking for businesses.

The parking boundary zone designates an area where developers and business owners within the boundaries may ask the city to waive the construction of the full number of parking

spaces that the zoning ordinance requires.

The petition drive acquired more than 700 signatures, with the minimum number of 675 signatures required. The election ballot will ask voters whether repeal the city commission's Sept. 11 approval of the parking exempt zone map, and the approval of an amendment to

the zoning ordinance.

BOYNE CITY — Not many people seemed to be familiar with Mike Cummings, but 297 voters approved of him over incumbent Jerry Douglas who received 94 votes in the Nov. 6 election for city commission.

Cummings, of 635 North St., ran on his outspoken support of the views and decisions of city commissioner Chuck Vondra, on what he, Cummings, said was a need for the commission to listen to the citizens, and on his belief that the waterfront is for the community instead of special interests.

Chuck Vondra was reelected to his third term on the city commission with 373 votes. Some of Vondra's decisions that were key to his re-election are his conviction that development adhere to the city's zoning ordinance, his opposition to the downtown parking boundary zone, saying it will

hurt downtown businesses, his concentration on bringing businesses into the industrial parks, and his desire to create more recreation for residents and visitors.

Vondra and Cummings were sworn in on Tuesday, Nov. 13, at the regular commission meeting. The terms are for four years.

East Jordan fills four seats

EAST JORDAN — Voters retained one of the two incumbents who ran for re-election to the city commission and elected three new city commissioners at the Nov. 6 election.

Incumbent Dan Bennett began his second four-year term as city commissioner following the swearing-in ceremony on Monday, Nov. 12, at City Hall. He received 225 votes.

Also sworn in were Ray Fisher, Deneille Moes and Paul Timmons. Fisher received 266 votes, Moes 182 and Timmons 214. Fred Vollbach who was running for reelection lost his seat with 137 votes. All terms are for four years. Two of the seats open were those of Todd McNitt and

Jean Timmons who decided not to run again. Voters also passed a refinancing on property owned by

the city adjacent to the boat launch. The purpose for refinancing is to obtain a lower interest rate, according to the city. The vote was 178-157.





Natural born teacher in harmony with students

EAST JORDAN — As a two-year-old in the mid-1980s, Patrick Ryan took the stage to plunk on a ukelele during his father's show at Duffy's in Charlevoix. Admittedly, it was more of a novelty than a musical high point, but for the little boy, it was the beginning of a life-long passion. And it has come full circle. Ryan recently played another weekend gig with his father, Sean Ryan, a popular singer and guitarist who has been entertaining Michigan audiences for more than 20 years.

But this is not his day job. Patrick is the new Director of Bands and Choirs for the East Jordan schools, where he teaches grades six-12. He graduated in May from Aquinas College in Grand Rapids and at the age of 23 he has the job that he had hoped for. He is having a wonderful time and he's taking the students with him. "I knew from a

very young age that I wanted to teach," Patrick said with a characteristic rush of around some teachers. Barry Bennett and Carl Brien were my high school. for Barry. He gave me his sixth-grade percussion class, who are seniors

this year. I'd worked hard to be a good percussionist and when I saw that the kids loved it and wanted to do more it was, well... It was really amazing." Following Patrick's conversation is somewhat

like tobogganing down a steep hill. The scenery is breath-taking, the ideas are engaging and the sharp turns can snap a person's neck like a twig. It is impossible not be caught up by his enthusiasm and

Patrick Ryan was born on Christmas Eve, 1984, in Petoskey. His parents were both born in Ireland, making him a first generation American citizen.

"My parents made me take piano lessons from first to fifth grade," Patrick said. "I'm really grateful now because the piano is such a great point of reference. All of the keys - everything is just laid right out in front of you."

Musical inspiration was plentiful and varied in the Ryan home. Besides his father's folk and Irish ballad influences, Patrick names the Beatles, Dave Mathews, Buddy Rich and John Coltrane as artists that have had an impact on his life.

When Patrick's afternoon choir class files in on a Monday, there is the raucous exchange of kids settling into another school week. It's hard to differentiate Patrick from the students. Although, at well over six feet, he is taller than most, his ease and good-natured give-and-take with his students make him seem more like a peer than a teacher. But after the preliminary hellos and high-fives have

been exchanged. Patrick calls for their attention and the class complies with obvious respect.

"I tend to have high expectations from my students. I feel like I'm cheating them if I don't expect the best," Patrick said. "I assign band practice homework on the honor system. I told the kids, 'Sure, if you want to, you could just say that you practiced and have your parents sign off on it. But I'll be able to tell by the way that you play."

He paused and added, "I think that teachers should get Academy Awards. You've got to be up and happy to be there. You can't bring things that might be bothering you in your life into the classroom."

Brandishing a pointer that he wields like a whip for emphasis and a wide grin, Patrick is perched on a stool surrounded by the circle of choir students seated in folding chairs. He crackles with an upbeat energy that is galvanizing.

"I like to let the band improvise for a few min-

utes every day," Patrick plained when asked about his teaching methods. "It's not productive to grind on one difficult piece to the point of exhaustion. It's better to have some fun and then come back to it.

If a student is struggling and needs some extra help, Patrick is happy to oblige.

"I let them know that I'm available after school. Pretty much every day there are 10 - 12 kids from the middle school who stay to work some more."


Maybe the turnout is so good because Mr. Ryan is good at making his students want to excel. There are some teachers that inspire that sort of commitment and effort. Teachers that lead by example and communicate an infectious joy for the subject. "My dad told me, 'Music is a gift - pass it on,"

Can you hear me now?

The Nov. 6 election in Boyne City sent a message to the city commissioners that is pretty darn clear. The voters' message: "You aren't listening to us so we'll find someone who does."

Meeting after meeting a number of residents advised city commissioners that the citizens were disgruntled because the commissioners were not listening to the people and their opinions about development. Several commissioners remarked that it was always the same residents making the statements. They seemed to think it was the few who spoke up who were disgruntled and not

That all changed on election day when incumbent Chuck Vondra, who is known for listening to the people, garnered 373 votes and newcomer Mike Cummings, who ran as a "Vondra-ite," received 297 votes. Incumbent Jerry Douglas took only 94 votes.

And make no mistake, this was not an anti-Jerry Douglas vote. It was a Jerry Douglas-isn't-listening-to-the-people vote.

Douglas isn't the only commissioner who has not been listening, but the others were not up for re-election. Eleanor Stackus, Ron Grunch, Dan Adkison, and at times, Chuck Vondra, supported a development that the majority of citizens thought was too large. A Michigan Department of Environmental Quality public meeting held in July was packed with opponents of the One Water Street marina plans that were part of the development.

The MDEQ denied the marina plans that the city commissioners had approved. The state of Michigan knew the plans were not good for the city and Lake Charlevoix. The public knew the plans were not good for the city and Lake Charlevoix. The Tip of the Mitt Watershed Council knew, as did the Charlevoix County Planning Commission. Everyone knew except for the city commissioners. Why is that?

A smaller development project may be an asset at the One Water Street location, but what would be great is for the commission to put more effort into creating ways to entice industries and businesses into the industrial park. Businesses that would bring jobs to Boyne City, jobs that pay more than minimum wage and are offered to local people, not workers who are shipped in to clean summer residences or build houses. Jobs that will keep young people here to raise their families.

The city commissioners ultimately want what the citizens want a friendly, vibrant city that is still recognizable as "home." The commissioners should listen less to developers, consultants and "experts" and more to the people who trusted them with their votes.







Robby Jensen was one of two 1,000-yard rushers for the Ramblers this season, and received the team's Most Valuable Player award presented at Sunday's banquet.


Boyne City's other 1,000-yard rusher, Trevor Kruzel, was named the Offensive Most Valuable Player.

was to work together as a team, and Nelson said that was one goal his team definitely achieved.


"This group never gave up," he said. "They constantly worked hard no matter the score or the time left." Looking forward to

Other hazards of diving past 100' include: DCS (decompression sickness or "the bends") and nitrogen bubbles that form in your blood stream from the added pressures.


According to Miller, these potential dangers can be avoided by closely monitoring times and depths. Also, a slow assent is crucial.

Another danger is nitrogen narcosis, which is the narcotic affect of breathing compressed air at depths approaching 100'. Nitrogen narcosis can cause irrational thinking and poor judgement.

Students are also taught bouyancy control to avoid a "silt-out," or when the bottom is stirred up reducing visibility to zero. Silt-outs cause buddy separation and disorientation.
