

#### New law for off road vehicles

CHARLEVOIX — Off Road Vehicles may be permitted on the far right side of designated roadways in Charlevoix County and other Northern Michigan counties under a new state

Public Acts 240 and 241 allow individual counties to pass an ordinance that permits and regulates the use of Off Road Vehicles (ORV) on the far right of the maintained portion of roads and streets at speeds not to exceed 25

The law also permits counties, cities, villages and townships to close any roads and streets desired to ORV traffic.

The Charlevoix County Board of Commissioners reviewed the new law and the six roads that the county road commission recommends be closed to ORVs at its Aug. 27 meeting. Commissioners will meet with the county sheriff's office to determine any roads it may want closed to ORVs before drafting an ordinance.

The road commission's recommended list of roads to be exempt are listed in a sidebar to this

**Charlevoix County roads** proposed by the Charlevoix County Road Commission to be closed to ORVs:

• Boyne City-Charlevoix Road from Boyne City city limits to U.S. 31

• Boyne City-East Jordan Road from M-75 to East Jordan city limits

• Ellsworth Road from East Jordan city limits to Antrim County line

• Marion Center Road from Charlevoix city limits to Antrim County line

• Thumb Lake Road from U.S. 131 to Otsego County line

• Main Street and Kings Highway, Beaver Island, from the lighthouse to East Side

story. The list includes the Boyne City-Charle-Ellsworth Road and Thumb Lake Road.

voix Road, the Boyne City-East Jordan Road, Charlevoix County has 713.81 miles of roads.

The law allows up to 30 percent of the road miles to be closed to ORV travel. Currently, the road commission proposes to close 47.62 miles of roadway to ORVs.

In a letter from the road commission to the county board of commissioners dated Aug. 26, the road commission explained that safety and liability on high speed roads are the reason for naming certain roads as not permitted for ORV

"The combination of heavy vehicular traffic operating above the speed limit, combined with the slower speed of ORVs creates an unacceptable risk to both the vehicle driver and the ORV operator who would have limited protection and a subsequent high mortality rate in case of col-

lision," road commissioners said in the letter. The road commission also recommended that additional road miles be added to the list if requested by any county township board prior to

any ORV ordinance Charlevoix County adopts. More discussions will take place by the county commissioners before an ordinance al-

lowing ORVs on roadways is drafted.

#### Cars roar into Boyne City for annual drag race



CITY BOYNE Screeching tires and the smell of burnt rubber ruled the day at the Annual Boyne City Police Department Drag Race at the Boyne City Airport this past Sunday.

Racers included both cars and motorcycles with any driver welcome to tear up the asphalt. Boyne City Police Chief Randall Howard puts together this widely anticipated race on the Sunday of each Memorial and Labor Day weekends since 2003.

"We expect between 85

to 100 entries and races vary per individual. We race for six hours from noon to 6 p.m. and drivers are welcome to make as many passes as they can get in during that time," Howard said. "There will be a wide variety of cars, everything from street cars to pro stock race cars, modified diesel pickups to motorcycles and even asphalt

drag snowmobiles." Trophies were awarded for best reaction time and individuals who traveled the furthest distance to participate. Also the fastest mph on the day received an

Howard said based on the information he has received, the drag race has been very well received in the community. The Police Chief looks most forward to watching people come from all over the state and out of state to gather in Boyne City for a great time.

"Probably about 25 percent of the drivers will be local. The farthest we had a driver travel is from Beckley, West Virginia," Howard added. "We invite spectators to attend. It is a great spectator event. Our local Boyne Valley Lions Club

will be providing food and beverages throughout the day. Children under 12 are free. It makes for a wonderful family outing."

When the event started in 2003, it was stipulated that 75 percent of the proceeds would go directly to the airport to be earmarked for improvements and upgrades. 25 percent goes to the Police Department.

Howard said the event has benefited all the parties involved with the airport making many improvements from the race proceeds.

The races are side-byside 1/8 mile drags with Full Tree or Pro Tree Options. Organizers also encourage "grudge" matches between participants. Each vehicle does have to pass tech inspections before being allowed to participate.

According to Howard, the track record for the fastest vehicle in the 1/8 mile is 125 mph set in 2006.

#### rexamai lays off 95 employees

Company explores restructuring

BOYNE CITY - Lexa-Mar Corporation located in Boyne City's industrial park laid off about 95 em; ployees just before the Labor Day weekend.

The action is a "permanent layoff' and is "a result of current automotive market conditions and a corresponding reduction in cus tomer production vol-umes," said a spokesperson for LexaMar's parent company, Magna International of America Inc. The layoffs affect both salaried and hourly employees. LexaMar produces dec-

orative moldings for vehicle exteriors. It is one of the largest businesses in the industrial park, employing approximately 400 employees.

Boyne City manager Mi-chael Cain said he has met with LexaMar management and with Northern Lakes Economic Alliance to discuss LexaMar's situation.

"Right now we're focused on what we can do to make sure they (LexaMar) stay here, stay viable and keep their doors open and employ as many people as possible," Cain said.

That is one of the reasons the city will not cancel the tax abatements it awarded to LexaMar. Tax abatements are a reduction in the company's property taxes



"The purpose is to provide timely information and to encourage networking among all those attending. We will do this every month or two," Baumann said. "Future speakers might be focused on a political issue such as the county road millage or a speaker to help business people with marketing ideas.'

Baumann said Cain and Alger will be giving updates on any new developments in the city and the schools and Catt will discuss the lakefront property he is planning to develop.

"The city always has a lot of issues in their hopper, and it's the start of a new school year. September is a good time to get an update since everyone is somewhat distracted by all the activities of the summer," Baumann explained. "We asked Glenn Catt to give us an update on the lakefront property he is planning to develop. He isn't quite ready to tell us all the details, since he won't have his proposal ready for another month or so, but perhaps he can give us a sneak peak, and he is open to input from the

public." Baumann has been very busy since taking over the role of Executive Director earlier this year. He said the job has been great and everyone has been very accommodating since he arrived.

'I just love this town. My priority in the early going has been to meet as many people as I can and to get to know the local issues and concerns of the community, and in particular the business community," Baumann said. 
'Communication is also important. I've made it a priority to improve our website and our weekly email newsletters. There is a lot going on here, especially in the summer, and that means we have a lot of good things to promote," Baumann added. ## Senior Project FRESH supports local farm markets

**CHARLEVOIX** COUNTY — The Michigan State University Extension has offered Senior Project FRESH, a USDA Farmers' Market nutrition education program, since 2005. "I submitted grant proposals on behalf of Charlevoix County, MSU Extension to the Charlevoix County Community Foundation in 2006-2008 and the Foundation has awarded graciously funds for the program,' Diane Rellinger, MSU Extension Educator for Charlevoix and Emmet Counties said. Charlevoix County Community Foundation highlighted Senior Project FRESH in their 2007 an-

nual report as a quality educational program that meets an identified need for seniors. Many limited income seniors are nutritionally at-risk; many live with chronic diseases and often do not have adequate funds to purchase fresh fruits and vegeta-

In her role as an MSU Extension Educator, Rellinger works in the USDA Food Stamp Nutrition Education program, a federal grant to promote healthier eating and more active lifestyles for limited income audiences through educational program-

"Since 2005, the Office of Services to the Aging in Lansing has partnered with MSU Extension and other lead agencies to administer the federal dollars for the Senior Project FRESH Rellinger program," commented. "Additional local dollars are needed each year to provide the complete funding for the program. Each Charle-County senior voix household receives \$40 of coupons through the local and federal dollars that are raised.'

The Charlevoix County Commission on Aging also provided \$1,500 and

Charlevoix County Senior Centers to assist MSU Extension in enrolling 222 seniors this harvest season. Charlevoix County Project FRESH farmers' markets that accept the Senior Project FRESH coupons are Kiteley Farms, Marvin's Gardens Lawn & Garden Supply, Boyne City Farmers' Market, East Jordan Garden Club Farmers' Market, Country Apple Farm Market, Charlevoix Downtown

Farmers' Market, and

Johnecheck Farm Mar-

"In 2007 and 2008, the Charlevoix County Commission on Aging Board of Directors also honored my request for funds for this senior program," Rellinger explained. "The Commission on Aging has been a valuable community partner helping to provide program promotion, use of facilities for enrollment classes and adequate local funding to serve a larger senior audience."

When Senior Project FRESH was initially launched in Michigan, only 17 Michigan counties participated in the first year with Charlevoix County included in that group. Since then more counties have come aboard and in 2008, a federal funding through a USDA expansion grant was secured to bring the program to all 83 counties. Charlevoix County senior enrollhave ments since steadily increased from 97 seniors in 2005 to 223 seniors this year.

"Participating seniors live throughout Charlevoix County. Community collaboration is the key to the success of Senior Project FRESH," Rellinger said. "MSU Extension extends a special thank you to East Jordan, Boyne City and Charlevoix Housing Commissions for the use of their senior housing complexes for enroll-

ment classes.' According to Rellinger, the community response for Senior Project FRESH has been overwhelmingly positive and seniors have commented on how much they appreciate the program and how the \$40 is very helpful, especially in tough economic times. Rellinger said the word of mouth has spread throughout the community deriving a real sense of satisfaction with the program.

Partnering agencies have

also given positive feedback on the effects of the program on seniors and each year these agencies make numerous referrals. Rellinger has also offered additional nutrition education classes for senior participants through MSU Extension to further educate citizens on nutrition questions.

Local Project FRESH farmers have also benefited, reporting increased sales with more seniors shopping at the farm markets. Rellinger said that along with the Emmet County Project FRESH program, the potential sales revenue from the two programs could total \$17,920.

"Every dollar for Senior Project FRESH program benefits two groups, seniors and local farmers. This unique program is a win-win because of that reason," Rellinger added. "No other agency or program provides free nutrition education and free access to fresh Michigan produce to promote healthier eating. It is a privilege to offer such a successful, vital program."

Cats and dogs allow for physical contact and offer consistent companionship, as well as unconditional love. They act as a support system for older people without homes or families or close friends, Lizzat said.

Pets also offer protection socially from isolation, separation anxiety for people in nursing homes and for people who don't have much opportunity to interact with other people, Lizzat said. Pets help seniors stick to regular routines such as going out for groceries and performing the everyday care routines for the pet.

Acute Stress Disorder

(ASD) is classified as an

anxiety disorder. ASD was introduced in 1994 because the experiences in the first month following a significant trauma did not fully meet the criterion for Post Traumatic Stress Disorder (PSTD). Those suffering ASD after witnessing or confronted with a threatened death, life threatening illness or injury experience a sense of numbing, detachment, and the traumatic event is repeatedly recalled. The hallmark feature of ASD is avoidance of similar stimulus where anxiety might be activated. Undiagnosed ASD following a significant trauma for instance an automobile accident resulting in the death of another has the potential for developing into more complex psychological difficulties. ASD can be addressed with critical debriefings following trauma, immediate and organized support by professionals, family and friends. It is cautionary for all general medical

problems to be assessed

before ASD is diagnosed.

Let's get some caramel corn, and I'll do it again." Christine Gwidt welcomes reader's comments. Email her at



Although the clean-ups will continue, JRAG's efforts will be a great help.

#### Audry M. Meadows

Audry M. Meadows, age 89, passed away August 31, 2008, at Northern Michigan Regional Hospital.

Audry was born on Aug. 11, 1919, in Evangeline Twp., the daughter of Earl and Mable (Barkley) Griffin, and graduated from Boyne City High School in 1936. She later attended North Central Michigan College in Petoskey and received her teaching certificate.

On Oct. 9, 1940, Audry married Lloyd Meadows in Boyne City and he preceded her in death on Nov. 28, 2007.

In 1956, Audry went to work for the Melrose School and continued to work in Petoskey Public Schools after their merger, retiring in 1983.





#### Ramblers rush McBain

95-yard return triggers offensive explosion

MCBAIN — Any first-game jitters the Boyne City Ramblers may have been feeling as they lined up for the opening kickoff of the 2008 high school football season were decisively erased in the span of a few seconds.

Fifteen, to be exact.

That's all the time it took for Drew Nohel to gather in the McBain kickoff and scamper 95 vards to the end zone for the first score of the game.

Just that quickly, Boyne City established its dominance over its non-conference opponent from the Highland Conference, eventually rolling up an impressive 43-14 vic-

And just as fast, the Ramblers sent a message out to the Lake Michigan Conference that they intend to be contending for the league title.

Last year's leading rusher Robbie Jensen might be gone, but the Ramblers proved they have just as much offensive punch as ever with a balanced running attack featuring two backs, Trever Kruzel and Steve Robinson.

Like two powerful fists, Kruzel and Robinson continued to deal punishing body blows to the midsection of McBain's defense throughout the game.


Kruzel had the bigger day of the two, rushing for 105 yards and scoring three touchdowns on 10 carries (10.5 yards per rush), but Robinson emerged as an effective second option in the Ramblers' running attack.

Robinson finished with 68 yards on just six attempts for an impressive 11.3-yard average per carry, while Nohel had 60 yards on seven

Those three accounted for 233 of the Ramblers' total of 334 yards rushing, and gave them the balance on offense every coach craves.

It's the second consecutive openng-game win over McBain for the Ramblers, who cruised to a 34-0 triumph in last year's game.

Nohel's opening kickoff return was the first of two scores Boyne City had in the first quarter. The other came midway through the

first on a 45-yard run by Kruzel. He also ran in the two-point conversion to make it 14-0, Boyne City.

Junior quarterback Nick Young capped a six-minute Boyne City drive with a perfect 10-yard touchdown pass to Dalton Looze, extending the Ramblers' lead to 20-0 early in the second quarter.

McBain cut the Boyne City lead to 20-6 at the half, scoring on a 13yard touchdown pass with only 28

Boyne City's defense set up the

Ramblers' third score of the game. A bad center snap on a punt attempt resulted in the McBain punter being tackled on his own 20-yard line, and Nohel ended the short drive with a four-yard burst up the middle. His two-point conversion

run made it 28-6, Boyne City. Kruzel scored twice more, from 22 and 5 yards out. Nohel kicked an extra point after one score, and Kruzel ran in a two-point conversion following the other to bump Boyne City's lead to 43-6.

"They (McBain) showed us some things we weren't expecting, so we had some adjustments to make (on defense)," Boyne City coach Dave Hills said.

"I thought our kids responded to that well. All in all, we played okay on both sides of the ball. Special teams are always a big question mark in any season.

"We had hoped that our special teams would play well. We weren't expecting to have one run back on

the opening kickoff."

Kruzel led the defense with 13 tackles, nine of them solo hits. Marc Calo made 10 tackles and recovered a fumble, while Cody Wilmot had seven tackles and a fumble recovery. Nohel finished with five tackles and a pass interception, and Robinson had nine tackles.

"Offensively, I thought we controlled the tempo and had a couple of real nice, long drives," Hills said. "We had some breakdowns that need to be cleaned up.

"Typically your defense is ahead of your offense. I thought we contained (McBain)."

Hills expects the Ramblers to get a much harder test from Newberry on Friday.

"They're a much improved team," Hills said. "They have a coach in his second year. They're doing a lot of things that put a lot of pressure on a team.

"It's going to take a good effort from us during the week to get prepared for them, because they're going to throw things at us that we haven't seen a lot.'

Newberry dropped a tight game to Hancock in its season opener after leading late.

#### Safety in numbers

The University of Michigan football team opened the season against Utah last Saturday, unranked in the preseason coaches' poll. In recent years, U of M fans have been accustomed to seeing the Wolverines ranked at least in the top twenty of the college elite teams, if not in the top ten, or top five.

I note this not because I expected to see the Wolverines get a high ranking; after all they do have a new coach, an untested quarterback and a new face at tailback; but rather because I would not have been surprised to see the Wolverines ranked

whether they deserved it or not. It just seems to be that every year a few teams — U of M, Nebraska and Notre Dame are good examples — get an extra edge that often goes to the bigtime, big draw, big-audience programs.

The big schools with big names always get low numbers in parentheses after their names. The higher a team's ranking is at the start of the season, the easier the road is towards the eventual goal – the Bowl Championship Series.

Another boost given to these teams, as well as others that start out with a high ranking, is how these teams are able to absorb a loss in the first few weeks and still stay within reach of the top spot. It seems the higher the ranking, the lower the fall after a stumble early in the schedule.

I have always felt that any poll taken before games are actually played is, at best, a crap shoot and actually nothing more than a good-old-boys popularity contest. Granted, these polls are based on the opinions of coaches in the know, who should know best, but in the end football games are won

with points – not opinions. It's no wonder that smaller schools from the lesser known conferences have a much harder road to travel when it comes to national recognition.

Until conference races get underway, I don't put a lot of stock in the polls. Too many non-conference games match up local teams or inter-state schools

that result in big scores and resume building numbers that do nothing to gauge a team's merit. The competition is not there, the intensity is not there and the pressure is not there to get a true measure of any team's true ability.

Later in the season, other factors become involved as power rankings, strength of conference and difficulty of schedule all take on meaning when considering a football team's strength. Then a better picture will begin to take shape, just when each game begins to count a little more and a little



• On Sept. 11, 1857, Mormon guerillas murder 120 emigrants at Mountain Meadows, Utah. The guerillas persuaded the emigrants that they had convinced nearby Piute Indians to let them go if they would surrender their arms. At a pre-arranged signal, the Mormons opened fire on the unarmed male emigrants, while the Piutes reportedly murdered the women.

 On Sept. 10, 1897, a 25-year-old London taxi driver named George Smith becomes the first person ever arrested for drunk driving after slamming his cab into a building. Smith later pled guilty and was fined 25 shillings.

• On Sept. 8, 1900, a Category 4 hurricane rips through Galveston, Texas, killing an estimated 6,000 to 8,000 people as a 15-foot storm surge flooded the barrier island. The hurricane remains the worst weather-related disaster in U.S. history in terms of loss of life.

· On Sept. 13, 1916, Roald Dahl, author of "Charlie and the Chocolate Factory" (1964), is born in South Wales. In World War II, he joined the Royal Air Force as a fighter pilot and was shot down in the Libyan desert, suffering serious injuries. He saved a piece of his femur, removed in an operation after the accident, and later used it as a paperweight in his office.

. On Sept. 9, 1942, a Japanese floatplane drops incendiary bombs on Mount Emily, an Oregon state forest, in the first and only air attack on the U.S. mainland during World War II.
The president immediately called for a news blackout for the sake of morale.

· On Sept. 12, 1963, "Leave It to Beaver," which had debuted in 1957. airs its final episode. The typical 1950s wholesome family comedy presented the lives of the Cleaver family from the perspective of 7-year-old Theodore "Beaver" Cleaver.

• On Sept. 14, 1975, Elizabeth Ann Seton, born in 1774, is canonized by Pope Paul VI at the Vatican in Rome, becoming the first American-born Catholic saint. She devoted much of her time to charity work with the poor. In 1856, Seton Hall University was named for her.




