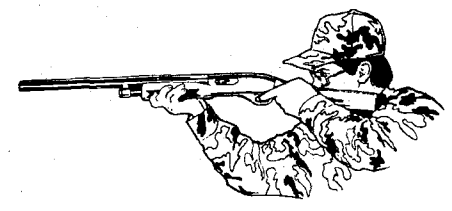

### Fortune smiles on area elk hunters

Citizens in many Michigan cities had no luck at all. But in the East Jordan area, not one but local two residents are among 170 fortunate hunters to be chosen to participate in the 1992 December elk hunt.

Computer-drawn at random from 49,069 applications for the Dec. 8-15 hunt were Diane Skrocki and Burton Wilson.

Skrocki is among 107 hunters to secure an Antlerless Only permit. Charlevoix resident Leo Kleiber was also among that number.

Wilson's Hunters Choice permit allows him to take either an antlered or antlerless trophy. Only 63 of the coveted permits were issued.

The Department of Natural Resources has identified the December elk-hunting area as including Emmet, Charlevoix, Cheboygan, Otsego, Montmorency, Presque Isle and Alpena counties.

The December hunt follows two such events in September, in which 86 elk were taken by 100 hunters.

According to DNR officials, the September elk were taken mostly from private land in the western part of the elk range, where hunters have difficulty securing access in December.

## New flag, continuing improvements for your paper

What's in a name? A whole lot, according to postal authorities.

As a result, there will be a change in the front page "flag" that identifies your hometown newspaper, beginning this week.

Because regulations (including a lengthy waiting period) have made it difficult to satisfy readers eager to subscribe to *The Torch's* new "sister," the *East Jordan Journal*, those neighboring publications have been renamed as one: *The Torch & East Jordan Journal*.

The original plan to produce two separate front pages to individually serve the two areas remains intact. Just as in previous weeks, the inside pages of both papers will feature a combination of the news, sports, and events that affect the lives of readers in the Central Lake, Eastport, Ellsworth, Atwood and East Jordan areas.

The move is only the first step in a long-range plan expanding the newspaper family of *Up North Publications, Inc.* to serve a broader range of reader interests in a greater geographical territory.

While the intention was to increase coverage gradually as community support grows, interest in the new *Journal* has already pushed plans ahead of schedule.

Meanwhile, readers of *The Torch* are enjoying the benefits of improved production techniques and a renewed commitment to the Central Lake area in every issue.

According to *The Torch & East Jordan Journal* publisher Jeffrey Hallberg, the name change will not affect that progress.

"Basically, the change allows East Jordan residents to enjoy the same mailed-to-the-home benefits their Central Lake neighbors have had for a hundred years," he stated.

In a related move, *Up North Publications* is conducting a search for a part-time editor to coordinate production of *The Torch & East Jordan Journal*.

"Once that person is in place," Hallberg said, "we will be accelerating our efforts to upgrade our coverage in upper Antrim and lower Charlevoix counties."

## Local election favors incumbents; 9-1-1 approved over E.J. dissent

About 65 percent of East Jordan's registered voters took time to cast their ballots in the Nov. 3 election.

Final counts showed incumbent mayor Ross Peck elected for another one-year term, while Guy Vallance, Greg Chappuies, Ralph Kitson and Ruth Gee were winners in council races.

East Jordan voted with the rest of the country in the presidential election, giving Bill Clinton the edge over George Bush and Ross Perot.

(In surrounding townships, the order of finish varied, with South Arm voting Bush, Clinton, Perot; Wilson going for Perot, Clinton and Bush; and Evaline choosing Bush, Clinton and Perot.)

Although Charlevoix County ultimately approved the emergency 9-1-1 proposal, East

Jordan residents turned thumbs down by a vote of 399 to 492.

In the 4th District Commissioner contest, Democrat Howard Hosler gathered 940 votes, while Republican opponent Mike Dionne finished with 549. The district encompasses the City of East Jordan and South Arm Township.

East Jordan voters fell in line with state-wide results in rejecting Proposal A (property tax limitation) 340 to 548; approving Proposal B (term limits) 614 to 276; and rejecting Proposal C (exempt property from portion of school tax) 392 to 506. They differed in response to Proposal D, with 478 approving the movement to modify auto insurance laws, and 425 opposing.

### Look familiar?

This post card view has a postmark of April 10, 1910, and shows State Street in an earlier incarnation. The cards came to the Shermans through Jim's mother, the result of a long-ago correspondence between his paternal grandmother (an East Jordan resident) and her family in the Gaylord/Vanderbilt area.

## A history of Traverse Bays Telephone Company

[Editor's note: Central Lake resident Julia Sage authored this fascinating glimpse of the past]

The history of the Traverse Bays Telephone Company is colorful and varied over the seventy-one years that it has served in Antrim County.

The Company was originated by Arthur Williams in December 1896, at the time that the logging and lumbering industry was in full swing. The earliest records of the company at that time show that there were nine telephones in service: C.B. Ramsey; Davse Charise; Cameron Lumber Co. Store; Wallbzecht Bros.; Fisk Bros.; Liken Brown Lumber Co.; C.W. & M.R.R. Co.; M.W. Neukink, and the Cameron Lumber Co. officer.

In 1897, the company gained nine new telephones. Long distance calling as we know it today was unheard of. Voice transmission with only one wire was limited to short distances. New names added to the list of subscribers were: Thurston Company; Dr. Thad Lewis; Guy S. Brown; M.E. Woolocher; W.C. McFarlan Store; W.W. Easton; W.C. Chamberlin; E.E. Noll; and Muckle and Devlin Saloon.

At this time all essential parts of the telephone, such as transmitters, receivers and bells, were leased either from the manufacturer or from the Michigan Telephone Company of Detroit, a forerunner of the present Michigan Bell Company. All telephone parts had serial numbers and were rigidly controlled under the patents of Alexander Graham Bell.

By 1900, the company had grown to 171 telephones, with names such as the Central Lake Cigar Company and the Antrim County Bank appearing for the first time.

In September 1903, the company was incorporated under the name of Traverse Bays Telephone Company. It was capitalized at \$4,000 and acknowledgment was made in the articles of incorporation that of this sum, only \$1,070 had been raised.

The original signers and stockholders were: Frederick L. Church of Bank Twp. Post Office, Essex, Elkanah Mudge of Central Lake Twp. Post Office, Eastport; William H. Upthegrove, Central Lake Twp. Post Office, Central Lake; William L. Frink, Milton Twp. Post Office, Elk Rapids; Ezra J. Hollenbeck, Milton Twp. Post Office, Elk Rapids; Demster H. Stebbins, Banks Twp. Post Office, Atwood; Ethan Jolliffe, Banks Twp. Post Office, Atwood; Arthur Williams, Banks Twp. Post Office, Central Lake.

Theodore Guyer became the first President and General Manager. At the time of filing the articles of Association, Clark E. Densmore was the Clerk of the Antrim County Circuit Court. It is interesting to note that at this time the legal

forms used were printed by the Independent Power Print Company of Bellaire.

After September 1903, the company's lines began to spread across Antrim County. A clipping of the Antrim County record of December 1903 reads: "Loads of material are passing through Bellaire. A line is being built from Bellaire to Torch River by way of Clam River and Alden. It will have 40 subscribers on it. Each subscriber will pay for his telephone and one-half mile of line. Total cost for each \$37.50. Charges for telephone service will be \$2.00 per year."

Records for a few years from this point are incomplete but we do know that the company grew rapidly with H.R. Maddocks the President in 1912 and W.D. Hickin, Mgr.

Leonard Armstrong became President in 1914. R.L. Mason Manager in 1919.

In 1921, B.R. Sage became Manager of Traverse Bays and guided the fortunes of the company through the depression years and several bad fires that destroyed critical parts of the telephone system in the early 20s, together with much of the business districts of Bellaire, Ellsworth and Rapid City. He ended his career in 1945, serving 438 subscribers.

Next, K. B. Sage, son of B. R. Sage, assumed his duties and was appointed Manager of the Company. He immediately made plans for converting the area to dial service, a field in which he had been highly trained.

It took nine years, a long, hard, and at times a most discouraging struggle, but finally his dream became a reality and in 1954 the company changed its operations from manual to dial with 958 telephones.

Thirteen years later in Feb. 1967, with a total of 3,300 stations, all facilities were completely filled, many years ahead of schedule.

It was time to re-invest and to expand. Consequently rather than having still a small company take this risk, a decision was made to terminate the services of Traverse Bays Telephone Company. The business was sold to General Telephone Company of Michigan, the largest company in the independent field.

Modernization of the Industry brings its advantages but loses the personal touch of our Operators of former years. A few of those who contributed so much include Hildred Stafford, Jennie Hadcock, Mae Loper, Esther Crawford, Altha Drog, Marion Bowers Cornett, Louise Lashbrook, Nora Roberts, Vivian Loper Henderson, Flossie Bullock, Mary Keller McKay, Dorthy Bailey, Helen Batcheler, Bessie Little, Janet Dinger, Natalie Bailey, Kay Rose, Hazel Dunn, Fern Shippey, Inez Hiatt, Lucy DeWitt, Jennie Essengerg, Henrietta Merrow, Jen Bueker, Florence Stucker, and Rhea Dawson.

Julia Sage worked closely with her husband for 22 years.

## Sheriff reports

### Bogus caller caught

A Sept. 3 call falsely reporting a serious accident at Glen's parking lot of East Jordan has led to the apprehension of a 16-year-old East Jordan male.

His identity came to light after Charlevoix County Sheriff Department investigated the call, which came in on a recorded line. The suspect admitted to the false report, adding that he had also made a similar call on a supposed car fire at the Marathon Gas Station Aug. 31.

The youth has been petitioned into Probate Court on a charge of using the telephone to make a false report of an accident. His hearing is set for November.

### Charlevoix woman injured


A 72-year-old Charlevoix woman suffered multiple injuries in a Nov. 6 accident on Barnard Road near Klooster. Martha Strawbridge lost control of her 1988 Oldsmobile on an icy stretch and struck a large tree head-on. She was taken to Charlevoix Area Hospital by private vehicle. According to the sheriff department report, her car was totaled in the 10 p.m. incident. Strawbridge and a 9-year-old passenger were both wearing seatbelts. Aside from seatbelt abrasions, the child was not injured.

### Icy roads claim pick-up

A 1988 Ford pick-up skidded through an icy Barnard Road intersection on Klooster Road Saturday morning, striking a ditch slope. Driver Kenneth Ravencraft, 53, of Boyne City, apparently escaped injury in the Nov. 7 incident, but his passenger, 52-year-old Patricia Ravencraft was taken to Charlevoix Area Hospital by private vehicle for arm, back and neck injuries. According to the Charlevoix County Sheriff Department report, the vehicle was still driveable, and the victim was wearing a seatbelt.

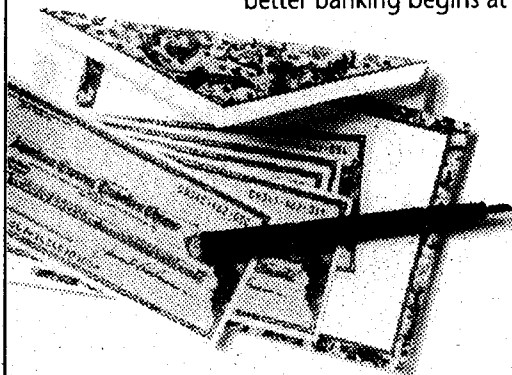

The Lady Lancers made quick work of Wolverine, racing ahead 21-4 in quarter one and holding to a 39-6 lead at the half.

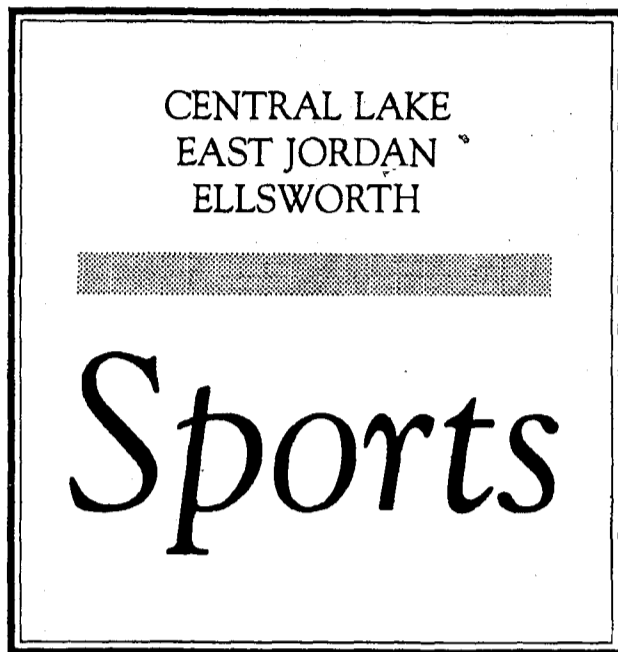
By the end of the third quarter, it was 60-12, and everyone was seeing playing time in bunches, with all 11 players hitting the scoreboard.

# Hunter safety courses make a big difference

"Mom, have you found out when the Hunter's Safety class is yet?" was asked of me constantly this summer by my 12-year-old son Jamie as he prepared for his first hunting season.

After practicing his shooting skills all summer at the trap and skeet range and an entire lifetime of following his mother through the woods, Jamie was almost ready to begin his life in the hunter's world.

The Hunter's Safety program was begun in 1946 by the former Department of

Conservation to promote hunter education and safety in the field. It is required by a 1988 law as a prerequisite for anyone born after Jan. 1, 1960 who want to hunt.

Some 130,000 hunters have graduated from the classes offered all over Michigan. In conjunction with the fluorescent orange color law for small game and firearms deer season, Michigan is now a much safer state to hunt in.

And that's saying a lot. With firearms deer season right around the corner, 780,000 hunters will be taking to the woods, most with high-powered rifles capable of hitting an object with deadly velocity 500 yards or more away.

Lt. Harold Hammond, DNR District Law

Supervisor, stated from his office in Gaylord they anticipate "less than 30 accidents statewide this deer season, with maybe four or five fatalities."

This is quite a change from back in the 30s, when with maybe 300,000 hunters in the fields during the autumn, an average 70 or 80 accidents occurred each season and about 30 fatalities.

Compared to the 3 or 4 million hunters statewide in the field today, this is a dramatic improvement," Hammond said.

Lt. Bruce Gustafson of the DNR Law Enforcement and Safety Division in Lansing

said, "Statistically, you have a greater chance of being struck by lightning than being hurt in a hunting accident in Michigan today."

Hunter's Safety classes are generally offered in the fall prior to the opening of small game season. The Elk Rapids Sportsman's Club, Central Lake VFW and Alba Sportsman's Club all sponsored classes in September in Antrim County.

These courses average two days in length with target shooting under DNR supervision and National Rifle Association specifications. Workbooks used teach safety laws and ethics, archery and firearms understanding and handling, and basic sportsman and conservation ethics.

The courses are taught by trained volunteer instructors, all dedicated sportsmen. No fee is charged for the class which is available to anyone, regardless of age. After testing, graduates are issued their Hunter's Safety Certificate.

Along with some 32,000 new hunters across the state this year, Jamie is now my companion of choice for a day afield with Smoky, the bird

dog.

We've enjoyed a good woodcock season, a two-day foray downstate for pheasants and learned to lower the gun barrel on the occasional pat; there simply aren't enough out there, Jamie, leave them to nest for next year. The elements of conservation.

Although Jamie won't be deer hunting this year (the state sets a minimum age of 14 for firearms deer season), I would feel comfortable with him if he did.

My older son has been deer hunting for two years now and has displayed more safety awareness and common sense than many seasoned hunters.

Overconfidence can be just as dangerous as inexperience. It is still not unheard of to run into someone on public land (where you're liable to have a rifle pointing at you from anywhere) who is wearing only an orange hat, or worse yet, sometimes no blaze orange at all. Someone facing their very first wild turkey season ever might even claim, "I've been hunting and fishing all my life. I don't need any advice on how to be a safe turkey hunter."

Maybe everyone should be required to take a Hunter's Safety course.

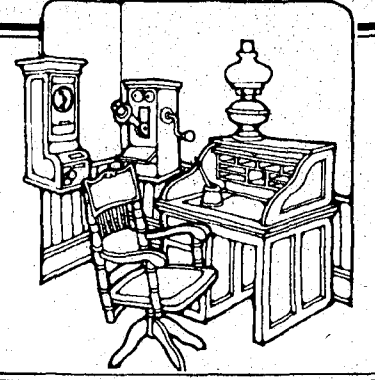

■ The Central Lake junior class has begun plans for a gala occasion that means fun for everyone - a carnival, with games prizes, movies and food. There will be a Carnival Queen who will be elected by the townspeople. The three candidates were elected from the three high school grades that one taking part in the carnival. From the freshman class is Ruth Cary, from the sophomore class is Arlene James and from the junior class is Elaine Cronover.

■ The installation of Central Lake's new street lights was started this week by a crew of men from the Michigan Public Service Company. Unlike boulevard lights, these new enclosure suspension-type lights will give two and a half times as much lumination from the same number of outlets as were formerly used on our Main Street.

**From Nov. 10, 1955**

■ Buck Austin's Argo Mill could now almost be termed the Little Red Mill, what with a brand new coat of red paint received a couple weeks ago. Gone also is the big old brick chimney, and added is a new lumber shed.

■ A.C. James has started work on the installation of a new oil furnace to heat the entire building housing the Post Office, James Hardware, A.C.'s apartment and the Masonic Hall.

■ Well drillers have arrived in town and will soon be at work on Central Lake's first public water pumping system.

■ Michigan Week (after two years) is standardized, starting the third Sunday in May - late enough for good weather for outdoor celebrations, and early enough to be a major event of the school year. # On decades-old public roadway Hearing generates more heat than light

Should Central Lake Township's only public access on the east side of Intermediate Lake be vacated?

A Nov. 5 public hearing on a circuit court petition requesting such action drew a standing-room-only crowd to the Government Center last week.

At issue is a 33-foot strip known as South Street. Platted around 1912, the roadway never saw significant public use. Over the past eight decades, abutting neighbors have gradually encroached on the strip.

Today, the township-owned property hosts a septic field, an underground sprinkler system, a dumpster and a roadway leading back to otherwise inaccessible cottages on Alma Kingma's Central Lake Cabanas property.

In addition, part of Kingma's garage protrudes over the southern boundary of the roadway.

Kingma, one of the plaintiffs in the case, told the crowd at Thursday's hearing that she was only vaguely aware of the access road's existence when she purchased her property (about a quarter-mile south of the lake's northern end) in 1988.

A subsequent survey identified the South Street strip as much closer than she had originally thought, but it was a recently installed sign identifying the land as a public access site that spurred her to action, she said.

In their petition, Kingma and South Street's other abutting property owners, Philip Ewing and Anne Shahan, contend that "in attempting to utilize South Street for a public access or park, Defendant Central Lake Township will turn this once peaceful, serene and secluded residential area into an uncontrolled and obnoxiously loud, busy and otherwise intolerable thoroughfare."

The petition further notes the "absolute absence of parking facilities," and expresses concern about "an utterly intolerable depreciation to the property rights" of neighboring residents.

It asks for relief in the form of release of the South Street title to Kingma and the Shahans, as well as costs and attorney fees.

In explaining the situation to the 70-plus members of the audience, attorney Jim Young stated, "The plaintiffs support their request with numerous statements and allega-

tions, but the key paragraphs say basically this: Since approximately 1911, the South Street site has been unused for any public purpose and has been under the sole and exclusive use of the adjacent property owners; that no public monies have been spent on the area and that it has never been formally or otherwise accepted by any government agency."

Young urged the audience to share any evidence supporting or refuting those claims.

"Either way, the township needs to know the facts, because they must decide whether to contest this petition or not," he noted.

Audience comments ran substantially in favor of retaining the site for township use. Several individuals stated they had either bought or sold property with the South Street access promoted as a desirable feature.

More than one commented that the land should be held "for the future - for our children."

"They're not making any more of it (lakefront property) and nobody's donating it back," observed East Intermediate Lake Road resident Bob Wilson.

Several speakers also sided with the plaintiffs. Kingma's neighbor

township.

The continued presence of the access site threatens her privacy and property values, Kingma added.

It was also noted that a well-equipped access site, including a boat launch and ample parking space, is maintained by the DNR just two miles south on the lake's east shore.

While some recollections of regular usage in previous decades and a few possible examples of public agency spending were mentioned, little concrete evidence to support a possible township case was generated during the 90-minute meeting.

Central Lake Township Supervisor Paul Vernon stated that a reply from the State Treasurer's office (one

of 27 defendants named in the case) indicated the state's opposition to the plaintiffs' requests. The state's reply cited the plaintiffs' failure to obtain a supporting resolution vacating South Street from Central Lake Township - a requirement under Section 226 of PA 288.

As the meeting drew to a close, Vernon asked for a show of hands and counted roughly 60 in favor of retaining the site and 10 in opposition.

Cautioning the audience that the battle to retain South Street could be an expensive one, Vernon stated that an extension of the original deadline would allow the new board to delay a decision on the issue "until as soon after their Dec. 16 meeting as practicable."

Mike Patrola said he would sign an affidavit swearing that the public has not used South Street since his arrival in 1970, and that all work on the site in the years since has been done by the immediate neighbors.

"We would be glad and very willing to pay taxes on it," Kingma stated, noting the benefit that could bring to the

# Village Council addresses varied agenda

Central Lake Village President Donald Seifried announced at the Nov. 9 council meeting that the village has completed a transaction to purchase a parcel of property to be used for the water system.

The property is on the east side of Intermediate Lake and was once part of the Dunson estate.

Seifried explained that Art Lennox of Lennox & Associates of Bellaire is in the process of staking out the property to ensure the boundaries are correct.

Councilman Donald Smith voiced concern about the village's liability on the property. He explained that many area residents use that area for rifle target practice to sight their guns. He said that if someone were injured, they would hold the property owner liable.

Seifried explained he has spoken with a representative of the municipal league and was told that the property is now public property and the village will not be liable. Any hunting

or shooting done on the property would be done at the hunter's risk. Seifried also stated that he will check further with the sheriff department on closing the property to public use.

In other matters, Larry Eckhardt of the Downtown Development Association addressed the council. He explained that at the last meeting of the DDA, several private homes were removed from the area included in the DDA boundaries.

Eckhardt explained he was informing the village council as part of the agreement to let them know about any action taken by the DDA.

Don Seifried stated that the Northern Lakes Economic Alliance has been in contact with the village. The alliance is a group of business and governmental entities set up to promote the area.

The alliance is requesting a contribution in order to make use of their expertise and to join the alliance.

Seifried asked Eckhardt if the DDA thinks their group is in a position to make use of the alliance's expertise.

Eckhardt explained that the DDA is not at the point of gaining any benefit from the organization at this time.

Both Eckhardt and Seifried feel that when the village and the DDA need guidance from a group such as the alliance, they will contact them.

The council also unanimously approved the purchase of a generator to be used at the village garage. Village superintendent Ron Donaldson explained that when there is a power failure in the village, employees must first meet at the garage to get the equipment needed to run restore power to the water and sewer system.

When there is no power, it is difficult to function in the garage and the generator will allow them to have lights, open electric doors and operate the furnace.

# Healthline: How to avoid lead poisoning

We own an older home and worry about our young children and lead poisoning. What can we do to avoid this?

Lead based paints are a major source of lead poisoning in children. Lead based paints were used in two-thirds of the homes built before 1940 and one-half of the homes built from 1940-1960. Even some homes built after 1960 may contain heavily leaded paint.

One way children are exposed to lead is by eating paint chips. Another even more common way is through ingesting or inhaling lead dust that is created as lead-based paints peel from deteriorating surfaces. Walking on small paint chips can also create lead dust or dust can be produced by sanding, scraping or heating lead-based paints.

Lead dust then settles on walls, floors and furniture where it can be ingested through food or a child's hand to mouth contact.

In children, lead poisoning can cause irreversible brain damage and impaired mental function. It can retard mental and physical development and may also affect the normal development of the unborn child. Infants, children, unborn babies and adults with high blood pressure need to be especially concerned about lead poisoning.

If your house is old and deteriorating, you should have your children checked periodically for lead poisoning. Because the symptoms of lead poisoning are similar to other illnesses, it is difficult to diagnose without medical testing. Failure to treat children in the early stages can

cause permanent brain damage. As a precaution, consider having any home built prior to 1980 tested for lead before renovating it, especially if children and pregnant women are present.


