Rotary Club achieves unique status

East Jordan's Rotary club recently earned honors that no other rotary club in Michigan, and only a few in the entire United States have achieved.

At a special Dec. 8 dinner at Shanty Creek Resort, Regional Rotary Governor Bruce Dewhurst praised the local club for a special distinction - every one of the club's 46 active members is a Paul Harris Fellow.

The six members who most recently achieved fellowship status were honored (see picture) and local Rotarian John Smith received special recognition for his efforts on behalf of the Rotary Foundation.

To become a Paul Harris Fellow, a Rotarian must obtain \$1,000 in contributions to the Rotary Foundation, which supports world-wide humanitarian efforts. Their most recent was a campaign to eliminate polio world-wide.

Paul Harris was one of the founding members of the Rotary International.

The East Jordan club was founded in 1939. The main purposes are to encourage fellowship and the exchange of ideas among men and women in the community, and to support charitable and educational efforts.

Most recently, the club has made contributions to the East Jordan Family Health Center and to Camp Dagget on Waloon Lake. While membership is by invitation, the club is currently encouraging applications.

Meetings are held each Tuesday at noon at the First Presbyterian Church, 207 Williams Street in East Jordan.

Plans deal with bus law violators

Parent/Teachers Organization from Charlevoix, East Jordan, Boyne City and Boyne Falls have contacted the Charlevoix County Sheriff Department with concerns about motorists continually violating school bus red lights on roadways in Charlevoix County.

The following steps will be implemented to deal with the problem:

- Letters submitted to 90th District Court Judge, Harvey Varnum, requesting consideration to increase the fines of those convicted.
- Deputy sheriffs, with portable radios, will be assigned to certain buses that have had a history of problems with motorists violating the school bus law; to secure license numbers of violators for citations.
- Prosecuting Attorney's office has agreed to honor statements from school bus drivers and parents who observe a violator for the purpose of issuing a citation through the Sheriff's office.
- Updated statistics and education articles and radio announcements to remind the motoring public.

Bob Cullen named editor for Torch/East Jordan Journal

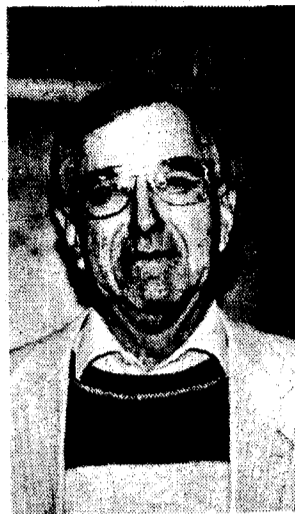

Reward offered for elk killer

Michigan conservation officers are looking for the person or persons who shot an elk cow and calf and two deer fawns in eastern Charlevoix County just before Thanksgiving and left the animals at the site of a deer bait pile.

"We're offering a reward of \$2,500 for information leading to the conviction of the people responsible for this wanton waste," said Lt. Harold Hammond of the Department of Natural Resources District 5 office at Gaylord. "We lose some elk every year during the deer hunting season, probably mistaken by hunters for deer, but people who would take this deliberate act are of a different mindset. We want to get them out of the woods!"

It's time to get a working team

FOR THE PAST several weeks we have been inundated with reports of the Central Lake Township "fiasco," a small town, back woods, rhubarb involving a few local egotistical politicians who apparently will go overtime to make monkeys of themselves.

I am not a registered voter in the township, but I do own property there, pay my share of the costs of the area in the form of taxes, support the local businesses, enjoy my spare time at our Torch Lake home.

According to reports, the township clerk was appointed to office by the township board in April 1992. She ran for election unopposed in November. Four board members, including the supervisor and treasurer were also elected to office in that November election. None of these people appear to be new to the community or unfamiliar with township operations.

On Nov. 5, two days after the election, at a township board meeting that appears to have first met privately, serious questions were raised about the performance of the clerk, demands made for her resignation, the newly elected board members refusing to take their oaths of office until their demands are satisfied. In other words, they refused to assume duties they supposedly asked for when they sought election.

If one can believe what one reads in the paper, the performance of the clerk is alleged to have been "substandard and her judgement faulted." One has to ask why that performance was permitted to continue unchallenged over half a

year? Why was she permitted to seek re-election unopposed?

Normally one expects a well-run office to have rules of procedure for such things as office hours, access to the office after hours, credit cards. Where were they?

At the same time, how can people who seek public office ask the public for their votes then refuse to take their oath of office and serve? Have they no obligation to their electing public? If they knew of questionable practices, why was not the correction of those practices a part of their stated platform for re-election?

It is now a month since that election. It is high time to quit the posturing and juvenile name calling. It is time to get down to work, accept the will of the people who elected all five of those people, settle down around the table and work out their differences, get some procedures ironed out that all understand and can live with, get the show on the road.

It is time to make Central Lake Township a community to be proud of, not the laughing stock of northern Michigan. It is time to get a working team on the road!

After all, my taxes are due according to today's mail. Who am I to pay them to? Certainly not to someone who refused to take office.

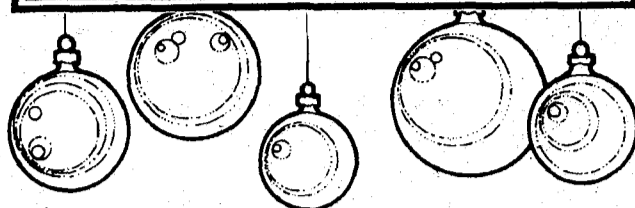

Personal ID cards are valid

The Michigan Department of State is reminding businesses which require identification from customers during this busy shopping season that Michigan's personal identification card is as valid as a driver license for proving the holder's identity.

There are approximately 500,000 valid personal identification cards in Michigan, most of which have been issued since improvements in Michigan law governing I.D. cards went into effect Oct. 1, 1987.

"Over the years, Michigan's personal identification card has been upgraded so it is reliable identification for such routine activities as check cashing," Secretary Austin said today. "We want to assure those people who request identification from their customers, that the personal identification card is just as valid as a Michigan driver license."

Today, personal identification cards are issued every four years, expiring on the holder's birthday, and must be updated for a change of address if one occurs.

To obtain a personal identification card, applicants are subject to

the same requirements as driver license applicants. They must provide proof of identification such as a certified birth certificate, a valid United States or Canadian passport, or official court adoption documents. Two supporting documents, such as a marriage license or divorce decree, a hospital birth certificate or a photo military I.D. card will be required of applicants between the ages of 18 and 64.

Applicants over age 64 can provide three documents of varying importance, as long as one document shows the applicant's date of birth.

Secretary of State

branch offices are diligent in requiring proper identification before issuing a personal identification card to an applicant.

A personal identification card is an alternative for individuals who do not drive, have visual limitations, have voluntarily surrendered a driver license, or have other reasons for

preferring this form of identification.

There is a \$6 fee for the personal identification card, which is waived for residents who are blind, age 65 or older, or who have had their driver license suspended or revoked because of a mental or physical disability which prevents them from operating a vehicle safely.

Friday, Elk Rapids came to town and found a

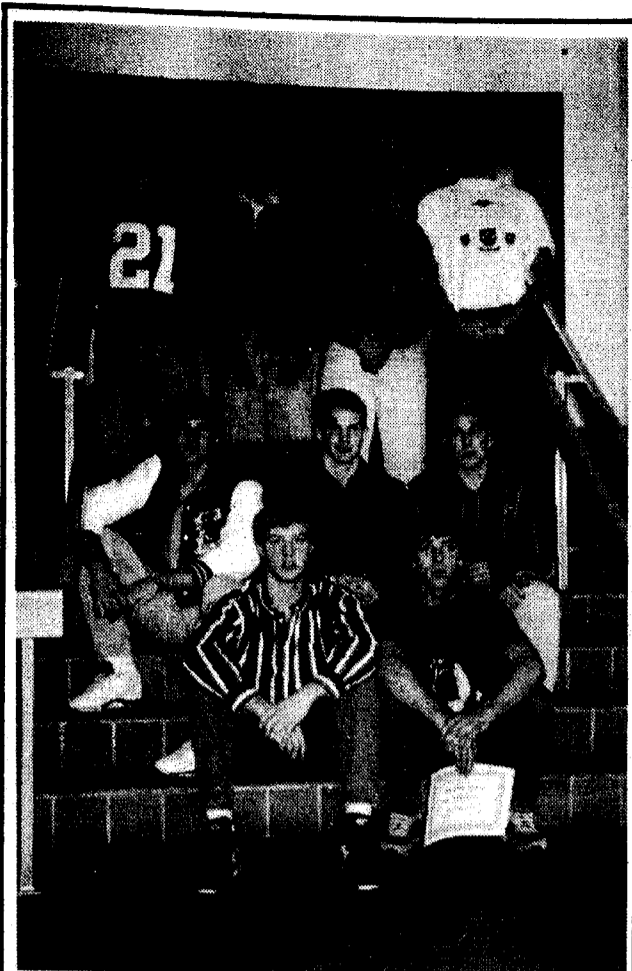

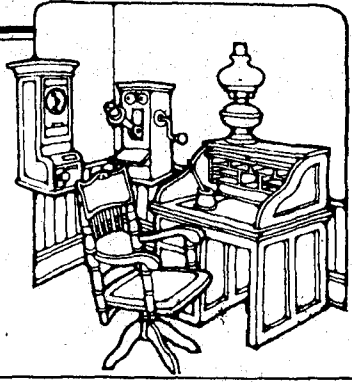

SNOWPLOWING SERVICE
UNIMPROVED COUNTY ROADS

Because of limitations imposed by narrowness, trees, stumps, steep grades and soft surfaces, the Antrim County Road Commission is unable to provide snowplowing service on unimproved county roads. In order to provide such service, the unimproved road must be improved (including gravel surfacing) to minimum plowing standards.

The following procedure is established to provide for such road improvement to allow county snowplowing.

1. Person requesting improvement apply to the township board in the township where the road is located.
2. Township board requests the road commission to inspect the road and jointly determine if the improvement is justified. If the improvement is approved, the road commission will submit an estimate of the cost of the necessary improvement.
3. Upon approval of the project the road commission will agree to pay for 1/3 of its costs. The remaining 2/3 of the cost must be met by others, such as the township, the person requesting the service or other interested parties.
4. The road commission will schedule the work to be done. The person requesting the improvement shall deposit his share of the estimated cost with the road commission before the work is started. The township may authorize their participation in the work by resolution.

The above procedure is a restatement of existing road commission policy adopted on January 18, 1973. Persons living on or considering living on unimproved county roads are herewith advised of the necessary procedure for having such roads improved for wintertime plowing.

The above policy was adopted at the regular meeting of the Antrim County Road Commission on March 14, 1988.

PARKING ON ROAD RIGHT-OF-WAY &
PLOWING DRIVEWAYS

The following ordinance is published to remind residents of certain practices which:

- A. Interfere with plowing of county roads;
- C. Create serious hazards to the traveling public; and
- D. Expose violators to substantial penalties as well as personal liability in the event of accidents caused by such activities.

SECTION 1. No person shall park or abandon any vehicle or other objects or occupy the right-of-way of a public road in any manner which interferes with snow removal or maintenance on any public highway, street or alley.

SECTION 2. No person shall park or abandon any vehicle or other objects or occupy the right-of-way of a public road in any manner which encumbers, obstructs or endangers the use of any public highway, street or alley.

SECTION 3. No person shall deposit on any public highway, street or alley or the right-of-way thereof, snow or ice which has been removed from private driveways or private property.

SECTION 4. The County Clerk is hereby directed to cause this ORDINANCE to be published as soon as possible in all newspapers of general circulation in the County. This ORDINANCE shall take effect sixty (60) days after its adoption by the Board of Commissioners.

SECTION 5. Any person who shall be convicted of a violation of this ORDINANCE shall be subject to a fine not to exceed One Hundred Dollars (\$100.00) or imprisonment in the County Jail for ninety (90) days or both.

The Central Lake Board of Education unanimously approved a resolution to hold an election on Feb. 2, 1993 for the purpose of issuing bonds in the amount of \$1,450,000. The action came during their regular meeting Mon., Dec. 14. The monies will be used for the proposed addition to the elementary school building.

The board also agreed to continue the cooperative football program with Ellsworth Schools for the 1993-94 and 1994-95 school years.

Summer tax agreements with Echo and Torch Lake Townships were discussed and approved. Property assessments in these townships will be calculated in the same manner as they have been for the last several years.

The board also agreed to a three year audit contract with the accounting firm of Baird,

Cotter and Bishop.

Principal Chet Budzynski informed the board of an upcoming unit on HIV/AIDS instruction to be taught at the eighth and ninth grade levels. The unit will be taught by someone from Planned Parenthood with the help of trained eleventh and twelfth graders as peer teachers.

"Youngsters seem to be more receptive to this kind of information coming from a peer rather than an adult," Budzynski stated.

A meeting will be scheduled in January so parents may "preview" the unit before it is presented to their children.

The board regretfully accepted the resignation of Dennis YoungeDyke as football coach. Superintendent Lary Blamer commended YoungeDyke for his invaluable service to the Central Lake-Ellsworth Schools.

New members appointed to planning commission

The Central Lake village council voted unanimously to approve appointments of Walter Russell, Ted Pierce and John Kohlruss to the Central Lake Planning Commission. The action was needed with the resignation of previous members of the commission.

Tips for mailing tasty treats

Sharing cookies with friends and family is a holiday tradition of long standing. It is nice when they can be served at parties and get together, but sometimes they have to travel in order to be shared.

Generally fruit cookies, bars, and drop and molded cookies make the best travelers. Since your package may encounter humidity, high and low temperatures, and rough handling you should avoid mailing sticky cookies or cookies topped with icing.

Each variety of cookie should be wrapped separately or placed in a different container. This will help maintain the special texture and flavor of each variety. Avoid packaging soft cookies and crisp cookies together.

Pack cookies securely so they won't jostle about and become

damaged in transit. You might wrap cookies in small stacks with plastic wrap or layer cookies in rigid containers with waxed paper between the layers.

If the container you chose isn't airtight, seal it with a plastic bag. Pack the cookie gift in a sturdy box padded with foam packing pellets or air-popped popcorn (no butter, oil or margarine).

Be sure to avoid

mailing cookies that have meat or cheese fillings or cookies with undercooked eggs as one of the ingredients. An example is cookies made with meringues. The possibility for contracting food-borne illness from bacterial contamination is higher with these kinds of cookies.

Send the package first class or by a selected carrier to ensure prompt arrival.

As an extra precau-

tion, write "perishable," or "handle with care" on the box near the receiver's address.
