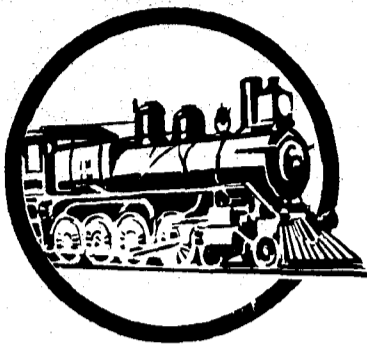


OUR WEATHER

School board statement to ease controversy?

An official position statement concerning the human development curriculum recently adopted by the East Jordan Board of Education was reviewed at the regular meeting on March 8. The statement attempts to clarify the goals of the human development curriculum and defuse the controversy that has surrounded the work of the human development committee.

The position, among other things, affirms that parents are the primary teachers of sex education and that abstinence should be taught as a lifestyle and the only certain method of birth control. It also asserts that all teenagers do not choose abstinence, and since the school district has an obligation to provide appropriate education for all students, contraception should be a component of the curriculum.

The board of education believes that students must realize that sexual activity is a choice that carries risks and consequences. The statement further asserts that abstinence is the only unquestioned safe choice available to students.

Curriculum director Ann Dingman has been designated as the sole spokesperson concerning the human development curriculum. The board

of education established a single spokesperson to ensure that a consistent message is given to the public. In addition, differing interpretations of many individuals has led to misunderstandings and controversy. Dingman also serves as chair of the human development committee.

Clare Zitka, a leader of East Jordan Concerned Parents, thanked the board for the statement, but questioned if his group could expect

cooperation from Dingman. East Jordan Superintendent of Schools Chip Hanson assured Zitka that all concerns will be responded to.

In other business, the East Jordan Parent-Teacher Organization elementary school playground initiative was discussed. The plan seeks systematic improvements over five to six years.

A planning study will be conducted by M. C. Smith Architects and

Associates of Grand Rapids. The board of education and the PTO will equally share the \$3,000 cost.

The board is also considering several summer repair and improvement projects with estimated costs totalling \$35,500. Preliminary discussion was also held on possible additional classroom space at the K-8 complex. Using the middle school stage and creating two rooms from the band room are options under consideration.

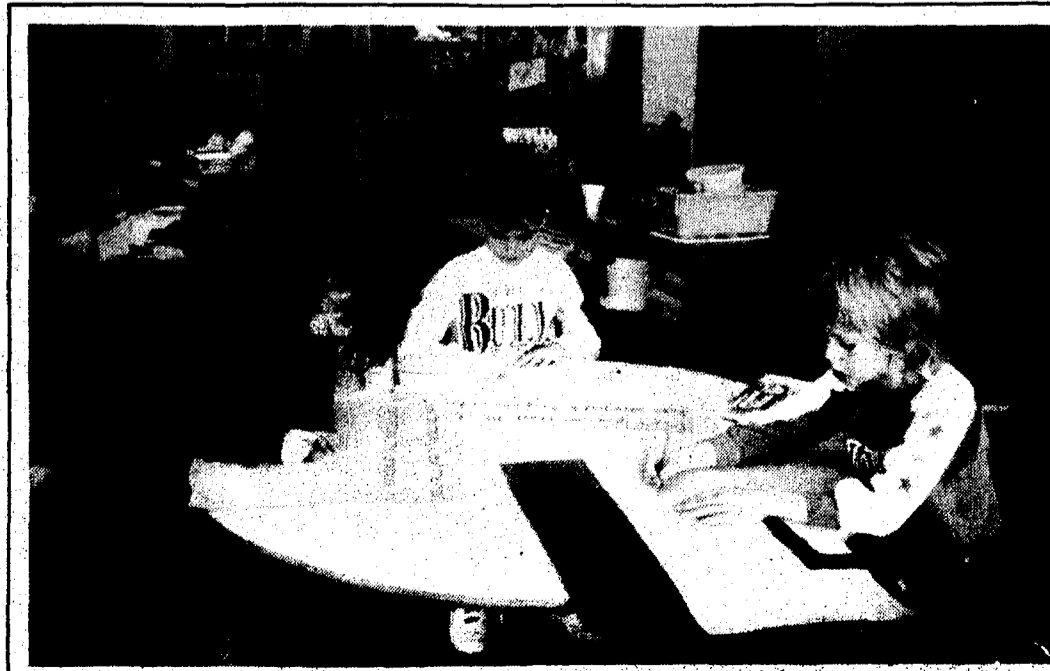
freely. She also states "it can relieve tension and stress, but above all, induce a sense of well being without the use of drugs."

training.

Moblo contends that daily stress causes muscles to contract putting pressure on blood and lymph vessels. Massage reduces muscle tension and extends the stretch reflex response. The stretch reflex response is an involuntary muscle contraction in response to stretching. Muscle pain is reduced when the muscle relaxes and no longer puts pressure on pain receptors.

Torch to have cable soon?

Resident Ed Knoechel presented a detailed report on the progress of cable TV installation at the Torch Lake Township Board Meeting March 9. Having volunteered at the February meeting to pursue an inquiry, Knoechel contacted Village Cable Chief Officer Gernie Isip.

Village Cable Company has a non-exclusive lease with Torch Lake Township to install and service cable in the area. The lease is now \$1000 in arrears. Equipment installed by the company, including four satellite dishes, seems to have been abandoned.

Isip claims to be continuing the process of installation, but has run into financial difficulties. He is presently searching for a partnership to provide added financial backing.

With future dealings remaining questionable, Knoechel contacted Phoenix Communications. Phoenix had shown some interest in the township franchise last year.

The contact with Knoechel apparently sparked a renewed interest by Phoenix. Phoenix Communications has installed another system in Northern Michigan and has a full-time technician servicing the area.

Phoenix is not interested in a buy-out of Village Cable equipment already installed, calling it below standard. The township board will scan the Village Cable lease to ascertain whether the township has any responsibility for the equipment.

In other business, fire chief Stan Dawson requested the board consider some needed improvements to the south fire department build-

ing. Recent damage to the building will be covered by insurance. Torch Lake Township Supervisor Schmidt suggested taking advantage of insurance reimbursement to make door improvements at the same time the damage is repaired.

Other necessary changes to the building include weather-proofing and roof improvements.

Dawson also reported a renovation project the department is considering. There is a need to assign all rescue equipment, including the "jaws of life" to one vehicle. The department has decided that the 1969 small pumper would be the best truck to be used as a rescue vehicle.

Dawson will research financing. Municipal loans are available for funding fire department improvements at no cost to the township. The project is expected to cost about \$22,000.

The township board decided to reapply for a grant denied recently by the DNR. The township is hoping to use the grant to purchase property for the Torch/Bay Trail and Beach project.

Supervisor Schmidt discussed the board of review work of the past week. In two days, the Board has already listened to 100 tax assessment appeals with no end in sight. Schmidt thanked the Board for their dedication in the face of many angry taxpayers. He also thanked clerk Elva Cowell and treasurer Rochell Smedley for their extra hours answering telephones and questions.

Recently snowmobilers have been running over the airport landing strips. Residents are reminded that this area is posted off-limits to snowmobiles. A stiff fine will be given to trespassers.

The airport is a designated emergency landing area. The tracks made by snow machines across the runway can cause a small plane to flip or spin.

Carlton takes board seat

New board member David Carlton took the oath of office during the regular meeting of the Central Lake Board of Education, Mon., March 8.

Carlton, a former school board member, was appointed to serve the remaining four months of the late Claudia Hickman's term.

Don Morgridge from DEM Architects presented design plans and a preliminary cost estimate for the elementary school addition.

The board agreed to purchase a software package from Specialized Data Systems to be used in the offices for student services such as attendance, grading and recording.

Superintendent Lary Blamer stated, "These things

are currently being done by hand and take a tremendous amount of time."

In other action the board:

- authorized the superintendent to form a committee to determine which employees are at risk in the Bloodborne Pathogens Control Plan.

- resolved to hold the annual election June 14.
- voted to freeze the substitute teacher rate for the 93-94 school year.

- agreed to purchase computer hardware from Nu-Way Computers of Gaylord.

The board also discussed the possibility of taking tuition students from Kalkaska.

Apple referendum to be held

Michigan apple producers are being asked to vote on whether to continue the Michigan Apple Advertising and Promotion Program, according to Bill Schuette, Director of the Michigan Department of Agriculture. Michigan law requires that a program continuation referendum be held every five years.

The purpose of the Michigan Apple Advertising and Promotion Program is to enhance the economic position of the Michigan apple producer by developing advertising, promotion and publicity programs that will help to create new markets for apples and apple products; maintain present markets; and, conduct research and development projects that will strengthen the apple industry.

The referendum will be conducted by MDA

from March 22, 1993 through April 2, 1993. Ballots will be mailed to all growers of record. The ballots must be postmarked no later than April 2, 1993 to be counted.

For the program to continue, the referendum must be approved by at least 50 percent of the growers voting, representing more than 50 percent of the state's apple production.

A producer is entitled to one vote representing a single firm, individual proprietorship, corporation, company, association, partnership, husband-wife, or family ownership.

Ballots will also be available at MDA offices in Lansing, all MDA regional offices, and at county Cooperative Extension Office. For more information, contact MDA's Marketing and Market Development Division at (517) 373-1058.

Letter deserves explanation

A letter to the editor from Vivian DeMorrow in last week's issue of the *Torch* deserves an explanation because of the inaccuracies it contained.

My W-2 form received from Central Lake Township shows my compensation is much less than the \$5,280 quoted in her letter.

Supervisor Vernon had nothing to do with the \$150 per month that was set by the previous supervisor.

The trustees now get \$55 for each regular monthly board meeting, but we are not paid if we do not attend. We also get paid for special board meetings which at the present time are much more frequent than usual because the township clerk could not give us accurate figures to prepare a budget.

It is projected that the trustees will attend an average of less than two meetings a month in the upcoming fiscal year which will amount to less compensation than we have been paid and supervisor Vernon is responsible for that reduction.

You should also know that we do not get paid for any committee meetings such as the Budget Review Committee meeting attended by trustee Gadwau.

She criticized the Township Newsletter which most people really appreciate because it gives them facts about what is happening in township government.

Supervisor Vernon does a good job of reporting on those activities but I don't believe Mrs. DeMorrow wants to hear the truth.

If every winter and summer tax bill had a charge on it for publishing the newsletter it would only amount to 70 cents on each tax bill which is about 12 cents per month.

Clerk Lucas has been to several training seminars for computer operators and other accounting training programs but she kept making so many errors in the township bookkeeping records it seemed she wasn't getting any benefit from them.

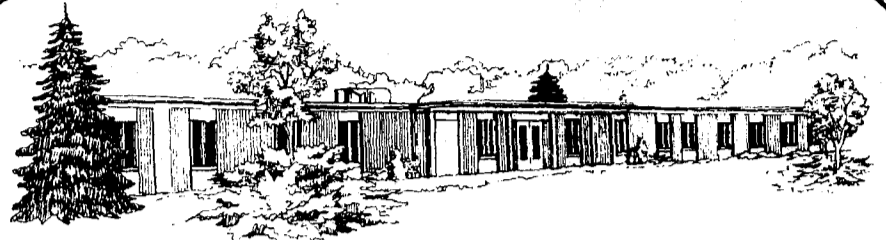

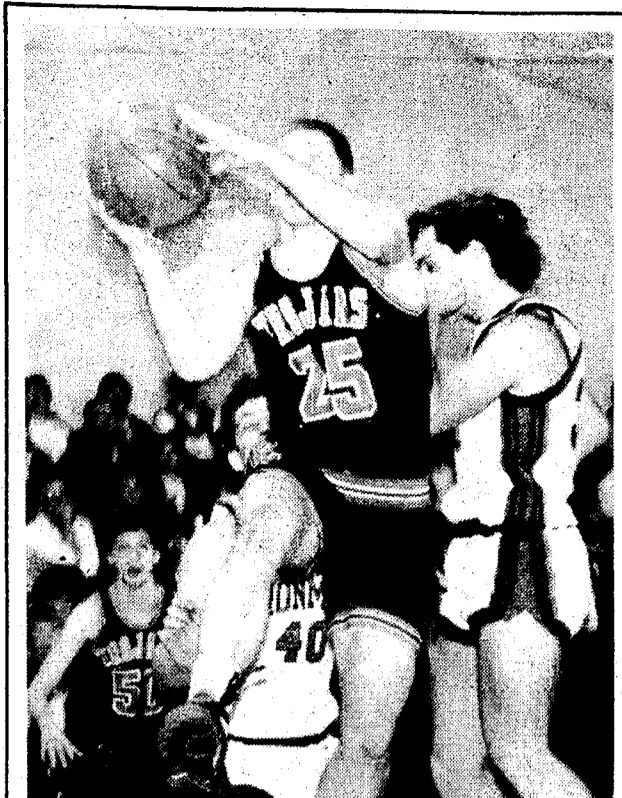

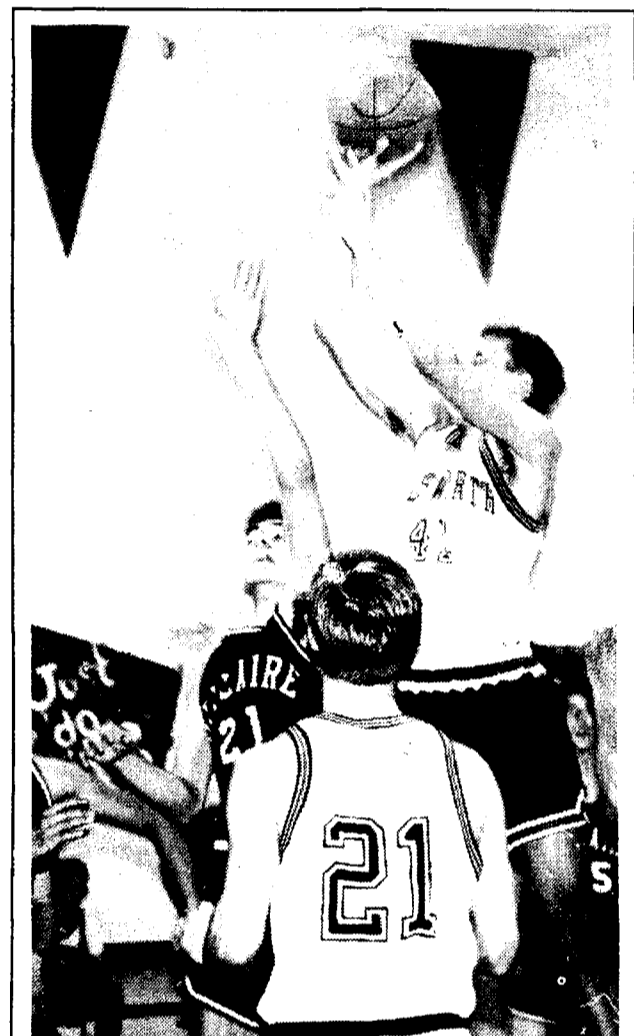
In Tuesday's action Ellsworth stifled Alba 68-37, allowing a Keith Misiak free throw early in the first quarter and nothing else.

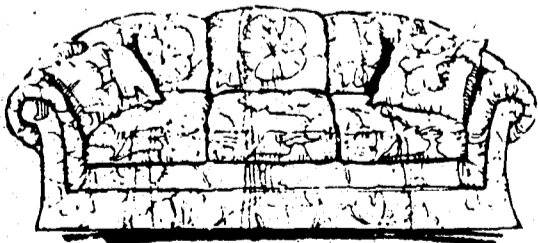

Special tax assistance available from IRS

"Many of the 4.1 million Michigan taxpayers who file federal income tax returns are ready to sit down and prepare them," said IRS district director John Hummel. "And as they do so, I want to remind them about a special assistance feature we provide."

"Our TELETAX system provides tax information 24-hours a day through a pre-recorded message system. This computer assisted program provides information on over 140 tax topics and may be reached by calling us toll-free on 1-800-829-4477."

Hummel said the ad-

vantage of the TELETAX system is that taxpayers can call any time of the day or night, while they are working on their taxes.

"We also have many information publications available to assist

taxpayers as they prepare their federal returns," he added. "Publication 17, Your Federal Income Tax, is an overall guide to individual income taxes, and will answer most of the questions taxpay-

ers may have. This publication may be ordered by calling, toll-free, 1-800-829-3676."

"I want to encourage Michigan taxpayers to file early," Hummel said. "And they should consider taking advan-

tage of electronic filing. Electronic filing means more accurate returns, and refunds in as little as two weeks."


