City budget figures are now official

The East Jordan City budget for 1993-94 is now official. After receiving no comment in a public hearing, the city council adopted the budget resolution at the March 16 meeting.

The budget was finalized with expenditures of \$1,164,949. That figure was reached by trimming approximately \$66,859 from the proposed disbursements. Even with the paring down, a \$32,384 shortfall is anticipated. The city will dip into a savings account of \$208,000 to cover the deficit.

The largest portion of the budget is allocated to the Police Department. The \$234,385 apportionment reflects a drop of nearly \$19 thousands from the original request. The general fund for city operations is

the other big spender at \$171,465.

The city budget is funded by a 15.6 base millage. This year's collection will show a slight increase over the past because of the tax assessment increases.

East Jordan also collects 2.5 mills for the fire department equipment fund. Another .5 mills is collected for the harbor debt retirement fund. The total revenue anticipated for 1993-94 is \$1,132,565.

Two major improvements are planned for the coming year, a harbor marina dredging project at a cost of \$400,000 and construction of a new city well at a cost of \$254,000. Both projects will be funded largely by a state grant.

In other business a public hearing for the resolution to vacate alleys in the Mill Street area prompted an



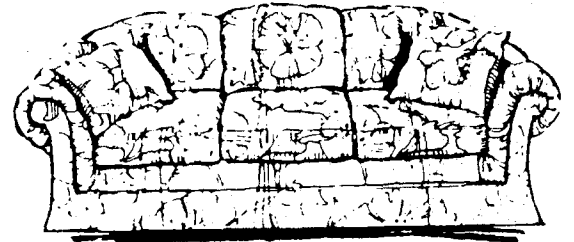
☞ Rick Guild was selected this past week as "My Favorite Teacher" in the Johannesburg School District. He is the son of Russ and Helen Guild and attended school here.

Ellsworth wins way into final eight

Ellsworth entered the boys basketball regionals and came away champions for the first time in over two decades, defeating Northport in the semis and drawing revenge against Atlanta in the finals, in overtime.

The result was a date with defending champions of Class D, Muskegon West Michigan Christian, Wednesday night in the Traverse City St. Francis gymnasium at 7:30 p.m.

Tuesday, Northport's Wildcats had upset on their minds, but they didn't start their offense as fast as the Lancers, who jumped up 9-0 on four shots, including a Mike Alfred trey. The Wildcats recovered enough to trail just 16-12 after the quarter.

A Scott Heeres triple pushed Ellsworth up 25-13, and the lead inched up to 31-17, before Northport stormed back on a pair of three-pointers amid a 12-0 Northport surge that cut the gap to 31-29 at the half.

Ellsworth returned the lead to six, 38-32, before another try and the talents of Wildcat

Shaun Craker kicked in full, the Wildcats making an 11-4 run at the end of the quarter to take a rare lead, 43-42, with eight minutes to go.

Jeremy DeYoung and company went to the tricks bag for the start of the fourth period, picking up a pair of quick scores on the infamous lob play, Alfred added a long two pointer, and Northport was looking up at the Ellsworth lead, 48-43. A Wildcat sub checked in, got a foul, and Essenberg hit the two free tosses.

With just under a minute to go, DeYoung went over Northport's Craker for a score, added a free throw later for a 59-53 lead, then saw Northport hit another trey to cut the lead to 59-56.

Scott Heeres stole the ball, and with three seconds to go, missed his toss from the line, but Tim Heneveld got the rebound with one second left, hitting the free throw that iced the contest, 60-56.

Jeremy DeYoung led the Lancer scoring with 18, Scott Essenberg added 16 and Tim Heneveld 14. Craker had 24 for

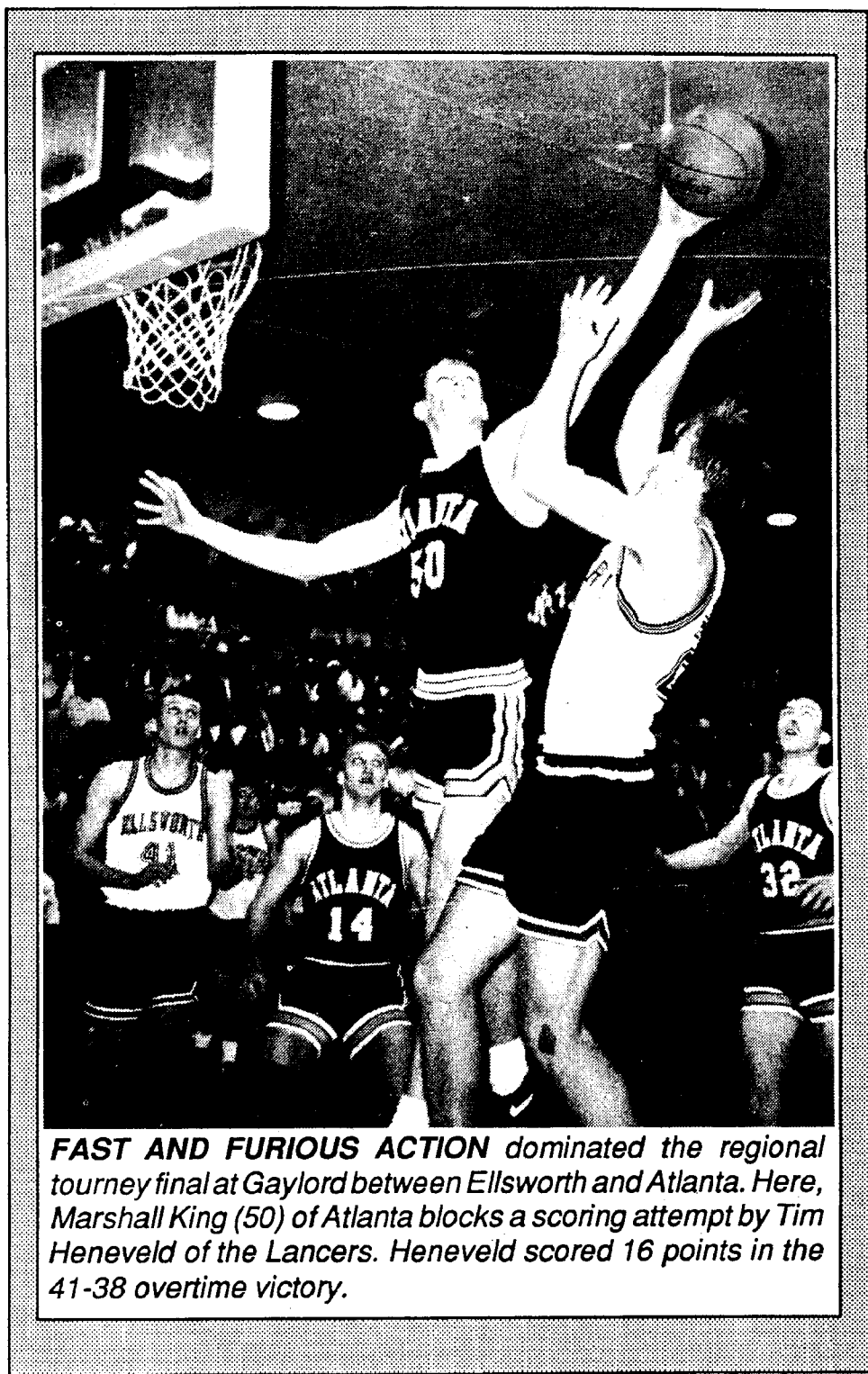

Northport. Friday night, Ellsworth had to contend with Atlanta, a team that had put Ellsworth out a year before and destroyed Au Gres to get to the finals.

The two squads traded scores at first, then Alfred hit his usual early three-pointer, DeYoung added a free throw, and by the end of the quarter Ellsworth hung to a 14-10 lead. DeYoung scored half the Lancer points from the free throw line, four, for the second quarter, Mike Alfred driving for two more and DeYoung a turnaround for the other two and a 22-16 lead at the half.

A Huskie free throw to start the third was followed by the alley Oop to Tim Heneveld, but Atlanta came back strong, taking the lead 25-24 before a DeYoung free throw tied it, and then increasing the margin to 28-25 at the end of the



Bi-partisan group supports school funding proposal

A group of more than 40 Democrats and Republicans supported an initiative before the House Taxation Committee that would cut property taxes and change the way Michigan funds its public schools.

The group, formerly known as "Team 14," is advancing a proposal that would eliminate property taxes as a major funding source for schools and provide a net tax cut of \$300 million. Legislation to implement the plan was introduced recently in the Michigan House, and garnered 19 Republican and 24 Democratic co-

sponsors. The reform package is composed of House Joint Resolution G and House Bills 4277-4286.

Under the plan, which is the culmination of several public hearings:

- school operating taxes on residential and agricultural property would be cut by over 50 percent this year

- school property tax rates for businesses would be capped at 1992 levels

- a new, equitable system of school finance would be provided

- the state income tax would go to 6 percent to compensate for the reduction in residential and agricultural property tax

- the personal exemption on the state income tax would be increased from \$2,100 to \$3,000 for a net tax cut of \$300 million

- public schools would have received a basic grant of \$4,700 per pupil in 1992-93. The fiscal year 1993-94 estimate is \$4,850

- tax cut and school funding changes are implemented directly by

the Legislature without a ballot proposal

- at the November 1994 general election, voters would have the opportunity to approve a sales tax rate increase from 4 percent to 6 percent, allowing for a rollback of

the state income tax to the current 4.6 percent or the elimination of school property taxes on homes and farms.

The lawmakers joined forces to enact a responsible, meaningful solution to the inequities of Michigan's outdated

property tax system and the enormous spending disparities between school districts.

objection by resident Dennis Shea. His tax assessment forms have always indicated his alley as already vacated.

City Superintendent Bob Johnson explained that the alleys or sections of alleys vacated in the past were unclear from existing records. According to Johnson "it's easiest to go through the process" to alleviate questions and clarify ownership.

Councilman Russ Gee assured Shea that it was to his advantage to have the city clear up the issue. Shea did not seem to agree. He expressed

dissatisfaction with the resolution and walked out of the hearing.

East Jordan City Attorney Scott Beatty reported on junk accumulation violation, in which East Jordan had to resort to seeking a judgment against the violating property owner.

The resident was convicted and sentenced to 90 days in jail. The sentence will be held in abeyance for 60 days. If the resident takes advantage of that time to clean up the property to the city's satisfaction, the sentence will be suspended.

Beatty also reported the police union contract was ready to be ratified. The council approved

the contract, which includes:

- Parity with the DPW contract
- Pay scale
- Cap on health care benefits
- Personal days not carried over or accumulated

The contract with DPW union employees is still under discussion.

Police Chief John Imeson told council about a grant received from Green Thumb, Inc. The grant will fully fund a position in the department for a senior citizen.

The police department will use the extra help for answering telephones and other light administrative duties.

February farm prices lower

The index of Prices Received by farmers in Michigan for all products as of Feb. 15, was 126 percent of its 1977 base, according to the Federal/State Michigan Agricultural Statistics Service. The February index is down three percent from January's index of 130 but two percent higher than last February's index of 124.

The price index for all crops in Michigan fell four percent from a month ago. Hay led the decline by falling 12 percent, while dry beans and winter wheat fell eight percent and four percent respectively. Potato prices rose slightly from last month gaining two percent.

The livestock index dropped one percent from last month. The decline was due to eggs falling nine percent and milk falling four percent from January. However, the meat animal index par-

tially offset the decline with hogs up nine percent and calves up four percent for the month.

Nationally, the All Farms products Index of Prices Received in February was 139 percent of its 1977 base, unchanged from January. Price gains from January for hogs, cattle, sweet corn, and celery offset price declines for tomatoes, milk, carrots and eggs.

The index of Prices Paid by Farmers for Commodities and Services, Interest, Taxes and Farm Wage Rates for January was 193 percent of its 1977 average. The index was up 0.5 percent from October 1992 and up 1.6 percent above January 1992. Since last surveyed in October, prices were significantly higher for feeder livestock with lower fuel prices moderating increases for other items in the current survey.
