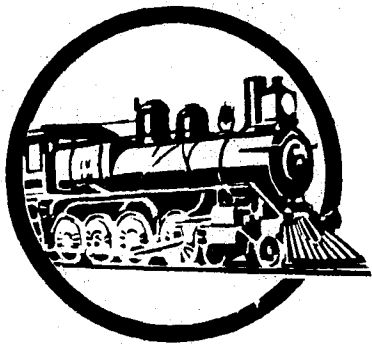

**East Jordan Rotary donates \$48,800 to scholarship fund**

The East Jordan Rotary Club has transferred \$48,800 from its scholarship foundation to a new endowment fund within the Charlevoix County Community Foundation. Income from the endowment will be used each year to grant scholarships to graduates of East Jordan High School.

According to Scott Beatty, president of the Charlevoix County Community Foundation, the first of the scholarships will be awarded later this spring. "This gift reaffirms a long-standing commitment East Jordan Rotarians have made to our community's young people," Beatty says. "Their generosity will enable students to pursue a college education who otherwise might not have had that chance."

The gift not only boosts the Foundation's permanent scholarship endowment to \$148,800—it also qualified for matching grant money from the W.K. Kellogg Foundation. Under an arrangement with Kellogg, each local dollar raised by the Charlevoix County Community Foundation is eligible for a 50-cent matching gift.

Beatty says that's one of the primary benefits of the new Community Foundation. "We have an opportunity to increase our capacity for funding local programs and responding to community needs that much sooner because of matching gifts," he explained. "Tax incentives and challenge grants such as the Kellogg match make charitable gifts to our Community Foundation a wise investment."

Those who are interested in learning more about the East Jordan area scholarships may do so by contacting a counselor at the East Jordan High School. Applications are available at the counseling office.

Started in 1992, The Charlevoix County Community Foundation receives charitable donations, manages them in a permanent endowment, and redistributes earned income through grants to meet local need.

**Walk Saturday, concert Sunday**  
 Weekend to benefit wetland acquisition

Two activities will signal the start of formal fund-raising efforts for the Lake St. Clair-Six Mile Lake Natural Area next weekend.

Both will advance the goal of purchase and preservation of the valuable wetlands where the two lakes connect.

And both will allow participants to see the positive results of their involvement on a local level.

"There is so much interest in protecting the environment, and so many worthy possibilities calling for our attention that it sometimes gets confusing," noted project activist JoAnne Beemon. "The great thing about the St. Clair-Six Mile Lake project is that people can get involved right here in their own back yards, and reap the rewards of their efforts for years and years to come."

Although \$3,000 in individual contributions have been raised toward the estimated \$17,000 needed to purchase the 17-acre Upper Chain of

Lakes property, next weekend's fundraisers will reach out to larger segments of the public.

Among the many exciting aspects of the project is that it brings the Little Traverse Conservancy of Harbor Springs and the Grand Traverse Regional Land Conservancy together in their first united conservation effort, Beemon said.

**April 17: Earth Day Walk**

Walkers from all over are invited to take part in this special event, coordinated by The Lake St. Clair-Six Mile Lake Natural Area Committee in conjunction with the National Parks and Conservation Association's fourth annual Walk for Parks and Open Spaces.

It all gets underway Saturday at 9 a.m. in Ellsworth Wooden Shoe Park, where groups like the East Jordan Garden Club and area 4-Hers will join interested individuals like Antrim County Sheriff Dale Roggenbeck and Charlevoix County Sheriff George Lasater for the 1.9 mile hike.

"We're crossing our fingers for good weather, because this is a beautiful walk," Beemon stated.

## Clarification

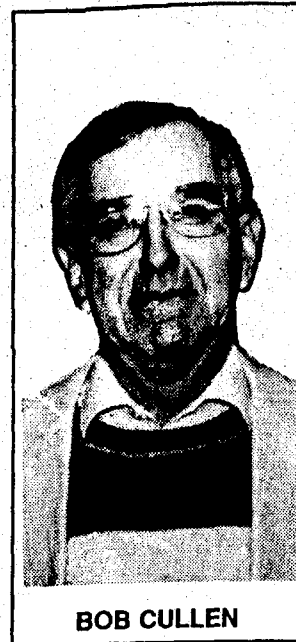
## Evening will celebrate the arts

# Take a spin - your school will win!

If the Central Lake and Ellsworth communities respond as positively as they did last year, their school districts are on their way to earning hundreds - even thousands - of dollars worth of advanced learning aids.

The reason? Both areas are participating in a unique promotion known as "Driving for Education" this spring.

According to local sponsor Crown Motors of Charlevoix spokesperson Bruce Wilson, "This program is part of a nationwide effort of Chevrolet dealers who are stimulating volunteer community activity in support of local schools and the improvement of education in America."

Wilson isn't just paying lip service to that ideal, either. Last year, his dealership awarded \$3,000-plus worth of computers and software to Ellsworth and Central Lake schools.

"We've found that the Driving for Education program is an effective way to provide important and much-needed leading edge learning equipment to our own local schools without resorting to tax dollars in these days of tight budgets and scarce money," he said.

All area schools - public, private and parochial, were invited to participate in the innovative promotion.

Basically, the program awards a point for every test drive taken at Crown Motors during special Test Drive Weeks. For Central Lake, that special week is already underway - April 5 through April 10.

At Ellsworth Schools, Test Drive Weeks are April 26 through May 1 and May 3 through May 8.

Each school accumulated an amazing 150-plus points by Driving for Education in 1992 - the first year of the program - enough to earn an Apple computer and plenty of ex-

pensive software.

According to Wilson, both districts far outperformed larger areas such as Charlevoix - "A real tribute to the level of community involvement in your area."

Also taking part for the first time this year from the Central Lake area is Ebenezer Christian School. Their effort earlier this month netted 41 points - far above the minimum 25 required to be eligible for awards that now include Texas Instruments calculators, Wilson sporting goods and Encyclopaedia Britannica, along with the Apple computers and Magnavox audio/visual equipment offered in 1992.

There is no pressure on participants to buy, Wilson stated. Drivers must be licensed and over 21; licensed drivers under 21 must be accompanied by a parent or guardian. The requirements: Take a test drive and fill out a simple form.

"Last year, we had a few convertibles and vans that were especially popular," Wilson noted. "It was great; actually a lot of fun for everyone."

During its first year of operation, Driving for Education attracted 300,000 volunteers across America.

For Crown Motors, participation has been a satisfying experience, Wilson said. "Almost every day we hear or read about the pressing challenges that our schools, teachers and

ultimately our children face. The challenges are intensifying. That's what makes this program so appropriate right now."



## Burning ban imposed

Department of Natural Resources Director Roland Harmes announced that the DNR, United States Forest Service and those local units of government authorized under the state's forest fire law (Act 329) will not be issuing burn permits from April 17 to May 16 in an effort to curb Michigan wildfires.

"Spring is the most critical time of year for wildfires in Michigan," Harmes said. "Some 42 percent of all the state's wildfires and more than half of those that burn over 100 acres occur during the last two weeks of April and the first two weeks of May. The outdoor burning of yard and household debris is responsible for 37 percent of the wildfires during this time period."

While burning permits are not required under the state's forest fire law for recreational campfires, burning in an approved debris burner (a

masonry or metal container with a metal cover having openings no larger than 3/4 inch), or when the ground is snow-covered, wildfire officials are asking people to refrain from outdoor burning during the April 17 to May 16 period.

This 30-day action does not affect those townships and municipalities with local ordinances on burning permit issuances that are stricter than the state forest fire law. However, all units of government with such authority are strongly encouraged not to issue permits during the moratorium.

In Antrim County, burning permits must be obtained through the DNR office in Bellaire, 533-8431, or the Gaylord office, (517) 732-3541.

DNR Fire Officer Carl Stahl reminds residents the sheriff department no longer issues burning permits.

## Rollover injures driver

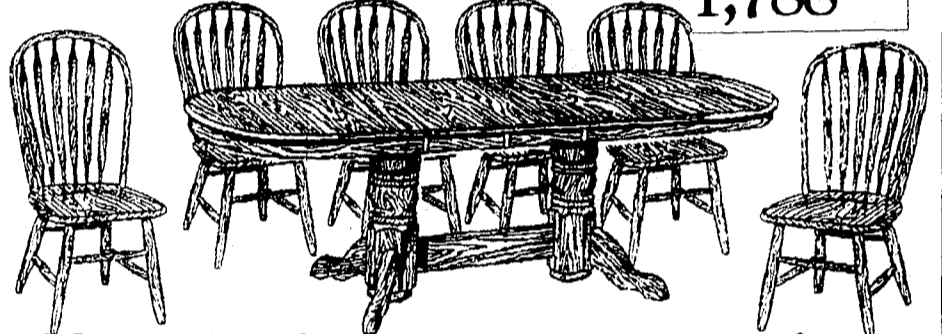

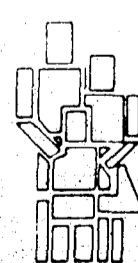

he noted.

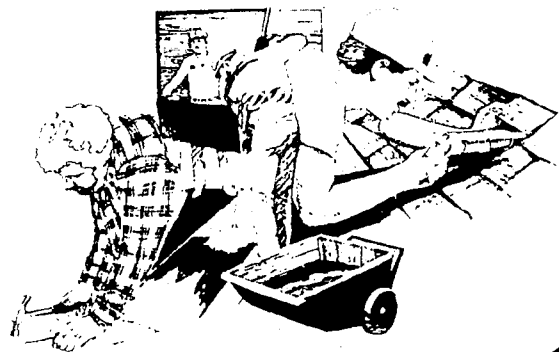
"The student council does everything but man the nurses station," Sheridan said. "That includes running the canteen, labeling the bags, serving as donor aides and registering everyone who participates."
