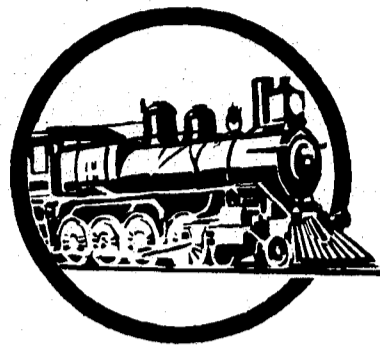

## School finances outlook unpredictable

## EJHS principal resigns post

After two years of service as East Jordan High School principal, Kenny Kent has resigned.

Kent will end his official ties on July 1, 1993.

In a letter to school board president Mary Jason, Kent explained the decision as a career move. He will become head principal at Reed City High School.

Kent thanked the school board for a positive experience. He cited a fine working relationship with the staff at East Jordan High School. Kent noted especially the good work of Linda Poole as office administrator.

Reed City is a Class B school, twice as large as East Jordan, according to Kent. He is excited to face the new challenges ahead.

Superintendent Chip Hansen expressed the same excitement for Kent's chosen professional change.

"We hope his experience at East Jordan will help him with his new responsibilities," Hansen said.

Hansen praised Kent's enthusiasm and his work in preparing East Jordan High School for North Central Association certification.

Board at the June 15 meeting.

Hansen outlined four scenarios that the district could find itself in in the aftermath of Proposal A.

The budget possibilities run from a \$588,780 worst case deficit to a \$132,809 fund balance.

The true statistics will probably be somewhere in between.

"At this point, though, the board is unable to predict revenues because of legislative inaction," Hansen said.

The superintendent explained that state law required a balanced budget by June 30. Consequently, many school districts are inflating revenues and will have to amend budgets monthly.

Usually, the budget would only need amendment once or twice within a year.

Hansen's scenarios considered various legislative actions or inaction, East Jordan in-formula or out-of-formula, and the possible local override of the Headlee amendment.

Nearly every scenario showed East Jordan school district to be in fiscal jeopardy.

"The fiscal irresponsibility of the Michigan State Legislature has placed us in this position," said Hansen.

"Until they do the right thing, the outlook is bleak."

The renewal of the .25 millage for technological programs was good news for East Jordan schools. Combined with last year's millage, the funds will bankroll the installation of a new Business Services Technology lab at the high school.

The 22-work-station IMB lab will cost \$71,340. That figure includes all hardware and software. Cable installation to provide power will add \$10,000 to the bill.

BST Program Director Jerry Hawes said the lab will be immediately functional and state of the art.

"At the same time," Hawes continued, "the lab has

the capability to be expanded and up-dated. It will serve us for many years to come."

The lab will be in constant use throughout the school day. For this reason, six auxiliary stations will be provided in the media center for out of class use.

The BST program will provide services to the teaching staff and the community. Plans for evening, summer and spring break activities are in the works.

The 26 Macintosh computers presently at the high school will be recycled to the middle and elementary schools.

Curriculum Director Anne Dingman gave a presentation on the work of the Drug Free Schools committee.

According to state directive, the district has issued a written policy. The policy contains a philosophy statement and an outline of district activities in prevention, education and treatment.

Also included in the statement are district expectations for students and staff participating or attending extracurricular activities.

School property will be tobacco free at all times. There will no longer be smoking allowed at school functions or on school grounds.

Signs will be posted and announcements made at activities attended by the public. The school board hopes to be able to enlist public cooperation for this policy in a positive manner.

Chief of Police John Imeson is now a member of the Drug Free team. He will receive training this summer in effective school/police department liaisons.

Dingman, along with counselor Karen Starkey, also discussed how the policy aligns with the curriculum. All K-12 students receive drug prevention education.

"We are presently in total compliance with the state mandates," Dingman concluded.

Your pictures of the Thimble Club of 1915 and the teachers of 1912-13 were much appreciated. It was very kind of Miss Norma Roman to write and give help with the identifications.

The picture of the teachers was particularly interesting to me because my mother, Burnice Miller Bennett, who was a 1915 graduate of Central Lake High School, spoke a number of times of Miss Helmer, who was apparently a loved and respected teacher.

I never met Miss Roman, but was glad to have her identify her mother in the picture of the Thimble Club. After they retired from the store, Mr. and Mrs. Fred Roman lived in a house they remodeled on a small farm which had belonged to the Cobb family (who moved to Central Lake), which was next door to the little Maple Hill School where I had my first eight grades. I remember them as very kind and friendly people. They were also intelligent and educated, but I don't know details of that. They sometimes boarded our teachers, and there was usually candy for any kid chosen to go and see if teacher had received a letter in the mail. They grew delicious Snow Apples that they always shared with the school children.

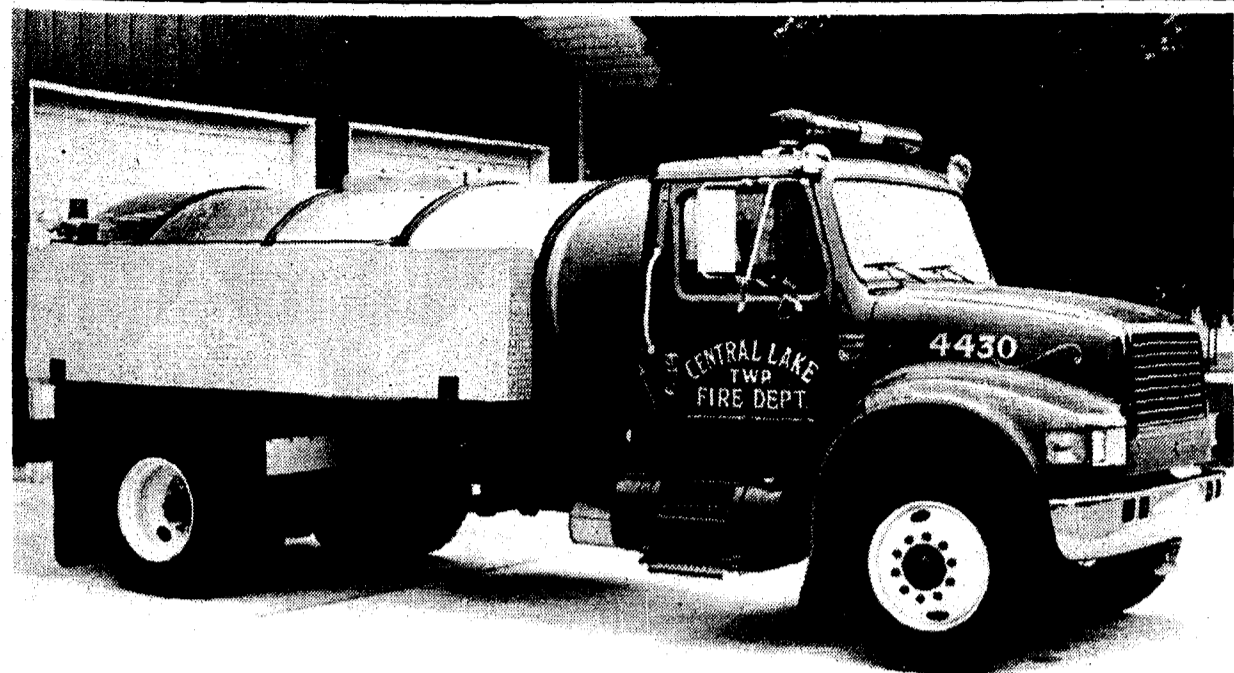

# Property tax appeal available

If you appealed your property tax assessment in March because you believe that the SEV (State Equalized Value) of your property is greater than 50 percent of the fair market value and the local board of review declined your request, you can appeal to the State Tax Tribunal.

It doesn't cost any money, you don't need an attorney and you don't need to drive to Lansing. The State Tax Tribunal meets approximately once a month at your county building.

To appeal your assessment you must send a letter postmarked by June 30 to the State Tax Tribunal. Your letter should state the township or city from which you are appealing your property tax assess-

ment. In addition, be sure to specifically mention that you want a hearing before the State Tax Tribunal.

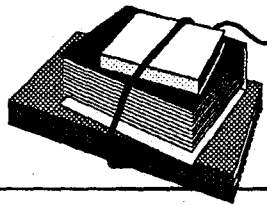

# Lady Trojans battle to semifinals

Central Lake's Trojans returned to familiar territory last week, winning their quarterfinal battle with Traverse City St. Francis and reaching the final four of Class D softball before bowing out.

June 15 saw TC St. Francis and Central Lake tangle in Gaylord, and for two innings, neither team could dent the scoreboard. The Gladiators finally got a pair of runs in the third, thanks to errors and a Jamie Doriot single.

Central Lake rebounded in the third with three runs of their own, starting with a Laura Murray walk and Sara Roach single. Julie Aenis' groundout brought in a run; Misty Boatwright's single plated another; and with two out, Amy Dawson slapped a single to score the lead run, 3-2.

A Shannon Flynn double and yet another error allowed St. Francis to tie the score at 3-3 in the fourth. Both teams would have opportunities that slipped away before the climactic bottom of the sixth.

With two out and nobody on, Murray started the winning rally with a walk. Roach singled to right, Murray racing for third. The throw to third would hit Murray, deflecting into short left field and letting her jump up and race home with the eventual winning run. Julie Aenis then singled to score Roach with an insurance run.

TC St. Francis went quietly in the seventh on flies to Murray in left and a comebacker to Dhana Lockhart on the mound, removing one more obstacle to the Trojan victory march, 5-3.

Lockhart outdueled the Glads Flynn, allowing just three hits and striking out six, while Flynn lost by allowing five hits and striking out seven.

The Trojan softballers finally fell to Morrice 11-4 in the June 18 semi-final game at Bailey Park. The Trojans were hoping to avenge the semi-final loss of last year but it just wasn't to be, as Morrice jumped out

to an early 2-0 lead and stretched it to 7-0 before the Trojans could get on the board.

Central Lake had the bases loaded three times but couldn't push the runs home. Central Lake had three hits; singles by Sara Roach and Elissa Wagner and a triple by Misty Boatwright. The Trojans drew nine walks but just couldn't put the right combinations together, having to play catch-up the entire game.

Dhana Lockhart completed her four-year pitching career with a fine 27-4 record on the season. Misty Boatwright, senior at firstbase, completed another season as the leading hitter with a .368 batting average. Shana Lockhart, senior at second base, completed her career with fine defensive showing.

Morrice was defeated by Waterford Our Lady of the Lakes 7-2 in the championship game.

# Athletes head "down under" with coach

Two young cross country athletes and their coach depart today for Australia and four weeks with Sport for Understanding, a non-profit exchange program for teen athletes.

Ron Clone, Elk Rapids High School cross country coach, who went to the Netherlands under this program last year, will lead a team of eight young cross country runners.

Three runners on the team are from this area: Clone's daughter, Megan, 16, will travel with him as will freshman Jaime Yates, 15, of Williamsburg and Neil Booze of East Jordan.

"It really helps to know three of the eight team members well, and we are looking forward to this trip, as I know it will be a tremendous experience for all of

us," Clone commented.

The first two weeks, the group will stay in Canberra, and the the second two weeks, will be in Adelaide, where they will compete in a cross country championship and a 10k road race. Also included is a three-day stay on Kangaroo Island, just off the coast of Adelaide, which is purported to be the place to see Australian wildlife.

SFU teams are involved in sport and cultural learning activities, as well as the opportunity to spend time with a host family and learn firsthand about the country's culture, language and customs.

According to Coach Clone, the cost to students, while not small, includes air fare, uniforms, and the costs of any planned sight-seeing or travel. Of course, the room and meals is supported by the host families.

Weather in Australia now is winter, but winter there is about the same as one might experience in northern

Georgia. "There probably won't be snow, but it will be in the 30s at night and probably 50-60s during the day," Clone said.

The area is also maritime, by the ocean, so it would be right to expect dampness such as any coastal states would have.

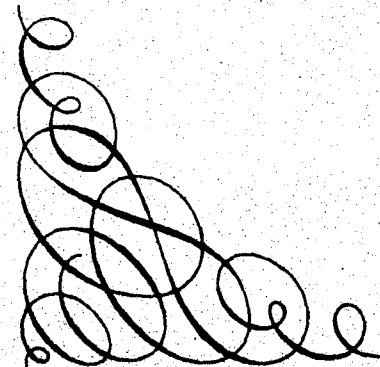

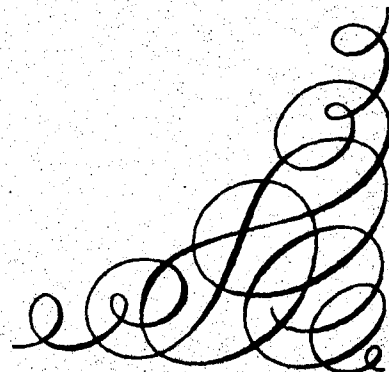

## Central Lake Township Briefs: June 16 meeting

### Fire department lauded

Central Lake Township has a fire department to be proud of. That was the consensus after a departmental report by fire chief Don Smith. Smith noted that Central Lake has satisfied virtually all MIOSHA requirements, "although we've had some problems finding someone to take off the fire truck tires and look inside," a MIOSHA mandate every 10 years, he said.

During his review, the inspector had commented that the department must have excellent cooperation from their township board to meet the demanding requirements so successfully, Smith noted.

Supervisor Paul Vernon went a bit further. "The inspector was very impressed," he stated. "In fact, he asked permission to cite the Central Lake Fire Department as an example that it can be done (satisfying MIOSHA standards). We can all be proud of your performance. It speaks well of your department and the quality of protection the people of this area are getting."

### No news on lake access

In response to a question from Bob Wilson regarding the status of the Kingma/Shahan access site question, Vernon stated that the township is now awaiting

the arrival of the Shahans, whose property borders the northern edge of the access (on Intermediate Lake's north-east shore.)

"I can tell you that we're close to an agreement that will keep the township out of court," Vernon added. "We hope to find a resolution that is acceptable to all parties."

### Lucas supporter speaks

"I would classify myself as a friend of the clerk's," Jack DeMorrow stated during the audience comment portion of the meeting. "I hope I'm not the only one."

DeMorrow went on to detail the reasons for his support of Marilyn Lucas, the subject of a current recall attempt.

"You went to her and asked her to serve," he told the board. "She knew her limitations and asked for help, but she was refused ..."

Regarding the township's financial status, DeMorrow urged, "Go back and look - you haven't had a balanced budget in three years ... Each time, the auditor made a recommendation to upgrade your software, but it was never done ..."

DeMorrow also protested the "continual harassment" of the clerk, and "recall petitions served with your meal" in a local restaurant.

### Treasurer reports will be read at meetings

At the request of Jackie Watson, the treasurer's report will now be read and copies made available for residents attending township meetings.

"It occurred to me that I never see a treasurer's report," she stated. "At other meetings I've attended, that information is usually part of the proceedings."

Vernon stated that although public dissemination of the treasurer's report is not the current practice, he saw no difficulty in initiating it. However, he expressed doubt that the information would be very informative to the average citizen.

"I think it would be very interesting," Watson demurred. "After all, it's the taxpayers' money. It seemed that last month, there was quite a bit of confusion about the amount in various funds. I thought to myself, 'Why don't we ask Cheryl? [Shooks, township treasurer].'"

Vernon noted that Shooks' report is a financial overview, with accounting details being the clerk's responsibility.

f) Supervisor and E. Knoechel attended a Cable TV Conference recently. A court date of 6/23 is set re Village Cable. They have called to notify Township they have a new partner. Phoenix Communications is still interested in contracting with Township and is a possible option if Village Cable does not work out.

5. Letter John Berst mailed to Sheriff requesting more patrolling at north end of Torch Lake was read. Sheriff responded and will have a patrol boat in the north end of lake more frequently.

Laura Schmidt talked about work the Drug Free School Comm. does. Motion by Cowell, supported by Schmidt the Board endorse this Drug Free Program and send a letter to that effect. Carried.

Letter read from attorney with regard to options available to the Township re Kruger Road. Letter was just received before the meeting so a Special Meeting will have to be called to discuss this further.

6. J. Hubbell has not found a trailer to transport tractor for lawns cutting at park as yet, however, he will continue looking.

7. Rauch property next to the access on the Bay was discussed. Hubbell is concerned about possible liabilities as far as a portion of septic system (dry well) infringing on Township access. More information will be obtained in order to make an amicable decision.

8. Supervisor discussed fund raising for the Day Park. He stated he hoped to have his newsletter out soon and would save a space for a tear off strip for any donations. He stated there had been a Recreation Comm. meeting a few weeks ago.

Eight people were in attendance and they discussed fund raising - self-supporting ideas, etc. Recent information received from the attorney made the Board aware of a plan called Installment Purchase Contracts which could be handled by attorneys - Miller, Canfield & Assoc., that do municipal financing. Appraisals required

by DNR for Day Park were secured from 3 different sources and the value given is \$320,000. Purchase price as of this meeting is \$263,898.01. Grant approved by DNR is \$176,000 and a donation will be made by W. & V. Good of approximately \$55,000. Deducting the grant and donation from the purchase price leaves a debt to the Township of about \$89,000. The cost to the Township for services of Miller, Canfield & Assoc. would be \$1,200.00. All Board members expressed their reasons for being in favor of the purchase of Day Park.

There was considerable discussion whereby it was contended that various properties and businesses in Torch Lake Village have or have had a problem with contamination. N. Ellison read from an article that cautioned the "Buyer Beware" and make sure property is not contaminated. W. Good had at the meeting, and submitted to the Board an environmental site assessment from Gosling Czubak Assoc. dated Oct. 30, 1989 showing 6 borings having been made and no indication of compounds entering the campground site from the west through the upper aquifer. M. Lathers referred to a report from the DNR covering the background of contamination in the village area. The case study he referred to was Residential Well - Torch Lake Township - Site #1D050011. He indicated that Torch Crest Grocery in the village had a problem with water contamination last year; also he was concerned that the gas pumps at the Marina were closed this year. N. Ellison stated she heard the Marina tanks were pulled recently and they were leaking. Mr. Lathers also stated that at one time the Park did test out to be contaminated. Supervisor will contact DNR re this property, testing, etc.

J. Pilkington - M. Klooster and W. Trendle expressed the opinion they would still like a confidence vote for acquisition of the Park.

Resolution made by Smedley the Torch Lake Township Board accept conditional pledges and donations for the acquisition of the Torch Lake Township Day Park. Funds to be deposited in a Trust & Agency Account. Supported by Schmidt. Carried by unanimous vote.

9. Accesses (Marking of) Canceled until next month.

10. Name for Township Hall - Canceled until next month.

11. It was noted that S. Matthews term on Planning Comm. will terminate this month.

12. It was suggested a sign be installed at Park for emergency phone numbers and where phone is located.

W. Trendle inquired about school publications and whether or not they were put in two papers. Schools legally are only required to publish votes, etc. in one paper.

Meeting adjourned at 10:30 p.m.

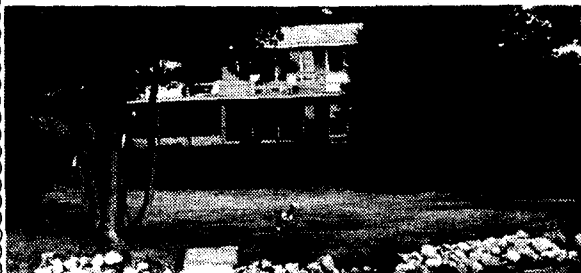

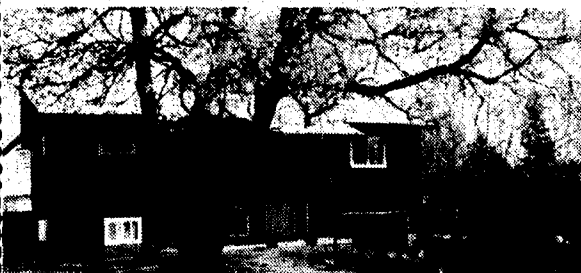
