



August meeting rough for city council

The atmosphere was tense and adversarial at the East Jordan City Council meeting August 17.

East Jordan businessman Arlon Leonard was particularly vocal in his condemnation of nearly all the council's actions.

Leonard made several accusations during the course of the meeting and finally walked out angrily.

Although many of the issues were controversial, the most emotional item was introduced by council member Lyle Etcher.

Etcher proposed a reprimand of city clerk Kathy O'Rear, treasurer Susan Moreau and DPW foreman William Breakey for the unprofessional behavior characterized by a document introduced at the July 22 hearing on charges against Breakey.

The document, on a city purchase order form, alluded to sexual favors between the city office workers and Breakey. Both women volunteered at the hearing that the document was a joke, and part of an ongoing pattern of jokes and obscenities meant in fun.

At the hearing, council member Guy Vallance expressed concern over the issue, though it was dropped from the charges against Breakey. Vallance seconded Etcher's motion to reprimand.

Council members Greg Chappuies, Jerald Cihak and Mayor Russ Peck opposed the motion. Members Etcher, Vallance and Ruth Gee supported the reprimand. Council member Russ Gee was absent.

Because of a lack of majority, the motion was not

After the meeting, Moreau said she could understand the council's concern over public perception. She feels it is a misunderstanding that could have been prevented.

"If it could have been brought to us before the hearing, we could have taken care of it and it wouldn't have gotten to the public," Moreau said.

Parking - Parallel or angle?

A request by Police Chief John Imeson to consider changing the status of Main Street parking provoked another debate between council members and the

Imeson made the original request at a June council meeting, but the subject was tabled so informal opinion surveys could be carried out.

Imeson recommended the change for several reasons, including safety in backing into traffic and pulling out onto Main from cross streets.

The state of Michigan could withhold funds if the city is unwilling to comply with a statute that requires




New look awaits area students

EJ council faces tough issues

Several controversial issues emerged at the Aug. 17 meeting of the East Jordan City Council.

Problems with Elm Pointe access were discussed. The Parks and Recreation committee proposed short-term permit parking for the area located next to the museum and residence.

Mayor Russ Peck questioned allowing the park caretakers authority to issue permits, citing a recent problem at a wedding reception. Apparently the caretakers were abusing their privilege to park near their residence, leaving no room for the group that leased the lodge.

Other council and audience members reported similar incidents. Rudeness and verbal abuse from the caretaker were also mentioned as recent problems.

The process for defining and providing the permits is in the development stage. "We've never tried this before," said Superintendent Bob Johnson, "so we'll have to experiment with ideas. We don't have all the answers yet."

Johnson called the permits a step toward resolving a problem that has occurred this year because of expanded public use of the facility.

Drug policy reviewed

The Public Safety and Personnel committees met jointly to discuss the recently implemented drug policy for city workers. Council accepted the committee recommendation that the drug policy remain as adopted. The council clarified that its own members are expected to abide by the policy provisions.

City attorney Scott Beatty warned that the policy will be difficult to enforce against council members.

"Elected officials are responsible only to their constituents," commented Beatty.

At the council's request, Beatty will develop a process by which a council member may be disqualified from attending a meeting.

Zoning change denied

AJ Auto Parts and Repair Center owner Eliseo "Al" Cesaro approached the council to request a change in zoning for his State Street business. Cesaro had obtained a recommendation from the planning commission to grant Commercial 2 status to the property.

The business is presently zoned Professional/Office. According to officials, Cesaro has been operating in violation of the zoning ordinance, despite several notifications by the city.

His alleged violations include performing auto repairs and retail sales, as well as excavation without a permit.

Council member Greg Chappuies explained that the East Jordan City master plan does not allow C2 (described as heavy or commercial use) variance in a residential zone. Other C2 uses of the area were in place before the plan. Chappuies said the trend will be away from commercial use in that area.

The planning commission will be notified of its error in making the recommendation.

Chappuies offered Cesaro the alternative of applying for a C1 variance. According to the master plan, C1 is more compatible with the neighborhood surrounding Cesaro's business.

The C1 zoning would allow Cesaro to continue his auto parts sales, but would disqualify the repair work.

"Am I supposed to be going out of business now?" asked an angry Cesaro before walking out of the meeting.



Meeting before recall: Errors, anger persist

The last meeting before the Aug. 23 recall election of township clerk Marilyn Lucas underscored the problems that have plagued the board in recent months.

agreed with those totals, noting, for instance, that only \$7,000 was actually budgeted for WRS payroll. The board tabled payment on the bill, pending an investigation by Vernon and Shooks.

Among the most serious were charges that clerk-supplied figures resulted in a miscalculation of workers compensation premiums, resulting in an unbudgeted additional charge to the township of \$2,578.

Supervisor Vernon questioned two payroll projection figures (on which the pre-paid premium was partially based), of \$13,363 for "Care of the Township Hall" and \$19,361 for payroll at the Waste Receiving Station.

Both Vernon and treasurer Cheryl Shooks dis-

utes were rejected for inadaquacies, but this time Vernon was prepared - offering a resolution authorizing the township to use his personal tapes as the official record of the April 21 meeting.

"I am getting a little weary of playing the game of trying to get acceptable minutes," he stated, noting that corrections requested by the board were not incorporated in the resubmitted documents.

The resolution, against which Lucas cast the only nay, was subsequently repeated to cover minutes

for the June 16 meeting as well.

A third set of minutes. compiled by deputy clerk Vivian DeMorrow during the Lucas' July absence, was refused because the board judged them incomplete. Noting the absence of any record of a discussion on why previous minutes had

been rejected. Vernon stated that the bare facts as presented put the board in an unflattering light.

"I suspect this was a deliberate attempt to be misleading," he stated - a charge emphatically denied by DeMorrow.

Another subject of discontent was a list of bills submitted by Lucas. Although several inconsistancies were explained as the result of late charges already paid, Lucas had no defense for



Cihak appointed to East Jordan council seat

In the midst of a controversial Aug. 17 meeting of the East Jordan City Council, Jerald Cihak was sworn in as the new Second Ward representative.

The circumstances of Cihak's appointment was one of the issues that evoked discussion at the meeting.

Mayor Russ Peck began by clarifying his statement to the press at the time of former council member Ralph Kitson's resignation.

"I am making a recommendation to appoint the

winner of the Aug. 2 primary election (as Kitson's replacement)," said Peck. The mayor can only recommend. The actual appointment requires a council resolution.

Second ward council member Greg Chappuies submitted a motion to appoint Cihak to the seat. Because, under Roberts Rules, there is no discussion on the motion until after it is seconded, Chappuies' motion died for lack of support.

A discussion of precedents for resolving the situation followed. Some council and audience members were concerned that half the votes of the Second Ward would be disenfranchised if the seat was left vacant until November.

Concerns about giving Cihak an edge over his November opponent, Brian Sweet, were also voiced.

Referring to the city charter, Attorney Scott Beatty informed the council that the seat cannot be left vacant. There are no instructions in the charter as to procedure, however. This leaves the mechanism for the appointment up to council.

Chappuies presented the motion a second time and Ruth Gee supported. Cihak was appointed by voice vote with three in favor and two opposed.

Cihak, 47, is chief electrician at East Jordan Iron Works. As a lifelong resident of East Jordan and former firefighter, he believes he knows most of the people in town and will be more receptive to their needs.

A historical perspective of the Gleaners



THE APTLY NAMED Pleasant Valley Belles lined up in the summer of 1914 are (left to right) Mable Hill, Ella Harris, Bertha Sadler, Beatrice Hill, Murrel Spence, Hazel Swain and Dessie Spence. Notes Floyd Churchill, "Beatrice and Mable married the Scott brothers, Ella married my uncle Perry Hill, Murrel married Bill Derenzy, Hazel was George Spence's first wife; Dessie became Avery Wilson's wife, and Bertha married Harve Hill. Bertha is now living in Petoskey at age 99; Murrel lives in East Jordan and Dessie is in Central Lake.

Just before the turn of the century, due to the lack of transportation and communications, there was a great need for meeting places and recreational facilities in the rural areas of Michigan.

In 1894, a Mr. Grant H. Slocum of Caro met some of these needs by organizing the Insurance and Fraternal Establishment under the name of the "Ancient Order Of The Gleaners."

Patterned after the Grange, Oddfellows, Macabees, etc., it kept that name until 1931, when it was changed to "The Gleaner Life Insurance Society."

Around 1900, the Gleaner Maple Arbor was formed and located on donated land, half-way down the Densmore Hill in Echo Township.

Iknow William Spence donated most of the land, and I believe my grandfather, Norvell, a civil war veteran, furnished some of the land to the North. The Gleaners supplied

the building material and local labor provided the carpenter work.

The Hall was located on the south side of Old State Road.

The horse barn was just to the east and accommodated stalls for about six teams. A picnic grounds could be found across the road, complete with refreshment stand, a stage and dressing rooms, plus rustic seating on the side hill facing the stage.


The Petrie Sugar Bush occupied the same site for many years after the picnics were discontinued in the mid-20s. The old barn survived till the late 30s.

The Hall was about 30 by 45 ft. The outside was covered by simulated brick pressed in a brick red sheet metal. The dance hall section upstairs walls were covered with embossed creamcolored sheet panels, resulting in very good acoustics. The dance floor was waxed hard maple and very beauti-

ful.

The cooking and dining area was downstairs and rather unfinished. A long rustic table down the middle was covered with red oilcloth. The benches were attached and you had to step over to get seated. The wood cook-

continued from page 8 ing stove was a large institutional type shaped like the old Home Com-

fort Ranges.

The lighting downstairs was from a battery of kerosene lamps and the dancing area had an early double-mantle gasoline lamp hanging dead center. A platform for the piano, fiddler and caller was at west center. The walls had the usual pictures of Washington and Lincoln hanging and I believe they had another showing field workers, titled "The Gleaners."

Over the years, formal lodge meetings were held and one of the pictures shows a 1912 vintage Degree Team, a highly trained and uniformed drill group, used for entertainment at lodge meetings and picnics.

For many years Howard Spence and my father, Hugh, managed the Saturday night dances. Efton LaValley and Eva King were hired for the music. I remembered they were paid \$15 per evening.

There was a raised area over the stairwell where we kids were allowed to sleep. I still have a love for fiddle music that sort of filtered into and out of my head as I dreamed away.

We were all awakened for lunch time. My mother Madge and Sylvia

Spence furnished the food. It was always good, but I liked "Oyster Stew Night" best. They were stewed in a five-gallon lard can, sold for 50 cents a bowl, crackers and coffee included.

For the picnics, Dad always ordered, by train from Traverse City, a barrel of cones a couple of five-gallon tubs of Velvet Brand ice cream, a couple cases of Cracker jack, a case of candy and two bunches of bananas.

Sylvia and Mother ran the stand. Ice cream sold for five cents a cone. Cracker jack and a bananas were also five cents each. My aunt Pearl, being an ex-school teacher, used to organize skits, poetry recitation, etc., for picnic entertainment.

I have heard that black minstrels and plays were given in earlier years. The singing was very good as no radio or TV was available and so people did a lot more for themselves in those days.

I attended my last Gleaner Picnic in 1923. The coming of WW I and the great Depression caused a decline in the Gleaner organization.

As people moved to the cities, membership diminished. Our family moved to Metro Detroit in 1924 and I know my parents kept up their insurance payments till 1930.

I know very little of the Eastport Gleaner race track, and picnic area. The present camp sites face the old oval track, and the picnic ground and beach have been popular for 100 years.

About 20 years ago, the late Walter Petrie, an old neighbor, told me my grandfather used to hitch up a couple teams of horses and take the Pleasant Valley Sunday School classes out there on the Fourth of July. Walter said Norvell never failed to put on his uniform

jacket and cap, buckle on his Cavalry saber and make a patriotic speech.

The Echo Township Gleaner area must have been biodegradable because the old hall and barn area is completely covered with 10 and 20-foot high maple trees. Maple Arbor was a well chosen title.




parallel parking on major streets.

Imeson also recommended dropping the posted time restriction of an hour.

"We cannot enforce the restriction in a fair and consistent manner," Imeson explained. He noted that lack of funding prevented the department from hiring a parking officer for the past two years.

Main Street business owner Arlon Leonard challenged the council to replace the lost parking. His estimate was that 10 places would be lost.

Leonard also charged that city council is attempting to disrupt Main Street businesses with the change.


