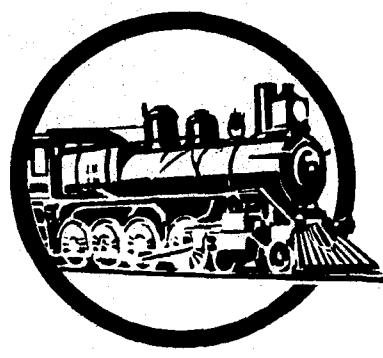

EJ Council assesses management of meetings

As a result of recent disorderly discussions at city council meetings, East Jordan mayor Russ Peck announced a more formal approach.

Peck explained that any speaker addressing council will need to be recognized by the mayor first. The change was made in an effort to avoid the disruptive arguments that have surfaced at recent meetings.

Also at the Sept. 21 council meeting, the city personnel policy manual was discussed. Both superintendent Bob Johnson and council member Greg Chappuies had serious questions on several issues in the manual.

Although many members wish the project to be completed and approved, some expressed concern that revisions still need to be made.

The personnel committee had not yet solicited reaction from department heads and union Local 214. Several council members felt it important to have some involvement from these officials before approving the policy.

Other problems with the manual include lack of job descriptions, need to clarify at-will employment and too many duplications.

According to committee member Lyle Etcher, city attorney Scott Beatty also needs to survey the policy language.

Etcher was concerned that the work be completed soon. He offered a motion of intent to complete the manual within 30 days.

The council then set up a workshop specifically to discuss the complicated issues. Along with committee members and Beatty, all department heads will attend the Oct. 6 meeting.

Special Olympics holds run

About a dozen state troopers along with six runners from the Bergmann Center in Charlevoix united for an eight-mile run in East Jordan on Mon., Sept. 20, as part of the ninth annual Michigan Law Enforcement Torch Run that started Sept. 18 and ended this past Saturday.

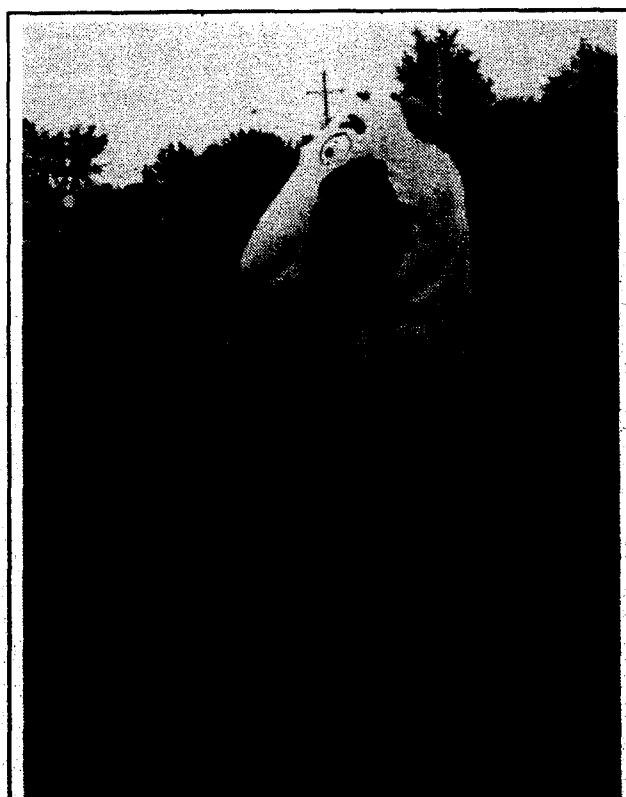
The runs were held throughout communities in the state's two peninsulas. The kick-off for this year's event was at Tiger Stadium and runs were held as far north as Houghton. During the eight-day event, over 1,200 law enforcement personnel and Special Olympic athletes participated.

On Monday afternoon in East Jordan, runners started at the intersection of Deer Lake road and M-32 and finished up at Glen's Plaza.

Joe Mason, from Charlevoix, was the first to cross the finish line.

The Little Caesars in East Jordan provided free pizza and beverages for the participants and received a plaque in thanks for their participation in this year's fundraiser.

The Michigan Special Olympics hope to raise \$350,000 during this year's Torch Run. Last year, over \$325,000 was raised for the organization.

Don't let the flu get you!

The "flu" (influenza) usually hits from November through April; however, January, February, and March are the worst months. Some flu experts predict that the 1993-94 flu season may be a bad one. The good news is the new flu strain was caught early enough for scientists to incorporate it into this fall's flu vaccine.

High risk people should make an effort to protect themselves from effects of influenza. These include:

- Adults and children with long term heart or lung problems needing regular visits to a doctor.
- Residents of nursing homes and other institutions housing persons of any age with serious long term health problems.
- Healthy people age 65 years or older.
- People of any age who during the past year have regularly seen a doctor for treatment of illnesses such as kidney disease, cystic fibrosis, diabetes, anemia, or asthma.

- People who have a type of cancer or immunological disorder (or use certain types of medicines) that lowers the body's normal resistance to infections.
- Children and teenagers (six months through 18 years of age) who must use aspirin. They might be at risk for Reye's Syndrome if they get the flu.

Most people have no problems with a flu shot. The vaccine does not cause the flu. A common side effect is soreness for a day or two at the spot where the shot was given. Sometimes fever or achiness for one or two days may happen. Allergic or more serious reactions could occur after the shot but are not common.

People with a history of allergic reactions to flu vaccine, chicken eggs, or to any component of the vaccine, should call their doctor first for evaluation. Do not receive the shot until the evaluation is done. People who have been paralyzed with Guillian-Barre Syndrome, are pregnant, or are ill with a fever should consult their doctor.

Good news! Medicare will pay for the flu vaccination for Medicare-eligible persons this year. If your provider does not bill Medicare directly, you may request a receipt and submit the cost of the vaccine to Medicare yourself.

Flu vaccinations are available from your family physician and again this year at District Health Department No. 3 sponsored Commissions of Aging Flu Clinics in your local community.

- Elk Rapids Senior Center - Oct. 28, 12:30 - 1:30 p.m.
- East Jordan Senior Center - Oct. 5, 10 a.m. - 1 p.m.

The theme reinforces the commitment of Michigan 4-H Youth Programs to provide youths with opportunities and learning experiences that prepare them to become productive and involved citizens.

This year Antrim County 4-H Youth Programs National 4-H Week celebration will feature:

- The 4-H volunteer leader and teen leader recognition banquet at John R. Rodger Elementary School in Bellaire, on Mon., Oct. 4. It will begin with a social time at 6:30 p.m., with a potluck dinner at 7:00 p.m. All leaders and teen leaders, along with their families, are invited to attend. The program for the evening will be an upbeat video and commentary of the trip to Washington, D.C. by Triston Cole and Ryan Letter.

- On Tues., Oct. 5, immediately after school, the Ellsworth-Atwood area will hold their fall sign-up for members in the library of the Ellsworth Elementary School. There will be something for all ages, 5-19.

- On Thurs., Oct. 7, the women of Sacred Heart (Elk Rapids) will be treated to a showcase of 4-H projects from the youth in their area: sewing, crafts, leatherwork, writing, art, collections, and other projects. Everyone is invited. Leaders and children will give

brief overviews of their learning experiences.

- On Friday and Saturday, Oct. 8 and 9, several leaders and teens will attend a Personal Appearance leader training workshop at Kettunen Center located in Tustin (near Cadillac). Leader training workshops are offered throughout the fall, winter and spring, at a nominal cost (which in Antrim County is paid by the 4-H Leader's Association) to volunteers age 13 and up.

Other upcoming workshops include Visual Arts/Crafts, Oct. 22-23; Photography, Oct. 23-24; Food, Nutrition and Fit-

ness and Folkpatterns, Nov. 5-7; Adult Horse Leaders, Nov. 19-21; Peer Plus, Group Dynamite and YEA (Youth Experiencing Action), Dec. 3-5; Spaces: The World of Inner Space: Meeting Needs of Today's Kids, Dec. 11-12.

Other leadership training sessions are offered locally, regionally, and around the state throughout the year. More volunteers are always needed in all areas of the county.

The 4-H program is the Cooperative Extension

System's nonformal educational program for young people. It brings together volunteer leaders; state land-grant universities; federal, state and local governments; and the U.S. Department of Agriculture to develop and deliver educational programming for young people.

The 4-H youth programs are conducted in 3,150 counties of the United States, the District of Columbia, Puerto Rico, the Virgin Islands, Guam, American Samoa,

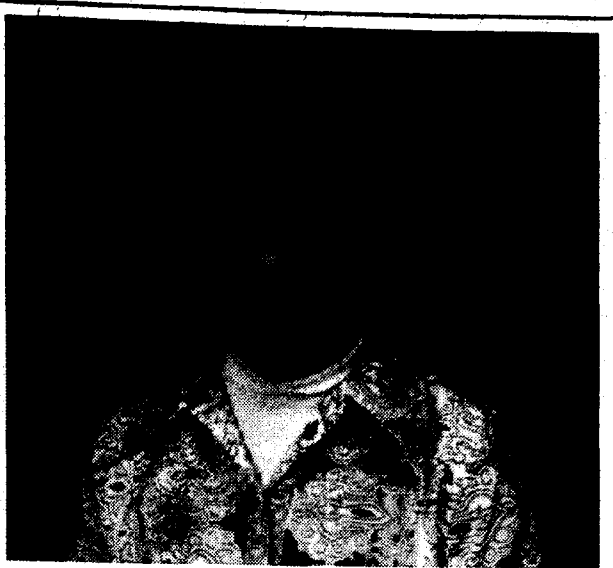

Carol Boros

She's the one they refer to when they say, "If you want something done ask a busy person, to do it." You could tell that it wasn't exactly a habit of Carol Boros' to be extolling her own virtues, but she was agreeable to the interview and modestly listed them for me.

During the couple of hours we spent together she seemed surprised as she recalled more of her accomplishments. Evi-

dently her days are so filled that she doesn't have time to realize what a difference she is making in the little town of Bellaire.

After fighting in the Civil War, her Ohio-born grandfather homesteaded in Antrim County near Bellaire and family generations have been a contributing part of the community since. For the most part Carol has resided in Bellaire, but Grand Rapids and Holland were her addresses for short periods while she was raising her three

children at home.

With all of her talents she evidently had no problem filling the gap when her children went out on their own. Her husband passed away in 1953 and she is proud of her five grandchildren and five great-grandchildren.

She was part of the small group of citizens who fought to save the Antrim County courthouse. Her role was to write countless letters, make phone calls and, in whatever way possible, help convince enough individuals that the beautiful landmark should be saved.

Carol has also been instrumental in the development and operation of the Bellaire Historical Museum. Each year, since 1976, it is a bigger success and attracts many visitors. The historical Society has been aided greatly by the generosity and cooperation of the village, township and local businesses in offering the Bridge Street building free rent, lights, and bathroom facilities. Ten volunteers keep the mu-

seum open five days a week in the summer. In 1992, 1,001 visitors enjoyed the impressive collection the members have cataloged and displayed.


In addition to keeping the museum's volunteer schedule running smoothly, she spends part of two days of her week delivering Meals on Wheels to local residents. Ultimately, as fire protection responsibilities were transferred to the township tax roll, the building as it now stands was transferred to the township with the permission that UTLA could use it



Trojans victors over Alanson and Boyne City

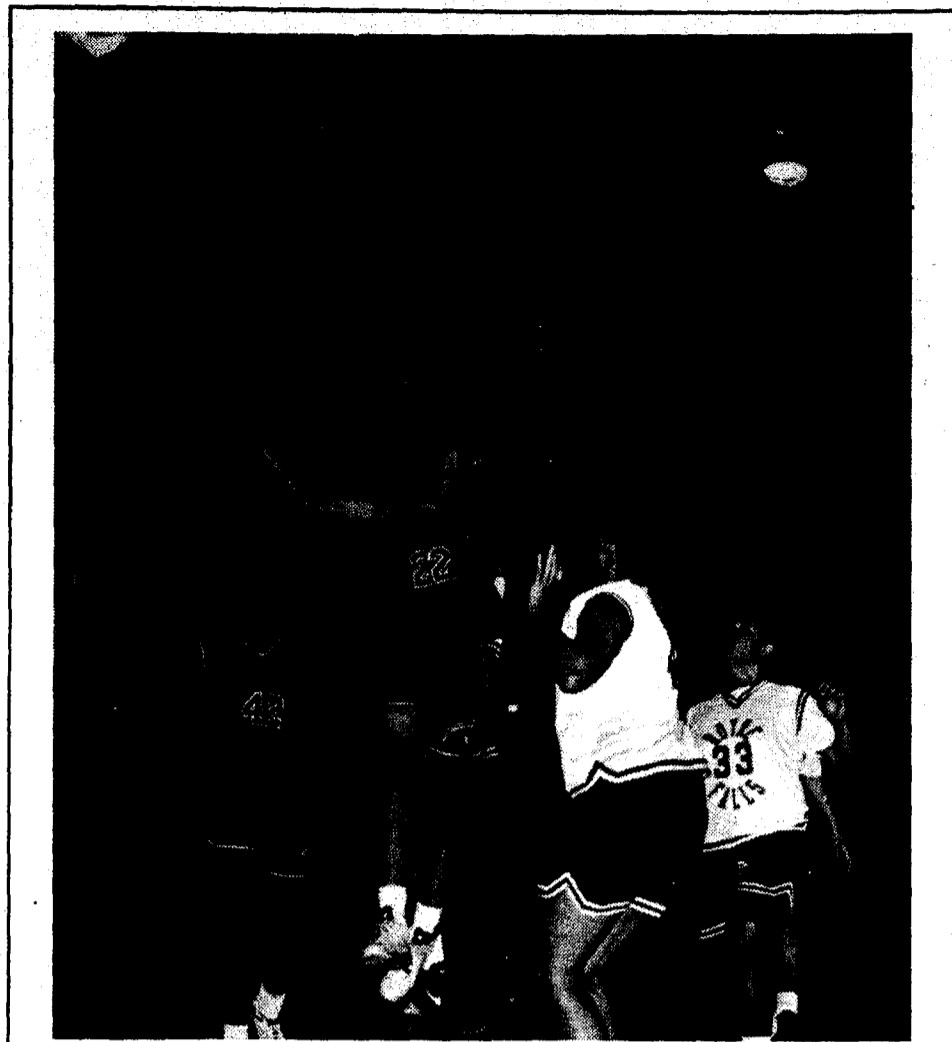

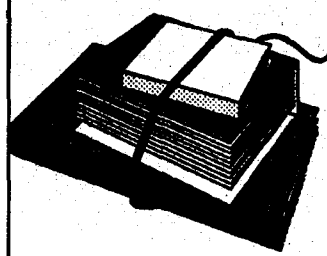

Extreme Measures By Michael Palmer

A missing undercover agent, a dedicated young doctor, a sinister organization, a pretty young woman searching for her missing brother and a mysterious clinic in Utah are the ingredients for a first-rate thriller. To tell you more would spoil the fun. This page-turner will keep you reading till the wee small hours of the morning. Look for it in the un-cataloged paperback section of the Central Lake Township Library.

Paper Doll

By Robert B. Parker

This is Robert Parker at his best. The plot, while being very basic, allows the reader to become reacquainted with the ongoing Parker characters: Spenser, the wily private eye with the prize fighter's nose and quick wit; Susan, a successful physiologist, with a Neiman Markus charge card; Hawk, with ebony skin stretched over a 6' 4" frame, a shaved head, a short fuse and a very large gun; and the dapper Lt. Quirk with painted on hair and the Brooks Bros. clothes.

The plot revolves around Boston social figure Loudon Tripp, who hires Spenser to find the person who murdered his wife. Parker takes the reader by the hand and leads them down the seamy road of life lined with a lecherous senator, whose florid complexion complete with cheeks covered by a web of tiny red veins, indicating a close personnel attachment to Jack

Daniels. Two bumbling henchman, whose talents proved they passed with high grades the CIA course in how to foul up without really trying, and finally the good ole cops, whose success is measured by the number of welts inflicted by their rubber persuaders.

This is one of the few novels where the dialogue should not be glossed over. The verbal exchanges are filled with witty, scathing and humorous prose. Example: Spenser walks into a greasy spoon restaurant and remarks "I can smell the cholesterol."

Another instance, Spenser is describing a man's hand as "being graceful, like he might play the harp or deal cards."

The plot is good, but the dialogue is great.

This book is available in the Central Lake Township Library.

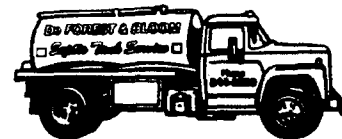

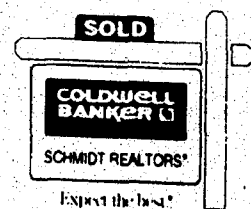

did, for special orders, that too must be one of her many talents. One might suspect she had had a little engineering training the way she goes about some of her tasks with charts she has drawn up and efficient templates.

"Oh, yes, I used to play piano for square dances," she remembered. She did the chording with Lloyd Burns. "Mother traded a crop of beans for an organ so I could learn to

chord," she recalled. "Mother took in ironings and traded thick cream in exchange for my piano lessons," Carol added.

In 1953 she wove her first rag run, and weaving still takes a lot of her time. She has three looms and cuts all of her own rags while she treats herself to a favorite television program. Of course, they all have to be sewn together and she has devised her own time-saving device for that step, too. She's creative with

her patterns and keeps her mind open to new trends and ideas and easily implements them into her routine.

Cooking for one is a challenge but nothing in Carol's kitchen is wasted. When she makes something too much for one person, she cooks it up with whatever else she has and mixes corn meal with it, bakes it and makes dog food packages for her granddaughter's dog.

She almost forgot she worked at Shanty Creek

for 17 years. When the resort opened, she took waitressing lessons but soon discovered she wasn't meant for that job. She found herself doing all kinds of jobs that needed doing, but were other than her waitressing tasks, and her hungry customers became impatient. The solution was to put her in charge of salads where she stayed for 16 more years.

During those years, young people in the area for summer jobs at Shanty

Creek needed lodging. So she opened her home to a few of them. She has many stories to tell about those experiences, most of them good, and she made many friends in the process.

As I left to go out the door she added, "Oh, yes, I've traveled over 100,000 miles in that camper (pointing to the vehicle parked in her yard) and have been in every state in the U.S.A." She adds that she invited

6. Tickets are available at \$1.00 each for a 50/50 drawing to be held by the Central Lake VFW to help pay for a memorial and flag pole honoring veterans to be erected in the Lakeview Cemetery.
7. Revision of the Public Dock Parking Ordinance was presented for discussion and tabled until a future date.
8. The Township has purchased a trailer that can be used to transfer equipment for mowing Day Park.
9. Motion by Cowell, supported by Schmidt we accept bid from Drog and Sons in the amount of \$2985.00 for work to be done at cemetery, and funds for this project to be transferred from the Golden Key Account to General Fund. Carried.
10. A report was received from the Road Committee advising the Board of the business discussed at a meeting held on August 31. J. Norris commented on the NAFTA agreement about to be signed and encouraged everyone to become as informed as possible on this issue.

East Jordan Council Sept. 21 meeting briefs

■ Mike Dionne of the Charlevoix County Snowmobile Council gave a presentation on the current snowmobile trail through East Jordan.

A leased right-away was recently withdrawn from the snowmobile group. The property owner decided after eight years not to continue allowing the trail to cross his property, Dionne discussed a possible alternative through the city along 4th Street.

"We have a desire to make the snowmobile trail more palatable to neighborhoods," said Dionne. Efforts towards

curbing speeders include supporting local law enforcement and DNR officials in patrolling the trails.

Dionne mentioned the possibility of providing a snowmobile to the police department for use in such patrols.

The Snowmobile Council is a volunteer program. Members work to promote the sport. The focus is on education of snowmobilers as well as the public. Other services the group provides are maintenance and grooming of the trails and bridges and insurance for owners of leased property.

■ Police Chief John Imeson warned council about the annual barrage of telephone solicitations from the Michigan Association of Police, based in Detroit.

Imeson has received several complaints that the group is collecting

money for child finger-printing. Although the work is legitimate, Imeson doesn't understand why East Jordan citizens should be approached to support a project in Detroit.

"It's not ethical," said Imeson and suggested directing complaints to the attorney-general's office.

■ Set a special council meeting to approve a cable TV regulatory ordi-

nance and an increase in sewer rates.

The sewer rate increase of about 20 percent is the first since 1990.

■ The council will support a request by Charlevoix County Commissioner Howard Hosler for a sheriff's sub-station in East Jordan.

Hosler is working with Sheriff George Lasater in researching financing options for the post.

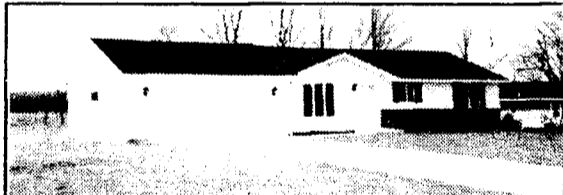

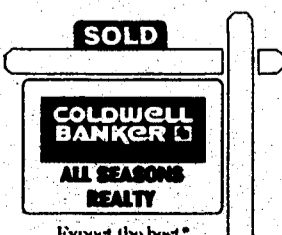

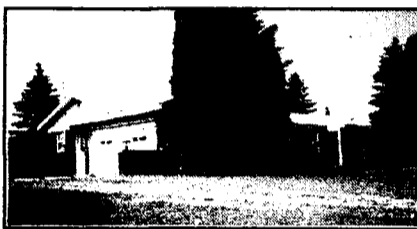
