"John Philip Sousa is coming to town," said band director Mike Haynes. "Not since 1920 has there been such an exhilarating and exciting performance in our area."

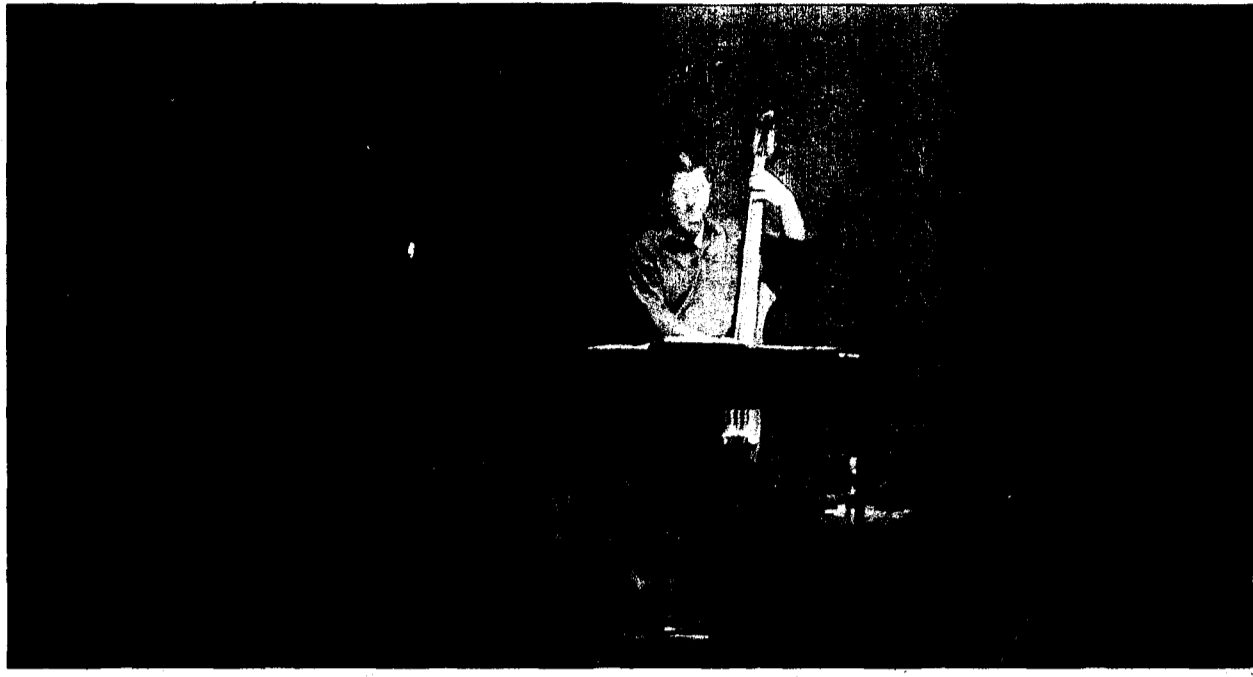

Juday pleads guilty

She awaits sentencing for stealing from food service program

Former Boyne City Public School employee Wendy Juday pleaded guilty April 19 in a plea hearing before U.S. Magistrate Judge Joseph G. Scovill in Grand Rapids to pocketing nearly \$100,000 in student lunch money.

The charge carries a maximum penalty of up to 10 years imprisonment, a fine of \$250,000 and restitution.

Juday, 43, will be sentenced July 18 by U.S. District Judge David W. McKeague in Lansing.

Daniel Mekaru of the U. S. Attorney's office in Grand Rapids said the penalty could be substantially less than the maximum, adding that Juday had no prior criminal record.

As part of her plea agreement, however, she agreed to pay back the stolen funds.

Juday is currently free on a \$50,000 unsecured bond, Mekaru said, but cannot leave the district, which roughly encompasses all of western Michigan north from Lansing and the Upper Peninsula.

The former cafeteria cashier was arrested March 16 on criminal complaint charges of embezzling more than \$100,000 from the school food service. She was arraigned April 1.

On June 1, 2004, the Boyne City police department was contacted by the Boyne City School District regarding the apparent ongoing theft of funds from the food service department. Because school food services are subsidized by the United States Department of Agriculture, federal investigators were contacted and a joint investigation began.

Mark McClutchey, a special agent of the USDA Office of Inspector General, issued an affidavit in support of a criminal complaint alleging that Juday stole funds from the Boyne City Public Schools lunch program over the five years of her employment with BCPS.

According to McClutchey's interview with Kathy Frugé, food service director at Boyne City schools, the food service department grossed ap-

VOTERS HEAD TO THE POLLS FOR ELECTION

May 3 is a big day for schools

Boyne City, Boyne Falls and East Jordan public schools all have their annual school elections on May 3.

Boyne Falls school board has an opening for one four-year term: East Jordan has two four-year positions open, as does Boyne City.

In Boyne Falls, current board member Marvin Schwem is running unopposed.

In Boyne City, retiring board member Jim Stackus's position will be open, as well as Scott Hausler's term, which was completed by Jerry Kelts. Kelts and Ross McLane are running unopposed for the open seats.

In East Jordan, current board members Korinna Holt and Mike Spence are also running for re-election, unopposed.

In addition to board members, vot-

ers will be asked to vote on millages in both Boyne City and East Jordan.

East Jordan residents will vote on a Building and Site Sinking Fund levy of .4 mill, or 40¢ per \$1,000 of taxable valuation on property for a period of five years.

If approved, the school will collect approximately \$123,199 over the next six years to establish a sinking fund for improvements to the buildings and grounds. Specifically, the sinking fund would be used to repair the roofs at the high school and elementary school, as well as replace the dehumidifying system at the Community Pool, in addition to smaller maintenance projects.

Boyne City schools will be asking voters to approve two millages.

The first millage request is for 18

mills, or \$18 on each \$1,000 of taxable valuation for three years, for an operating millage renewal which will allow the district to continue to levy the statutory rate of 18 mills on all property except principal residence and qualified agricultural property. This is a renewal of a levy that expired with the 2004 tax levy. If approved, the school district will collect approximately \$4,614,150 over the next three years.

In addition, Boyne City public schools is requesting a second operating millage of 1 mill, or \$1 on each \$1,000 of taxable valuation for the next three years. The millage is to restore millage lost as a result of the reduction required by the Michigan Constitution of 1963, and will be levied only to the extent necessary to

restore that reduction.

If approved, the millage would bring approximately \$256,342 into the district over the next three years.

THE POLLS WILL open at 7 a.m. on May 3, and will close at 8 p.m. The Boyne City polling locations are: Boyne City City Hall, 319 N. Lake St.; Bay Township Hall, 05045 Boyne City Rd., or Wilson Township Hall at 02530 BC/EJ Rd.

For East Jordan, polling locations are: East Jordan City Hall, 201 Main St.; South Arm Township Hall; 02811 S. M66.

In Boyne Falls, residents will be able to cast their votes for the seat on the school board from 7 a.m. to 8 p.m. at the Boyne Valley Township Hall at 3008 Main St.

Hud is a world champ

His fish carving wins top prize at international competition

Well, he's done it. Hud Robinson captured the First Place in the World, something few even strive for.

When we last caught up with Hud, he was a second-place wood-carving champion, but the World Taxidermy and Fish Carving championships in Springfield, Ill., were looming and he had a couple of fish to finish for entry.

The world championship takes place every two years, and Hud was competing against carvers from 18 different countries. Hud entered four fish. Two were carvings, and two went into the taxidermy category.

The taxidermy category allows fiberglass fish that are cast from real fish, cleaned and prepped and then painted to life-like authenticity. Hud's taxidermy entries each took second place. Hud doesn't like anything outside of first place, but those seconds made him happy.

"I was really excited about that, because I was up against people who do it for a living," he said. "They don't make it look good, and they don't eat."

And then the other two: he saw the carved rainbow trout and its antique-looking creel first.

"When we first walked in we saw the rainbow trout and there was a beautiful third place ribbon on it," Hud's wife, Patricia, said. "So he said, 'Let's go see what the other one got.'"

On his way to the competition, Hud felt okay. He felt like he'd done things right.

"As far as whether I felt confident ... it's hard to figure out. I try to do every fish better than the last. I thought I had everything right," he said. "But every judge is different."

He was a little worried about the judge who would be judging his category. "He's a tough judge," Hud said. "I went in there and I really felt good. I think I said, 'I got first place!'"

That first place was in his category. The best was yet to come. The championships ended in a banquet — "It was like the Oscars," Patricia said. There were girls, evening gowns, and envelopes — "And the winner is..."

"I didn't even hear my name. I didn't even know I won until all of a sudden my fish showed up on the screen," Hud said.

"I've had to pull all the bands on my hats," he said. "I think he's awesome," said Patricia.

"Some of those people are artists. They really know what they're doing," he said.

His proud wife pointed out that people don't get first place ribbons without being artists.

"Lucky shot," Hud said, grinning.

But he admits to feeling good about the event. They left with four fish and came back with four ribbons. Not bad, Hud thought, for little old people from the swamp.

SCHOOL BOARD APPROVES HIRING OF SCOTT HAUSLER

Lady Ramblers have new head coach

Scott Hausler was approved for employment as the new Boyne City Girls Varsity basketball coach last week at the Boyne City school board meeting, in what superintendent Jim Cooper said was the most exciting event of the evening.

The board also did the work of approving the payment of general fund bills, as well as hearing recommendations on probationary and tenure teachers.

Each of the teachers was granted his or her continuing status as recommended. Becoming eligible for tenure teacher status in 2005-06 were Jim Beckering, Lisa Klepper, and Amy Janssens; and continuing probationary status were Brandon Ivie, Jodi Barriger, Aaron Fritzsche, Marla Ryder, Don Richards, Susan Hicks, Roger Coates, Sandra Thomason, Regina Lacey, Bradley Klooster, Jenna Vratnina, and Annette Longcore.

"You have to have a passion to do this job," Cooper said of the teachers. "For those with the passion, it is an admirable profession." He complimented the teachers whose recommendations were before the board last week,

as well as the complete educational and support staff of the Boyne City schools.

The board also recognized the "outstanding efforts" of Susan Vrondran and Ray Speltz, who were the Boyne City Public Schools recipients of the Michigan Education Association's 2005 Outstanding Persons in Education Award.

"They are two excellent nominees and recipients," Cooper said. "Ray is a wonderful member of our team... Susan is a veteran teacher, very dedicated."

THE EAST JORDAN SCHOOL board also met last week, and superintendent Chip Hansen was able to provide the board with an update on the 2005-06 School Aid Fund discussions and their impact on the school district's finances.

Hansen said a lower-than-expected increase in school staff health insurance, 12.4 percent rather than the anticipated 15 percent, has reduced projected expenditures, which improves the overall financial position for 2005-

06 by approximately \$28,000. However, he indicated that the district still needs to reduce next year's budget by \$584,000 in order to balance expenditures against expected revenues.

The board reviewed an extensive list of potential budget reductions or revenue enhancements that may be considered. The board's discussions "focused on priorities, which include classroom instruction, programming and class size," according to Hansen.

The board also pointed out that with 80 percent of the school's budget being payroll-related, reductions in staff will be necessary.

The number of staff who may be displaced by the reductions in state funding may be reduced by voluntary leaves of absence, but the full impact will be unknown until it is clear how many leaves of absence are taken, and how many retirements occur.

All reductions will be finalized by June 30, when the board is required by law to approve a proposed operating budget for the 2005-06 school year.

The board also discussed summer school needs, directing high school principal Tammy Jackson to "further assess the need for summer coursework, as well as the anticipated number of students involved." The board is expected to set a fee for the summer program at their May meeting, according to Hansen.

Wilson Township lends a hand

■ It makes donation to Boyne City and East Jordan EMS

The local emergency medical services are better equipped this week, thanks to generous gifts made by Wilson Township recently.

Both John Lamont, Boyne City EMS director, and Jay Peck, East Jordan EMS director, expressed their gratitude to the township and Todd Sorenson, the township supervisor.

The Boyne City EMS was presented with a "stair chair," a device for transporting patients from places that are not accessible to a cot, such as an upstairs bedroom or through a narrow hall or doorway. The East Jordan EMS was given a portable transport ventilator.

"The ventilator allows us to breathe for a patient, delivering the right amount and rate of oxygen, without the human element of too much air, or too little, too fast or too slow," Peck said.

"It was a tremendous gift," he said. "For them to come to us and say, 'We'd like to help you. What can we do?' — it is so rare."

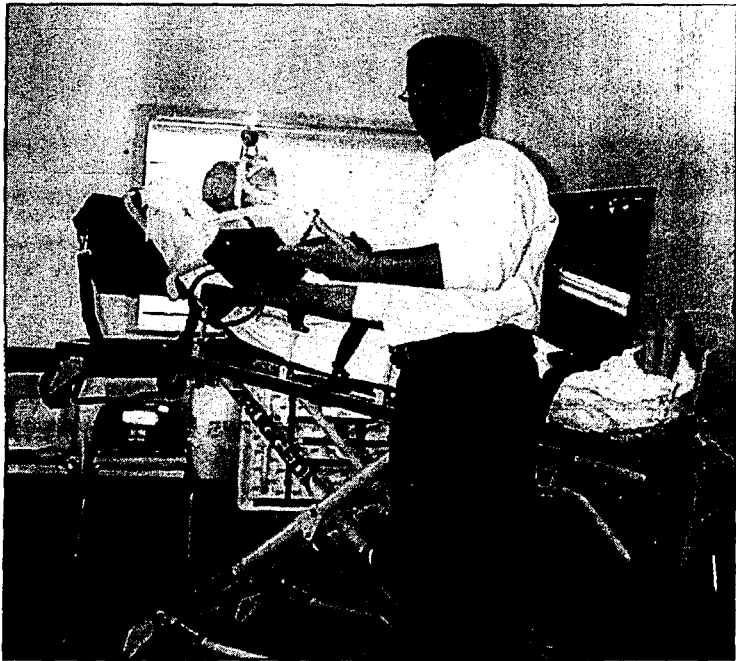
Peck explained that the townships pay a certain amount per year to keep the EMS services on standby as well as actual per-run user fees. Wilson Township budgets a certain amount of money for fire and EMS for payment of contracts. If there is money at the end of their fiscal year, the township uses it for special projects. Past projects have been underground water reservoirs and thermal imagers for the fire department. This year Sorenson asked for emergency medical service needs.

"It was a progressive move on the part of the township," Peck said. "They want to take care of potential problems. It reflects foresightedness. 'We want to be

ahead of the game.'"

In other EMS news, both services have recently completed training programs, with Boyne City having recently finished both a medical first responder course and an Emergency Medical Technician course. East Jordan is planning a medical first responder course, and has also has completed an Emergency Medical Technician course. Both EMT classes are taking state exams in the beginning of May. These classes will help build the volunteer staff of each service.

Boyne City EMS has recently purchased a new

Stryker XP-Pro cot for an ambulance.

Lamont also expressed his gratitude to the townships in his service area which have acted on an ambulance service agreement, helping to fund the capital needs of the service in Boyne City.

Both Lamont and Peck are available to teach cardio pulmonary resuscitation classes for workplace certification, as mandated by Occupational Safety and Health Administration.

EJ commission in mood to say yes

The East Jordan City Commission meeting was more about approving requests than anything else, with one after another moving quickly through the approval process.

There was a public hearing on the East Jordan proposed budget for fiscal year 2005-06, which has been described by city manager David White as a "very tight budget with some spending on capital and repair projects, also some much needed equipment. The continued uncertainty of State Shared Revenue and substantial cost increases make this budget very, very tight."

The proposed budget includes a balance of revenues and expenditures with an increase of approximately 2 percent over the current budget: the cost, according to White, of doing business.

"There is an increased cost for employees, equipment and the services we pay for," White said.

The biggest line items on the budget are for paving city streets, a project that has been put off for the last three years due to budgetary constrictions, and some equipment purchases, such as two new vehicles for the police department.

The public hearing was closed without comment from any of the members of the audience.

In East Jordan the budget is adopted by

ordinance. The commission acknowledged receipt of the introduction to Ordinance #195, the fiscal year 2005-06 budget. The city then had 14 days to adopt the Ordinance.

In other news, the commission heard from Dale Holland, director of the Crooked Tree Arts Council, about an effort by the arts council to introduce pieces of outdoor art to the northern Michigan area by rotating seven sculptures between seven northern Michigan communities. The council was asked to allow East Jordan to participate in the program. The sculptures would be for sale, and communities would have the opportunity to buy them, but would not be able to take possession until all the sculptures had been at all the communities for six months.

The program is free to the participating municipalities.

The commission agreed to participate, allowing for coordination with city staff in site selection.

White presented Mayor Mark Postma with a wall plaque which will be displayed at the Main Street Center. The city and Main Street, LLC won the Historic Preservation Network's Building Award, which was presented to White at the Kellogg Center in East Lansing.

"I would like to commend administrator

White for working a long time to help make this happen," said Postma.

A request was made by Tom Cannon, the city parks and recreation department head, to revise Tourist Park reservation policy to allow the city to take reservations at any time of the year, not, as current policy demands, starting on April 15.

This request was approved, to be implemented in January of 2006, with early reservations being taken by mail or E-mail only.

A request was made by Lori Campbell for use of the Tourist Park the weekend of Aug. 27 and 28 for the Charlevoix County Relay for Life event. The request also included reduced campsite rates as well as use of the Beach House and waiver of its rental fee.

The request was approved.

Other requests were by Lady Biker Day, Freedom Festival and Jordan River Sportsman's Club, as well as a request by a local business owner to erect a traditional buck pole during firearm deer hunting season.

The commission meeting did go into closed session for discussion of a possible real estate purchase. When the meeting was reopened, the city had made a back-up offer on the Four Corners building near the city boat launch. There is an offer currently pending on that building by a separate party.

Catching up with an old friend

When I was 11, our family got up early on Aug. 18 (Mom's birthday). Our dining room had big, triptic windows to the north and south, and they were open that morning. A cloud had come in, inadvertently, like a bird down the chimney, and hung over the table like a cool, damp ghost.

We closed the windows, trapping the cloud inside. I suppose, and left our house for a year.

We flew to England, Mom, Dad and seven children, like Captain Von Trapp and Maria. We went to the ancient Roman city of Bath, where my father taught English to the English, and we children enrolled in public schools — except for Ann, the oldest, who went to a girls' school, where she could get Spanish.

I remember the first few days there; I didn't have a uniform. We had packed lightly, too, naturally, so I had one dress. It was a beautiful, gypsy-style dress, a lovely print on a maroon background, with lacing at the waist, and a gathered neckline and sleeves. I loved it, but not for long.

My school, Ralph Allen, had a grey uniform: v-neck sweater, pleated skirt, tie. I stuck out like the proverbial sore thumb, and got some unwanted attention.

But once I had the regular uniform, it got much better. Well, I still got some attention — but in uniform, the attention was different.

It was the accent. I was popular from the first time I opened my mouth — which took a while as I was debilitatingly shy — merely by virtue of being a foreigner (that popularity caused me to permanently overcome my shyness, by the way).

Jane Hughes was in my class, my best friend, fiercest competitor, and my neighbor. I lived at 63 Dover's Park; she lived just five houses down, partway around a circle of grassy earth that we called the Green. The Green was flamboyantly green, lush as grass can only be in a climate that is almost always damp.

Because we lived around this Green, our houses were not in a line, but on a curve, and thus Jane's bedroom window and mine lined up, with just a small half-moon of Green between us.

We made telephones with cans and string, and strung them between our two bedrooms, and talked in loud whispers into them across the darkness of night — and they worked. Our houses were in a bowl on the side of a large surrounding hill, and the natural acoustics may have rendered the cans unnecessary, though; I do not know.

Jane swore using words like "bloody" and "bugger," and so I swore the same way, without breaking a single significant rule. There were other swear words Jane used that I did not dare, and others still that I mistakenly thought were benign merely because I had not heard them before, but was to learn my error the hard way. She wasn't a bad kid, but gritty. And besides, some words my parents just never reconciled to, if other parents did.

Jane was marvelously smart. She was athletic and witty, and fun to be around. She was in love with Donny Osmond. She was the (far) youngest child and only daughter, and probably pretty spoiled, but not in a way that spoiled her. She was generous. She wrote to me for years after I came home.

Even after I was long gone, Jane and I met infrequently via letters, sharing bits and pieces of life better confided in someone safely far away.

Thirty years after I left, I went back to England and saw Jane again.

I called her from a cell phone in Bath and asked her to meet me.

She said, "Where are you?" I said, "Bath." She said, "Baaath?" in the most obnoxious, nasally way. Nothing had changed: I loved her regal accent, she disdained my plebeian one.

Jane is here to visit me this week. It is her first time in the United States, so I am on vacation. I have racked my brain for weeks to think of the right ways to spend her precious days here, and I have decided we will do some really American things — like go shopping at a mall.

But mostly we are doing "vacation" things — Brits get holidays, not vacation, so it will be authentic. We're going out to Neil's cabin in the valley and roast hotdogs and make S'mores at the campfire. We'll drive up across the Straits. We will go canoeing if weather permits. We will see if we can beat the morel mushroom rush (what will be new about not finding any?).

It doesn't matter what we do, you know. We are catching up, each in her own separate accent, and it beats the heck out of a string and some cans.

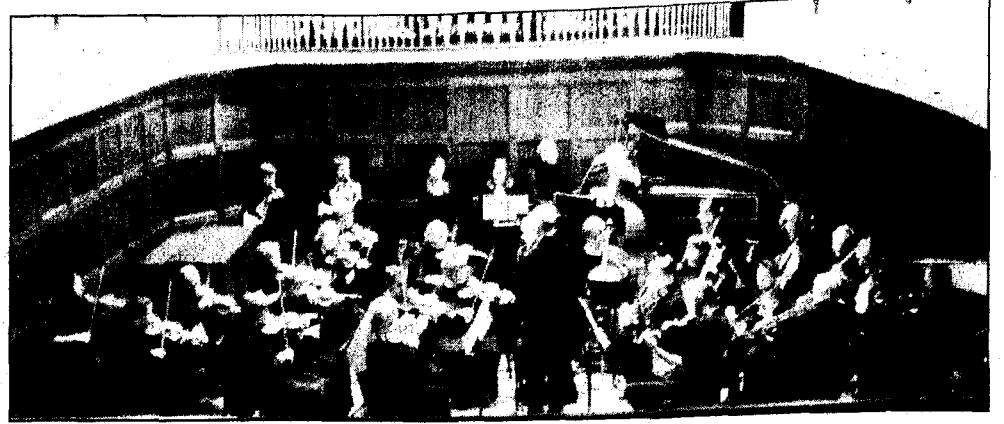

Arts center hosts printmaking exhibition

Artists and art patrons can still see the great collection of fine art prints now on exhibit at the Jordan River Arts Center.

Highlights of the 24th annual Alma College statewide print competition are on display. The many large, colored prints often incorporate traditional techniques with more contemporary printing processes.

Another winner, "Archimago," a print by Rebecca Zeiss, is constructed of "smaller panels arranged to create mirror images of reflective spheres and ladder structures that are ... machine-like and mysterious," according to a press release by the JRAC.

Viewer favorites include two very strong prints: "Beneath the Forest Floor Pleistocene Echidnasment Cuddles," and "Flesh-Eating Marsupial Lions with Wounds of Banksias," by Jenny Pope. There are color reductions, using only one block printed several times, with a final collograph printing.

Peggy Midener, area artist and JRAC board member, said, "It is a very professional show with lots of

variety with many conveying messages."

Meredith Krell and Steve Toornman, area printmakers, hung the show and led a discussion during the opening reception.

Informational materials are available to help art patrons be better informed about the art of printmaking.

In the opener the Chiefs scored one run in each of the first two frames and added four more in the fifth inning, while the Ramblers scored once in the fourth and twice in the fifth.

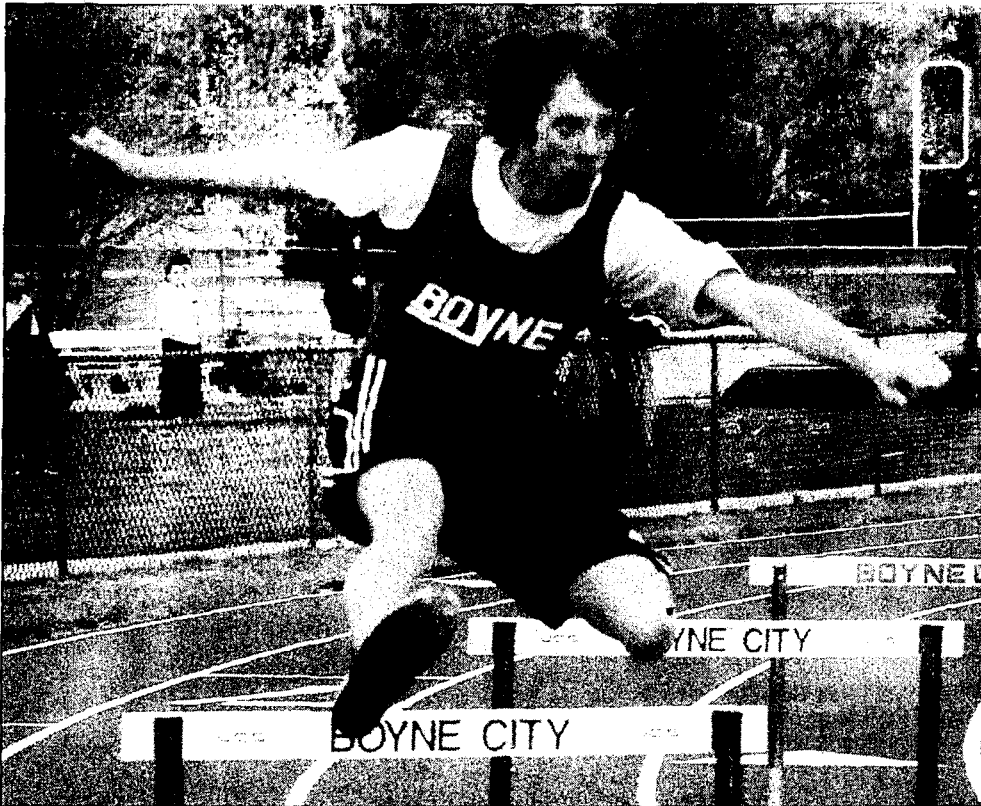
Rambler pitcher Tyler Kruzal took the loss, striking out seven and walking four in six innings of work.

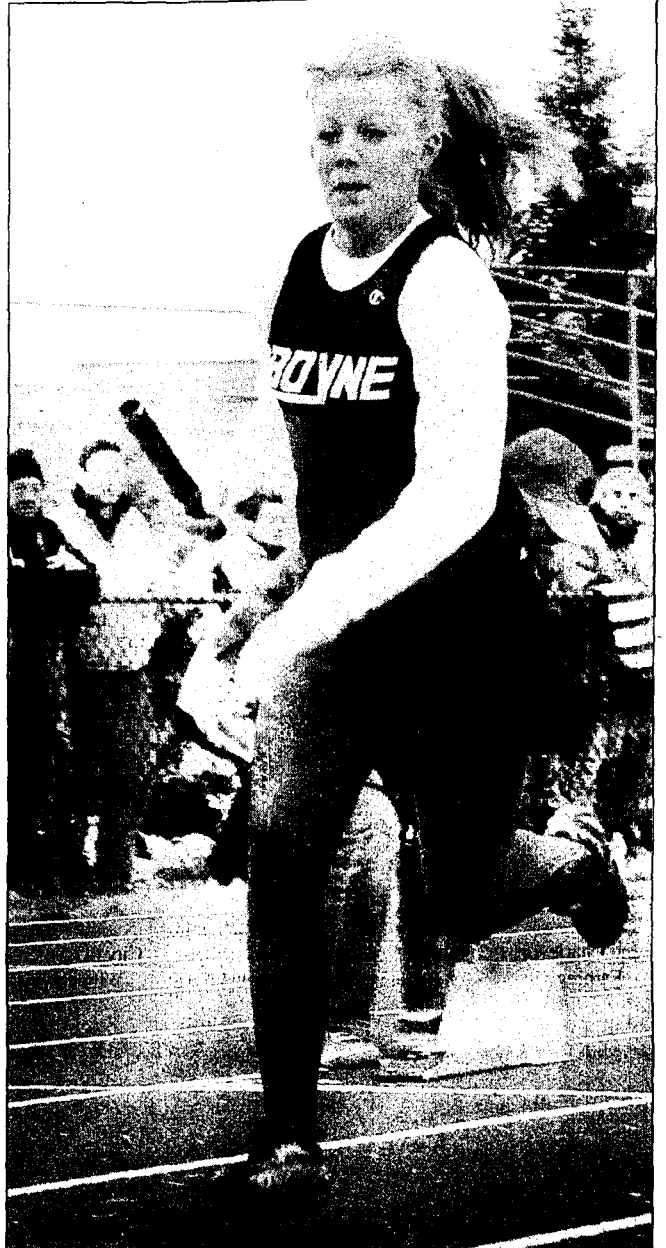

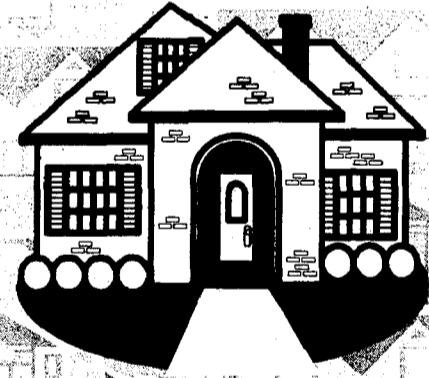

proximately \$30,000 during the 1997-98 school year. The following year Juday began working as a cashier. That year the gross revenue dropped to \$15,000.

By the 2002-03 school year, the food service department at BCPS was losing approximately \$20,000 annually, according to the complaint.

During the 2003-04 school year, Frugé began comparing recorded food sales on the days each of the cashiers, including Juday, worked against sales on the days each cashier did not work. In her statement to McClutchey, Frugé reported that she noticed that food sales were significantly higher on the days Juday did not work.

On Jan. 6, 2004, according to the complaint, Frugé watched from a remote computer monitor, and witnessed real-time transactions taking place at Juday's cash register. She observed Juday accept cash payments from students and then not register the sales. Frugé observed Juday at the end of the day as she closed out her register, and she saw her hit the "total" button first, which allowed Juday to know the amount of sales registered during that day.

A deficit averaging \$125 occurred on the days Juday was working. Based on this information,

McClutchey's affidavit alleges that Juday embezzled about \$106,700 during her five-year employment. Juday's employment was terminated on Feb. 19, 2004, but she had not reported to work since Jan. 9, according to Boyne City Assistant Police Chief Jeffrey Gettel.

On June 24, 2004, McClutchey interviewed Juday, who issued a written sworn statement.

"Within two to three months of starting work, I began taking money from the cash register," she wrote.

"I would intentionally not input food sales into the cash register, so that extra cash would be available at the end of the day.

"At the end of each day, I would total the food sales inputted into the computerized register, and keep all the cash in excess of that amount," she said.

According to her statement, Juday was taking the money when she transported the lunch money to the bank for deposit. She also stated that the amount varied every day depending upon what was being served in the lunchroom, but that she estimated that she was taking between \$40 and \$80 a day.

She also admitted to taking some money from football admissions before "handing over the money bag."

Juday also said that she used the money for living expenses and to pay for her children's activities.
